3		→SECTION 1. A NEW SECTION OF KRS 158.810 TO 158.818 IS CREATED
4	TO	READ AS FOLLOWS:
5	<u>(1)</u>	In order to ensure that Kentucky's system of career and technical education is
6		unified, equitably funded, collaborative, responsive to industry, and sustainable
7		and provides equalized access to all Kentucky students, notwithstanding KRS
8		156.844 and 157.069, the Kentucky Department of Education is directed to
9		develop a plan that transitions the management of every state-operated secondary
10		area vocational education and technology center to a local school district by July
11		1, 2024, and implements processes and requirements to achieve the system's
12		goals. Each local school district shall be subject to the plan and shall collaborate
13		with the department as needed to achieve the plan's objectives.
14	<u>(2)</u>	The commissioner of education shall establish and appoint members to a Career
15		and Technical Education Transition workgroup to work with the department on
16		the development and implementation of the comprehensive plan. The workgroup
17		shall include two (2) members of the Kentucky House of Representatives
18		appointed by the Speaker of the House of Representatives; two (2) members of the
19		Kentucky Senate appointed by the President of the Senate; representatives of
20		business and industry, the Office of Career and Technical Education, locally
21		operated secondary area centers, state-operated secondary area centers, the
22		Kentucky Association of School Superintendents, the Kentucky Association for
23		Career and Technical Education, the Kentucky School Boards Association, and
24		the Kentucky Association of School Administrators, including at least one (1)
25		technical center principal; and any other individuals deemed appropriate by the
26		commissioner.

1	<u>(a)</u>	Creating a process for determining which local board of education shall
2		assume management and control of each state-operated center;
3	<u>(b)</u>	Facilitating an interlocal agreement among school districts for the
4		transition of a state-operated center that serves students from more than
5		one (1) district;
6	<u>(c)</u>	Facilitating interlocal agreements among school districts to promote
7		regional academies;
8	<u>(d)</u>	Establishing requirements for the transfer of employees to local districts,
9		including but not limited to salary, accrued leave, and tenure;
10	<u>(e)</u>	Creating a process for determining needed career pathway programs that
11		aligns with the process established in KRS 158.6455(1)(c) for prioritizing
12		high-demand, industry-recognized postsecondary credentials, certifications,
13		and licensures, and incentivizing the offering of such programs;
14	<u>(f)</u>	Creating a process for the department's approval of new programs and
15		closing of existing programs, including developing guidelines for
16		determining continuing need for programs after one (1) year of being
17		transferred from a state-operated center to a local district;
18	<u>(g)</u>	Ensuring the alignment of career pathway programs with state standards;
19	<u>(h)</u>	Creating conditions for equalized access by all Kentucky students to at least
20		three (3) high-demand career pathways;
21	<u>(i)</u>	Developing a comprehensive, equitable funding model that includes
22		elements based on offering high-demand career pathways, district
23		collaboration and utilization of regional offerings, purchasing and
24		maintaining large equipment, and student outcomes; and
25	<u>(j)</u>	Developing a reorganization plan for the Office of Career and Technical
26		Education that reflects the ending of state management of the centers
27		including the transition of the office's employees.

1	(4) The plan's provisions shall be subject to the approval of the Kentucky Board of
2	Education.
3	(5) Beginning in 2020, the department shall provide an annual report by November
4	30 to the Interim Joint Committee on Education on the progress of the
5	workgroup and the implementation of the plan, including any needed statutory
6	changes and budget requests identified by the workgroup. The annual reports
7	shall be provided until the transition of all state-operated centers is completed.
8	→ Section 2. Having determined that changes are needed to the current state
9	processes for funding career and technical education to ensure adequate and equitable
10	funding and that a unified locally operated career and technical system is essential to
11	ensuring the Commonwealth's investments in career and technical education lead to
12	accomplishing state priorities, it is the intent of the General Assembly that all funds
13	appropriated for career and technical education beginning with the 2024-2025 fiscal year
14	be allocated using the comprehensive funding model developed in Section 1 of this Act.
