3		→SECTION 1. A NEW SECTION OF KRS 258.095 TO 258.500 IS CREATED
4	TOI	READ AS FOLLOWS:
5	<u>A</u> lo	ocal government may enact and enforce any ordinance, regulation, or policy
6	<u>conc</u>	erning dog safety and welfare or public safety, so long as that ordinance,
7	<u>regu</u>	lation, or policy does not regulate ownership of a dog because of its breed or
8	<u>perc</u>	eived breed and is consistent with state law.
9		→ Section 2. KRS 258.095 is amended to read as follows:
10	As u	sed in KRS 258.095 to 258.500, unless the context requires otherwise:
11	(1)	"Department" means the Department of Agriculture;
12	(2)	"Commissioner" means the Commissioner of Agriculture;
13	(3)	"Board" means the Animal Control Advisory Board created by KRS 258.117;
14	(4)	"Dog" means any domestic canine, six (6) months of age or older;
15	(5)	"Owner," when applied to the proprietorship of a dog, includes:
16		(a) Every person having a right of property in the dog; and
17		(b) Every person who:
18		1. Keeps or harbors the dog;
19		2. Has the dog in his or her care;
20		3. Permits the dog to remain on or about premises owned and occupied by
21		him or her; or
22		4. Permits the dog to remain on or about premises leased and occupied by
23		him or her;
24	(6)	"Attack" means a dog's attempt to bite or successful bite of a human being. This
25		definition shall not apply to a dog's attack of a person who has illegally entered or is
26		trespassing on the dog owner's property in violation of KRS 511.060, 511.070,
27		511.080, or 511.090;

- 1 (7) "Vicious dog" means any individual dog declared by a court to be a vicious dog;
- 2 (8) "Animal control officer" means an individual who is employed or appointed by, or
  3 has contracted with:
- 4 (a) A city, county, urban-county, charter county, or consolidated local
  5 government to enforce the provisions of this chapter, the provisions of the
  6 Kentucky Revised Statutes relating to cruelty, mistreatment, sexual crimes
  7 against, or torture of animals, and local animal control ordinances; or
- 8 (b) An entity that has contracted with a city, county, urban-county, charter county, 9 or consolidated local government to enforce the provisions of this chapter, the 10 provisions of the Kentucky Revised Statutes relating to cruelty, mistreatment, 11 sexual crimes against, or torture of animals, and local animal control 12 ordinances;
- (9) "Designated license facility" means any person, facility, or business designated by
  resolution of the governing body of the county to collect license fees under KRS
  258.135;

16 (10) "Cat" means any domestic feline three (3) months of age or older;

17 (11) "Ferret" means any domestic musteline three (3) months of age or older;

(12) "Euthanasia" means the act of putting an animal to death in a humane manner by
methods specified as acceptable for that species by the most recent report of the
American Veterinary Medical Association Panel on Euthanasia, subject to the
requirements provided by KRS 258.505;

- (13) "Animal shelter" means any facility used to house or contain animals, operated or
   maintained by a governmental body, incorporated humane society, animal welfare
   society, society for the prevention of cruelty to animals, or other nonprofit
   organization;
- (14) "Quarantine" means the confinement of an animal for observation of clinical signs
  of illness indicating rabies infection, and the prevention of escape or contact with

- 1 any person or other animal; 2 (15) "Livestock" means poultry; ratites; and cervine, bovine, ovine, porcine, caprine, or 3 equine animals that are privately owned and raised in a confined area for breeding 4 stock, food, fiber, or other products; [ and] 5 (16) "Poultry" means chickens, ducks, turkeys, or other domestic fowl: and 6 (17) "Local government" means any city, county, consolidated local government, 7 urban-county, charter county, unified local government, special purpose 8 government entity, or other local governmental unit created by or pursuant to an 9 Act of the General Assembly or Constitution of Kentucky, or any department,
- 10 <u>agency, or authority thereof</u>.
