- 3 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

- Section 1. KRS 61.595 is amended to read as follows:
- 5 Except as limited by KRS 61.5955 or 61.5956:

6 (1) Effective July 1, 1990, upon retirement at normal retirement date or subsequent
7 thereto, a member may receive an annual retirement allowance, payable monthly
8 during his lifetime, which shall consist of an amount equal to two and two-tenths
9 percent (2.2%) for the County Employees Retirement System and one and ninety10 seven hundredths percent (1.97%) for the Kentucky Employees Retirement System
11 of final compensation multiplied by the number of years of service credit, except
12 that:

13 Effective February 1, 1999, a member of the Kentucky Employees Retirement (a) 14 System who was participating in one (1) of the state-administered retirement 15 systems as of January 1, 1998, and continues to participate through January 1, 16 1999, shall receive an annual retirement allowance, payable monthly during 17 his lifetime, which shall consist of an amount equal to two percent (2%) of 18 final compensation multiplied by the number of years of service credit. Any 19 Kentucky Employees Retirement System member whose effective date of 20 retirement is between February 1, 1999, and January 31, 2009, and who has at 21 least twenty (20) years of service credit in one (1) of the state-administered 22 retirement systems and who was participating in one (1) of the state-23 administered retirement systems as of January 1, 1998, and continues to 24 participate through January 1, 1999, shall receive an annual retirement 25 allowance, payable monthly during his lifetime, which shall consist of an 26 amount equal to two and two-tenths percent (2.2%) of final compensation 27 multiplied by the number of years of service credit. 2 3 (b)	For a member of the County Employees Retirement System whose
4	participation begins on or after August 1, 2004, the annual retirement
5	allowance upon retirement at normal retirement date or later shall be equal to
6	two percent (2%) of final compensation multiplied by the number of years of
7	service credit and shall be payable monthly during his lifetime;
8 (c)	The annual normal retirement allowance for members of the General
9	Assembly, who serve during the 1974 or 1976 General Assembly, and will
10	have eight (8) years or more of total legislative service as of January 6, 1978,
11	shall not be less than two hundred forty dollars (\$240) multiplied by the
12	number of years of service as a member of the General Assembly;
13 (d)	For a member of the Kentucky Employees Retirement System or the County
14	Employees Retirement System who begins participating on or after September

4 (e) The annual normal retirement allowance for members of the General
5 Assembly who will have fewer than eight (8) years of service as of December
6 31, 1975, shall be as prescribed in Chapter 116, section 36(1), Acts of the
7 1972 General Assembly for legislative service prior to January 1, 1974;

8 (f) Former members of the General Assembly who have eight (8) or more years 9 of legislative service prior to the 1976 Regular Session are eligible for an 10 increased retirement allowance of two hundred forty dollars (\$240) times the 11 years of legislative service, if the member pays to the Kentucky Employees 12 Retirement System thirty-five percent (35%) of the actuarial cost of the higher 13 benefit, as determined by the system, except that a former member with 14 sixteen (16) or more years of legislative service, or his beneficiary, who is 15 receiving a retirement allowance, also is eligible under this section and may 16 apply for a recomputation of his retirement allowance. The employer's share 17 of sixty-five percent (65%) of the computed actuarial cost shall be paid from 18 the State Treasury to the Kentucky Employees Retirement System upon 19 presentation of a properly documented claim to the Finance and Administration Cabinet. If any member with sixteen (16) or more years of 20 21 legislative service previously applied for and is receiving a retirement 22 allowance, he may reapply and his retirement allowance shall be recomputed 23 in accordance with this paragraph, and he shall thereafter be paid in 24 accordance with the option selected by him at the time of the reapplication; 25 and

26 (g) The annual normal retirement allowance for a member with ten (10) or more
27 years of service, in the Kentucky Employees Retirement System, at least one

1 2 (1) of which is current service, shall not be less than five hundred twelve dollars (\$512).

- 3 (2)Upon service retirement prior to normal retirement date, a member may (a) 4 receive an annual retirement allowance payable monthly during his lifetime 5 which shall be determined in the same manner as for retirement at his normal 6 retirement date with years of service and final compensation being determined 7 as of the date of his actual retirement, but the amount of the retirement allowance so determined shall be reduced at an amount determined by the 8 9 board's actuary to reflect the earlier commencement of benefits.
- 10 A member of the Kentucky Employees Retirement System or the County (b) 11 Employees Retirement System who begins participating before September 1, 12 2008, who has twenty-seven (27) or more years of service credit, at least 13 fifteen (15) of which are current service, may retire with no reduction in the 14 retirement allowance. A member who begins participating before September 15 1, 2008, who has earned vested service credit in a retirement system, other 16 than the Teachers' Retirement System, sponsored by a Kentucky institution of 17 higher education, the Council on Postsecondary Education, or the Higher Education Assistance Authority, may count the vested service toward attaining 18 19 the necessary years of service credit as provided in KRS 61.559(2)(c) and (d) 20 to qualify for a retirement allowance. The credit from a Kentucky institution 21 of higher education, the Council on Postsecondary Education, or the Higher 22 Education Assistance Authority shall not be used toward the minimum fifteen 23 (15) years of current service required by KRS 61.559(2)(c) and (d) or to 24 calculate his retirement allowance pursuant to this section. The provisions of 25 this paragraph shall not be construed to limit the use of Teachers' Retirement 26 System credit pursuant to KRS 61.680(2)(a).

(c) A member of the Kentucky Employees Retirement System or the County

1		Employees Retirement System who begins participating on or after September
2		1, 2008, may retire with no reduction in benefits if the member is fifty-seven
3		(57) years of age or older and has an age and years of service total of at least
4		eighty-seven (87) years. The years of service used to determine eligibility for
5		an unreduced retirement allowance under this paragraph shall only include
6		years of service credited under KRS 16.543(1), 61.543(1), or 78.615(1) or
7		another state-administered retirement system.
8		(d) A member who began participating in the systems prior to January 1, 2014,
9		who has earned vested service credit in a retirement plan established by an
10		agency voluntarily ceasing participating in the Kentucky Employees
11		Retirement System pursuant to KRS 61.522, may count the vested service
12		toward attaining the necessary years of service credit as provided in
13		subsections (2)(c), (2)(d), and (3)(b) of Section 2 of this Act to qualify for a
14		retirement allowance or to reduce any applicable penalties under paragraph
15		(b) or (c) of this subsection. The credit from a plan established by an agency
16		ceasing participating in the Kentucky Employees Retirement System
17		pursuant to KRS 61.522 shall not be used to calculate his or her retirement
18		allowance pursuant to this section. The provisions of this paragraph shall
19		not be construed to limit the use of Teachers' Retirement System credit
20		pursuant to KRS 61.680(2)(a).
21	(3)	Subsections (1) and (2) of this section shall not apply to members who begin
22		participating in the system on or after January 1, 2014. Members who begin
23		participating in the system on or after January 1, 2014, shall receive the retirement

- 24 benefits prescribed by KRS 61.5956 or 61.597, as applicable.

- (1) In lieu of any other benefits due under KRS 61.510 to 61.705 and 78.510 to 78.852,

23			state-administered retirement system.
24	(4)	Sub	sections (1) to (3) of this section shall not apply to members who begin
25		parti	cipating in the system on or after January 1, 2014. Members who begin
26		parti	cipating in the system on or after January 1, 2014, shall receive the retirement
27		bene	efits prescribed by KRS 61.597 or the 401(a) money purchase plan prescribed by

1 KRS 61.5956, as applicable.
