1	A JOINT RESOLUTION directing the Cabinet for Health and Family Services to
2	establish the Task Force on Services for Persons with Brain Injuries.
3	WHEREAS, according to the Brain Injury Association of America, it is estimated
4	that every nine seconds a person in the United States sustains a brain injury; and
5	WHEREAS, an acquired brain injury (ABI) is an injury to the brain that is not
6	hereditary, congenital, degenerative, or induced by birth trauma; and
7	WHEREAS, typical causes of ABI include electric shock, infectious disease, stroke,
8	substance use disorder or overdose, and tumors; and
9	WHEREAS, there are many causes of traumatic brain injury (TBI), a type of ABI
10	caused by outside force, including falls, motor vehicle accidents, and assault; and
11	WHEREAS, every day an estimated 137 people die in the United States because of
12	a TBI-related injury; and
13	WHEREAS, brain injury is unpredictable in its consequences and can change
14	everything about a person in a matter of seconds; and
15	WHEREAS, for some, brain injury is the start of a lifelong disease process
16	requiring access to a full continuum of treatment and community-based supports provided
17	by appropriately educated clinicians serving on an interdisciplinary treatment team; and
18	WHEREAS, the availability of community-based services and supports for persons
19	with brain injury varies from state to state; and
20	WHEREAS, the focus of rehabilitation is to enable individuals to perform their
21	activities of daily living safely and independently so they can move on to other forms of
22	rehabilitation or transition to their home; and
23	WHEREAS, when a person sustains a brain injury, several members of that person's
24	community are affected, including families, friends, employers, government agencies,
25	healthcare providers, attorneys, insurance companies, and educators; and
26	WHEREAS, it is in the interest of all citizens of the Commonwealth to help persons
27	with ABIs to access the services and supports they need to reach their fullest life

1 Governor from a list of three names submitted by the Kentucky Advisory Board for 2 the Brain Injury Association of America; 3 (13) One family member of a person with an acquired or traumatic brain injury to be 4 appointed by the Governor from a list of three names submitted by the Kentucky 5 Advisory Board for the Brain Injury Association of America; and 6 (14) Two brain injury specialists with at least five years of experience in the field from a 7 list of three names submitted by the Kentucky Advisory Board for the Brain Injury 8 Association of America. 9 \rightarrow Section 4. The task force shall meet at least monthly beginning June 1, 2020. 10 The task force shall submit findings and recommendations for the improvement of 11 rehabilitation, residential, and integrated community-based support services for persons 12 with an acquired or traumatic brain injury and their families to the Legislative Research 13 Commission for referral to the appropriate committee or committees by December 1, 14 2020. 15 \rightarrow Section 5. The Task Force on Services for Persons with Brain Injuries shall
