

1 A RESOLUTION adjourning the Senate in honor and loving memory of Taylor Rae
2 Nolan, and in honor of the Rae of Sunshine Foundation.

3 WHEREAS, Taylor Rae Nolan was a daughter of this Commonwealth, having been
4 born in Lexington on April 28, 1999, to Taylora Schlosser and Donald Ray Nolan; and

5 WHEREAS, Taylor Rae Nolan was a member of the Creek Church in London and
6 attended Southland Christian Church in Lexington; and

7 WHEREAS, a 2017 graduate of Washington County High School, Taylor Rae
8 Nolan was a sophomore at the University of Kentucky, where she majored in
9 communication and digital media and design, and was a member of the Lambda Alpha
10 Chapter of Chi Omega; and

11 WHEREAS, Taylor Rae Nolan, cherished daughter, sister, and granddaughter,
12 departed this earthly life on January 8, 2019, leaving her family, friends, and all those
13 whose lives she touched in solemn mourning; and

14 WHEREAS, Taylor Rae Nolan is survived by her mother and father; stepfather,
15 Keith Schlosser; brothers, Colton Nolan, David Clay Brown, and Will Schlosser; sister,
16 Ava Nolan; paternal grandparents, Don and Bobbie Nolan; paternal step-grandparents,
17 Scott and Tina Schlosser; maternal grandparent, Leslie Couch; boyfriend, Noah Anthony;
18 and a host of other family members, friends, and loved ones who will dearly miss her
19 presence in their lives; and

20 WHEREAS, after Taylor Rae Nolan's tragic passing, the Rae of Sunshine
21 Foundation was created, which works to bring awareness to mental health issues, and
22 supports institutions which stress the importance of mental health; and

23 WHEREAS, this body honors the Rae of Sunshine Foundation on this day for their
24 tireless work to help those struggling with mental health, and in so doing grants the Nolan
25 and Schlosser families best wishes as they work to help some of this Commonwealth's
26 most vulnerable citizens;

27 NOW, THEREFORE,

1 *Be it resolved by the Senate of the General Assembly of the Commonwealth of*
2 *Kentucky:*

3 ➔Section 1. The members of the Senate hereby express their most profound
4 sympathy upon the passing of Taylor Rae Nolan, and rightfully honor the Rae of
5 Sunshine Foundation for its work and advocacy for mental health.

6 ➔Section 2. When the Senate adjourns this day, it does so in honor and loving
7 memory of Taylor Rae Nolan, and in honor of the Rae of Sunshine Foundation.
