1	A RESOLUTION declaring 2020 as the Year of the Eye Exam.
2	WHEREAS, the number of Kentuckians with impaired vision, including blindness
3	could more than double over the next three decades if appropriate preventive steps are no
4	taken; and
5	WHEREAS, eye diseases, vision loss, and eye disorders create an estimate two
6	billion dollar economic burden for Kentuckians; and
7	WHEREAS, 16 percent of Americans with no new symptoms or vision problems
8	were diagnosed with a new eye condition during a routine eye exam, including glaucoma
9	macular degeneration, and diabetic retinopathy—all of which can result in blindness; and
10	WHEREAS, it is widely recognized by healthcare professionals that an eye
11	examination provides the best window to assess the body's vascular health condition and
12	many previously undiagnosed systemic conditions, such as diabetes, can be found; and
13	WHEREAS, from 2000 to 2017, diagnosed diabetes in Kentucky adults nearly
14	doubled, with the Commonwealth ranking seventh highest in the United States for
15	diabetes; and
16	WHEREAS, making a comprehensive eye exam with primary eye-care providers
17	part of annual healthcare routines is the simplest step people can take to protect vision
18	and ensure early diagnosis of and treatment for visual system diseases such as glaucoma
19	a leading cause of blindness; and
20	WHEREAS, the Kentucky Optometric Association and its member doctors of
21	optometry serve as gatekeepers to the overall health of their patients; and
22	WHEREAS, the year 2020 creates the unique opportunity to encourage citizens to
23	understand the importance of eye health and take care of their vision and health by
24	making an appointment for an in-person, comprehensive eye exam;
25	NOW, THEREFORE,
