

1 AN ACT relating to nursing.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 314.021 is amended to read as follows:

4 (1) It is the declared policy of the General Assembly of Kentucky that the practice of  
5 nursing, ***and the practices of licensed certified professional midwives and dialysis***  
6 ***technicians***, should be regulated and controlled as provided herein and by  
7 regulations of the board in order to protect and safeguard the health and safety of  
8 the citizens of the Commonwealth of Kentucky.

9 (2) All individuals licensed or privileged under provisions of this chapter ***and***  
10 ***administrative regulations of the board*** shall be responsible and accountable for  
11 making decisions that are based upon the individuals' educational preparation and  
12 experience~~[in nursing]~~ and shall practice ~~[nursing]~~ with reasonable skill and safety.

13 ➔Section 2. KRS 314.042 is amended to read as follows:

14 (1) An applicant for licensure to practice as an advanced practice registered nurse shall  
15 file with the board a written application for licensure and submit evidence, verified  
16 by oath, that the applicant:

17 (a) Has completed an education program that prepares the registered nurse for one  
18 (1) of four (4) APRN roles that has been accredited by a national nursing  
19 accrediting body recognized by the United States Department of Education;

20 (b) Is certified by a nationally established organization or agency recognized by  
21 the board to certify registered nurses for advanced practice registered nursing;

22 (c) Is able to understandably speak and write the English language and to read the  
23 English language with comprehension; and

24 (d) Has passed the jurisprudence examination approved by the board as provided  
25 in subsection (12) of this section.

26 (2) The board may issue a license to practice advanced practice registered nursing to an  
27 applicant who holds a current active registered nurse license issued by the board or

1 holds the privilege to practice as a registered nurse in this state and meets the  
2 qualifications of subsection (1) of this section. An advanced practice registered  
3 nurse shall be:

4 (a) Designated by the board as a certified registered nurse anesthetist, certified  
5 nurse midwife, certified nurse practitioner, or clinical nurse specialist; and

6 (b) Certified in at least one (1) population focus.

7 (3) The applicant for licensure or renewal thereof to practice as an advanced practice  
8 registered nurse shall pay a fee to the board as set forth in regulation by the board.

9 (4) An advanced practice registered nurse shall maintain a current active registered  
10 nurse license issued by the board or hold the privilege to practice as a registered  
11 nurse in this state and maintain current certification by the appropriate national  
12 organization or agency recognized by the board.

13 (5) Any person who holds a license to practice as an advanced practice registered nurse  
14 in this state shall have the right to use the title "advanced practice registered nurse"  
15 and the abbreviation "APRN." No other person shall assume the title or use the  
16 abbreviation or any other words, letters, signs, or figures to indicate that the person  
17 using the same is an advanced practice registered nurse. No person shall practice as  
18 an advanced practice registered nurse unless licensed under this section.

19 (6) Any person heretofore licensed as an advanced practice registered nurse under the  
20 provisions of this chapter who has allowed the license to lapse may be reinstated on  
21 payment of the current fee and by meeting the provisions of this chapter and  
22 regulations promulgated by the board pursuant to the provisions of KRS Chapter  
23 13A.

24 (7) The board may authorize a person to practice as an advanced practice registered  
25 nurse temporarily and pursuant to applicable regulations promulgated by the board  
26 pursuant to the provisions of KRS Chapter 13A if the person is awaiting~~the results~~  
27 ~~of the national certifying examination for the first time or is awaiting~~ licensure by

1 endorsement. ~~[A person awaiting the results of the national certifying examination~~  
2 ~~shall use the title "APRN Applicant" or "APRN App."]~~

- 3 (8) (a) Except as authorized by ~~[KRS 314.196 and ]~~subsection (9) of this section,  
4 before an advanced practice registered nurse engages in the prescribing or  
5 dispensing of nonscheduled legend drugs as authorized by KRS 314.011(8),  
6 the advanced practice registered nurse shall enter into a written "Collaborative  
7 Agreement for the Advanced Practice Registered Nurse's Prescriptive  
8 Authority for Nonscheduled Legend Drugs" (CAPA-NS) with a physician  
9 licensed in Kentucky that defines the scope of the prescriptive authority for  
10 nonscheduled legend drugs.
- 11 (b) The advanced practice registered nurse shall notify the Kentucky Board of  
12 Nursing of the existence of the CAPA-NS and the name of the collaborating  
13 physician and shall, upon request, furnish to the board or its staff a copy of the  
14 completed CAPA-NS. The Kentucky Board of Nursing shall notify the  
15 Kentucky Board of Medical Licensure that a CAPA-NS exists and furnish the  
16 collaborating physician's name.
- 17 (c) The CAPA-NS shall be in writing and signed by both the advanced practice  
18 registered nurse and the collaborating physician. A copy of the completed  
19 collaborative agreement shall be available at each site where the advanced  
20 practice registered nurse is providing patient care.
- 21 (d) The CAPA-NS shall describe the arrangement for collaboration and  
22 communication between the advanced practice registered nurse and the  
23 collaborating physician regarding the prescribing of nonscheduled legend  
24 drugs by the advanced practice registered nurse.
- 25 (e) The advanced practice registered nurse who is prescribing nonscheduled  
26 legend drugs and the collaborating physician shall be qualified in the same or  
27 a similar specialty.

1 (f) The CAPA-NS is not intended to be a substitute for the exercise of  
2 professional judgment by the advanced practice registered nurse or by the  
3 collaborating physician.

4 (g) The CAPA-NS shall be reviewed and signed by both the advanced practice  
5 registered nurse and the collaborating physician and may be rescinded by  
6 either party upon written notice~~[ via registered mail]~~ to the other party and~~[,~~  
7 the Kentucky Board of Nursing~~[, and the Kentucky Board of Medical~~  
8 ~~Licensure]~~.

9 (9) (a) Before an advanced practice registered nurse may discontinue or be exempt  
10 from a CAPA-NS required under subsection (8) of this section, the advanced  
11 practice registered nurse shall have completed four (4) years of prescribing as  
12 a nurse practitioner, clinical nurse specialist, nurse midwife, or as a nurse  
13 anesthetist. For nurse practitioners and clinical nurse specialists, the four (4)  
14 years of prescribing shall be in a population focus as defined in KRS 314.011.

15 (b) After four (4) years of prescribing with a CAPA-NS in collaboration with a  
16 physician:

17 1. An advanced practice registered nurse whose license is in good standing  
18 at that time with the Kentucky Board of Nursing and who will be  
19 prescribing nonscheduled legend drugs without a CAPA-NS shall notify  
20 that board that the four (4) year requirement has been met and that he or  
21 she will be prescribing nonscheduled legend drugs without a CAPA-NS;

22 2. The advanced practice registered nurse will no longer be required to  
23 maintain a CAPA-NS and shall not be compelled to maintain a CAPA-  
24 NS as a condition to prescribe after the four (4) years have expired, but  
25 an advanced practice registered nurse may choose to maintain a CAPA-  
26 NS indefinitely after the four (4) years have expired; and

27 3. If the advanced practice registered nurse's license is not in good

1 standing, the CAPA-NS requirement shall not be removed until the  
2 license is restored to good standing.

3 (c) An advanced practice registered nurse wishing to practice in Kentucky  
4 through licensure by endorsement is exempt from the CAPA-NS requirement  
5 if the advanced practice registered nurse:

6 1. Has met the prescribing requirements in a state that grants independent  
7 prescribing to advanced practice registered nurses; and

8 2. Has been prescribing for at least four (4) years.

9 (d) An advanced practice registered nurse wishing to practice in Kentucky  
10 through licensure by endorsement who had a collaborative prescribing  
11 agreement with a physician in another state for at least four (4) years is  
12 exempt from the CAPA-NS requirement.

13 ~~[(e) 1.— An advanced practice registered nurse whose license is in good standing  
14 at that time with the Kentucky Board of Nursing and who will be  
15 prescribing nonscheduled legend drugs without a CAPA-NS shall notify  
16 that board that the four (4) year requirement has been met and that he or  
17 she will be prescribing nonscheduled legend drugs without a CAPA-NS.~~

18 ~~2.— An advanced practice registered nurse who has maintained a CAPA-NS  
19 for four (4) years or more will no longer be required to maintain a  
20 CAPA-NS and shall not be compelled to maintain a CAPA-NS as a  
21 condition to prescribe after the four (4) years have expired, but an  
22 advanced practice registered nurse may choose to maintain a CAPA-NS  
23 indefinitely after the four (4) years have expired.~~

24 ~~3.— An advanced practice registered nurse who has maintained a CAPA-NS  
25 for less than four (4) years shall be required to continue to maintain a  
26 CAPA-NS until the four (4) year period is completed, after which the  
27 CAPA-NS will no longer be required.]~~

- 1 (10) (a) Before an advanced practice registered nurse engages in the prescribing of  
2 Schedules II through V controlled substances as authorized by KRS  
3 314.011(8), the advanced practice registered nurse shall enter into a written  
4 "Collaborative Agreement for the Advanced Practice Registered Nurse's  
5 Prescriptive Authority for Controlled Substances" (CAPA-CS) with a  
6 physician licensed in Kentucky that defines the scope of the prescriptive  
7 authority for controlled substances.
- 8 (b) The advanced practice registered nurse shall notify the Kentucky Board of  
9 Nursing of the existence of the CAPA-CS and the name of the collaborating  
10 physician and shall, upon request, furnish to the board or its staff a copy of the  
11 completed CAPA-CS. The Kentucky Board of Nursing shall notify the  
12 Kentucky Board of Medical Licensure that a CAPA-CS exists and furnish the  
13 collaborating physician's name.
- 14 (c) The CAPA-CS shall be in writing and signed by both the advanced practice  
15 registered nurse and the collaborating physician. A copy of the completed  
16 collaborative agreement shall be available at each site where the advanced  
17 practice registered nurse is providing patient care.
- 18 (d) The CAPA-CS shall describe the arrangement for collaboration and  
19 communication between the advanced practice registered nurse and the  
20 collaborating physician regarding the prescribing of controlled substances by  
21 the advanced practice registered nurse.
- 22 (e) The advanced practice registered nurse who is prescribing controlled  
23 substances and the collaborating physician shall be qualified in the same or a  
24 similar specialty.
- 25 (f) The CAPA-CS is not intended to be a substitute for the exercise of  
26 professional judgment by the advanced practice registered nurse or by the  
27 collaborating physician.

- 1 (g) Before engaging in the prescribing of controlled substances, the advanced  
2 practice registered nurse shall:
- 3 1. Have been licensed to practice as an advanced practice registered nurse  
4 for one (1) year with the Kentucky Board of Nursing; or
  - 5 2. Be nationally certified as an advanced practice registered nurse and be  
6 registered, certified, or licensed in good standing as an advanced  
7 practice registered nurse in another state for one (1) year prior to  
8 applying for licensure by endorsement in Kentucky.
- 9 (h) Prior to prescribing controlled substances, the advanced practice registered  
10 nurse shall obtain a Controlled Substance Registration Certificate through the  
11 U.S. Drug Enforcement Agency.
- 12 (i) The CAPA-CS shall be reviewed and signed by both the advanced practice  
13 registered nurse and the collaborating physician and may be rescinded by  
14 either party upon written notice to the other party and the Kentucky Board of  
15 Nursing.
- 16 (j) The CAPA-CS shall state the limits on controlled substances which may be  
17 prescribed by the advanced practice registered nurse, as agreed to by the  
18 advanced practice registered nurse and the collaborating physician. The limits  
19 so imposed may be more stringent than either the schedule limits on  
20 controlled substances established in KRS 314.011(8) or the limits imposed in  
21 regulations promulgated by the Kentucky Board of Nursing thereunder.
- 22 **(k) Within thirty (30) days of obtaining a Controlled Substance Registration**  
23 **Certificate from the United States Drug Enforcement Administration, and**  
24 **prior to prescribing controlled substances, the advanced practice registered**  
25 **nurse shall register with the electronic system for monitoring controlled**  
26 **substances established by KRS 218A.202 and shall provide a copy of the**  
27 **registration certificate to the board.**

1 (11) Nothing in this chapter shall be construed as requiring an advanced practice  
2 registered nurse designated by the board as a certified registered nurse anesthetist to  
3 enter into a collaborative agreement with a physician, pursuant to this chapter or any  
4 other provision of law, in order to deliver anesthesia care.

5 (12) The jurisprudence examination shall be prescribed by the board and be conducted  
6 on the licensing requirements under this chapter and board regulations and  
7 requirements applicable to advanced practice registered nursing in this  
8 Commonwealth. The board shall promulgate administrative regulations in  
9 accordance with KRS Chapter 13A, establishing the provisions to meet this  
10 requirement.

11 ➔Section 3. KRS 314.107 is amended to read as follows:

12 Any person licensed by the board shall maintain a current mailing address **and an**  
13 **electronic mailing address** with the board and immediately notify the board in writing of  
14 a change of mailing address **or electronic mailing address**. As a condition of holding a  
15 license from the board, a licensee is deemed to have consented to service of notices or  
16 orders of the board at the mailing address on file with the board, and any notice or order  
17 of the board mailed or delivered to the mailing address on file with the board constitutes  
18 valid service of the notice or order.

19 ➔Section 4. KRS 314.131 is amended to read as follows:

20 (1) The board shall meet at least annually and shall elect from its members a president  
21 and any other officers that it deems necessary. Nine members of the board including  
22 one (1) officer shall constitute a quorum at any meeting. The board is authorized to  
23 promulgate administrative regulations not inconsistent with the law and subject to  
24 the provisions of KRS Chapter 13A, as may be necessary to enable it to carry into  
25 effect the provisions of this chapter. **The board may require, by administrative**  
26 **regulation, that licensees and applicants utilize a specific method of submission**  
27 **of documents or information that is required to be provided to the board under**



1       *this chapter and the administrative regulations of the board, including electronic*  
2       *submission.*

3       (2) The board shall approve programs of nursing and shall monitor compliance with  
4       standards for nurse competency under this chapter. It shall examine, license, and  
5       renew the license of duly-qualified applicants; determine notice of place and time of  
6       licensure examinations; approve providers of continuing education; administer  
7       continuing education requirements; issue advisory opinions or declaratory rulings  
8       dealing with the practice of nursing; register and designate those persons qualified  
9       to engage in advanced nursing practice; and it shall conduct administrative hearings  
10      in accordance with KRS Chapter 13B upon charges calling for discipline of a  
11      licensee and cause the prosecution of all persons violating any provisions of this  
12      chapter. It shall keep a record of all its proceedings and make an annual report to the  
13      Governor.

14      (3) The board shall develop specific guidelines to follow upon receipt of an allegation  
15      of sexual misconduct by a nurse licensed by the board. The guidelines shall include  
16      investigation, inquiry, and hearing procedures which ensure that the process does  
17      not revictimize the alleged victim or cause harm if a nurse is falsely accused.

18      (4) The board and investigators hired by the board shall receive training on the  
19      dynamics of sexual misconduct of professionals, including the nature of this abuse  
20      of authority, characteristics of the offender, the impact on the victim, the possibility  
21      and the impact of false accusations, investigative procedure in sex offense cases,  
22      and effective intervention with victims and offenders.

23      (5) The board shall employ a qualified person to serve as executive director to the  
24      board, and shall fix the compensation and define the duties of the executive  
25      director. It may employ other persons as may be necessary to carry on the work of  
26      the board.

27      (6) The executive director shall have at least the qualifications for board members, and

1 a master's degree in nursing or equivalent and shall have had at least two (2) years  
2 of experience in nursing administration immediately preceding the time of  
3 appointment.

4 (7) Each member of the board shall receive, in addition to traveling, hotel, and other  
5 necessary expenses, one hundred fifty dollars (\$150) for each day the member is  
6 actually engaged in the discharge of official duties.

7 (8) The board may, in its discretion, purchase liability insurance for board and staff  
8 members against acts performed in good faith discharge of duties.

9 (9) The board may, by administrative regulation issued pursuant to the provisions of  
10 KRS Chapter 13A, determine which disciplinary action records may be expunged.  
11 Any records which are expunged shall be exempt from disclosure under the  
12 Kentucky Open Records Law, KRS 61.870 to 61.884. The board shall not report its  
13 disciplinary actions for any purpose other than statistical.

14 (10) The board may reimburse any person appointed by direction of the board to any  
15 committee, subcommittee, or task force created by the board for his or her travel  
16 and subsistence expenses as established through the promulgation of administrative  
17 regulations in accordance with KRS Chapter 13A.
