- 3 Be it enacted by the General Assembly of the Commonwealth of Kentucky:
- 4 → Section 1. KRS 150.255 is amended to read as follows:
- 5 (1) Upon request of any state agency or any other entity, the department may contract
- 6 with the agency or party to undertake any compensatory mitigation project,
- 7 including, but not limited to, wetland or stream mitigation.
- 8 (2) The department may establish and manage wetland or stream compensatory
- 9 mitigation banks, the purpose of which shall be to restore, create, or enhance
- 10 wetlands and streams as compensatory mitigation where a state agency or other
- party is required to provide compensatory mitigation, and where the use of banked
- mitigation is approved by the agency requiring mitigation. The department may
- create the bank in advance of requests for banked mitigation credits.
 - (3) There is established and created in the State Treasury the "Kentucky Wetland and
- 15 Stream Mitigation Fund" for the purpose of restoring, creating, enhancing, or
- preserving the Commonwealth's wetlands or streams that may be damaged or
- destroyed due to any project, recovering costs associated with performing these
- projects, and administering these programs. The fund shall be deemed a trust and
- agency fund account and made available solely for the purposes and benefits of the
- 20 Kentucky wetland and stream mitigation projects. The fund may receive state
- appropriations, gifts, grants, federal funds, revolving funds, and any other funds
- both public and private. Money deposited in the fund shall be disbursed by the State
- 23 Treasurer upon the request of the commissioner with the approval of the
- 24 commission. Any unallocated or unencumbered balance in the fund shall be
- invested as provided in KRS 42.500(9), and any income earned from the
- investments, along with the unallocated or unencumbered balance in the fund, shall
