11	(c) ''Immediate family member'' means a parent, grandparent, spouse, child,

14	(d) "Personally identifying information" means information that identifies or
15	reasonably can be used to identify an individual, including but not limited

17	1. Social Security number or other government-issued identifier;
18	2. Date of birth;
19	3. Home or physical address;
20	4. Electronic-mail address or telephone number;
21	5. Financial account number or credit or debit card number;
22	6. Biometric, health, or medical data, or insurance information; or
23	7. School or employment locations.
24	(2) A person is guilty of disseminating personally identifying information about
25	another person when, with the intent to intimidate, abuse, threaten, harass, or

2		(b) The dissemination would cause a reasonable person to be in fear of physical
3		injury to himself or herself, or to his or her immediate family member or
4		household member.
5	<u>(3)</u>	This section shall apply to electronic communications originating within or
6		accessible within the Commonwealth.
7	<u>(4)</u>	Disseminating personally identifying information is a Class A misdemeanor,
8		unless the dissemination results in:
9		(a) Physical injury to the victim or to a victim's immediate family member or
10		household member, in which case it is a Class D felony;
11		(b) Serious physical injury to the victim or to a victim's immediate family
12		member or household member, in which case it is a Class C felony; or
13		(c) Death of the victim or of a victim's immediate family member or household
14		member, in which case it is a Class B felony.
15	<u>(5)</u>	Nothing in this section shall be construed to impose liability on a broadband
