

1 AN ACT related to dementia services.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 194A.600 is amended to read as follows:

4 As used in KRS 194A.600 to 194A.609:

- 5 (1) "Council" means the Alzheimer's Disease and Related Disorders Advisory Council;
- 6 (2) "Dementia" means Alzheimer's disease and related dementia illnesses and disorders;
- 7 and
- 8 (3) "Office" means the Office ***of Dementia Services***~~[on Alzheimer's Disease and~~  
9 ~~Related Disorders]~~.

10 ➔Section 2. KRS 194A.601 is amended to read as follows:

- 11 (1) The Office ***of Dementia Services***~~[on Alzheimer's Disease and Related Disorders]~~ is  
12 established within the cabinet. The purpose of the office is to oversee information  
13 and resources related to policy and services affecting ~~[the sixty thousand (60,000)~~  
14 ~~]residents of Kentucky with dementia, and the caregivers and families of the~~  
15 residents.
- 16 (2) The ***dementia services coordinator***~~[director of the office]~~ shall be a full-time,  
17 permanent employee and shall be responsible for the staffing and operational details  
18 of the office. A report on the ***operations of the office shall be made to the secretary***  
19 ***within ninety (90) days of the effective date of this Act. An annual report on the***  
20 ***operation of the office***~~[start-up and implementation of the office]~~ shall be made to  
21 the Interim Joint Committee on Health, ***Welfare, and Family Services***~~[and~~  
22 ~~Welfare]~~ by ***December 1 of each year***~~[September 30, 2000, and on a quarterly basis~~  
23 ~~thereafter]~~.
- 24 (3) The ***duties of the*** office shall ***include but not be limited to:***
- 25 (a) ***Creating, implementing, and updating the Kentucky Alzheimer's and***  
26 ***Related Dementias State Plan;***
- 27 (b) ***Coordinating and managing the Alzheimer's Disease and Related Disorders***

1           Advisory Council;

2           (c) Assessing and analyzing dementia-specific data collected by the cabinet,  
3           including the behavioral risk factor surveillance system, and data from  
4           other relevant departments and divisions;

5           (d) Evaluating of state-funded dementia services;

6           (e) Identifying and supporting the development of dementia-specific trainings;

7           (f) Streamlining all applicable state government services to increase efficiency  
8           and improve the quality of care in residential and home and community-  
9           based settings;

10          (g) Identifying any duplicative services to eliminate all unnecessary costs;

11          (h) Identifying and applying for grant opportunities to expand the scope of  
12          services while reducing state costs; and

13          (i) Completing other duties relevant to supporting policy development and  
14          implementation to support individuals with dementia and their family  
15          caregivers ~~Enhance the quality of life for persons affected by dementia and~~  
16          ~~for their caregivers;~~

17          ~~(b) Recommend the delivery of services in the most effective and efficient~~  
18          ~~manner possible to facilitate the needs of people with dementia and their~~  
19          ~~caregivers, after consultation with other agencies of state government that~~  
20          ~~work with dementia-related illness;~~

21          ~~(c) Determine ways the Commonwealth may secure additional federal and private~~  
22          ~~funding to provide additional services and programs through a coordinated~~  
23          ~~effort;~~

24          ~~(d) Apply for any public or private funding relating to dementia that will enhance~~  
25          ~~the office's abilities to perform its duties under this section;~~

26          ~~(e) Promote public and professional awareness and education of dementia and~~  
27          ~~access to needed services and programs;~~

- 1 ~~(f) Oversee and receive reports from the Alzheimer's Disease and Related~~  
 2 ~~Disorders Advisory Council; and~~
- 3 ~~(g) Coordinate and oversee the implementation of the recommendations of the~~  
 4 ~~1995 Governor's Task Force on Alzheimer's Disease and Related Disorders].~~

5 ➔Section 3. KRS 194A.603 is amended to read as follows:

- 6 (1) The Alzheimer's Disease and Related Disorders Advisory Council is created. The  
 7 council shall report directly to the office.
- 8 (2) The council shall be composed of *the following*~~[a minimum of]~~ fifteen (15)  
 9 members:
- 10 *(a) The secretary of the Cabinet for Health and Family Services or his or her*  
 11 *designee;*
- 12 *(b) The commissioner of the Department for Aging and Independent Living or*  
 13 *his or her designee;*
- 14 *(c) The commissioner of the Department for Public Health or his or her*  
 15 *designee;*
- 16 *(d) The commissioner of the Department for Medicaid Services or his or her*  
 17 *designee;*
- 18 *(e) The state long-term care ombudsman or his or her designee;*
- 19 *(f) The executive director of the Area Agencies on Aging or his or her*  
 20 *designee;*
- 21 *(g) One (1) individual who is the family caregiver of an individual living with*  
 22 *Alzheimer's disease or another dementia, appointed by the Governor from a*  
 23 *list of names of qualified persons submitted by any interested parties;*
- 24 *(h) One (1) individual who represents the residential long-term care industry,*  
 25 *appointed by the Governor from a list of names of qualified persons*  
 26 *submitted by any interested parties;*
- 27 *(i) One (1) individual who represents providers of adult day care services,*

- 1           appointed by the Governor from a list of names of qualified persons  
2           submitted by any interested parties;
- 3           (j) One (1) individual who represents the home care providers, appointed by  
4           the Governor from a list of names of qualified persons submitted by any  
5           interested parties;
- 6           (k) One (1) individual employed by and representing an organization that  
7           advocates solely on behalf of physicians, appointed by the Governor from a  
8           list of names of qualified persons submitted by any interested parties;
- 9           (l) One (1) individual employed by and representing an organization that  
10           advocates solely on behalf of nurses, appointed by the Governor from a list  
11           of names of qualified persons submitted by any interested parties;
- 12           (m) One (1) individual who conducts research regarding Alzheimer's disease or  
13           other dementias, appointed by the Governor from a list of names of  
14           qualified persons submitted by any interested parties;
- 15           (n) One (1) individual who represents an organization that advocates solely on  
16           behalf of individuals living with Alzheimer's disease or other dementias,  
17           appointed by the Governor from a list of names of qualified persons  
18           submitted by any interested parties; and
- 19           (o) One (1) individual representing a statewide organization that advocates on  
20           behalf of Kentuckians aged fifty (50) or older, appointed by the Governor  
21           from a list of names of qualified persons submitted by any interested  
22           parties. ~~Three (3) members shall represent agencies of state government~~  
23           ~~dealing with dementia, three (3) shall represent local health departments, one~~  
24           ~~(1) shall represent the University of Kentucky Alzheimer's Disease Research~~  
25           ~~Center at the Sanders Brown Center on Aging, at least one (1) shall be~~  
26           ~~appointed from each of the chapters of the Alzheimer's Disease and Related~~  
27           ~~Disease Association that serve the Commonwealth, and the remainder shall~~

1 represent consumers, health care providers, and the medical research  
2 community.]

3 **(3)** Members who are not state employees shall be reimbursed for necessary and actual  
4 expenses.

5 **(4)** The council shall meet ***at least*** quarterly ***and at other such times as it determines***  
6 ***necessary to perform its duties***. A majority of the members shall constitute a  
7 quorum for the transaction of the council's business.

8 ~~**(5)**~~~~**(3)**~~ The council shall:

9 (a) Elect its own chairperson and establish other officers and subcommittees as  
10 needed to execute the duties of the council;

11 (b) Adopt bylaws and operate under its bylaws;

12 (c) ***Starting on July 1, 2021, and repeating every four (4) years after that date,***  
13 ***submit an updated Kentucky Alzheimer's and Related Dementias State Plan***  
14 ***to the Governor for his or her approval and thereafter make it available to***  
15 ***the General Assembly. If the council determines that amendments need to***  
16 ***be made to the state plan, an amended Kentucky Alzheimer's and Related***  
17 ***Dementia State Plan may be presented to the Governor for review and***  
18 ***approval;***

19 ***(d) Starting on July 1, 2021, and repeating every year after that date, submit an***  
20 ***annual report on the implementation progress of the Kentucky Alzheimer's***  
21 ***and Related Dementias State Plan to the Governor. This annual report shall***  
22 ***include a summary of the progress toward implementation of the state plan***  
23 ***and recommendations for amendments to the state plan; and***

24 ***(e) Serve in an advisory capacity to the Governor, the General Assembly, the***  
25 ***cabinet and all other state agencies on matters relating to the Kentucky***  
26 ***Alzheimer's and Related Dementias State Plan. The council shall review***  
27 ***and make recommendations regarding progress towards the goals of the***

1           state plan and on progress in implementing resources and services to serve  
2           individuals with dementia and related diseases across Kentucky in the  
3           future[Select the director of the office;

4           (d) ~~Establish and evaluate goals and outcomes for the office that may facilitate~~  
5           ~~treatment and care of persons with dementia;~~

6           (e) ~~Assist with the dissemination of information about the availability of program~~  
7           ~~materials, education materials, and curriculum guides; and~~

8           (f) ~~Prepare a report of its activities, at least annually, for submission to the~~  
9           ~~office].~~

10       ~~(6)~~~~(4)~~   Members shall serve for a term of two (2) years and may be reappointed. All  
11       subsequent appointments or reappointments shall be for terms of two (2) years. If  
12       an appointee resigns or is otherwise unable to complete the appointed term, the  
13       Governor shall appoint a new individual whose expertise or experience satisfies  
14       the vacated position within ninety (90) days[The office shall provide requested  
15       personnel to assist the council in fulfilling its responsibilities].
