

1 AN ACT relating to the Uniform Deployed Parents Custody and Visitation Act.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. KRS CHAPTER 403A IS ESTABLISHED AND A NEW
4 SECTION THEREOF IS CREATED TO READ AS FOLLOWS:

5 *This chapter may be cited as the Uniform Deployed Parents Custody and Visitation*
6 *Act.*

7 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
8 READ AS FOLLOWS:

9 *As used in this chapter:*

10 *(1) "Adult" means an individual who has attained eighteen (18) years of age or an*
11 *emancipated minor;*

12 *(2) "Caretaking authority" means the right to live with and care for a child on a day-*
13 *to-day basis. The term includes physical custody, parenting time, right to access,*
14 *and visitation;*

15 *(3) "Child" means:*

16 *(a) An unemancipated individual who has not attained eighteen (18) years of*
17 *age; or*

18 *(b) An adult son or daughter by birth or adoption, or under law of this state*
19 *other than this chapter, who is the subject of a court order concerning*
20 *custodial responsibility;*

21 *(4) "Court" means a tribunal authorized under law of this state other than this*
22 *chapter to make, enforce, or modify a decision regarding custodial responsibility;*

23 *(5) "Custodial responsibility" includes all powers and duties relating to caretaking*
24 *authority and decision-making authority for a child. The term includes physical*
25 *custody, legal custody, parenting time, right to access, visitation, and authority to*
26 *grant limited contact with a child;*

27 *(6) "Decision-making authority" means the power to make important decisions*

1 regarding a child, including decisions regarding the child's education, religious
2 training, health care, extracurricular activities, and travel. The term does not
3 include the power to make decisions that necessarily accompany a grant of
4 caretaking authority;

5 (7) "Deploying parent" means a service member, who is deployed or has been
6 notified of impending deployment and is:

7 (a) A parent of a child under law of this state other than this chapter; or

8 (b) An individual who has custodial responsibility for a child under law of this
9 state other than this chapter;

10 (8) "Deployment" means the movement or mobilization of a service member for
11 more than ninety (90) days but less than eighteen (18) months pursuant to
12 uniformed service orders that:

13 (a) Are designated as unaccompanied;

14 (b) Do not authorize dependent travel; or

15 (c) Otherwise do not permit the movement of family members to the location to
16 which the service member is deployed;

17 (9) "Family member" means a sibling, aunt, uncle, cousin, stepparent, or
18 grandparent of a child or an individual recognized to be in a familial relationship
19 with a child under law of this state other than this chapter;

20 (10) "Limited contact" means the authority of a nonparent to visit a child for a
21 limited time. The term includes authority to take the child to a place other than
22 the residence of the child;

23 (11) "Nonparent" means an individual other than a deploying parent or other parent;

24 (12) "Other parent" means an individual who, in common with a deploying parent, is:

25 (a) A parent of a child under law of this state other than this chapter; or

26 (b) An individual who has custodial responsibility for a child under law of this
27 state other than this chapter;

1 (13) "Record" means information that is inscribed on a tangible medium or that is
2 stored in an electronic or other medium and is retrievable in perceivable form;

3 (14) "Return from deployment" means the conclusion of a service member's
4 deployment as specified in uniformed service orders;

5 (15) "Service member" means a member of a uniformed service;

6 (16) "Sign" means, with present intent to authenticate or adopt a record:

7 (a) To execute or adopt a tangible symbol; or

8 (b) To attach to or logically associate with the record an electronic symbol,
9 sounds, or process;

10 (17) "State" means a state of the United States, the District of Columbia, Puerto Rico,
11 the United States Virgin Islands, or any territory or insular possession subject to
12 the jurisdiction of the United States; and

13 (18) "Uniformed service" means:

14 (a) Active and reserve components of the Army, Navy, Air Force, Marine
15 Corps, or Coast Guard of the United States;

16 (b) The United States Merchant Marine;

17 (c) The commissioned corps of the United States Public Health Service;

18 (d) The commissioned corps of the National Oceanic and Atmospheric
19 Administration of the United States; or

20 (e) The National Guard of a state.

21 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
22 READ AS FOLLOWS:

23 In addition to other remedies under law of this state other than this chapter, if a court
24 finds that a party to a proceeding under this chapter has acted in bad faith or
25 intentionally failed to comply with this chapter or a court order issued under this
26 chapter, the court may assess reasonable attorney's fees and costs against the party and
27 order other appropriate relief.

1 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
2 READ AS FOLLOWS:

3 *(1) A court may issue an order regarding custodial responsibility under this chapter*
4 *only if the court has jurisdiction under the Uniform Child Custody Jurisdiction*
5 *and Enforcement Act, KRS 403.800 to 403.880.*

6 *(2) If a court has issued a temporary order regarding custodial responsibility*
7 *pursuant to Sections 13 to 23 of this Act, the residence of the deploying parent is*
8 *not changed by reason of the deployment for the purposes of the Uniform Child*
9 *Custody Jurisdiction and Enforcement Act during the deployment.*

10 *(3) If a court has issued a permanent order regarding custodial responsibility before*
11 *notice of deployment and the parents modify that order temporarily by agreement*
12 *pursuant to Sections 8 to 12 of this Act, the residence of the deploying parent is*
13 *not changed by reason of the deployment for the purposes of the Uniform Child*
14 *Custody Jurisdiction and Enforcement Act.*

15 *(4) If a court in another state has issued a temporary order regarding custodial*
16 *responsibility as a result of impending or current deployment, the residence of the*
17 *deploying parent is not changed by reason of the deployment for the purposes of*
18 *the Uniform Child Custody Jurisdiction and Enforcement Act.*

19 *(5) This section does not prevent a court from exercising temporary emergency*
20 *jurisdiction under the Uniform Child Custody Jurisdiction and Enforcement Act.*

21 ➔SECTION 5. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
22 READ AS FOLLOWS:

23 *(1) Except as otherwise provided in subsection (4) of this section, and subject to*
24 *subsection (3) of this section, a deploying parent shall notify in a record the other*
25 *parent of a pending deployment not later than seven (7) days after receiving*
26 *notice of deployment unless reasonably prevented from doing so by the*
27 *circumstances of service. If the circumstances of service prevent giving*

1 notification within the seven (7) days, the deploying parent shall give the
2 notification as soon as reasonably possible.

3 (2) Except as otherwise provided in subsection (4) of this section, and subject to
4 subsection (3) of this section, each parent shall provide in a record the other
5 parent with a plan for fulfilling that parent's share of custodial responsibility
6 during deployment. Each parent shall provide the plan as soon as reasonably
7 possible after notification of deployment is given under subsection (1) of this
8 section.

9 (3) If a court order currently in effect prohibits disclosure of the address or contact
10 information of the other parent, notification of deployment under subsection (1)
11 of this section, or notification of a plan for custodial responsibility during
12 deployment under subsection (2) of this section, may be made only to the issuing
13 court. If the address of the other parent is available to the issuing court, the court
14 shall forward the notification to the other parent. The court shall keep
15 confidential the address or contact information of the other parent.

16 (4) Notification in a record under subsection (1) or (2) of this section is not required
17 if the parents are living in the same residence and both parents have actual notice
18 of the deployment or plan.

19 (5) In a proceeding regarding custodial responsibility, a court may consider the
20 reasonableness of a parent's efforts to comply with this section.

21 ➔SECTION 6. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
22 READ AS FOLLOWS:

23 (1) Except as otherwise provided in subsection (2) of this section, an individual to
24 whom custodial responsibility has been granted during deployment pursuant to
25 Sections 8 to 12 or 13 to 23 of this Act shall notify the deploying parent and any
26 other individual with custodial responsibility of a child of any change of the
27 individual's mailing address or residence until the grant is terminated. The

1 individual shall provide the notice to any court that has issued a custody or child
2 support order concerning the child which is in effect.

3 (2) If a court order currently in effect prohibits disclosure of the address or contact
4 information of an individual to who custodial responsibility has been granted, a
5 notification under subsection (1) of this section may be made only to the court
6 that issued the order. The court shall keep confidential the mailing address or
7 residence of the individual to who custodial responsibility has been granted.

8 ➔SECTION 7. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
9 READ AS FOLLOWS:

10 In a proceeding for custodial responsibility of a child of a service member, a court may
11 not consider a parent's past deployment or possible future deployment in itself in
12 determining the best interest of the child but may consider any significant impact on
13 the best interest of the child of the parent's past or possible future deployment.

14 ➔SECTION 8. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
15 READ AS FOLLOWS:

16 (1) The parents of a child may enter into a temporary agreement under Sections 8 to
17 12 of this Act granting custodial responsibility during deployment.

18 (2) An agreement under subsection (1) of this section shall be:

19 (a) In writing; and

20 (b) Signed by both parents and any nonparent to whom custodial responsibility
21 is granted.

22 (3) Subject to subsection (4) of this section, an agreement under subsection (1) of
23 this section, if feasible, shall:

24 (a) Identify the destination, duration, and conditions of the deployment that is
25 the basis for the agreement;

26 (b) Specify the allocation of caretaking authority among the deploying parent,
27 the other parent, and any nonparent;

- 1 (c) Specify any decision-making authority that accompanies a grant of
2 caretaking authority;
- 3 (d) Specify any grant of limited contact to a nonparent;
- 4 (e) If under the agreement custodial responsibility is shared by the other parent
5 and a nonparent, or by other nonparents, provide a process to resolve any
6 dispute that may arise;
- 7 (f) Specify the frequency, duration, and means, including electronic means, by
8 which the deploying parent will have contact with the child, any role to be
9 played by the other parent in facilitating the contact, and the allocation of
10 any costs of contact;
- 11 (g) Specify the contact between the deploying parent and child during the time
12 the deploying parent is on leave or is otherwise available;
- 13 (h) Acknowledge that any party's child-support obligation cannot be modified
14 by the agreement, and that changing the terms of the obligation during the
15 deployment requires modification in the appropriate court;
- 16 (i) Provide that the agreement will terminate according to the procedures
17 under Sections 24 to 27 of this Act after the deploying parent returns from
18 deployment; and
- 19 (j) If the agreement must be filed pursuant to Section 12 of this Act, specify
20 which parent is required to file the agreement.
- 21 (4) The omission of any of the items specified in subsection (3) of this section does
22 not invalidate an agreement under this section.

23 ➔SECTION 9. A NEW SECTION OF KRS CHAPTER 403A IS CREATED TO
24 READ AS FOLLOWS:

- 25 (1) An agreement under Sections 8 to 12 of this Act is temporary and terminates
26 pursuant to Sections 24 to 27 of this Act after the deploying parent returns from
27 deployment, unless the agreement has been terminated before that time by court

1 order or modification under Section 10 of this Act. The agreement does not create
 2 an independent, continuing right to caretaking authority, decision-making
 3 authority, or limited contact in an individual to whom custodial responsibility is
 4 given.

5 (2) A nonparent who has caretaking authority, decision-making authority, or limited
 6 contact by an agreement under Sections 8 to 12 of this Act has standing to
 7 enforce the agreement until it has been terminated by court order, by
 8 modification under Section 10 of this Act, or under Sections 24 to 27 of this Act.

9 ➔SECTION 10. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 10 TO READ AS FOLLOWS:

11 (1) By mutual consent, the parents of a child may modify an agreement regarding
 12 custodial responsibility made pursuant to Sections 8 to 12 of this Act.

13 (2) If an agreement is modified under subsection (1) of this section before
 14 deployment of a deploying parent, the modification shall be in writing and signed
 15 by both parents and any nonparent who will exercise custodial responsibility
 16 under the modified agreement.

17 (3) If an agreement is modified under subsection (1) of this section during
 18 deployment of a deploying parent, the modification shall be agreed to in a record
 19 by both parents and any nonparent who will exercise custodial responsibility
 20 under the modified agreement.

21 ➔SECTION 11. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 22 TO READ AS FOLLOWS:

23 A deploying parent, by power of attorney, may delegate all or part of custodial
 24 responsibility to an adult nonparent for the period of deployment if no other parent
 25 possesses custodial responsibility under law of this state other than this chapter, or if a
 26 court order currently in effect prohibits contact between the child and the other parent.
 27 The deploying parent may revoke the power of attorney by signing a revocation of the

1 power.

2 ➔SECTION 12. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
3 TO READ AS FOLLOWS:

4 *An agreement or power of attorney under Sections 8 to 12 of this Act shall be filed*
5 *within a reasonable time with any court that has entered an order on custodial*
6 *responsibility or child support that is in effect concerning the child who is the subject*
7 *of the agreement or power. The case number and heading of the pending case*
8 *concerning custodial responsibility or child support shall be provided to the court with*
9 *the agreement or power.*

10 ➔SECTION 13. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
11 TO READ AS FOLLOWS:

12 *As used in Sections 13 to 23 of this Act, "close and substantial relationship" means a*
13 *relationship in which a significant bond exists between a child and a nonparent.*

14 ➔SECTION 14. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
15 TO READ AS FOLLOWS:

16 *(1) After a deploying parent receives notice of deployment and until the deployment*
17 *terminates, a court may issue a temporary order granting custodial responsibility*
18 *unless prohibited by the Servicemembers Civil Relief Act, 50 U.S.C. Appendix*
19 *Sections 521 and 522. A court may not issue a permanent order granting*
20 *custodial responsibility without the consent of the deploying parent.*

21 *(2) At any time after a deploying parent receives notice of deployment, either parent*
22 *may file a motion regarding custodial responsibility of a child during deployment.*
23 *The motion shall be filed in a pending proceeding for custodial responsibility in a*
24 *court with jurisdiction under Section 4 of this Act or, if there is no pending*
25 *proceeding in a court with jurisdiction under Section 4 of this Act, in a new*
26 *action for granting custodial responsibility during deployment.*

27 ➔SECTION 15. A NEW SECTION OF KRS CHAPTER 403A IS CREATED

1 TO READ AS FOLLOWS:

2 *If a motion to grant custodial responsibility is filed under subsection (2) of Section 14*
3 *of this Act before a deploying parent deploys, the court shall conduct an expedited*
4 *hearing.*

5 ➔SECTION 16. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
6 TO READ AS FOLLOWS:

7 *In a proceeding under Sections 13 to 23 of this Act, a party or witness who is not*
8 *reasonably available to appear personally may appear, provide testimony, and present*
9 *evidence by electronic means unless the court finds good cause to require a personal*
10 *appearance.*

11 ➔SECTION 17. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
12 TO READ AS FOLLOWS:

13 *In a proceeding for a grant of custodial responsibility pursuant to Sections 13 to 23 of*
14 *this Act, the following rules apply:*

15 *(1) A prior judicial order designating custodial responsibility in the event of*
16 *deployment is binding on the court unless the circumstances meet the*
17 *requirements of law of this state other than this chapter for modifying a judicial*
18 *order regarding custodial responsibility; and*

19 *(2) The court shall enforce a prior written agreement between the parents for*
20 *designating custodial responsibility in the event of deployment, including an*
21 *agreement executed under Sections 8 to 12 of this Act, unless the court finds that*
22 *the agreement is contrary to the best interest of the child.*

23 ➔SECTION 18. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
24 TO READ AS FOLLOWS:

25 *(1) On motion of a deploying parent and in accordance with law of this state other*
26 *than this chapter, if it is in the best interest of the child, a court may grant*
27 *caretaking authority to a nonparent who is an adult family member of the child*

1 or an adult with whom the child has a close and substantial relationship.

2 (2) Unless a grant of caretaking authority to a nonparent under subsection (1) of this
 3 section is agreed to by the other parent, the grant is limited to an amount of time
 4 not greater than:

5 (a) The amount of time granted to the deploying parent under a permanent
 6 custody order, but the court may add unusual travel time necessary to
 7 transport the child; or

8 (b) In the absence of a permanent custody order that is currently in effect, the
 9 amount of time that the deploying parent habitually cared for the child
 10 before being notified of deployment, but the court may add unusual travel
 11 time necessary to transport the child.

12 (3) A court may grant part of a deploying parent's decision-making authority, if the
 13 deploying parent is unable to exercise that authority, to a nonparent who is an
 14 adult family member of the child or an adult with whom the child has a close and
 15 substantial relationship. If a court grants the authority to a nonparent, the court
 16 shall specify the decision-making powers granted, including decisions regarding
 17 the child's education, religious training, health care, extracurricular activities,
 18 and travel.

19 ➔SECTION 19. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 20 TO READ AS FOLLOWS:

21 On motion of a deploying parent, and in accordance with law of this state other than
 22 this chapter, unless the court finds that the contact would be contrary to the best
 23 interest of the child, a court shall grant limited contact to a nonparent who is a family
 24 member of the child or an individual with whom the child has a close and substantial
 25 relationship.

26 ➔SECTION 20. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 27 TO READ AS FOLLOWS:

1 (1) A grant of authority under Sections 13 to 23 of this Act is temporary and
2 terminates under Sections 24 to 27 of this Act after the return from deployment of
3 the deploying parent, unless the grant has been terminated before that time by
4 court order. The grant does not create an independent, continuing right to
5 caretaking authority, decision-making authority, or limited contact in an
6 individual to whom it is granted.

7 (2) A nonparent granted caretaking authority, decision-making authority, or limited
8 contact under Sections 13 to 23 of this Act has standing to enforce the grant until
9 it is terminated by court order or under Sections 24 to 27 of this Act.

10 ➔SECTION 21. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
11 TO READ AS FOLLOWS:

12 (1) An order granting custodial responsibility under this article shall:

13 (a) Designate the order as temporary; and

14 (b) Identify to the extent feasible the destination, duration, and conditions of
15 the deployment.

16 (2) If applicable, an order for custodial responsibility under Sections 13 to 23 of this
17 Act shall:

18 (a) Specify the allocation of caretaking authority, decision-making authority, or
19 limited contact among the deploying parent, the other parent, and any
20 nonparent;

21 (b) If the order divides caretaking or decision-making authority between
22 individuals, or grants caretaking authority to one (1) individual and limited
23 contact to another, provide a process to resolve any dispute that may arise;

24 (c) Provide for liberal communication between the deploying parent and the
25 child during deployment, including through electronic means, unless
26 contrary to the best interest of the child, and allocate any costs of
27 communication;

1 (d) Provide for liberal contact between the deploying parent and the child
 2 during the time the deploying parent is on leave or otherwise available,
 3 unless contrary to the best interest of the child;

4 (e) Provide for the reasonable contact between the deploying parent and the
 5 child after return from deployment until the temporary order is terminated,
 6 even if the time of contact exceeds the time the deploying parent spent with
 7 the child before entry of the temporary order; and

8 (f) Provide that the order will terminate pursuant to Sections 24 to 27 of this
 9 Act after the deploying parent returns from deployment.

10 ➔SECTION 22. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 11 TO READ AS FOLLOWS:

12 If a court has issued an order granting caretaking authority under this article, or an
 13 agreement granting caretaking authority has been executed under Sections 8 to 12 of
 14 this Act, the court may enter a temporary order for child support consistent with law of
 15 this state other than this chapter if the court has jurisdiction under the Uniform
 16 Interstate Family Support Act, KRS 407.5101 to 407.5902.

17 ➔SECTION 23. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 18 TO READ AS FOLLOWS:

19 (1) Except for an order under Section 17 of this Act, except as otherwise provided in
 20 subsection (2) of this section, and consistent with the Servicemembers Civil Relief
 21 Act, 50 U.S.C. Appendix Sections 521 and 522, on motion of a deploying or other
 22 parent or any nonparent to whom caretaking authority, decision-making
 23 authority, or limited contact has been granted, the court may modify or terminate
 24 the grant if the modification or termination is consistent with Sections 13 to 23 of
 25 this Act and it is in the best interest of the child. A modification is temporary and
 26 terminates pursuant to Sections 24 to 27 of this Act after the deploying parent
 27 returns from deployment, unless the grant has been terminated before that time

1 by court order.

2 (2) On motion of a deploying parent, the court shall terminate a grant of limited
3 contact.

4 ➔SECTION 24. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
5 TO READ AS FOLLOWS:

6 (1) At any time after return from deployment, a temporary agreement granting
7 custodial responsibility under Sections 8 to 12 of this Act may be terminated by
8 an agreement to terminate signed by the deploying parent and the other parent.

9 (2) A temporary agreement under Sections 8 to 12 of this Act granting custodial
10 responsibility terminates:

11 (a) If an agreement to terminate under subsection (1) of this section specifies a
12 date for termination, on that date; or

13 (b) If the agreement to terminate does not specify a date, on the date the
14 agreement to terminate is signed by the deploying parent and the other
15 parent.

16 (3) In the absence of an agreement under subsection (1) of this section to terminate,
17 a temporary agreement granting custodial responsibility terminates under
18 Sections 8 to 12 of this Act sixty (60) days after the deploying parent gives notice
19 to the other parent that the deploying parent returned from deployment.

20 (4) If a temporary agreement granting custodial responsibility was filed with a court
21 pursuant to Section 12 of this Act, an agreement to terminate the temporary
22 agreement also shall be filed with that court within a reasonable time after the
23 signing of the agreement. The case number and heading of the case concerning
24 custodial responsibility or child support shall be provided to the court with the
25 agreement to terminate.

26 ➔SECTION 25. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
27 TO READ AS FOLLOWS:

1 At any time after a deploying parent returns from deployment, the deploying parent
 2 and the other parent may file with the court an agreement to terminate a temporary
 3 order for custodial responsibility issued under Sections 13 to 23 of this Act. After an
 4 agreement has been filed, the court shall issue an order terminating the temporary
 5 order effective on the date specified in the agreement. If a date is not specified, the
 6 order is effective immediately.

7 ➔SECTION 26. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 8 TO READ AS FOLLOWS:

9 After a deploying parent returns from deployment until a temporary agreement or
 10 order for custodial responsibility established under Sections 8 to 12 of this Act or
 11 Sections 13 to 23 of this Act is terminated, the court shall issue a temporary order
 12 granting the deploying parent reasonable contact with the child unless it is contrary to
 13 the best interest of the child, even if the time of contact exceeds the time the deploying
 14 parent spent with the child before the deployment.

15 ➔SECTION 27. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 16 TO READ AS FOLLOWS:

17 (1) If an agreement between the parties to terminate a temporary order for custodial
 18 responsibility under Sections 13 to 23 of this Act has not been filed, the order
 19 terminates sixty (60) days after the deploying parent gives notice to the other
 20 parent and any nonparent granted custodial responsibility that the deploying
 21 parent has returned from deployment.

22 (2) A proceeding seeking to prevent termination of a temporary order for custodial
 23 responsibility is governed by law of this state other than this chapter.

24 ➔SECTION 28. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
 25 TO READ AS FOLLOWS:

26 In applying and construing the Uniform Deployed Parents Custody and Visitation Act,
 27 consideration shall be given to the need to promote uniformity of the law with respect

1 to its subject matter among states that enact it.

2 ➔SECTION 29. A NEW SECTION OF KRS CHAPTER 403A IS CREATED
3 TO READ AS FOLLOWS:

4 *This chapter modifies, limits, or supersedes the Electronic Signatures in Global and*
