- There shall be established and maintained in the Commonwealth of Kentucky state veterans' nursing homes to provide long-term care to veterans who are residents of Kentucky.
- 9 (3) There is created the Office of Kentucky Veterans' Centers <u>within the Office of the</u>

 10 <u>Commissioner of [within]</u> the Department of Veterans' Affairs. The office shall be

 11 headed by an executive director appointed pursuant to KRS 12.050. The office shall

 12 operate the Kentucky state veterans' <u>centers and medical division [nursing homes]</u>.

- 19 (5) The executive director of the Office of Kentucky Veterans' Centers, with the approval of the commissioner of the Department of Veterans' Affairs, may contract to hire licensed nurses and nurse aides in order to provide needed long-term care of veterans in residence at state veterans' nursing homes, and those contracts shall not be subject to KRS 45A.550 to 45A.554 or 45A.690 to 45A.725.
- Section 3. The General Assembly hereby confirms Executive Order 2020-823, dated September 28, 2020, relating to the reorganization of the Department of Veterans'

 Affairs, to the extent it is not otherwise confirmed or superseded by this Act.
