4	(1)	Except as otherwise expressly provided, the prosecution of a felony is not subject to
5		a period of limitation and may be commenced at any time.
6	(2)	Except as otherwise expressly provided, the prosecution of an offense other than a
7		felony must be commenced within one (1) year after it is committed.
8	(3)	(a) For a misdemeanor <u>sex</u> offense [under KRS Chapter 510] when the victim is \underline{a}
9		minor[under the age of eighteen (18)] at the time of the offense, the

7		(a) "Childhood sexual assault <u>or abuse</u> " means an act or series of acts against a
8		person less than eighteen (18) years old and which meets the criteria defining
9		a <u>misdemeanor or</u> felony <u>in:</u>

11		2. KRS 529.040 when the defendant advances or profits from the
12		prostitution of a minor; [in KRS 510.040, 510.050, 510.060, 510.070,

15		activity <u>;</u> [,]

17	its effective date of June 29, 2017. This section is a remedial statute which is
18	to be given the most liberal interpretation to provide remedies for victims of
19	childhood sexual assault or abuse.
20	(b) Notwithstanding any provision of law to the contrary, any claim for
21	childhood sexual assault or abuse that was barred as of the effective date of
22	this Act because the applicable statute of limitations had expired is hereby
23	revived, and the action may be brought if commenced within five (5) years

2 → Section 4. The restrictions of KRS 6.945(1) shall not apply to Sections 1 and 2
3 of this Act.

Section 5. If any provision of this Act or the application thereof to any person or
circumstances is held invalid, the invalidity shall not affect other provisions or
applications of the Act that can be given effect without the invalid provision or
application, and to this end the provisions of this Act are severable.

Section 6. Whereas Kentucky has the highest rate of child abuse in the country,
an emergency is declared to exist, and this Act takes effect upon its passage and approval
by the Governor or upon its otherwise becoming a law.
