1	A RESOLUTION affirming support for services and providers addressing the
2	domestic violence, sexual violence, and child abuse public health crisis.
3	WHEREAS, the Kentucky Constitution guarantees all citizens the right to enjoy and
4	defend their rights and liberty; and
5	WHEREAS, the Kentucky Constitution guarantees all citizens the right to seek and
6	pursue their safety and happiness; and
7	WHEREAS, victims of abuse experience threats to the free exercise of these rights
8	by their abusers; and
9	WHEREAS, every Kentuckian is impacted by domestic violence, sexual violence,
10	and child abuse; and
11	WHEREAS, the cumulative societal, familial, and individual damage caused by
12	domestic violence, sexual assault, and child abuse is one of the most prevalent public
13	health issues facing the Commonwealth; and
14	WHEREAS, domestic violence creates costs which exceed \$5.8 billion nationally
15	each year, including nearly \$1 billion in lost productivity at work; and
16	WHEREAS, Kentucky's state-funded domestic violence shelters, rape crisis centers,
17	and child advocacy centers served over 393,000 individuals in the past decade, including
18	over 52,000 children; and
19	WHEREAS, the majority of domestic, sexual, and child abuse is either
20	underreported or not reported at all; and
21	WHEREAS, Kentucky has the highest rate of child abuse in the nation, with such
22	staggering statistics as: one in ten children being sexually abused before their 18th
23	birthday; 26% of 10th graders who reported experiencing sexual victimization having
24	attempted suicide; and almost 29,000 children being involved in reports of family
25	violence in 2019 alone; and
26	WHEREAS, domestic violence is a form of gender-based violence which women
27	experience with greater frequency, severity, and impacts; and

1	WHEREAS, 45% of Kentucky women have experienced sexual violence, physical
2	violence, or stalking at the hands of an intimate partner at least once in their lifetime, half
3	of all female murder victims are killed by an intimate partner, and 32 Kentucky women
4	were killed by an intimate partner between September, 2019, and December, 2020; and
5	WHEREAS, 39% of Kentucky women and 18.3% of Kentucky men reported being
6	violated by sexual contact violence at some point in their lives, and 70% of survivors of
7	sexual violence experience moderate to severe distress and are at a greater risk for
8	trauma-related health problems, including depression, post-traumatic stress disorder,
9	suicidal ideation, sleep disorders, and eating disorders; and
10	WHEREAS, the COVID-19 pandemic presented new challenges for both survivors
11	experiencing abuse and the providers who serve them; and
12	WHEREAS, domestic violence, sexual violence, and child abuse cannot be
13	prevented until it is openly recognized and addressed; and
14	WHEREAS, the causes, prevalence, and effects of abuse on our public systems and
15	families must be brought into public focus;
16	NOW, THEREFORE,
17	Be it resolved by the House of Representatives of the General Assembly of the
18	Commonwealth of Kentucky:
19	\rightarrow Section 1. The House of Representatives does hereby affirm a commitment to
20	defending and championing the rights, liberty, safety, health, and wellbeing of survivors
21	of violence and abuse as well as their families and communities.
22	\rightarrow Section 2. The House of Representatives resolves to prioritize the public health
23	issue of domestic violence, sexual violence, and child abuse by providing safe and
24	affirming care for all survivors throughout all state systems, and by working together to
25	prevent and ultimately eliminate all forms of abuse and violence throughout the
26	Commonwealth.

→ Section 3. When the House of Representatives adjourns this day, it does so in

honor of Kentucky's network of domestic violence shelters, rape crisis centers, and child
 advocacy centers; the courage and resilience of all survivors of abuse in the
 Commonwealth; and in solemn memory of those who did not survive their encounters
 with abuse.
