

1 AN ACT relating to pari-mutuel wagering and declaring an emergency.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 230.210 is amended to read as follows:

4 As used in this chapter, unless the context requires otherwise:

- 5 (1) "Advance deposit account wagering" means a form of pari-mutuel wagering in
6 which an individual may establish an account with a person or entity licensed by the
7 racing commission, and may place a pari-mutuel wager through that account that is
8 permitted by law;
- 9 (2) "Advance deposit account wagering licensee" means a person or entity licensed by
10 the racing commission to conduct advance deposit account wagering and accept
11 deposits and wagers, issue a receipt or other confirmation to the account holder
12 evidencing such deposits and wagers, and transfer credits and debits to and from
13 accounts;
- 14 (3) "Appaloosa race" or "Appaloosa racing" means that form of horse racing in which
15 each horse participating in the race is registered with the Appaloosa Horse Club of
16 Moscow, Idaho, and is mounted by a jockey;
- 17 (4) "Arabian" means a horse that is registered with the Arabian Horse Registry of
18 Denver, Colorado;
- 19 (5) "Association" means any person licensed by the Kentucky Horse Racing
20 Commission under KRS 230.300 and engaged in the conduct of a recognized horse
21 race meeting;
- 22 (6) "Harness race" or "harness racing" means trotting and pacing races of the
23 standardbred horses;
- 24 (7) "Horse race meeting" means horse racing run at an association licensed and
25 regulated by the Kentucky Horse Racing Commission, and may include
26 Thoroughbred, harness, Appaloosa, Arabian, paint, and quarter horse racing;
- 27 (8) "Host track" means the track conducting racing and offering its racing for intertrack

- 1 wagering, or, in the case of interstate wagering, means the Kentucky track
2 conducting racing and offering simulcasts of races conducted in other states or
3 foreign countries;
- 4 (9) "Intertrack wagering" means pari-mutuel wagering on simulcast horse races from a
5 host track by patrons at a receiving track;
- 6 (10) "Interstate wagering" means pari-mutuel wagering on simulcast horse races from a
7 track located in another state or foreign country by patrons at a receiving track or
8 simulcast facility;
- 9 (11) "Kentucky quarter horse, paint horse, Appaloosa, and Arabian purse fund" means a
10 purse fund established to receive funds as specified in KRS 230.3771 for purse
11 programs established in KRS 230.446 to supplement purses for quarter horse, paint
12 horse, Appaloosa, and Arabian horse races. The purse program shall be
13 administered by the Kentucky Horse Racing Commission;
- 14 (12) "Kentucky resident" means:
- 15 (a) An individual domiciled within this state;
- 16 (b) An individual who maintains a place of abode in this state and spends, in the
17 aggregate, more than one hundred eighty-three (183) days of the calendar year
18 in this state; or
- 19 (c) An individual who lists a Kentucky address as his or her principal place of
20 residence when applying for an account to participate in advance deposit
21 account wagering;
- 22 (13) **"Licensed premises" means a track or simulcast facility licensed by the racing**
23 **commission under this chapter;**
- 24 **(14)** "Paint horse" means a horse registered with the American Paint Horse Association
25 of Fort Worth, Texas;
- 26 **(15)~~(14)~~ "Pari-mutuel wagering," "pari-mutuel system of wagering," or "mutuel**
27 **wagering" each means any method of wagering previously or hereafter approved**

1 by the racing commission in which one (1) or more patrons wager on a horse
2 race or races, whether live, simulcast, or previously run. Wagers shall be placed
3 in one (1) or more wagering pools, and wagers on different races or sets of races
4 may be pooled together. Patrons may establish odds or payouts, and winning
5 patrons share in amounts wagered including any carryover amounts, plus any
6 amounts provided by an association less any deductions required, as approved by
7 the racing commission and permitted by law. Pools may be paid out incrementally
8 over time as approved by the racing commission.

9 **(16)** "Principal" means any of the following individuals associated with a partnership,
10 trust, association, limited liability company, or corporation that is licensed to
11 conduct a horse race meeting or an applicant for a license to conduct a horse race
12 meeting:

- 13 (a) The chairman and all members of the board of directors of a corporation;
- 14 (b) All partners of a partnership and all participating members of a limited
15 liability company;
- 16 (c) All trustees and trust beneficiaries of an association;
- 17 (d) The president or chief executive officer and all other officers, managers, and
18 employees who have policy-making or fiduciary responsibility within the
19 organization;
- 20 (e) All stockholders or other individuals who own, hold, or control, either directly
21 or indirectly, five percent (5%) or more of stock or financial interest in the
22 collective organization; and
- 23 (f) Any other employee, agent, guardian, personal representative, or lender or
24 holder of indebtedness who has the power to exercise a significant influence
25 over the applicant's or licensee's operation;

26 **(17)**~~[(15)]~~ "Quarter horse" means a horse that is registered with the American Quarter
27 Horse Association of Amarillo, Texas;

1 ~~(18)~~~~(16)~~ "Racing commission" means the Kentucky Horse Racing Commission;

2 ~~(19)~~~~(17)~~ "Receiving track" means a track where simulcasts are displayed for wagering
3 purposes. A track that submits an application for intertrack wagering shall meet all
4 the regulatory criteria for granting an association license of the same breed as the
5 host track, and shall have a heated and air-conditioned facility that meets all state
6 and local life safety code requirements and seats a number of patrons at least equal
7 to the average daily attendance for intertrack wagering on the requested breed in the
8 county in which the track is located during the immediately preceding calendar year;

9 ~~(20)~~~~(18)~~ "Simulcast facility" means any facility approved pursuant to the provisions of
10 KRS 230.380 to simulcast live racing and conduct pari-mutuel wagering on live
11 racing;

12 ~~(21)~~~~(19)~~ "Simulcasting" means the telecast of live audio and visual signals of horse
13 races for the purpose of pari-mutuel wagering;

14 ~~(22)~~~~(20)~~ "Telephone account wagering" means a form of pari-mutuel wagering where
15 an individual may deposit money in an account at a track and may place a wager by
16 direct telephone call or by communication through other electronic media owned by
17 the holder of the account to the track;

18 ~~(23)~~~~(21)~~ "Thoroughbred race" or "Thoroughbred racing" means a form of horse racing
19 in which each horse participating in the race is a Thoroughbred, (i.e., meeting the
20 requirements of and registered with The Jockey Club of New York) and is mounted
21 by a jockey; and

22 ~~(24)~~~~(22)~~ "Track" means any association duly licensed by the Kentucky Horse Racing
23 Commission to conduct horse racing and~~["Track"]~~ shall include:

24 (a) For facilities in operation as of 2010, the location and physical plant
25 described in the "Commonwealth of Kentucky Initial/Renewal Application
26 for License to Conduct Live Horse Racing, Simulcasting, and Pari-Mutuel
27 Wagering," filed for racing to be conducted in 2010;

1 **(b) Real property of an association, if the association received or receives**
 2 **approval from the racing commission after 2010 for a location at which live**
 3 **racing is to be conducted; or**

4 **(c) One (1)**~~any~~ facility or real property that is:

5 **1.** Owned, leased, or purchased by **an association**~~[a track within the same~~
 6 ~~geographic area]~~ within a sixty (60) mile radius of **the association's**
 7 **racetrack**~~[a track]~~ but not contiguous to **racetrack**~~[track]~~ premises, upon
 8 racing commission approval;~~;~~ and

9 **2.** ~~[provided the noncontiguous property is]~~Not within a sixty (60) mile
 10 radius of another licensed track premise where live racing is conducted
 11 and not within a forty (40) mile radius of a simulcast facility, unless any
 12 affected track or simulcast facility agrees in writing to permit a
 13 noncontiguous facility within the protected geographic area.

14 ➔Section 2. KRS 230.361 is amended to read as follows:

15 (1) **(a)** The racing commission shall promulgate administrative regulations governing
 16 and regulating mutuel wagering on horse races under what is known as the
 17 pari-mutuel system of wagering.

18 **(b)** The wagering shall be conducted only by a person licensed under this chapter
 19 to conduct a race meeting and only upon the licensed premises, **and provided**
 20 **further that only pari-mutuel wagering on simulcasting shall be allowed at**
 21 **simulcast facilities.**

22 **(c)** The pari-mutuel system of wagering shall be operated only by a totalizator or
 23 other mechanical equipment approved by the racing commission. The racing
 24 commission shall not require any particular make of equipment.

25 (2) The operation of a pari-mutuel system for betting where authorized by law shall not
 26 constitute grounds for the revocation or suspension of any license issued and held
 27 under KRS 242.1238 and 243.265.

1 (3) All reported but unclaimed pari-mutuel winning tickets held in this state by any
2 person or association operating a pari-mutuel or similar system of betting at horse
3 race meetings shall be presumed abandoned if not claimed by the person entitled to
4 them within one (1) year from the time the ticket became payable.

5 (4) The racing commission may issue a license to conduct pari-mutuel wagering on
6 steeple chases or other racing over jumps; if all proceeds from the wagering, after
7 expenses are deducted, is used for charitable purposes. If the dates requested for
8 such a license have been granted to a track within a forty (40) mile radius of the
9 race site, the racing commission shall not issue a license until it has received written
10 approval from the affected track. Pari-mutuel wagering licensed and approved under
11 this subsection shall be limited to four (4) days per year. All racing and wagering
12 authorized by this subsection shall be conducted in accordance with applicable
13 administrative regulations promulgated by the racing commission.

14 ➔Section 3. Whereas the horse racing industry is crucial to the overall economy
15 of the Commonwealth, and whereas the definition of pari-mutuel wagering is key to the
16 successful operation of horse racing tracks for the upcoming racing season, an emergency
17 is declared to exist, and this Act takes effect upon its passage and approval by the
18 Governor or upon its otherwise becoming a law.
