The coverage may contain a 19 limitation on the number of home health care visits for which benefits are payable, 20 but the number of such visits shall not be less than sixty (60) in any calendar year or 21 in any continuous period of twelve (12) months for each person covered under the 22 policy. Each visit by an authorized representative of a home health agency shall be 23 considered as one (1) home health care visit, except that at least four (4) hours of 24 home health aide service shall be considered as one (1) home health visit.

The coverage may contain a limitation on the number of home health care visits for which benefits are payable, but the number of such visits shall not be less than sixty (60) in any calendar year or in any continuous period of twelve (12) months for each person covered under the policy. Each visit by an authorized representative of a home health agency shall be considered as one (1) home health care visit except that at least four (4) hours of home health aide service shall be considered as one (1) home health visit.
