

1 AN ACT relating to transportation.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

15 ➔Section 2. KRS 12.020 is amended to read as follows:

16 Departments, program cabinets and their departments, and the respective major
17 administrative bodies that they include are enumerated in this section. It is not intended
18 that this enumeration of administrative bodies be all-inclusive. Every authority, board,
19 bureau, interstate compact, commission, committee, conference, council, office, or any
20 other form of organization shall be included in or attached to the department or program
21 cabinet in which they are included or to which they are attached by statute or statutorily
22 authorized executive order; except in the case of the Personnel Board and where the
23 attached department or administrative body is headed by a constitutionally elected officer,
24 the attachment shall be solely for the purpose of dissemination of information and
25 coordination of activities and shall not include any authority over the functions,
26 personnel, funds, equipment, facilities, or records of the department or administrative
27 body.

18 ➔Section 3. KRS 189.390 is amended to read as follows:

19 (1) As used in this section, unless the context requires otherwise:

- 20 (a) "Business district" means the territory contiguous to and including a highway
21 if, within six hundred (600) feet along the highway, there are buildings in use
22 for business or industrial purposes that occupy three hundred (300) feet of
23 frontage on one (1) side or three hundred (300) feet collectively on both sides
24 of the highway;
- 25 (b) "Residential district" means the territory contiguous to and including a
26 highway not comprising a business district if the property on the highway for a
27 distance of three hundred (300) feet or more is improved with residences or

1 residences and buildings in use for business; and

2 (c) "State highway" means a highway or street maintained by the Kentucky
3 Department of Highways.

4 (2) An operator of a vehicle upon a highway shall not drive at a greater speed than is
5 reasonable and prudent, having regard for the traffic and for the condition and use
6 of the highway.

7 (3) The speed limit for motor vehicles on state highways shall be as follows, unless
8 conditions exist that require lower speed for compliance with subsection (2) of this
9 section, or the secretary of the Transportation Cabinet establishes a different speed
10 limit in accordance with subsection (4) of this section:

11 (a) Sixty-five (65) miles per hour on interstate highways and parkways;

12 (b) Fifty-five (55) miles per hour on all other state highways; and

13 (c) Thirty-five (35) miles per hour in a business or residential district.

14 (4) (a) If the secretary of transportation determines, upon the basis of an engineering
15 and traffic investigation, that any speed limit is greater or less than is
16 reasonable or safe under the conditions found to exist at any intersection, or
17 upon any part of a state highway, the secretary of transportation may establish
18 by official order a reasonable and safe speed limit at the location. The
19 secretary shall not increase any speed limit established by subsection (3) of
20 this section in excess of sixty-five (65) miles per hour, except that,
21 notwithstanding the provisions of subsection (3)(a) of this section, the
22 secretary may increase the speed limit on any of the following segments of
23 highway to seventy (70) miles per hour:

24 1. Interstate 24 (entire length);

25 2. Interstate 64 from Interstate 264 to the West Virginia state line;

26 3. Interstate 65 from Interstate 264 to the Tennessee state line;

27 4. Interstate 69 (entire length);

- 1 5. Interstate 71 from Interstate 264 to Interstate 275;
- 2 6. Interstate 75 from the Tennessee state line to Interstate 275;
- 3 7. Interstate 165 (entire length);
- 4 8. The Audubon Parkway (entire length);
- 5 9. The Julian M. Carroll Purchase Parkway (entire length);
- 6 10. The Bert T. Combs Mountain Parkway (entire length);
- 7 11. The Bert T. Combs Mountain Parkway Extension (entire length);
- 8 12. The Edward T. Breathitt Pennyrile Parkway (entire length);
- 9 13. The Wendell H. Ford Western Kentucky Parkway (entire length);
- 10 14. The Louie B. Nunn Cumberland Expressway~~Parkway~~ (entire length);
- 11 15. The Martha Layne Collins Bluegrass Parkway (entire length); and

13 (b) In a highway work zone, the Transportation Cabinet may temporarily reduce
 14 established speed limits without an engineering or traffic investigation. A
 15 speed limit established under this paragraph shall become effective when and
 16 where posted. The Transportation Cabinet shall post signs notifying the
 17 traveling public of the temporary highway work zone maximum speed limit.
 18 Nothing in this paragraph shall be construed to prevent the Transportation
 19 Cabinet from using moveable or portable speed limit signs in highway work
 20 zones.

21 (5) (a) A city or a county may by ordinance establish speed limits within its own
 22 jurisdiction, except as provided in paragraph (b) of this subsection.

23 (b) The alteration of speed limits on state highways within a city or a county shall
 24 not be effective until the alteration has been approved by the secretary of
 25 transportation. The secretary shall not approve any alteration that could
 26 increase any speed limit established by subsection (3)(b) or (c) of this section
 27 in excess of fifty-five (55) miles per hour.

1 (c) If a county determines, upon the basis of an engineering and traffic
2 investigation and study, that it is unsafe to park motor vehicles on or along
3 any highway, other than a state highway, within the unincorporated areas of
4 the county, or that in any business district the congestion of traffic justifies a
5 reasonable limitation on the length of time any one (1) motor vehicle is
6 permitted to park in such district so as to reduce the congestion, the fiscal
7 court may by ordinance establish "no parking" areas on the highway, or limit
8 the length of time any motor vehicle may be parked in any business district.

9 (6) The speed limit for motor vehicles in an off-street parking facility offered for public
10 use, whether publicly or privately owned, shall be fifteen (15) miles per hour.

11 (7) A person shall not drive a motor vehicle at a speed that will impede or block the
12 normal and reasonable movement of traffic, except when reduced speed is necessary
13 for safe operation or in compliance with law.

14 (8) In every charge for a violation of any speed limit specified in this section, the
15 warrant or citation shall specify the speed at which the defendant is alleged to have
16 driven, and the lawful speed limit applicable at the location where the violation is
17 charged to have occurred.

18 ➔Section 4. The Transportation Cabinet is directed to change the name of the
19 "Louie B. Nunn Cumberland Parkway" in its entirety to the "Louie B. Nunn Cumberland
20 Expressway" and shall, within 30 days of the effective date of this Act:

21 (1) Make appropriate changes to official highway lists, electronic maps, Web sites, and
22 databases to denote the name change; and

23 (2) Take any necessary steps to ensure that:

24 (a) Appropriate signs and highway markers denoting this name change are
25 installed whenever new signage is required due to sign damage or in the
26 course of ordinary sign maintenance; and

27 (b) Physical maps produced by the Transportation Cabinet reflect this name

1 change at the time of their next publication.

2 ➔Section 5. The General Assembly confirms Executive Order 2020-1027,
3 regarding the reorganization of the Transportation Cabinet, to the extent it is not
4 otherwise confirmed by this Act.

5 ➔SECTION 6. A NEW SECTION OF KRS CHAPTER 189 IS CREATED TO
6 READ AS FOLLOWS:

7 *After the effective date of this Act and until July 1, 2024:*

8 *(1) As used in this section:*

9 *(a) "Local government" means a city, county, charter county government,*
10 *urban-county government, consolidated local government, or unified local*
11 *government that is located within the boundaries of a regional authority, or*
12 *the Kentucky Mountain Regional Recreation Authority established under*
13 *KRS 148.0222, acting on behalf of a local government that is part of the*
14 *authority;*

15 *(b) "Off-highway vehicle" or "OHV" means a motorized vehicle that:*

16 *1. Is designed to be primarily used for recreational purposes;*

17 *2. Has a maximum speed that is greater than thirty-five (35) miles per*
18 *hour;*

19 *3. Is equipped with the following:*

20 *a. Four (4) to six (6) highway or nonhighway tires;*

21 *b. A steering wheel or steering mechanism;*

22 *c. Brakes;*

23 *d. Headlamps;*

24 *e. Tail lamps;*

25 *f. Brake lights;*

26 *g. One (1) red reflex reflector on each side as far to the rear as*
27 *practicable and one (1) red reflex reflector on the rear;*

- 1 *h. A working muffler;*
2 *i. A parking brake;*
3 *j. A spark arrestor; and*
4 *k. For multi-passenger vehicles, an exterior mirror mounted on the*
5 *driver's side of the vehicle, either an interior mirror or an*
6 *exterior mirror mounted on the passenger's side of the vehicle,*
7 *and for each designated seating position, a seatbelt assembly that*
8 *conforms to the federal motor vehicle safety standard provided in*
9 *49 C.F.R. sec. 571.209; and*

10 *(c) "Regional authority" means:*

- 11 *1. The Kentucky Mountain Regional Recreation Authority established in*
12 *KRS 148.0222; and*
13 *2. Any other authority established in Kentucky Revised Statutes, prior to*
14 *the effective date of this Act, that oversees lands in two (2) or more*
15 *contiguous counties, on which there is a system of recreational trails,*
16 *including streams, rivers, and other waterways, and appurtenant*
17 *facilities, including trailhead centers, parking areas, camping*
18 *facilities, picnic areas, recreational areas, historic or cultural*
19 *interpretive sites, and other facilities in Kentucky and designated by*
20 *the regional authority.*

- 21 *(2) (a) The legislative body of a local government that is currently or formerly*
22 *located within the boundaries of a regional authority, or which currently*
23 *operates a public OHV trail system, may establish a pilot program, by*
24 *ordinance, to authorize and regulate the operation of an OHV on any public*
25 *roadway or any section of city or county roadway for which it bears*
26 *responsibility.*

- 27 *(b) Prior to enacting an OHV ordinance under paragraph (a) of this*

1 subsection, the legislative body of a local government shall notify the public
2 of its plans to allow OHV use on roadways under its jurisdiction. Public
3 notice under this paragraph shall:

4 1. Notify the public of the time, subject, and location of the public
5 meeting and shall be posted in both a local newspaper, if any, and a
6 newspaper of general circulation in the county;

7 2. Include a list and map of all roadways and connecting trails that the
8 local government intends to designate for OHV use; and

9 3. Be placed on the Web site of the local government.

10 (c) A local government may petition the Transportation Cabinet to include, in
11 an OHV ordinance adopted under paragraph (a) of this subsection, state-
12 maintained roadways or sections of state-maintained roadways located
13 within the local government's jurisdictional boundaries. The local
14 government shall submit the following to the Transportation Cabinet for
15 approval:

16 1. The minutes from the public meeting or meetings held prior to
17 adoption of an OHV ordinance under this subsection;

18 2. A list and map of all roadways and connecting trails that the local
19 government intends to designate for OHV use;

20 3. An enforcement plan to ensure that all OHVs operating on roadways
21 under this section meet all of the requirements established under this
22 section, including verification of required insurance coverage;

23 4. A plan to notify the public and OHV users of the operation of OHVs
24 on state and local roadways within the boundaries of the local
25 government;

26 5. A safety plan for OHV roadway use; and

27 6. Any other requirements established by the Transportation Cabinet

- 1 under subsection (16) of this section.
- 2 (d) The Transportation Cabinet shall, within ninety (90) days of receipt of a
3 petition and all information required in paragraph (c) of this subsection,
4 respond to the local government with approval or denial of the request
5 submitted.
- 6 (e) Any OHV ordinance adopted under this section shall be adopted at a public
7 meeting.
- 8 (3) A fully controlled access highway shall not be designated for OHV use under this
9 section.
- 10 (4) A local government that has enacted an OHV ordinance under this section shall
11 notify the Transportation Cabinet of any collision involving an OHV that
12 occurred on any roadway approved for OHV use under this section.
- 13 (5) A person may operate an OHV on a public roadway pursuant to subsection (2) of
14 this section if the:
- 15 (a) Operator is eighteen (18) years of age or older;
16 (b) Operator has a valid operator's license in his or her possession;
17 (c) OHV is insured by the owner or operator, for the payment of tort liabilities
18 in the same form and amounts as set forth in KRS 304.39-110 for
19 motorcycles;
- 20 (d) Proof of insurance is inside the OHV at all times of operation on a public
21 roadway; and
- 22 (e) OHV is equipped with all safety equipment required under this section.
- 23 (6) Any person operating an OHV on a public roadway under this section shall be
24 subject to the same traffic regulations of KRS Chapter 189 as a motor vehicle,
25 including KRS 189.520 prohibiting the operation of a vehicle that is not a motor
26 vehicle, while under the influence of intoxicants or substances which may impair
27 driving.

- 1 (7) A person shall not operate an OHV under this section on any public roadway:
- 2 (a) Between one (1) hour after sunset and one (1) hour before sunrise, unless
- 3 the person can demonstrate cause for driving, including but not limited to
- 4 emergencies; or
- 5 (b) While carrying passengers on a trailer or any other towed unit.
- 6 (8) Any passenger of an OHV that is under the age of sixteen (16) shall be required
- 7 to wear a helmet that meets the national standards prescribed by the United
- 8 States Department of Transportation.
- 9 (9) An operator and any passengers shall wear eye protection when operating or
- 10 riding an OHV that is not equipped with a windshield.
- 11 (10) (a) The Transportation Cabinet shall be responsible for the cost, placement,
- 12 and maintenance of signage denoting state highways that have been
- 13 authorized for OHV use under this section.
- 14 (b) The local government shall be responsible for the cost, placement, and
- 15 maintenance of signage denoting local roadways that have been designated
- 16 for OHV use under this section.
- 17 (c) The local government shall be responsible for monthly inspection of state
- 18 and local OHV signage.
- 19 (11) An OHV operating on a public roadway designated by a local government under
- 20 subsection (2) of this section is not considered to be a motor vehicle and shall be
- 21 exempt from:
- 22 (a) Vehicle registration requirements of KRS 186.050; and
- 23 (b) Emissions compliance certificates pursuant to KRS 224.20-720.
- 24 (12) A local government may adopt more stringent local ordinances governing OHV
- 25 safety equipment and operation than specified in this section.
- 26 (13) If deemed in the interest of public safety, the Transportation Cabinet may:
- 27 (a) Prohibit the operation of an OHV on any public roadway designated under

1 subsection (2) of this section that crosses a state-maintained roadway; or

2 (b) Rescind approval given under subsection (2)(d) of this section.

3 (14) This section shall not apply to:

4 (a) An OHV operated on any private or public recreational trail or area;

5 (b) An OHV operating under the exemptions for highway use under Section 7
6 of this Act; or

7 (c) A publicly owned and operated OHV used for wildlife management, law
8 enforcement, emergency services, or other governmental purposes.

9 (15) Nothing in this section shall be interpreted or construed to require an insurance
10 company to provide OHV insurance coverage.

11 (16) The Transportation Cabinet shall promulgate administrative regulations
12 pursuant to KRS Chapter 13A to implement this section, including but not limited
13 to:

14 (a) Prescribing of any forms or applications needed;

15 (b) Establishing criteria for OHV ordinances;

16 (c) Establishing OHV enforcement requirements;

17 (d) Establishing criteria for rescinding approval pursuant to subsection (13) of
18 this section;

19 (e) Establishing OHV safety requirements;

20 (f) Establishing OHV safety equipment verification protocol; and

21 (g) Establishing OHV safety plan requirements.

22 ➔Section 7. KRS 189.515 is amended to read as follows:

23 (1) As used in this section, "federal all-terrain vehicle standards" means the all-terrain
24 vehicle standards set forth by the American National Standards Institute/Specialty
25 Vehicle Institute of America and incorporated by reference in 16 C.F.R. sec. 1420.3,
26 to the extent those standards are applicable.

27 (2) Except for vehicles authorized to operate on a public highway as of July 15, 1998,

1 and except as provided in subsection (7) of this section, a person shall not operate
2 an all-terrain vehicle upon any public highway or roadway or upon the right-of-way
3 of any public highway or roadway.

4 (3) A person shall not operate an all-terrain vehicle on private property without the
5 consent of the landowner, tenant, or individual responsible for the property.

6 (4) A person shall not operate an all-terrain vehicle on public property unless the
7 governmental agency responsible for the property has approved the use of all-terrain
8 vehicles.

9 (5) Except for vehicles authorized to operate on a public highway, a person sixteen (16)
10 years of age or older operating an all-terrain vehicle on public property shall wear
11 approved protective headgear, in the manner prescribed by the secretary of the
12 Transportation Cabinet, at all times that the vehicle is in motion. The approved
13 headgear requirement shall not apply when the operator of any all-terrain vehicle is
14 engaged in:

15 (a) Farm or agriculture related activities;

16 (b) Mining or mining exploration activities;

17 (c) Logging activities;

18 (d) Any other business, commercial, or industrial activity;

19 (e) Use of that vehicle on private property; or

20 (f) The crossing of a public roadway with a posted speed limit of fifty-five (55)
21 miles per hour or less. The crossing of a public roadway outlined in this
22 paragraph shall be in compliance with subsection (7)(a) of this section.

23 (6) (a) A parent or legal guardian of a minor who is under the age of six (6) shall not
24 knowingly allow that person to operate an all-terrain vehicle.

25 (b) A person under the age of sixteen (16) years shall not operate an all-terrain
26 vehicle except under direct parental supervision.

27 (c) A person under the age of sixteen (16) years, when operating or riding as a

1 passenger on an all-terrain vehicle, shall wear approved protective headgear,
2 in the manner prescribed by the secretary of the Transportation Cabinet, at all
3 times that the vehicle is in motion.

4 (d) A parent or guardian of a minor who is under the age of sixteen (16), or who
5 does not possess an instruction permit, an intermediate license, or an
6 operator's license, shall not knowingly allow that person to carry a passenger
7 while operating an all-terrain vehicle.

8 (e) A parent or guardian of a minor under the age of sixteen (16) shall not
9 knowingly allow that person to operate an all-terrain vehicle in violation of
10 the age restriction warning label affixed by the manufacturer as required by
11 the federal all-terrain vehicle standards.

12 (7) (a) **Except for off-highway vehicles described in Section 6 of this Act,** a person
13 may operate an all-terrain vehicle on any two (2) lane public highway in order
14 to cross the highway. In crossing the highway under this paragraph, the
15 operator shall cross the highway at as close to a ninety (90) degree angle as is
16 practical and safe, and shall not travel on the highway for more than two-
17 tenths (2/10) of a mile.

18 (b) A person may operate an all-terrain vehicle on any two (2) lane public
19 highway, if the operator is engaged in farm or agricultural related activities,
20 construction, road maintenance, or snow removal.

21 (c) The Transportation Cabinet may designate, and a city or county government
22 may designate, those public highways, segments of public highways, and
23 adjoining rights-of-way of public highways under its jurisdiction where all-
24 terrain vehicles that are prohibited may be operated.

25 (d) A person operating an all-terrain vehicle on a public highway under this
26 subsection shall possess a valid operator's license.

27 (e) A person operating an all-terrain vehicle on a public highway under this

1 subsection shall comply with all applicable traffic regulations.

2 (f) A person shall not operate an all-terrain vehicle under this subsection unless
3 the all-terrain vehicle has at least one (1) headlight and two (2) taillights,
4 which shall be illuminated at all times the vehicle is in operation.

5 (g) A person operating an all-terrain vehicle under this subsection shall restrict
6 the operation to daylight hours, except when engaged in snow removal or
7 emergency road maintenance.

8 (h) It shall be unlawful for a person to remove from an all-terrain vehicle the
9 manufacturer age restriction warning label required by the federal all-terrain
10 vehicle standards.

11 ➔Section 8. KRS 189.990 is amended to read as follows:

12 (1) Any person who violates any of the provisions of KRS 189.020 to 189.040,
13 subsection (1) or (4) of KRS 189.050, KRS 189.060 to 189.080, subsections (1) to
14 (3) of KRS 189.090, KRS 189.100, 189.110, 189.130 to 189.160, subsections (2) to
15 (4) of KRS 189.190, KRS 189.200, 189.285, 189.290, 189.300 to 189.360, KRS
16 189.380, KRS 189.400 to 189.430, KRS 189.450 to 189.458, KRS 189.4595 to
17 189.480, subsection (1) of KRS 189.520, KRS 189.540, KRS 189.570 to 189.590,
18 except subsection (1)(b) or (6)(b) of KRS 189.580, KRS 189.345, subsection (6) of
19 KRS 189.456, and 189.960 shall be fined not less than twenty dollars (\$20) nor
20 more than one hundred dollars (\$100) for each offense. Any person who violates

22 nor more than two thousand dollars (\$2,000) or imprisoned in the county jail for not
23 more than one (1) year, or both, unless the accident involved death or serious
24 physical injury and the person knew or should have known of the death or serious
25 physical injury, in which case the person shall be guilty of a Class D felony. Any
26 person who violates paragraph (c) of subsection (5) of KRS 189.390 shall be fined
27 not less than eleven dollars (\$11) nor more than thirty dollars (\$30). Neither court

1 costs nor fees shall be taxed against any person violating paragraph (c) of
2 subsection (5) of KRS 189.390.

- 3 (2) (a) Any person who violates the weight provisions of KRS 189.212, 189.221,
4 189.222, 189.226, 189.230, 189.270, or 189.2713 shall be fined two cents
5 (\$0.02) per pound for each pound of excess load when the excess is five
6 thousand (5,000) pounds or less. When the excess exceeds five thousand
7 (5,000) pounds the fine shall be two cents (\$0.02) per pound for each pound of
8 excess load, but the fine levied shall not be less than one hundred dollars
9 (\$100) and shall not be more than five hundred dollars (\$500).
- 10 (b) Any person who violates the provisions of KRS 189.271 and is operating on a
11 route designated on the permit shall be fined one hundred dollars (\$100);
12 otherwise, the penalties in paragraph (a) of this subsection shall apply.

14 189.050, subsection (4) of KRS 189.090, KRS 189.221 to 189.230, 189.270,

17 dollars (\$10) nor more than five hundred dollars (\$500).
- 18 (d) 1. Any person who violates the provisions of KRS 177.985 while operating
19 on a route designated in KRS 177.986 shall be fined one hundred dollars
20 (\$100).
- 21 2. Any person who operates a vehicle with a permit under KRS 177.985 in
22 excess of eighty thousand (80,000) pounds while operating on a route
23 not designated in KRS 177.986 shall be fined one thousand dollars
24 (\$1,000).
- 25 (e) Nothing in this subsection or in KRS 189.221 to 189.228 shall be deemed to
26 prejudice or affect the authority of the Department of Vehicle Regulation to
27 suspend or revoke certificates of common carriers, permits of contract

- 1 carriers, or drivers' or chauffeurs' licenses, for any violation of KRS 189.221
2 to 189.228 or any other act applicable to motor vehicles, as provided by law.
- 3 (3) (a) Any person who violates subsection (1) of KRS 189.190 shall be fined not
4 more than fifteen dollars (\$15).
- 5 (b) Any person who violates subsection (5) of KRS 189.190 shall be fined not
6 less than thirty-five dollars (\$35) nor more than two hundred dollars (\$200).
- 7 (4) (a) Any person who violates subsection (1) of KRS 189.210 shall be fined not
8 less than twenty-five dollars (\$25) nor more than one hundred dollars (\$100).
- 9 (b) Any peace officer who fails, when properly informed, to enforce KRS 189.210
10 shall be fined not less than twenty-five dollars (\$25) nor more than one
11 hundred dollars (\$100).
- 12 (c) All fines collected under this subsection, after payment of commissions to
13 officers entitled thereto, shall go to the county road fund if the offense is
14 committed in the county, or to the city street fund if committed in the city.
- 15 (5) Any person who violates KRS 189.370 shall for the first offense be fined not less
16 than one hundred dollars (\$100) nor more than two hundred dollars (\$200) or
17 imprisoned not less than thirty (30) days nor more than sixty (60) days, or both. For
18 each subsequent offense occurring within three (3) years, the person shall be fined

- 3 (9) (a) Any person who violates KRS 189.530(1) shall be fined not less than thirty-
4 five dollars (\$35) nor more than one hundred dollars (\$100), or imprisoned
5 not less than thirty (30) days nor more than twelve (12) months, or both.
- 6 (b) Any person who violates KRS 189.530(2) shall be fined not less than thirty-
7 five dollars (\$35) nor more than one hundred dollars (\$100).
- 8 (10) Any person who violates any of the provisions of KRS 189.550 shall be guilty of a

14 and, in the case of a privately owned road or bridge, be paid to the owner. These

- 16 (13) Any person who violates any of the provisions of KRS 189.120 shall be fined not
17 less than twenty dollars (\$20) nor more than one hundred dollars (\$100) for each
18 offense.
- 19 (14) Any person who violates any provision of KRS 189.575 shall be fined not less than
20 twenty dollars (\$20) nor more than twenty-five dollars (\$25).
- 21 (15) Any person who violates subsection (2) of KRS 189.231 shall be fined not less than
22 twenty dollars (\$20) nor more than one hundred dollars (\$100) for each offense.
- 23 (16) Any person who violates restrictions or regulations established by the secretary of
24 transportation pursuant to subsection (3) of KRS 189.231 shall, upon first offense,
25 be fined one hundred dollars (\$100) and, upon subsequent convictions, be fined not
26 less than one hundred dollars (\$100) nor more than five hundred dollars (\$500) or
27 imprisoned for thirty (30) days, or both.

- 1 (17) (a) Any person who violates any of the provisions of KRS 189.565 shall be guilty
2 of a Class B misdemeanor.
- 3 (b) In addition to the penalties prescribed in paragraph (a) of this subsection, in
4 case of violation by any person in whose name the vehicle used in the
5 transportation of inflammable liquids or explosives is licensed, the person
6 shall be fined not less than one hundred dollars (\$100) nor more than five
7 hundred dollars (\$500). Each violation shall constitute a separate offense.
- 8 (18) Any person who abandons a vehicle upon the right-of-way of a state highway for
9 three (3) consecutive days shall be fined not less than thirty-five dollars (\$35) nor
10 more than one hundred dollars (\$100), or imprisoned for not less than ten (10) days
11 nor more than thirty (30) days.
- 12 (19) Every person violating KRS 189.393 shall be guilty of a Class B misdemeanor,
13 unless the offense is being committed by a defendant fleeing the commission of a
14 felony offense which the defendant was also charged with violating and was
15 subsequently convicted of that felony, in which case it is a Class A misdemeanor.
- 16 (20) Any law enforcement agency which fails or refuses to forward the reports required
17 by KRS 189.635 shall be subject to the penalties prescribed in KRS 17.157.
- 18 (21) A person who operates a bicycle in violation of the administrative regulations
19 promulgated pursuant to KRS 189.287 shall be fined not less than ten dollars (\$10)
20 nor more than one hundred dollars (\$100).
- 21 (22) Any person who violates KRS 189.860 shall be fined not more than five hundred
22 dollars (\$500) or imprisoned for not more than six (6) months, or both.
- 23 (23) Any person who violates KRS 189.754 shall be fined not less than twenty-five
24 dollars (\$25) nor more than three hundred dollars (\$300).
- 25 (24) Any person who violates the provisions of KRS 189.125(3)(a) shall be fined fifty
26 dollars (\$50). This fine shall be subject to prepayment. A fine imposed under this
27 subsection shall not be subject to court costs pursuant to KRS 24A.175, additional

1 court costs pursuant to KRS 24A.176, the fee imposed pursuant to KRS 24A.1765,
2 or any other additional fees or costs.

3 (25) Any person who violates the provisions of KRS 189.125(3)(b) shall not be issued a
4 uniform citation, but shall instead receive a courtesy warning up until July 1, 2009.
5 For a violation on or after July 1, 2009, the person shall be fined thirty dollars (\$30).
6 This fine shall be subject to prepayment. A fine imposed under this subsection shall
7 not be subject to court costs pursuant to KRS 24A.175, additional court costs
8 pursuant to KRS 24A.176, a fee imposed pursuant to KRS 24A.1765, or any other
9 additional fees or costs. A person who has not been previously charged with a
10 violation of KRS 189.125(3)(b) may elect to acquire a booster seat meeting the
11 requirements of KRS 189.125. Upon presentation of sufficient proof of the
12 acquisition, the charge shall be dismissed and no fees or costs shall be imposed.

13 (26) Any person who violates the provisions of KRS 189.125(6) shall be fined an
14 amount not to exceed twenty-five dollars (\$25). This fine shall be subject to
15 prepayment. A fine imposed under this subsection shall not be subject to court costs
16 pursuant to KRS 24A.175, additional court costs pursuant to KRS 24A.176, the fee
17 imposed pursuant to KRS 24A.1765, or any other additional fees or costs.

18 (27) Fines levied pursuant to this chapter shall be assessed in the manner required by
19 KRS 534.020, in amounts consistent with this chapter. Nonpayment of fines shall
20 be governed by KRS 534.020 and 534.060.

21 (28) A licensed driver under the age of eighteen (18) charged with a moving violation
22 pursuant to this chapter as the driver of a motor vehicle may be referred, prior to
23 trial, by the court to a diversionary program. The diversionary program under this
24 subsection shall consist of one (1) or both of the following:

25 (a) Execution of a diversion agreement which prohibits the driver from operating
26 a vehicle for a period not to exceed forty-five (45) days and which allows the
27 court to retain the driver's operator's license during this period; and

1 (b) Attendance at a driver improvement clinic established pursuant to KRS
2 186.574. If the person completes the terms of this diversionary program
3 satisfactorily the violation shall be dismissed.

4 (29) A person who violates the provisions of subsection (2) or (3) of KRS 189.459 shall
5 be fined two hundred fifty dollars (\$250). The fines and costs for a violation of
6 subsection (2) or (3) of KRS 189.459 shall be collected and disposed of in
7 accordance with KRS 24A.180. Once deposited into the State Treasury, ninety
8 percent (90%) of the fine collected under this subsection shall immediately be
9 forwarded to the personal care assistance program under KRS 205.900 to 205.920.
10 Ten percent (10%) of the fine collected under this subsection shall annually be
11 returned to the county where the violation occurred and distributed equally to all
12 law enforcement agencies within the county.

13 (30) Any person who violates KRS 189.292 or 189.294 shall be fined twenty-five dollars
14 (\$25) for the first offense and fifty dollars (\$50) for each subsequent offense.

15 **(31) Any person who violates subsection (5) or (7)(b) of Section 6 of this Act shall be**
16 **subject to a fine of two hundred fifty dollars (\$250). This fine shall be subject to**
17 **prepayment. A fine imposed under this subsection shall not be subject to court**
18 **costs pursuant to KRS 24A.175, additional costs pursuant to KRS 24A.176, the**
19 **fee imposed pursuant to KRS 24A.1765, or any other additional fees or costs.**

20 ➔Section 9. Sections 6 to 8 of this Act are a part of a pilot program and shall
21 sunset on July 1, 2024.

22 ➔Section 10. Notwithstanding any provision of law to the contrary, with respect
23 to any violations on or after March 1, 2021, the Transportation Cabinet shall suspend
24 imposition and collection of fines and penalties on a coal haul truck operator for coal haul
25 truck weight exceedance violations under KRS 189.271(9) on roads not currently listed in
26 the Transportation Cabinet's Certified Transportation Plan if the operator:

27 Meets the requirements of this section, with exception of hauling an oversize load

1 on a road not listed in the Certified Transportation Plan;

2 Meets all other applicable state and federal license and permit requirements to haul
3 coal in Kentucky; and

4 Has given notice to the Transportation Cabinet by applying to bond the road under
5 KRS 189.271.

6 The suspension on collection of fines and penalties shall terminate upon a final
7 determination on the bond by the cabinet, and any violations that would be imposed
8 during that period shall not remain enforceable unless the bond is denied. The provisions
9 of this section shall expire thirty (30) days after the effective date of this Act.

10 ➔Section 11. The Transportation Cabinet shall designate the United States Route
11 27 Bypass in Jessamine County as the "Bernard T. Moynahan Memorial Highway," and
12 shall, within 30 days of the effective date of this Act, erect the appropriate signage. This
13 designation shall supersede the designation contained in 2020 Ky. Acts ch. 116, sec. 43.
