8	→ SECTION 4. A NEW SECTION OF KRS CHAPTER 214 IS CREATED TO
9	READ AS FOLLOWS:
10	(1) As used in this section:
11	(a) "Business entity" has the same meaning as "entity" in KRS 271B.1-400;
12	<u>and</u>
13	(b) "Vaccine passport" means documentation that an individual has been
14	vaccinated against SARS-CoV-2.
15	(2) No business entity may require patrons or customers to provide a vaccine
16	passport to gain access to, entry upon, or service from operations of the business
17	entity in this state. This subsection shall not restrict business entities from
18	instituting screening protocols consistent with controlling government-issued
19	guidance to protect public health.
20	(3) This section does not apply to hospitals, doctors, nurses, physicians assistants,
21	nurse practitioners, other health care providers, or health entities licensed by the
22	<u>cabinet.</u>
23	→SECTION 5. A NEW SECTION OF KRS CHAPTER 214 IS CREATED TO

25	The Cabinet for Health and Family Services may impose a fine not to exceed five
26	thousand dollars (\$5,000) per violation of Section 1, 2, 3, or 4 of this Act.
