

1 AN ACT relating to the Kentucky Public Pensions Authority and declaring an
2 emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 16.582 is amended to read as follows:

5 (1) (a) Total and permanent disability means a disability which results in the
6 member's incapacity to engage in any occupation for remuneration or profit.
7 Loss by severance of both hands at or above the wrists, or both feet at or
8 above the ankles, or one (1) hand above the wrist and one (1) foot above the
9 ankle, or the complete, irrevocable loss of the sight of both eyes shall be
10 considered as total and permanent.

11 (b) Hazardous disability means a disability which results in the member's total
12 incapacity to continue as a regular full-time officer or as an employee in a
13 hazardous position, as defined in KRS 61.592, but which does not result in the
14 member's total and permanent incapacity to engage in other occupations for
15 remuneration or profit.

16 (c) In determining whether the disability meets the requirement of this section,
17 any reasonable accommodation provided by the employer as provided in 42
18 U.S.C. sec. 12111(9) and 29 C.F.R. Part 1630 shall be considered.

19 (d) If the board determines that the total and permanent disability of a member
20 receiving a retirement allowance under this section has ceased, then the board
21 shall determine if the member has a hazardous disability.

22 (2) Any person may qualify to retire on disability, subject to the following:

23 (a) The person shall have sixty (60) months of service, twelve (12) of which shall
24 be current service credited under KRS 16.543(1), 61.543(1), or 78.615(1). The
25 service requirement shall be waived if the disability is a total and permanent
26 disability or a hazardous disability and is a direct result of an act in line of
27 duty;

- 1 (b) For a person whose membership date is prior to August 1, 2004, the person
2 shall not be eligible for an unreduced retirement allowance;
- 3 (c) The person's application shall be on file in the retirement office no later than
4 twenty-four (24) months after the person's last day of paid employment, as
5 defined in KRS 16.505, as a regular full-time officer or in a regular full-time
6 hazardous position under KRS 61.592;
- 7 (d) The person shall receive a satisfactory determination pursuant to KRS 61.665;
8 and
- 9 (e) A person's disability application based on the same claim of incapacity shall
10 be accepted and reconsidered for disability if accompanied by new objective
11 medical evidence. The application shall be on file in the retirement office no
12 later than twenty-four (24) months after the person's last day of paid
13 employment as a regular full-time officer or in a regular full-time hazardous
14 position.
- 15 (3) Upon the examination of the objective medical evidence by licensed physicians
16 pursuant to KRS 61.665, it shall be determined that:
- 17 (a) The incapacity results from bodily injury, mental illness, or disease. For
18 purposes of this section, "injury" means any physical harm or damage to the
19 human organism other than disease or mental illness;
- 20 (b) The incapacity is deemed to be permanent; and
- 21 (c) The incapacity does not result directly or indirectly from:
- 22 1. Injury intentionally self-inflicted while sane or insane; or
23 2. Bodily injury, mental illness, disease, or condition which pre-existed
24 membership in the system or reemployment, whichever is most recent,
25 unless:
- 26 a. The disability results from bodily injury, mental illness, disease, or
27 a condition which has been substantially aggravated by an injury or

1 accident arising out of or in the course of employment; or

2 b. The person has at least sixteen (16) years' current or prior service
3 for employment with employers participating in the retirement
4 systems administered by the Kentucky Retirement Systems or the
5 County Employees Retirement System.

6 For purposes of this subparagraph, "reemployment" shall not mean a
7 change of employment between employers participating in the
8 retirement systems administered by the Kentucky Retirement Systems or
9 the County Employees Retirement System with no loss of service credit.

10 (4) (a) 1. An incapacity shall be deemed to be permanent **for the purpose of**
11 **hazardous disability** if it is expected to result in death or can be
12 expected to last for a continuous period of not less than twelve (12)
13 months from the person's last day of paid employment in a position as **a**
14 regular full-time officer or a hazardous position.

15 2. The determination of a permanent incapacity **for the purpose of**
16 **hazardous disability** shall be based on the medical evidence contained
17 in the member's file and the member's residual functional capacity and
18 physical exertion requirements.

19 **3. The determination of a total and permanent incapacity shall be based**
20 **on the medical evidence contained in the member's file and the**
21 **member's residual functional capacity.**

22 (b) The person's residual functional capacity shall be the person's capacity for
23 work activity on a regular and continuing basis. The person's physical ability
24 shall be assessed in light of the severity of the person's physical, mental, and
25 other impairments. The person's ability to walk, stand, carry, push, pull, reach,
26 handle, and other physical functions shall be considered with regard to
27 physical impairments. The person's ability to understand, remember, and carry

1 out instructions and respond appropriately to supervision, coworkers, and
2 work pressures in a work setting shall be considered with regard to mental
3 impairments. Other impairments, including skin impairments, epilepsy, visual
4 sensory impairments, postural and manipulative limitations, and
5 environmental restrictions, shall be considered in conjunction with the
6 person's physical and mental impairments to determine residual functional
7 capacity.

8 (c) The person's physical exertion requirements shall be determined based on the
9 following standards:

- 10 1. Sedentary work shall be work that involves lifting no more than ten (10)
11 pounds at a time and occasionally lifting or carrying articles such as
12 large files, ledgers, and small tools. Although a sedentary job primarily
13 involves sitting, occasional walking and standing may also be required
14 in the performance of duties.
- 15 2. Light work shall be work that involves lifting no more than twenty (20)
16 pounds at a time with frequent lifting or carrying of objects weighing up
17 to ten (10) pounds. A job shall be in this category if lifting is
18 infrequently required but walking and standing are frequently required,
19 or if the job primarily requires sitting with pushing and pulling of arm or
20 leg controls. If the person has the ability to perform substantially all of
21 these activities, the person shall be deemed capable of light work. A
22 person deemed capable of light work shall be deemed capable of
23 sedentary work unless the person has additional limitations such as the
24 loss of fine dexterity or inability to sit for long periods.
- 25 3. Medium work shall be work that involves lifting no more than fifty (50)
26 pounds at a time with frequent lifting or carrying of objects weighing up
27 to twenty-five (25) pounds. If the person is deemed capable of medium

- 1 work, the person shall be deemed capable of light and sedentary work.
- 2 4. Heavy work shall be work that involves lifting no more than one
3 hundred (100) pounds at a time with frequent lifting or carrying of
4 objects weighing up to fifty (50) pounds. If the person is deemed capable
5 of heavy work, the person shall also be deemed capable of medium,
6 light, and sedentary work.
- 7 5. Very heavy work shall be work that involves lifting objects weighing
8 more than one hundred (100) pounds at a time with frequent lifting or
9 carrying of objects weighing fifty (50) or more pounds. If the person is
10 deemed capable of very heavy work, the person shall be deemed capable
11 of heavy, medium, light, and sedentary work.
- 12 (5) (a) The disability retirement allowance shall be determined as provided in KRS
13 16.576, except if the member's total service credit on his or her last day of
14 paid employment in a regular full-time position is less than twenty (20) years,
15 service shall be added beginning with his or her last date of paid employment
16 and continuing to his or her fifty-fifth birthday. The maximum service credit
17 added shall not exceed the total service the member had on his or her last day
18 of paid employment, and the maximum service credit for calculating his or her
19 retirement allowance, including his or her total service and service added
20 under this section, shall not exceed twenty (20) years.
- 21 (b) For a member whose participation begins on or after August 1, 2004, but prior
22 to January 1, 2014, the disability retirement allowance shall be the higher of
23 twenty-five percent (25%) of the member's monthly final rate of pay or the
24 retirement allowance determined in the same manner as for retirement at his
25 or her normal retirement date with years of service and final compensation
26 being determined as of the date of his disability.
- 27 (c) For a member who begins participating on or after January 1, 2014, in the

1 hybrid cash balance plan as provided by KRS 16.583, the disability retirement
2 allowance shall be the higher of twenty-five percent (25%) of the member's
3 monthly final rate of pay or the retirement allowance determined in the same
4 manner as for retirement at his or her normal retirement date under KRS
5 16.583.

6 (6) If the member receives a satisfactory determination of hazardous disability pursuant
7 to KRS 61.665 and the disability is the direct result of an act in line of duty as
8 defined in KRS 16.505, the member's retirement allowance shall be calculated as
9 follows:

10 (a) For the disabled member, benefits as provided in subsection (5) of this section
11 except that the monthly retirement allowance payable shall not be less than
12 twenty-five percent (25%) of the member's monthly final rate of pay; and

13 (b) For each dependent child of the member on his or her disability retirement
14 date, who is alive at the time any particular payment is due, a monthly
15 payment equal to ten percent (10%) of the disabled member's monthly final
16 rate of pay; however, total maximum dependent children's benefit shall not
17 exceed forty percent (40%) of the member's monthly final rate of pay. The
18 payments shall be payable to each dependent child, or to a legally appointed
19 guardian or as directed by the system.

20 (7) If the member receives a satisfactory determination of total and permanent disability
21 pursuant to KRS 61.665 and the disability is the direct result of an act in line of duty
22 as defined in KRS 16.505, the member's retirement allowance shall be calculated as
23 follows:

24 (a) For the disabled member, the benefits as provided in subsection (5) of this
25 section except that the monthly retirement allowance payable shall not be less
26 than seventy-five percent (75%) of the member's monthly average pay; and

27 (b) For each dependent child of the member on his or her disability retirement

1 date, who is alive at the time any particular payment is due, a monthly
2 payment equal to ten percent (10%) of the disabled member's monthly average
3 pay, except that:

4 1. Member and dependent children payments under this subsection shall
5 not exceed one hundred percent (100%) of the member's monthly
6 average pay; and

7 2. Total maximum dependent children's benefits shall not exceed twenty-
8 five percent (25%) of the member's monthly average pay while the
9 member is living and forty percent (40%) of the member's monthly
10 average pay after the member's death. The payments shall be payable to
11 each dependent child, or to a legally appointed guardian or as directed by
12 the system, and shall be divided equally among all dependent children.

13 (8) No benefit provided in this section shall be reduced as a result of any change in the
14 extent of disability of any retired member who is the age of normal retirement ~~age~~
15 ~~fifty five (55)}~~ or older.

16 (9) If a regular full-time officer or hazardous position member has been approved for
17 benefits under a hazardous disability, the board shall, upon request of the member,
18 permit the member to receive the hazardous disability allowance while accruing
19 benefits in a nonhazardous position, subject to proper medical review of the
20 nonhazardous position's job description by the system's medical examiner.

21 (10) For a member of the State Police Retirement System, in lieu of the allowance
22 provided in subsection (5) to (7) of this section, the member may be retained on the
23 regular payroll and receive the compensation authorized by KRS 16.165, if he or
24 she is qualified.

25 ➔Section 2. KRS 61.505 is amended to read as follows:

26 (1) There is created an eight (8) member Kentucky Public Pensions Authority whose
27 purpose shall be to administer and operate:

- 1 (a) A single personnel system for the staffing needs of the Kentucky Retirement
2 Systems and the County Employees Retirement System;
- 3 (b) A system of accounting that is developed by the Authority for the Kentucky
4 Retirement Systems and the County Employees Retirement System;
- 5 (c) Day-to-day administrative needs of the Kentucky Retirement Systems and the
6 County Employees Retirement System, including but not limited to:
- 7 1. Benefit counseling and administration;
- 8 2. Information technology and services, including a centralized Web site
9 for the Authority, the Kentucky Retirement Systems, and the County
10 Employees Retirement System;
- 11 3. Legal services;
- 12 4. Employer reporting and compliance;
- 13 5. Processing and distribution of benefit payments, and other financial,
14 investment administration, and accounting duties as directed by the
15 Kentucky Retirement Systems board of trustees or the County
16 Employees Retirement System board of trustees;
- 17 6. All administrative actions, orders, decisions, and determinations
18 necessary to carry out benefit functions required by the Kentucky
19 Retirement Systems and the County Employment Retirement System
20 statutes, including but not limited to administration of reduced and
21 unreduced retirement benefits, disability retirement, reemployment after
22 retirement, service purchases, computation of sick-leave credit costs,
23 correction of system records, qualified domestic relations orders, and
24 pension spiking determinations~~[, and all other administrative decisions~~
25 ~~and orders];~~ and
- 26 7. Completing and compiling financial data and reports;
- 27 (d) Any jointly held assets used for the administration of the Kentucky Retirement

1 Systems and the County Employees Retirement System, including but not
2 limited to real estate, office space, equipment, and supplies;

3 (e) ***The hiring of*** a single actuarial consulting firm who shall serve both the
4 Kentucky Retirement Systems and the County Employees Retirement System;

5 (f) ***The hiring of a single external certified public accountant who shall***
6 ***perform audits for both the Kentucky Retirement Systems and the County***
7 ***Employees Retirement System;***

8 (g) The ***promulgation of***~~Authority may promulgate~~ administrative regulations
9 as an authority or on behalf of the Kentucky Retirement Systems and the
10 County Employees Retirement System, individually or collectively, provided
11 such regulations are not inconsistent with the provisions of this section and
12 KRS 16.505 to 16.652, 61.505, 61.510 to 61.705, and 78.510 to 78.852,
13 necessary or proper in order to carry out the provisions of this section and
14 duties authorized by KRS 16.505 to 16.652 and 61.510 to 61.705;

15 ~~(h)~~~~(g)~~ ***A system of*** contracting management for administrative services; and

16 ~~(i)~~~~(h)~~ Other tasks or duties as directed solely or jointly by the boards of the
17 Kentucky Retirement Systems or the County Employees Retirement System.

18 (2) The eight (8) member Kentucky Public Pensions Authority shall be composed of
19 the following individuals:

20 (a) The chair of the Kentucky Retirement Systems board of trustees;

21 (b) The chair of the County Employees Retirement System board of trustees;

22 (c) The investment committee chair of the Kentucky Retirement Systems board of
23 trustees, unless the investment committee chair is also the chair of the board
24 of trustees in which case the chair of the Kentucky Retirement Systems shall
25 appoint an individual who serves on the investment committee;

26 (d) The investment committee chair of the County Employees Retirement System
27 board of trustees, unless the investment committee chair is also the chair of

1 the County Employees Retirement System board of trustees in which case the
2 chair of the County Employees Retirement System shall appoint an individual
3 who serves on the investment committee;

4 (e) Two additional (2) trustees of the Kentucky Retirement Systems board of
5 trustees selected by the chair of the Kentucky Retirement Systems board of
6 trustees of which one (1) shall be a trustee who was elected by the
7 membership of one (1) of the systems administered by Kentucky Retirement
8 Systems and one (1) shall be a trustee of Kentucky Retirement Systems who
9 was appointed by the Governor; and

10 (f) Two additional (2) trustees of the County Employees Retirement System
11 board of trustees selected by the chair of the County Employees Retirement
12 System board of trustees of which one (1) shall be a trustee who was elected
13 by the membership of the County Employees Retirement System and one (1)
14 shall be a trustee of the County Employees Retirement System who was
15 appointed by the Governor.

16 (3) The Kentucky Public Pensions Authority is hereby granted the powers and
17 privileges of a corporation, including but not limited to the following powers:

18 (a) To sue and be sued in its corporate name;

19 (b) To make bylaws not inconsistent with the law and in accordance with its
20 duties as provided by this section;

21 (c) To conduct the business and promote the purposes for which it was formed;

22 (d) To carry out the obligations of the Authority subject to KRS Chapters 45,
23 45A, 56, and 57;

24 (e) To purchase fiduciary liability insurance; and

25 (f) The Kentucky Public Pensions Authority shall reimburse any Authority
26 member, officer, or employee for any legal expense resulting from a civil
27 action arising out of the performance of his or her official duties. The hourly

1 rate of reimbursement for any contract for legal services under this paragraph
2 shall not exceed the maximum hourly rate provided in the Legal Services
3 Duties and Maximum Rate Schedule promulgated by the Government
4 Contract Review Committee established pursuant to KRS 45A.705, unless a
5 higher rate is specifically approved by the secretary of the Finance and
6 Administration Cabinet or his or her designee.

7 (4) Any vacancy which may occur in an appointed position on the Kentucky Public
8 Pensions Authority shall be filled in the same manner which provides for the
9 selection of the particular member of the Authority. No person shall serve in more
10 than one (1) position as a member of the Authority and if a person holds more than
11 one (1) position as a member of the Authority, he or she shall resign a position.

12 (5) (a) Membership on the Authority shall not be incompatible with any other office
13 unless a constitutional incompatibility exists. No Authority member shall
14 serve in more than one (1) position as a member of the Authority.

15 (b) An Authority member shall be removed from office upon conviction of a
16 felony or for a finding of a violation of any provision of KRS 11A.020 or
17 11A.040 by a court of competent jurisdiction.

18 (c) A current or former employee of the County Employees Retirement System,
19 Kentucky Retirement Systems, or the Kentucky Public Pensions Authority
20 shall not be eligible to serve as a member of the Authority.

21 (6) Kentucky Public Pensions Authority members who do not otherwise receive a
22 salary from the State Treasury shall receive a per diem of eighty dollars (\$80) for
23 each day they are in session or on official duty, and they shall be reimbursed for
24 their actual and necessary expenses in accordance with state administrative
25 regulations and standards, except that the members shall not receive a per diem or
26 receive reimbursements on the same day they receive a per diem or reimbursements
27 for service to the Kentucky Retirement Systems board of trustees or County

1 Employees Retirement Systems board of trustees.

- 2 (7) (a) The Authority shall meet at least once in each quarter of the year and may
3 meet in special session upon the call of the chair or the executive director of
4 the Authority.
- 5 (b) The Authority shall elect a chair and a vice chair. The chair shall not serve
6 more than four (4) consecutive years as chair or vice chair of the Authority.
7 The vice chair shall not serve more than four (4) consecutive years as chair or
8 vice chair of the Authority. A member who has served four (4) consecutive
9 years as chair or vice chair of the Authority may be elected chair or vice chair
10 of the Authority after an absence of two (2) years from the positions.
- 11 (c) A majority of the Authority members shall constitute a quorum and all actions
12 taken by the Authority shall be by affirmative vote of a majority of the
13 Authority members present.
- 14 (d) The Authority shall post on the Authority's Web site and shall make available
15 to the public:
- 16 1. All meeting notices and agendas of the Authority. Notices and agendas
17 shall be posted to the Authority's Web site at least seventy-two (72)
18 hours in advance of the Authority's meetings, except in the case of
19 special or emergency meetings as provided by KRS 61.823;
 - 20 2. All Authority minutes or other materials that require adoption or
21 ratification by the Authority. The items listed in this subparagraph shall
22 be posted within seventy-two (72) hours of adoption or ratification of
23 the Authority;
 - 24 3. All bylaws, policies, or procedures adopted or ratified by the Authority;
25 and
 - 26 4. A listing of the members of the Authority and membership on each
27 committee established by the Authority.

- 1 (8) (a) The Kentucky Public Pensions Authority shall appoint or contract for the
2 services of an executive director and fix the compensation and other terms of
3 employment for this position without limitation of the provisions of KRS
4 Chapter 18A, 45A, and KRS 64.640. The executive director shall be the chief
5 administrative officer of the Authority, the Kentucky Retirement Systems
6 board of trustees, and the County Employees Retirement System board of
7 trustees. The executive director shall work cooperatively with the chief
8 executive officers of the Kentucky Retirement Systems and the County
9 Employees Retirement System. **The Authority shall annually conduct a**
10 **performance evaluation of the executive director.**
- 11 (b) The Kentucky Public Pensions Authority shall authorize the executive director
12 to appoint the employees deemed necessary to transact the duties of the
13 Authority for the purposes outlined in subsection (1) of this section. **After the**
14 **effective date of this Act, approval by the Authority shall be required for a**
15 **petition to the secretary of the Personnel Cabinet for the creation of any**
16 **new unclassified position pursuant to KRS 18A.115(1)(e), (g), (h), and (i).**
- 17 (c) Effective April 1, 2021, the Kentucky Public Pensions Authority shall assume
18 responsibility of administering the staff of the Kentucky Retirement Systems
19 in order to provide the services established by this section.
- 20 (d) **1.** All employees of the Kentucky Public Pensions Authority, except for the
21 executive director **and no more than six (6) unclassified employees of**
22 **the Office of Investments employed pursuant to KRS 18A.115(1)(e),**
23 **(g), (h), and (i)**~~], chief investment officer, and one (1) deputy chief~~
24 ~~investment officer]~~, shall be subject to the state personnel system
25 established pursuant to KRS 18A.005 to 18A.204 and shall have their
26 salaries determined by the secretary of the Personnel Cabinet.
- 27 **2. The employees exempted from the classified service under this**

1 paragraph shall not be subject to the salary limitations specified in
2 KRS 64.640(2) and (3).

3 3. The Kentucky Public Pensions Authority shall adopt a written salary
4 and classification plan fixing a range of compensation and written
5 terms of employment for any of the unclassified employees of the
6 Office of Investments it authorizes under this paragraph. The
7 Authority shall authorize the executive director to appoint up to six (6)
8 unclassified employees of the Office of Investments subject to the
9 compensation ranges and terms of employment the Authority has
10 established. The Authority may amend the written salary and
11 classification plan adopted under this paragraph at any time.

12 (e) The Authority shall annually review, approve, and submit a report to the
13 Public Pension Oversight Board detailing the number of employees of the
14 Authority, the salary paid to each employee, and the change in the salaries of
15 each individual employed by the Authority over the prior year.

16 (f) The Authority shall require the executive director and the employees as it
17 thinks proper to execute bonds for the faithful performance of their duties
18 notwithstanding the limitations of KRS Chapter 62.

19 (g) Notwithstanding any other provision of statute to the contrary, including but
20 not limited to any provision of KRS Chapter 12, the Governor shall have no
21 authority to change any provision of this section by executive order or action,
22 including but not limited to reorganizing, replacing, amending, or abolishing
23 the membership of the Kentucky Public Pensions Authority.

24 (9) All employees of the Authority shall serve during its will and pleasure.
25 Notwithstanding any statute to the contrary, employees shall not be considered
26 legislative agents under KRS 6.611.

27 (10) The Attorney General, or an assistant designated by him or her, may attend each

1 meeting of the Authority and may receive the agenda, board minutes, and other
2 information distributed to Authority members upon request. The Attorney General
3 may act as legal adviser and attorney for the Authority, and the Authority may
4 contract for legal services, notwithstanding the limitations of KRS Chapter 12 or
5 13B.

6 (11) (a) 1. All expenses incurred by or on behalf of the Kentucky Public Pensions
7 Authority shall be paid by the systems administered by the Kentucky
8 Retirement Systems or the County Employees Retirement System and
9 shall be prorated, assigned, or allocated to each system as determined by
10 Kentucky Public Pensions Authority.

11 2. *Until June 30, 2024,* any additional initial costs determined by the
12 Authority to be attributable solely to establishing a separate County
13 Employees Retirement System board and the Kentucky Public Pensions
14 Authority as provided by this section and KRS 78.782 shall be paid by
15 the County Employees Retirement System. *Until June 30, 2024,* any
16 additional ongoing annual administrative and investment expenses that
17 occur after the establishment of a separate County Employees
18 Retirement System board and the Kentucky Public Pensions Authority
19 that are determined by the Authority to be a direct result of establishing
20 a separate County Employees Retirement System board and the
21 Kentucky Public Pensions Authority shall be paid by the County
22 Employees Retirement System. *Beginning on and after July 1, 2024,*
23 *any annual administrative and investment expenses shall be prorated,*
24 *assigned, or allocated to each system as determined by the Kentucky*
25 *Public Pensions Authority as provided by subparagraph 1. of this*
26 *paragraph but without attribution to the establishment of a separate*
27 *County Employees Retirement System board and the Kentucky Public*

1 *Pensions Authority*

2 *3. In order to evaluate the results of establishing a separate County*
3 *Employees Retirement System board and the Kentucky Public*
4 *Pensions Authority, on or before November 15, 2022, and on or before*
5 *November 15 following the close of each successive fiscal year, the*
6 *Kentucky Public Pensions Authority shall report to the Public*
7 *Pensions Oversight Board the annual administrative and investment*
8 *expenses of the Kentucky Retirement Systems and the County*
9 *Employees Retirement System. The report shall include but not be*
10 *limited to the process or manner the Authority used to prorate, assign,*
11 *or allocate to each system its share of the expenses, the amount of*
12 *expenses prorated, assigned, or allocated to each system itemized by*
13 *category, and any efforts by the systems or the Authority to reduce*
14 *administrative costs and staffing needs.*

15 (b) Any other statute to the contrary notwithstanding, authorization for all
16 expenditures relating to the administrative operations of the Kentucky Public
17 Pensions Authority, the Kentucky Retirement Systems, and the County
18 Employees Retirement System shall be contained in the biennial budget unit
19 request, branch budget recommendation, and the financial plan adopted by the

22 *its submission by the Authority.* The request from the Kentucky Public
23 Pensions Authority shall include any specific administrative expenses
24 requested by the Kentucky Retirement Systems board of trustees or the
25 County Employees Retirement System board of trustees pursuant to KRS
26 61.645(13) or 78.782(13), as applicable, that are not otherwise expenses
27 specified by paragraph (a) of this subsection.

- 1 (12) (a) An Authority member shall discharge his or her duties as a member of the
2 Authority, including his or her duties as a member of a committee of the
3 Authority:
- 4 1. In good faith;
 - 5 2. On an informed basis; and
 - 6 3. In a manner he or she honestly believes to be in the best interest of the
7 County Employees Retirement System and the Kentucky Retirement
8 Systems, as applicable.
- 9 (b) An Authority member discharges his or her duties on an informed basis if,
10 when he or she makes an inquiry into the business and affairs of the Authority,
11 system, or systems or into a particular action to be taken or decision to be
12 made, he or she exercises the care an ordinary prudent person in a like
13 position would exercise under similar circumstances.
- 14 (c) In discharging his or her duties, an Authority member may rely on
15 information, opinions, reports, or statements, including financial statements
16 and other financial data, if prepared or presented by:
- 17 1. One (1) or more officers or employees of the Authority whom the
18 Authority member honestly believes to be reliable and competent in the
19 matters presented;
 - 20 2. Legal counsel, public accountants, actuaries, or other persons as to
21 matters the Authority member honestly believes are within the person's
22 professional or expert competence; or
 - 23 3. A committee of the Authority of which he or she is not a member if the
24 Authority member honestly believes the committee merits confidence.
- 25 (d) An Authority member shall not be considered as acting in good faith if he or
26 she has knowledge concerning the matter in question that makes reliance
27 otherwise permitted by paragraph (c) of this subsection unwarranted.

1 (e) Any action taken as a member of the Authority, or any failure to take any
2 action as an Authority member, shall not be the basis for monetary damages or
3 injunctive relief unless:

4 1. The Authority member has breached or failed to perform the duties of
5 the member's office in compliance with this section; and

6 2. In the case of an action for monetary damages, the breach or failure to
7 perform constitutes willful misconduct or wanton or reckless disregard
8 for human rights, safety, or property.

9 (f) A person bringing an action for monetary damages under this section shall
10 have the burden of proving by clear and convincing evidence the provisions of
11 paragraph (e)1. and 2. of this subsection, and the burden of proving that the
12 breach or failure to perform was the legal cause of damages suffered by the
13 Kentucky Retirement Systems or County Employees Retirement System, as
14 applicable.

15 (g) In discharging his or her administrative duties under this section, an Authority
16 member shall strive to administer the systems in an efficient and cost-effective
17 manner for the taxpayers of the Commonwealth of Kentucky and shall take all
18 actions available under the law to contain costs for the trusts, including costs
19 for participating employers, members, and retirees.

10 temporary, interim, and part-time workers. In case of any doubt, the board shall
11 determine if a person is an employee within the meaning of KRS 61.510 to 61.705;

12 (6) "Employer" means a department or any authority of a department having the power
13 to appoint or select an employee in the department, including the Senate and the
14 House of Representatives, or any other entity, the employees of which are eligible
15 for membership in the system pursuant to KRS 61.525;

16 (7) "State" means the Commonwealth of Kentucky;

17 (8) "Member" means any employee who is included in the membership of the system or
18 any former employee whose membership has not been terminated under KRS
19 61.535;

20 (9) "Service" means the total of current service and prior service as defined in this
21 section;

22 (10) "Current service" means the number of years and months of employment as an
23 employee, on and after July 1, 1956, except that for members, officers, and
24 employees of the General Assembly this date shall be January 1, 1960, for which
25 creditable compensation is paid and employee contributions deducted, except as
26 otherwise provided, and each member, officer, and employee of the General
27 Assembly shall be credited with a month of current service for each month he

1 serves in the position;

2 (11) "Prior service" means the number of years and completed months, expressed as a
3 fraction of a year, of employment as an employee, prior to July 1, 1956, for which
4 creditable compensation was paid; except that for members, officers, and employees
5 of the General Assembly, this date shall be January 1, 1960. An employee shall be
6 credited with one (1) month of prior service only in those months he received
7 compensation for at least one hundred (100) hours of work; provided, however, that
8 each member, officer, and employee of the General Assembly shall be credited with
9 a month of prior service for each month he served in the position prior to January 1,
10 1960. Twelve (12) months of current service in the system are required to validate
11 prior service;

12 (12) "Accumulated contributions" at any time means the sum of all amounts deducted
13 from the compensation of a member and credited to his individual account in the
14 members' account, including employee contributions picked up after August 1,
15 1982, pursuant to KRS 61.560(4), together with interest credited, on such amounts
16 and any other amounts the member shall have contributed thereto, including interest
17 credited thereon. For members who begin participating on or after September 1,
18 2008, "accumulated contributions" shall not include employee contributions that are
19 deposited into accounts established pursuant to 26 U.S.C. sec. 401(h) within the
20 funds established in KRS 16.510 and 61.515, as prescribed by KRS 61.702(3)(b);

21 (13) "Creditable compensation":

22 (a) Means all salary, wages, tips to the extent the tips are reported for income tax
23 purposes, and fees, including payments for compensatory time, paid to the
24 employee as a result of services performed for the employer or for time during
25 which the member is on paid leave, which are includable on the member's
26 federal form W-2 wage and tax statement under the heading "wages, tips,
27 other compensation," including employee contributions picked up after

1 August 1, 1982, pursuant to KRS 61.560(4). For members of the General
2 Assembly, it shall mean all amounts which are includable on the member's
3 federal form W-2 wage and tax statement under the heading "wages, tips,
4 other compensation," including employee contributions picked up after
5 August 1, 1982, pursuant to KRS 6.505(4) or 61.560(4);

6 (b) Includes:

- 7 1. Lump-sum bonuses, severance pay, or employer-provided payments for
8 purchase of service credit, which shall be averaged over the employee's
9 total service with the system in which it is recorded if it is equal to or
10 greater than one thousand dollars (\$1,000);
- 11 2. Cases where compensation includes maintenance and other perquisites,
12 but the board shall fix the value of that part of the compensation not paid
13 in money;
- 14 3. Lump-sum payments for creditable compensation paid as a result of an
15 order of a court of competent jurisdiction, the Personnel Board, or the
16 Commission on Human Rights, or for any creditable compensation paid
17 in anticipation of settlement of an action before a court of competent

7 1. Living allowances, expense reimbursements, lump-sum payments for
8 accrued vacation leave, and other items determined by the board;

9 2. For employees who begin participating on or after September 1, 2008,

11 3. For employees who begin participating on or after August 1, 2016,
12 nominal fees paid for services as a volunteer; and

13 4. Any salary or wages paid to an employee for services as a Kentucky
14 State Police school resource officer as defined by KRS 158.441;

15 (14) "Final compensation" of a member means:

16 (a) For a member who begins participating before September 1, 2008, who is
17 employed in a nonhazardous position, the creditable compensation of the
18 member during the five (5) fiscal years he or she was paid at the highest
19 average monthly rate divided by the number of months of service credit during
20 that five (5) year period multiplied by twelve (12). The five (5) years may be
21 fractional and need not be consecutive. If the number of months of service
22 credit during the five (5) year period is less than forty-eight (48), one (1) or
23 more additional fiscal years shall be used;

24 (b) For a member who is employed in a nonhazardous position, whose effective
25 retirement date is between August 1, 2001, and January 1, 2009, and whose
26 total service credit is at least twenty-seven (27) years and whose age and years
27 of service total at least seventy-five (75), final compensation means the

1 creditable compensation of the member during the three (3) fiscal years the
2 member was paid at the highest average monthly rate divided by the number
3 of months of service credit during that three (3) years period multiplied by
4 twelve (12). The three (3) years may be fractional and need not be
5 consecutive. If the number of months of service credit during the three (3)
6 year period is less than twenty-four (24), one (1) or more additional fiscal

10 (c) For a member who begins participating before September 1, 2008, who is
11 employed in a hazardous position, as provided in KRS 61.592, the creditable
12 compensation of the member during the three (3) fiscal years he or she was
13 paid at the highest average monthly rate divided by the number of months of
14 service credit during that three (3) year period multiplied by twelve (12). The
15 three (3) years may be fractional and need not be consecutive. If the number of
16 months of service credit during the three (3) year period is less than twenty-
17 four (24), one (1) or more additional fiscal years shall be used;

18 (d) For a member who begins participating on or after September 1, 2008, but
19 prior to January 1, 2014, who is employed in a nonhazardous position, the
20 creditable compensation of the member during the five (5) complete fiscal
21 years immediately preceding retirement divided by five (5). Each fiscal year
22 used to determine final compensation must contain twelve (12) months of
23 service credit. If the member does not have five (5) complete fiscal years that
24 each contain twelve (12) months of service credit, then one (1) or more
25 additional fiscal years, which may contain less than twelve (12) months of
26 service credit, shall be added until the number of months in the final
27 compensation calculation is at least sixty (60) months; or

1 (e) For a member who begins participating on or after September 1, 2008, but
2 prior to January 1, 2014, who is employed in a hazardous position as provided
3 in KRS 61.592, the creditable compensation of the member during the three
4 (3) complete fiscal years he or she was paid at the highest average monthly
5 rate divided by three (3). Each fiscal year used to determine final
6 compensation must contain twelve (12) months of service credit. If the
7 member does not have three (3) complete fiscal years that each contain twelve
8 (12) months of service credit, then one (1) or more additional fiscal years,
9 which may contain less than twelve (12) months of service credit, shall be
10 added until the number of months in the final compensation calculation is at
11 least thirty-six (36) months;

12 (15) "Final rate of pay" means the actual rate upon which earnings of an employee were
13 calculated during the twelve (12) month period immediately preceding the
14 member's effective retirement date, including employee contributions picked up
15 after August 1, 1982, pursuant to KRS 61.560(4). The rate shall be certified to the
16 system by the employer and the following equivalents shall be used to convert the
17 rate to an annual rate: two thousand eighty (2,080) hours for eight (8) hour
18 workdays, nineteen hundred fifty (1,950) hours for seven and one-half (7-1/2) hour

27 Security adjustment option as provided for in KRS 61.635(8), in which case the

12 or contact with reality; or laboratory findings which are anatomical, physiological,

2 (37) "Participant" means a member, as defined by subsection (8) of this section, or a

- 27 (a) Once a department participates it shall continue to participate as long as it

2 (b) Any position initially required to participate in the Kentucky Employees
3 Retirement System shall continue to participate as long as the position exists.

3 ~~sent~~^{mailed} the notice of the recommendation **by United States**
4 **first-class mail** to the person's last address on file in the retirement
5 office, **by electronic mail to the person's last electronic mail**
6 **address on file in the retirement office, or by other electronic**
7 **means.**

8 (e) Any person whose disability benefits have been reduced or discontinued,
9 pursuant to paragraph (c)2. or (d)2. of this subsection, may file at the
10 retirement office a request for formal hearing to be conducted in accordance
11 with KRS Chapter 13B. The right to demand a formal hearing shall be limited
12 to a period of sixty (60) days after the person had notice, as described in
13 paragraph (c) or (d) of this subsection. The request for formal hearing shall be
14 filed with the system, at the retirement office in Frankfort. The request for
15 formal hearing shall include a short and plain statement of the reasons the
16 reduction, discontinuance, or denial of disability retirement is being contested.

17 (f) Failure of the person to request a formal hearing within the period of time
18 specified shall preclude the person from proceeding any further with
19 contesting the reduction or discontinuation of disability retirement allowance,
20 except as provided in subsection (6)(d) of this section. This paragraph shall
21 not limit the person's right to appeal to a court.

22 (g) A final order of the board shall be based on substantial evidence appearing in
23 the record as a whole and shall set forth the decision of the board and the facts
24 and law upon which the decision is based. If the board orders that the person's
25 disability retirement allowance be discontinued or reduced, the order shall
26 take effect on the first day of the month following the day the system
27 ~~sent~~^{mailed} the order **by United States first-class mail** to the person's last

1 address on file in the retirement office, by electronic mail to the person's last
2 electronic mail address on file in the retirement office, or by other electronic
3 means. Judicial review of the final board order shall not operate as a stay and
4 the system shall discontinue or reduce the person's disability retirement
5 allowance as provided in this section.

6 (h) Notwithstanding any other provisions of this section, the system may require
7 the person to submit to one (1) or more medical or psychological
8 examinations at any time. The system shall be responsible for any costs
9 associated with any examinations of the person requested by the medical
10 examiner or the system for the purpose of providing medical information
11 deemed necessary by the medical examiner or the system. Notice of the time
12 and place of the examination shall be provided~~mailed~~ to the person or his or
13 her legal representative. If the person fails or refuses to submit to one (1) or
14 more medical examinations, his or her rights to further disability retirement
15 allowance shall cease.

16 (i) All requests for a hearing pursuant to this section shall be made in writing.

17 (4) The board may establish an appeals committee whose members shall be appointed
18 by the chair and who shall have the authority to act upon the recommendations and
19 reports of the hearing officer pursuant to this section on behalf of the board.

20 (5) Any person aggrieved by a final order of the board may seek judicial review after all
21 administrative appeals have been exhausted by filing a petition for judicial review
22 in the Franklin Circuit Court in accordance with KRS Chapter 13B.

23 (6) If a disability retirement allowance is reduced or discontinued for a person who
24 began participating in the system prior to January 1, 2014, the person may apply for
25 early retirement benefits as provided under KRS 61.559, subject to the following
26 provisions:

27 (a) The person may not change his or her beneficiary or payment option, except

1 as provided by KRS 61.542(5);

2 (b) If the person has returned to employment with an employer participating in
3 one (1) of the systems administered by Kentucky Retirement Systems, the
4 service and creditable compensation shall be used in recomputing his or her
5 benefit, except that the person's final compensation shall not be less than the
6 final compensation last used in determining his or her retirement allowance;

7 (c) The benefit shall be reduced as provided by KRS 61.595(2);

8 (d) The person shall remain eligible for reinstatement of his or her disability
9 allowance upon reevaluation by the medical review board until his or her
10 normal retirement age. The person shall apply for reinstatement of disability
11 benefits in accordance with the provisions of this section. An application for
12 reinstatement of disability benefits shall be administered as an application
13 under KRS 61.600, and only the bodily injuries, mental illnesses, diseases, or
14 conditions for which the person was originally approved for disability benefits
15 shall be considered. Bodily injuries, mental illnesses, diseases, or conditions
16 that came into existence after the person's last day of paid employment shall
17 not be considered as a basis for reinstatement of disability benefits. Bodily
18 injuries, mental illnesses, diseases, or conditions alleged by the person as
19 being incapacitating, but which were not the basis for the award of disability
20 retirement benefits, shall not be considered. If the person establishes that the
21 disability benefits should be reinstated, the retirement system shall pay
22 disability benefits effective from the first day of the month following the
23 month in which the person applied for reinstatement of the disability benefits;
24 and

25 (e) Upon attaining normal retirement age, the person shall receive the higher of
26 either his or her disability retirement allowance or his or her early retirement
27 allowance.

1 (7) *If a disability retirement allowance is reduced or discontinued for a person who*
 2 *began participating in the system on or after January 1, 2014, the person shall*
 3 *remain eligible for reinstatement of his or her disability allowance as provided*
 4 *under subsection (6)(d) of this section.*

5 (8) No disability retirement allowance shall be reduced or discontinued by the system
 6 after the person's normal retirement date except in case of reemployment as
 7 provided for by KRS 61.637. If a disability retirement allowance has been reduced
 8 or discontinued, except if the person is reemployed as provided for by KRS 61.637,
 9 the retirement allowance shall be reinstated upon attainment of the person's normal
 10 retirement date to the retirement allowance prior to adjustment. No reinstated
 11 payment shall be less than the person is receiving upon attainment of the person's
 12 normal retirement date.

13 ➔Section 10. KRS 61.635 is amended to read as follows:

14 (1) Each member shall have the right to elect to have his *or her* retirement allowance
 15 payable under any one (1) of the options set forth in this section in lieu of the
 16 retirement allowance otherwise payable to *the member*~~[him]~~ upon retirement under
 17 any of the provisions of KRS 16.505 to 16.652, 61.510 to 61.705, and 78.510 to
 18 78.852. The amount of any optional retirement allowance shall be actuarially

21 (2) Survivorship one hundred percent (100%). The member may elect to receive a

- 1 his or her beneficiary during the lifetime of the person.
- 2 (4) Survivorship fifty percent (50%). The member may elect to receive a decreased
3 retirement allowance during his or her lifetime and have one-half (1/2) of the
4 retirement allowance continued after the member's~~[his]~~ death to his or her
5 beneficiary during the lifetime of the person.
- 6 (5) Life with ten (10) years certain. The member less than age seventy-six (76) may
7 elect to receive a monthly retirement allowance during his or her lifetime which
8 shall guarantee payments for one hundred twenty (120) months. If the member dies
9 before receiving payments for one hundred twenty (120) months, the member's~~[his]~~
10 beneficiary shall receive the remaining payments monthly, for the duration of the
11 one hundred twenty (120) months' period. However, if the trust is designated as
12 beneficiary, the trustee of the trust may elect to receive a lump-sum payment which
13 shall be the actuarial equivalent to the remaining payments, or the trustee may elect
14 to continue the remaining monthly payments to the trust of the member. If the estate
15 is designated as beneficiary, the estate shall receive a lump-sum payment which
16 shall be the actuarial equivalent to the remaining payments.
- 17 (6) Life with fifteen (15) years certain. The member less than age sixty-eight (68) may
18 elect to receive a monthly retirement allowance during his or her lifetime which
19 shall guarantee payments for one hundred ~~and~~ eighty (180) months. If the member
20 dies before receiving payments for one hundred ~~and~~ eighty (180) months, the
21 member's~~[his]~~ beneficiary shall receive the remaining payments monthly for the
22 duration of the one hundred ~~and~~ eighty (180) months' period. However, if the trust
23 is designated as beneficiary, the trustee of the trust may elect to receive a lump-sum
24 payment which shall be the actuarial equivalent to the remaining payments, or the
25 trustee may elect to continue the remaining payments to the trust of the member. If
26 the estate is designated as beneficiary, the estate shall receive a lump-sum payment
27 which shall be the actuarial equivalent to the remaining payments.

1 (7) Life with twenty (20) years certain. The member less than age sixty-two (62) may
2 elect to receive a monthly retirement allowance during his or her lifetime which
3 shall guarantee payments for two hundred ~~and~~ forty (240) months. If the member
4 dies before receiving payments for two hundred ~~and~~ forty (240) months, the
5 member's~~his~~ beneficiary shall receive the remaining payments for the duration of
6 the two hundred ~~and~~ forty (240) months period. However, if the trust is
7 beneficiary, the trustee of the trust may elect to receive a lump-sum payment which
8 shall be the actuarial equivalent to the remaining payments, or the trustee may elect
9 to continue the remaining payments to the trust of the member. If the estate is
10 designated as beneficiary, the estate shall receive a lump-sum payment which shall
11 be the actuarial equivalent to the remaining payments.

12 (8) Social Security adjustment options. These options shall be available to any member
13 who has not attained age sixty-two (62) as follows:

14 (a) No survivor rights. The member may elect to receive an increased retirement
15 allowance from his or her effective retirement date through the month he or
16 she attains age sixty-two (62) at which time his retirement allowance shall be
17 decreased for the remainder of his or her lifetime;

18 (b) Survivor rights. The member may elect to receive an increased retirement
19 allowance from his or her effective retirement date through the month he
20 attains age sixty-two (62) based on the option payable under subsection (2) of
21 this section, if the retirement allowance shall be decreased in the month
22 following the month he or she attains age sixty-two (62), or the month
23 following the month he or she would have attained age sixty-two (62), in
24 event of the member's~~his~~ death, and have the retirement allowance continue
25 after the member's~~his~~ death to his or her beneficiary during the lifetime of
26 the person.

27 (9) Beneficiary Social Security adjustment option. This option is available to the

1 beneficiary of a deceased member if the beneficiary, who is a person, has not
2 attained age sixty (60), and is eligible to receive Social Security payments at age
3 sixty (60). The beneficiary may elect to receive during his or her lifetime an
4 increased retirement allowance based on his or her annual benefit payable for life.
5 The payment shall begin on his or her effective retirement date and continue
6 through the month he or she attains age sixty (60) at which time his or her
7 retirement allowance shall be decreased for the remainder of his or her lifetime.

8 (10) Pop-up option. The member may elect to receive a decreased retirement allowance
9 during his or her lifetime and have the retirement allowance continued after the
10 member's~~his~~ death to his or her beneficiary during the lifetime of the person. If
11 the beneficiary dies prior to the member, or if the beneficiary is the member's
12 spouse and they divorce, the member's retirement allowance shall increase to the
13 amount that would have been payable as a single life annuity.

14 (11) Actuarial equivalent refund. A member who began participating in the system prior
15 to January 1, 2014, may elect to receive a one (1) time lump-sum payment which
16 shall be the actuarial equivalent of the amount payable for a period of sixty (60)
17 months under KRS 61.595 (1).

18 (12) Partial lump-sum option.

19 (a) No survivor rights. A member retiring on or before January 1, 2009, may elect
20 to receive a one-time lump-sum payment equal to twelve (12), twenty-four
21 (24), or thirty-six (36) monthly retirement allowances payable under the
22 applicable retirement formula for the system and receive a reduced monthly
23 retirement allowance payable for his or her lifetime. The lump-sum payment
24 shall be paid in the month the first monthly retirement allowance is payable.

25 (b) Survivor rights. A member retiring on or before January 1, 2009, may elect to
26 receive a one-time lump-sum payment equal to twelve (12), twenty-four (24),
27 or thirty-six (36) monthly retirement allowances payable under subsection (2)

1 of this section and receive a reduced monthly retirement allowance payable for
2 his or her lifetime. The lump-sum payment shall be paid in the month the first
3 monthly retirement allowance is payable. The reduced retirement allowance
4 shall be continued after the member's death to his or her beneficiary during
5 the lifetime of the person.

6 (13) The other provisions of this section notwithstanding, the beneficiary of a retired
7 member of the General Assembly shall, after the member's death, receive sixty-six
8 and two-thirds percent (66-2/3%) of the member's retirement allowance during his
9 or her lifetime if the member of the General Assembly began participating in the
10 system prior to January 1, 2014, and has elected this option and has made
11 contributions in accordance with subsection (14) of this section and of KRS 61.560.
12 The retirement allowance of the retired member of the General Assembly shall not
13 be actuarially reduced to provide for this survivor benefit.

14 (14) A member of the General Assembly who began participating in the system prior to
15 January 1, 2014, who wishes to obtain the survivorship option specified in
16 subsection (13) of this section shall so notify the Kentucky Public Pensions
17 Authority~~[retirement systems]~~:

18 (a) Within thirty (30) days after first becoming a member of the General
19 Assembly if he or she is not a member of the General Assembly on July 15,
20 1980; or

21 (b) Within thirty (30) days after July 15, 1980, if he or she is a member of the
22 General Assembly on July 15, 1980.

23 (15) The system shall forward to members of the General Assembly a form on which a
24 member who began participating in the system prior to January 1, 2014, may elect
25 the option provided for in subsections (13) and (14) of this section.

26 (16) The options described in subsections (2), (3), (4), (8)(b), (10), (12)(b), and (13) of
27 this section shall be extended to the member only if the designated beneficiary is a

1 person.

2 ➔Section 11. KRS 61.637 is amended to read as follows:

3 (1) A retired member who is receiving monthly retirement payments under any of the
4 provisions of KRS 61.510 to 61.705 and 78.510 to 78.852 and who is reemployed
5 as an employee by a participating agency prior to August 1, 1998, shall have his or
6 her retirement payments suspended for the duration of reemployment. Monthly
7 payments shall not be suspended for a retired member who is reemployed if he or
8 she anticipates that he or she will receive less than the maximum permissible
9 earnings as provided by the Federal Social Security Act in compensation as a result
10 of reemployment during the calendar year. The payments shall be suspended at the
11 beginning of the month in which the reemployment occurs.

12 (2) Employer and employee contributions shall be made as provided in KRS 61.510 to
13 61.705 and 78.510 to 78.852 on the compensation paid during reemployment,
14 except where monthly payments were not suspended as provided in subsection (1)
15 of this section or would not increase the retired member's last monthly retirement
16 allowance by at least one dollar (\$1), and the member shall be credited with
17 additional service credit.

18 (3) In the month following the termination of reemployment, retirement allowance
19 payments shall be reinstated under the plan under which the member was receiving
20 payments prior to reemployment.

21 (4) (a) Notwithstanding the provisions of this section, the payments suspended in
22 accordance with subsection (1) of this section shall be paid retroactively to the
23 retired member, or his or her estate, if he or she does not receive more than the
24 maximum permissible earnings as provided by the Federal Social Security Act
25 in compensation from participating agencies during any calendar year of
26 reemployment.

27 (b) If the retired member is paid suspended payments retroactively in accordance

1 with this section, employee contributions deducted during his or her period of
2 reemployment, if any, shall be refunded to the retired employee, and no
3 service credit shall be earned for the period of reemployment.

4 (c) If the retired member is not eligible to be paid suspended payments for his or
5 her period of reemployment as an employee, his or her retirement allowance
6 shall be recomputed under the plan under which the member was receiving
7 payments prior to reemployment as follows:

- 8 1. The retired member's final compensation shall be recomputed using
9 creditable compensation for his or her period of reemployment;
10 however, the final compensation resulting from the recalculation shall
11 not be less than that of the member when his or her retirement allowance

1 5. Any retired member who was reemployed prior to March 26, 1974, shall

3 provisions of this section on the first day of the month following March
4 26, 1974.

5 (5) A retired member, or his or her estate, shall pay to the retirement fund the total
6 amount of payments which are not suspended in accordance with subsection (1) of
7 this section if the member received more than the maximum permissible earnings as
8 provided by the Federal Social Security Act in compensation from participating
9 agencies during any calendar year of reemployment, except the retired member or
10 his or her estate may repay the lesser of the total amount of payments which were
11 not suspended or fifty cents (\$0.50) of each dollar earned over the maximum
12 permissible earnings during reemployment if under age sixty-five (65), or one dollar
13 (\$1) for every three dollars (\$3) earned if over age sixty-five (65).

14 (6) (a) "Reemployment" or "reinstatement" as used in this section shall not include a
15 retired member who has been ordered reinstated by the Personnel Board under
16 authority of KRS 18A.095.

17 (b) A retired member who has been ordered reinstated by the Personnel Board
18 under authority of KRS 18A.095 or by court order or by order of the Human
19 Rights Commission and accepts employment by an agency participating in the
20 Kentucky Employees Retirement System or County Employees Retirement
21 System shall void his or her retirement by reimbursing the system in the full
22 amount of his or her retirement allowance payments received.

23 (7) (a) Effective August 1, 1998, the provisions of subsections (1) to (4) of this
24 section shall no longer apply to a retired member who is reemployed in a
25 position covered by the same retirement system from which the member
26 retired. Reemployed retired members shall be treated as new members upon
27 reemployment. Any retired member whose reemployment date preceded

1 August 1, 1998, who does not elect, within sixty (60) days of notification by

14 retirement allowance. The member shall not change beneficiary or payment
15 option designations. This provision shall apply to members reemployed on or
16 after August 1, 1998.

17 (8) If a retired member accepts employment or begins serving as a volunteer with an
18 employer participating in the systems administered by Kentucky Retirement
19 Systems or County Employees Retirement System within twelve (12) months of his
20 or her retirement date, the retired member shall notify the Authority and the
21 participating employer shall submit the information required or requested by the
22 Authority to confirm the individual's employment or volunteer status. The retired
23 member shall not be required to notify the Authority regarding any employment or
24 volunteer service with a participating agency that is accepted after twelve (12)
25 months following his or her retirement date.

26 (9) If the retired member is under a contract to provide services as an independent
27 contractor or leased employee to an employer participating in the systems

1 administered by Kentucky Retirement Systems or County Employees Retirement
2 System within twelve (12) months of his or her retirement date, the member shall
3 submit a copy of that contract to the Authority, and the Authority shall determine if
4 the member is an independent contractor or leased employee for purposes of
5 retirement benefits. The retired member and the participating employer shall submit
6 the information required or requested by the Authority to confirm the individual's
7 status as an independent contractor or leased employee. The retired member shall
8 not be required to notify the Authority regarding any services entered into as an
9 independent contractor or leased employee with a participating agency that the
10 employee enters into after twelve (12) months following his or her retirement date.

11 (10) If a member is receiving a retirement allowance, or has filed the forms required for
12 a retirement allowance, and is employed within one (1) month of the member's
13 initial retirement date in a position that is required to participate in the same
14 retirement system from which the member retired, the member's retirement shall be
15 voided and the member shall repay to the retirement system all benefits received.
16 The member shall contribute to the member account established for him or her prior
17 to his or her voided retirement. The retirement allowance for which the member
18 shall be eligible upon retirement shall be determined by total service and creditable
19 compensation.

20 (11) (a) If a member of the Kentucky Employees Retirement System retires from a
21 department which participates in more than one (1) retirement system and is
22 reemployed within one (1) month of his or her initial retirement date by the
23 same department in a position participating in another retirement system, the
24 retired member's retirement allowance shall be suspended for the first month
25 of his or her retirement, and the member shall repay to the retirement system
26 all benefits received for the month.

27 (b) A retired member of the County Employees Retirement System who after

1 initial retirement is hired by the county from which the member retired shall
2 be considered to have been hired by the same employer.

- 3 (12) (a) If a hazardous member who retired prior to age fifty-five (55), or a
4 nonhazardous member who retired prior to age sixty-five (65), is reemployed
5 within six (6) months of the member's termination by the same employer, the
6 member shall obtain from his or her previous and current employers a copy of
7 the job description established by the employers for the position and a
8 statement of the duties performed by the member for the position from which
9 he or she retired and for the position in which he or she has been reemployed.
- 10 (b) The job descriptions and statements of duties shall be filed with the retirement
11 office.

12 (13) If the retirement system determines that the retired member has been employed in a
13 position with the same principal duties as the position from which the member
14 retired:

- 15 (a) The member's retirement allowance shall be suspended during the period that
16 begins on the month in which the member is reemployed and ends six (6)
17 months after the member's termination;
- 18 (b) The retired member shall repay to the retirement system all benefits paid from
19 systems administered by Kentucky Retirement Systems or County Employees
20 Retirement System under reciprocity, including medical insurance benefits,
21 that the member received after reemployment began;
- 22 (c) Upon termination, or subsequent to expiration of the six (6) month period
23 from the date of termination, the retired member's retirement allowance based
24 on his or her initial retirement account shall no longer be suspended, and the
25 member shall receive the amount to which he or she is entitled, including an
26 increase as provided by KRS 61.691;
- 27 (d) Except as provided in subsection (7) of this section, if the position in which a

1 retired member is employed after initial retirement is a regular full-time
2 position, the retired member shall contribute to a second member account
3 established for him or her in the retirement system. Service credit gained after
4 the member's date of reemployment shall be credited to the second member
5 account; and

6 (e) Upon termination, the retired member shall be entitled to benefits payable
7 from his or her second retirement account.

8 (14) (a) If the retirement system determines that the retired member has not been
9 reemployed in a position with the same principal duties as the position from
10 which he or she retired, the retired member shall continue to receive his or her
11 retirement allowance.

12 (b) If the position is a regular full-time position, the member shall contribute to a
13 second member account in the retirement system.

14 (15) (a) If a retired member is reemployed at least one (1) month after initial
15 retirement in a different position, or at least six (6) months after initial
16 retirement in the same position, and prior to normal retirement age, the retired
17 member shall contribute to a second member account in the retirement system
18 and continue to receive a retirement allowance from the first member account.

19 (b) Service credit gained after reemployment shall be credited to the second
20 member account. Upon termination, the retired member shall be entitled to
21 benefits payable from the second member account.

22 (16) A retired member who is reemployed and contributing to a second member account
23 shall not be eligible to purchase service credit under any of the provisions of KRS
24 16.505 to 16.652, 61.510 to 61.705, or 78.510 to 78.852 which he or she was
25 eligible to purchase prior to his or her initial retirement.

26 (17) Notwithstanding any provision of subsections (1) to (7)(a) and (10) to (15) of this
27 section, the following shall apply to retired members who are reemployed by an

1 agency participating in one (1) of the systems administered by Kentucky Retirement
2 Systems or County Employees Retirement System on or after September 1, 2008:

3 (a) Except as provided by paragraphs (c) and (d) of this subsection, if a member is
4 receiving a retirement allowance from one (1) of the systems administered by
5 Kentucky Retirement Systems or County Employees Retirement System, or
6 has filed the forms required to receive a retirement allowance from one (1) of
7 the systems administered by Kentucky Retirement Systems or County
8 Employees Retirement System, and is employed in a regular full-time position
9 required to participate in one (1) of the systems administered by Kentucky
10 Retirement Systems or County Employees Retirement System or is employed
11 in a position that is not considered regular full-time with an agency
12 participating in one (1) of the systems administered by Kentucky Retirement

15 be voided, and the member shall repay to the retirement system all benefits
16 received, including any health insurance benefits. If the member is returning
17 to work in a regular full-time position required to participate in one (1) of the
18 systems administered by Kentucky Retirement Systems:

- 19 1. The member shall contribute to a member account established for him or
20 her in one (1) of the systems administered by Kentucky Retirement
21 Systems or County Employees Retirement System, and employer
22 contributions shall be paid on behalf of the member by the participating
23 employer; and
- 24 2. Upon subsequent retirement, the member shall be eligible for a
25 retirement allowance based upon total service and creditable
26 compensation, including any additional service or creditable
27 compensation earned after his or her initial retirement was voided;

1 (b) Except as provided by paragraphs (c) and (d) of this subsection, if a member is
2 receiving a retirement allowance from one (1) of the systems administered by
3 Kentucky Retirement Systems or County Employees Retirement System and
4 is employed in a regular full-time position required to participate in one (1) of
5 the systems administered by Kentucky Retirement Systems or County
6 Employees Retirement System after a three (3) month period following the
7 member's initial retirement date, the member may continue to receive his or
8 her retirement allowance during the period of reemployment subject to the
9 following provisions:

10 1. If a member is reemployed by a participating agency within twelve (12)
11 months of the member's retirement date, the participating agency shall

8 specified by KRS 61.565, 61.702, and 78.635, as applicable, on all
9 creditable compensation earned by the employee during the period of
10 reemployment. The additional contributions paid shall be used to reduce
11 the unfunded actuarial liability of the systems; and
- 12 4. Except as provided by KRS 70.291 to 70.293, 95.022, and 164.952 and
13 except for any retiree employed as a school resource officer as defined
14 by KRS 158.441, the employer shall be required to reimburse the
15 systems for the cost of the health insurance premium paid by the systems
16 to provide coverage for the retiree, not to exceed the cost of the single
17 premium. Effective July 1, 2015, local school boards shall not be

6 any health insurance benefits. If the member is returning to work in a regular
7 full-time position required to participate in one (1) of the systems
8 administered by Kentucky Retirement Systems or County Employees
9 Retirement System:

- 10 1. The member shall contribute to a member account established for him or
11 her in one (1) of the systems administered by Kentucky Retirement
12 Systems or County Employees Retirement System, and employer
13 contributions shall be paid on behalf of the member by the participating
14 employer; and
- 15 2. Upon subsequent retirement, the member shall be eligible for a
16 retirement allowance based upon total service and creditable
17 compensation, including any additional service or creditable
18 compensation earned after his or her initial retirement was voided;

19 (d) If a member is receiving a retirement allowance from the State Police
20 Retirement System or from hazardous duty retirement coverage with the
21 Kentucky Employees Retirement System or the County Employees Retirement
22 System and is employed in a regular full-time position required to participate
23 in the State Police Retirement System or in a hazardous duty position with the
24 Kentucky Employees Retirement System or the County Employees Retirement
25 System after a one (1) month period following the member's initial retirement
26 date, the member may continue to receive his or her retirement allowance
27 during the period of reemployment subject to the following provisions:

- 1 1. If a member is reemployed by a participating agency within twelve (12)

9 and the participating employer shall be subject to paragraphs (a) to (d) of this
10 subsection for the period of volunteer service;

11 (f) Notwithstanding any provision of this section, any mayor or member of a city
12 legislative body shall not be required to resign from his or her position as
13 mayor or as a member of the city legislative body in order to begin drawing
14 benefits from the systems administered by Kentucky Retirement Systems or
15 subject to any provision of this section as it relates solely to his or her service
16 as a mayor or member of the city legislative body if the mayor or member of a
17 city legislative body:

- 18 1. Has not participated in the County Employees Retirement System prior

5 employee of an employer under contract with an employer participating in one
6 (1) of the systems administered by the Kentucky Retirement Systems or
7 County Employees Retirement System:

8 1. At any time following retirement, if the Authority determines the
9 employment arrangement does qualify as an independent contractor or
10 leased employee, the member may continue to receive his or her
11 retirement allowance during the period of the contract;

12 2. Within three (3) months following the member's initial retirement date,
13 if the Authority determines the employment arrangement does not
14 qualify as an independent contractor or leased employee, the member's
15 retirement shall be voided in accordance with paragraph (a) of this
16 subsection;

17 3. After three (3) months but within twelve (12) months following the
18 member's initial retirement, if the Authority determines the employment
19 arrangement does not qualify as an independent contractor or leased
20 employee and that a prearranged agreement existed between the member

2 The initiation of a contract or the initial date of the leased employment of a
3 retired member by a participating agency that occurs after twelve (12) months
4 or more following the retired member's retirement date shall not constitute a
5 prearranged agreement under this subsection; and

6 (h) The Authority shall issue a final determination regarding a certification of the
7 absence of a prearranged agreement or the retired member's qualification as an
8 independent contractor or leased employee as required under this section no
9 later than thirty (30) days after the retired member and participating employer
10 provide all required forms and additional information required by the
11 Authority.

12 (18) The Authority shall promulgate administrative regulations to implement the
13 requirements of this section, including incorporating by reference board-prescribed
14 forms that a retired member and participating agency shall provide the systems
15 under subsections (8), (9), and (17) of this section.

16 ➔Section 12. KRS 61.645 is amended to read as follows:

17 (1) The Kentucky Employees Retirement System and State Police Retirement System
18 shall be administered by the board of trustees of the Kentucky Retirement Systems
19 composed of nine (9) members, who shall be selected as follows:

20 (a) One (1) trustee, who shall be a member or retired from the State Police
21 Retirement System, elected by the members and retired members of the State
22 Police Retirement System;

23 (b) Two (2) trustees, who shall be members or retired from the Kentucky
24 Employees Retirement System, elected by the members and retired members
25 of the Kentucky Employees Retirement System;

26 (c) Six (6) trustees, appointed by the Governor of the Commonwealth, subject to
27 Senate confirmation in accordance with KRS 11.160 for each appointment or

1 reappointment. Of the six (6) trustees appointed by the Governor, three (3)
2 trustees shall have investment experience and three (3) trustees shall have
3 retirement experience;

4 (d) For purposes of paragraph (c) of this subsection, a trustee with "investment
5 experience" means an individual who does not have a conflict of interest, as
6 provided by KRS 61.655, and who has at least ten (10) years of experience in
7 one (1) of the following areas of expertise:

- 8 1. A portfolio manager acting in a fiduciary capacity;
- 9 2. A professional securities analyst or investment consultant;
- 10 3. A current or retired employee or principal of a trust institution,
11 investment or finance organization, or endowment fund acting in an
12 investment-related capacity;
- 13 4. A chartered financial analyst in good standing as determined by the CFA
14 Institute; or
- 15 5. A university professor, teaching investment-related studies; and

16 (e) For purposes of paragraph (c) of this subsection, a trustee with "retirement
17 experience" means an individual who does not have a conflict of interest, as
18 provided by KRS 61.655, and who has at least ten (10) years of experience in
19 one (1) of the following areas of expertise:

- 20 1. Experience in retirement or pension plan management;
- 21 2. A certified public accountant with relevant experience in retirement or

26 with relevant experience in retirement or pension plans; or

3 but not limited to the following powers:

 - 6 (c) To conduct the business and promote the purposes for which it was formed;
 - 7 (d) Except as provided in KRS 61.650(6), to contract for investment counseling,
8 auditing, medical, and other professional or technical services as required to
9 carry out the obligations of the board subject to KRS Chapters 45, 45A, 56,
10 and 57. Actuarial consulting services shall be provided by a firm hired by the
11 Kentucky Public Pensions Authority;
 - 12 (e) To purchase fiduciary liability insurance;

19 her official duties. The hourly rate of reimbursement for any contract for legal
20 services under this paragraph shall not exceed the maximum hourly rate
21 provided in the Legal Services Duties and Maximum Rate Schedule
22 promulgated by the Government Contract Review Committee established
23 pursuant to KRS 45A.705, unless a higher rate is specifically approved by the
24 secretary of the Finance and Administration Cabinet or his or her designee.
- 25 (3) (a) Notwithstanding the provisions of subsection (1) of this section, each trustee
26 shall serve a term of four (4) years or until his or her successor is duly
27 qualified except as otherwise provided in this section. An elected trustee or a

2 not serve more than three (3) consecutive four (4) year terms. An elected

7 receiving a plurality of votes shall be declared elected.

- 16 (h) For purposes of this subsection, an eligible voter shall be a person who was a
17 member of the retirement system on December 31 of the year preceding the
18 election year.
- 19 (i) Each individual who submits a request to be nominated by the board under
20 paragraph (a) of this subsection and each individual who is nominated by the
21 membership under paragraph (b) of this subsection shall:
- 22 1. Complete an application developed by the retirement systems which
23 shall include but not be limited to a disclosure of any prior felonies and
24 any conflicts of interest that would hinder the individual's ability to

15 vacancy occurs; however, any vacancy shall be filled only for the duration of

- 1 (b) A trustee shall be removed from office upon conviction of a felony or for a
2 finding of a violation of any provision of KRS 11A.020 or 11A.040 by a court
3 of competent jurisdiction.
- 4 (c) A current or former employee of Kentucky Retirement Systems, County
5 Employees Retirement System, or the Kentucky Public Pensions Authority
6 shall not be eligible to serve as a member of the board.
- 7 (7) Trustees who do not otherwise receive a salary from the State Treasury shall receive
8 a per diem of eighty dollars (\$80) for each day they are in session or on official
9 duty, and they shall be reimbursed for their actual and necessary expenses in
10 accordance with state administrative regulations and standards.
- 11 (8) (a) The board shall meet at least once in each quarter of the year and may meet in
12 special session upon the call of the chair or the chief executive officer.
- 13 (b) The board shall elect a chair and a vice chair. The chair shall not serve more
14 than four (4) consecutive years as chair or vice-chair of the board. The vice-
15 chair shall not serve more than four (4) consecutive years as chair or vice-

11 notwithstanding the limitations of KRS Chapter 62.

12 (d) The board shall have a system of accounting established by the Kentucky
13 Public Pensions Authority.

14 (e) The board shall do all things, take all actions, and promulgate all
15 administrative regulations, not inconsistent with the provisions of KRS 16.505
16 to 16.652 and 61.510 to 61.705, necessary or proper in order to carry out the
17 provisions of KRS 16.505 to 16.652 and 61.510 to 61.705. Notwithstanding
18 any other evidence of legislative intent, it is hereby declared to be the
19 controlling legislative intent that the provisions of KRS 16.505 to 16.652 and
20 61.510 to 61.705 conform with federal statute or regulation and meet the
21 qualification requirements under 26 U.S.C. sec. 401(a), applicable federal
22 regulations, and other published guidance. Provisions of KRS 16.505 to
23 16.652 and 61.510 to 61.705 which conflict with federal statute or regulation
24 or qualification under 26 U.S.C. sec. 401(a), applicable federal regulations,
25 and other published guidance shall not be available. The board shall have the
26 authority to promulgate administrative regulations to conform with federal
27 statute and regulation and to meet the qualification requirements under 26

1 U.S.C. sec. 401(a), including an administrative regulation to comply with 26
2 U.S.C. sec. 401(a)(9).

3 (f) Notwithstanding any other provision of statute to the contrary, including but
4 not limited to any provision of KRS Chapter 12, the Governor shall have no
5 authority to change any provision of KRS 16.505 to 16.652 and 61.510 to
6 61.705 by executive order or action, including but not limited to reorganizing,
7 replacing, amending, or abolishing the membership of the Kentucky
8 Retirement Systems board of trustees.

9 (10) Notwithstanding any statute to the contrary, employees shall not be considered
10 legislative agents under KRS 6.611.

11 (11) The Attorney General, or an assistant designated by him or her, may attend each
12 meeting of the board and may receive the agenda, board minutes, and other
13 information distributed to trustees of the board upon request. The Attorney General
14 may act as legal adviser and attorney for the board, and the board may contract for

19 accordance with generally accepted auditing standards. Except as provided by
20 paragraph (b) of this subsection, the board may select **the**~~[an]~~ independent

- 6 2. A member may not elect coverage for hospital and medical benefits
7 through more than one (1) of the state-administered retirement systems;

- 9 3. A state-administered retirement system shall not pay any portion of a
10 member's monthly contribution for medical insurance unless the member
11 is a recipient or annuitant of the plan.
- 12 (5) Premiums paid for hospital and medical insurance coverage procured under
13 authority of this section shall be exempt from any premium tax which might
14 otherwise be required under KRS Chapter 136. The payment of premiums by the
15 funds described by subsection (4)(a)2. of this section shall not constitute taxable
16 income to an insured recipient. No commission shall be paid for hospital and
17 medical insurance procured under authority of this section.
- 18 (6) The board shall promulgate an administrative regulation to establish a medical
19 insurance reimbursement plan to provide reimbursement for hospital and medical
20 insurance plan premiums of recipients of a retirement allowance who are not
21 eligible for the same level of hospital and medical benefits as recipients living in
22 Kentucky and having the same Medicare hospital and medical insurance eligibility
23 status. An eligible recipient shall file proof of payment for hospital and medical
24 insurance plan coverage with the retirement office. Reimbursement to eligible
25 recipients shall be made on a quarterly basis. The recipient shall be eligible for
26 reimbursement of substantiated medical insurance premiums for an amount not to
27 exceed the total monthly contribution rate determined under subsection (4) of this

1 section. The plan shall not be made available if all recipients are eligible for the
2 same coverage as recipients living in Kentucky.

4 (1) Upon the death of a member, retiree, or recipient who has an existing account or
5 other benefit in a retirement system administered by the Kentucky Retirement
6 Systems that totals no more than one thousand dollars (\$1,000), the surviving
7 spouse, or if none, a surviving child, or if none, a surviving parent, or if none, a
8 surviving brother or sister, may without formal administration of the estate collect

19 engaged as independent contractors, seasonal, emergency, temporary, and part-time

20 average monthly rate divided by the number of months of service credit during
21 that five (5) year period multiplied by twelve (12). The five (5) years may be

 11 member's incapacity to engage in any occupation for remuneration or
 12 profit. Loss by severance of both hands at or above the wrists, or both

4 disability or a hazardous disability and is a direct result of an act in line of

- 4 (1) Once each year following the retirement of a person on a disability retirement
5 allowance, **except for persons who become totally and permanently disabled as a**
6 **direct result of an act in line of duty as defined in Section 18 of this Act or**
7 **become disabled as a result of a duty-related injury as defined in KRS 61.621 in**
8 **which case shall be once every three (3) years following retirement,** or less

12 allowances, from workers' compensation, to arrive at a projected combined monthly
13 benefit.

14 (2) If the projected combined monthly benefit exceeds one hundred percent (100%) of
15 the disabled employee's final rate of pay or his or her final compensation, whichever
16 is greater, his or her disability retirement allowance from the County Employees
17 Retirement System and the Kentucky Retirement Systems shall be reduced to an
18 amount which would cause his or her projected combined monthly benefit to equal

25 **injury as defined in KRS 61.621 shall annually file, on a form or via an**
26 **electronic method established by the Authority, information on whether payments**

4 recipient who elects coverage becomes eligible for Medicare, he or she
5 shall participate in the plans offered by the systems for Medicare eligible

7 be required to obtain and pay for Medicare Part A and Part B coverage
8 in order to participate in the Medicare eligible plans offered by the

 19 except for any retiree employed as a school resource officer as defined
 20 by KRS 158.441, the employer shall pay employer contributions as
 21 specified by KRS 78.5536 and 78.635 on all creditable compensation
 22 earned by the employee during the period of reemployment. The
 23 additional contributions paid shall be used to reduce the unfunded
 24 actuarial liability of the system; and
 - 25 4. Except as provided by KRS 70.291 to 70.293, 95.022, and 164.952 and
 26 except for any retiree employed as a school resource officer as defined
 27 by KRS 158.441, the employer shall be required to reimburse the system

1 for the cost of the health insurance premium paid by the system to
2 provide coverage for the retiree, not to exceed the cost of the single
3 premium;

4 (e) Notwithstanding paragraphs (a) to (d) of this subsection, a retired member
5 who qualifies as a volunteer for an employer participating in the County
6 Employees Retirement System or the Kentucky Retirement Systems and who
7 is receiving reimbursement of actual expenses, a nominal fee for his or her
8 volunteer services, or both, shall not be considered an employee of the
9 participating employer and shall not be subject to paragraphs (a) to (d) of this
10 subsection if:

- 11 1. Prior to the retired member's most recent retirement date, he or she did
12 not receive creditable compensation from the participating employer in
13 which the retired member is performing volunteer services;
- 14 2. Any reimbursement or nominal fee received prior to the retired
15 member's most recent retirement date has not been credited as creditable
16 compensation to the member's account or utilized in the calculation of
17 the retired member's benefits;
- 18 3. The retired member has not purchased or received service credit under
19 any of the provisions of KRS 78.510 to 78.852 for service with the
20 participating employer for which the retired member is performing
21 volunteer services; and
- 22 4. Other than the status of volunteer, the retired member does not become
23 an employee, leased employee, or independent contractor of the
24 employer for which he or she is performing volunteer services for a
25 period of at least twelve (12) months following the retired member's
26 most recent retirement date.

27 If a retired member, who provided volunteer services with a participating

1 employer under this paragraph violates any provision of this paragraph, then
2 he or she shall be deemed an employee of the participating employer as of the
3 date he or she began providing volunteer services and both the retired member
4 and the participating employer shall be subject to paragraphs (a) to (d) of this
5 subsection for the period of volunteer service;

6 (f) Notwithstanding any provision of this section, any mayor or member of a city
7 legislative body shall not be required to resign from his or her position as
8 mayor or as a member of the city legislative body in order to begin drawing
9 benefits from the systems administered by the Kentucky Retirement Systems
10 or the County Employees Retirement System or subject to any provision of
11 this section as it relates solely to his or her service as a mayor or member of
12 the city legislative body, if the mayor or member of a city legislative body:

13 1. Has not participated in the County Employees Retirement System prior
14 to retirement, but is otherwise eligible to retire from the Kentucky
15 Employees Retirement System or the State Police Retirement System; or
16 2. Has been or is participating in the County Employees Retirement System
17 and is at least sixty-two (62) years of age. If a mayor or member of a city
18 legislative body who is at least sixty-two (62) years of age retires from
19 the systems administered by Kentucky Retirement Systems or the
20 County Employees Retirement System but remains in office after his or
21 her effective retirement date, the mayor or member of the city legislative
22 body shall not accrue any further service credit or benefits in the systems
23 administered by Kentucky Retirement Systems or the County Employees
24 Retirement System for any employment occurring on or after the
25 effective retirement date;

26 (g) If a member is receiving a retirement allowance from the County Employees
27 Retirement System and enters into a contract or becomes a leased employee of

- 1 an employer under contract with an employer participating in the County
2 Employees Retirement System or the Kentucky Retirement Systems:
- 3 1. At any time following retirement, if the Authority determines the
4 employment arrangement does qualify as an independent contractor or
5 leased employee, the member may continue to receive his or her
6 retirement allowance during the period of the contract;
 - 7 2. Within three (3) months following the member's initial retirement date,
8 if the Authority determines the employment arrangement does not
9 qualify as an independent contractor or leased employee, the member's
10 retirement shall be voided in accordance with paragraph (a) of this
11 subsection;
 - 12 3. After three (3) months but within twelve (12) months following the
13 member's initial retirement, if the Authority determines the employment
14 arrangement does not qualify as an independent contractor or leased
15 employee and that a prearranged agreement existed between the member
16 and the agency for the member to return to work with the agency, the
17 member's retirement shall be voided in accordance with paragraph (a) of
18 this subsection; and
 - 19 4. After a twelve (12) month period following the member's initial
20 retirement, the member may continue to receive his or her retirement
21 allowance during the period of the contract and the member shall not be
22 required to notify the Authority or submit any documentation for
23 purposes of this section to the Authority. The initiation of a contract or
24 the initial date of the leased employment of a retired member by a
25 participating agency that occurs after twelve (12) months or more
26 following the retired member's retirement date shall not constitute a
27 prearranged agreement under this subsection;

- 1 (h) The Authority shall issue a final determination regarding a certification of the
2 absence of a prearranged agreement or the retired member's qualification as an
3 independent contractor or leased employee as required under this section no
4 later than thirty (30) days after the retired member and participating employer
5 provide all required forms and additional information required by the
6 Authority; and
- 7 (i) Retired members of one (1) of the systems administered by Kentucky
8 Retirement Systems who are reemployed by an employer in the County
9 Employees Retirement System on or after September 1, 2008, shall not be
10 eligible to earn a second retirement account in the County Employees
11 Retirement System for his or her service to the employer.
- 12 (5) The Authority shall promulgate administrative regulations to implement the
13 requirements of this section, including incorporating by reference Authority-
14 prescribed forms that a retired member and participating agency shall provide the
15 systems under subsections (1) and (4) of this section.
- 16 (6) "Reemployment" or "reinstatement" as used in this section shall not include a
17 retired member who has been ordered reinstated by the Personnel Board under
18 authority of KRS 18A.095. A retired member who has been ordered reinstated by
19 the Personnel Board under authority of KRS 18A.095 or by court order or by order
20 of the Human Rights Commission and accepts employment by an agency
21 participating in the Kentucky Employees Retirement System or County Employees
22 Retirement System shall void his or her retirement by reimbursing the system in the
23 full amount of his or her retirement allowance payments received.
- 24 ➔Section 25. KRS 78.782 is amended to read as follows:
- 25 (1) The County Employees Retirement System shall be administered by the board of
26 trustees composed of nine (9) members, who shall be selected as follows:
- 27 (a) Three (3) trustees, who shall be members or retired from the County

1 Employees Retirement System, elected by the members and retired members
2 of the County Employees Retirement System, of which:

- 3 1. Two (2) shall have a majority of his or her service credit earned in the
4 County Employees Retirement System in a nonhazardous position; and
- 5 2. One (1) shall have a majority of his or her service credit earned in the
6 County Employees Retirement System in a hazardous position;

7 (b) Six (6) trustees appointed by the Governor, subject to Senate confirmation in

- 10 1. One (1) trustee with retirement experience shall be appointed from a list
11 of three (3) applicants submitted by the Kentucky League of Cities;

- 14 3. One (1) trustee with retirement experience shall be appointed from a list
15 of three (3) applicants submitted by the Kentucky Association of

- 17 4. One (1) trustee with investment experience shall be appointed from a list
18 of three (3) applicants submitted by the Kentucky Association of
19 Counties;
- 20 5. One (1) trustee with retirement experience shall be appointed from a list
21 of three (3) applicants submitted by the Kentucky School Boards
22 Association; and
- 23 6. One (1) trustee with investment experience shall be appointed from a list
24 of three (3) applicants submitted by the Kentucky School Boards
25 Association.

26 Notwithstanding the provisions of KRS 12.070(3), the Governor shall appoint
27 each individual trustee described by subparagraphs 1. to 6. of this paragraph

1 solely from each corresponding individual list required to be submitted by the
2 Kentucky League of Cities, the Kentucky Association of Counties, or the
3 Kentucky School Boards Association as provided by subparagraphs 1. to 6. of

8 (c) For purposes of paragraph (b) of this subsection, a trustee with "investment
9 experience" means an individual who does not have a conflict of interest, as
10 provided by KRS 61.655, and who has at least ten (10) years of experience in
11 one (1) of the following areas of expertise:

- 12 1. A portfolio manager acting in a fiduciary capacity;
- 13 2. A professional securities analyst or investment consultant;
- 14 3. A current or retired employee or principal of a trust institution,
15 investment or finance organization, or endowment fund acting in an
16 investment-related capacity;
- 17 4. A chartered financial analyst in good standing as determined by the CFA
18 Institute; or
- 19 5. A university professor, teaching investment-related studies; and

20 (d) For purposes of paragraph (b) of this subsection, a trustee with "retirement
21 experience" means an individual who does not have a conflict of interest, as
22 provided by KRS 61.655, and who has at least ten (10) years of experience in
23 one (1) of the following areas of expertise:

- 24 1. Experience in retirement or pension plan management;
- 25 2. A certified public accountant with relevant experience in retirement or
26 pension plan accounting;
- 27 3. An actuary with relevant experience in retirement or pension plan

- 1 consulting;
- 2 4. An attorney licensed to practice law in the Commonwealth of Kentucky
- 3 with relevant experience in retirement or pension plans; or
- 4 5. A current or former university professor whose primary area of emphasis
- 5 is economics or finance.
- 6 (2) The board is hereby granted the powers and privileges of a corporation, including
- 7 but not limited to the following powers:
- 8 (a) To sue and be sued in its corporate name;
- 9 (b) To make bylaws not inconsistent with the law;
- 10 (c) To conduct the business and promote the purposes for which it was formed;
- 11 (d) Except as provided in KRS 78.790(6), to contract for investment counseling,
- 12 auditing, medical, and other professional or technical services as required to
- 13 carry out the obligations of the board subject to the provisions of KRS
- 14 Chapters 45, 45A, 56, and 57. Actuarial consulting services shall be provided
- 15 by a firm hired by the Kentucky Public Pensions Authority;
- 16 (e) To purchase fiduciary liability insurance;
- 17 (f) Except as provided in KRS 78.790(6), to acquire, hold, sell, dispose of,
- 18 pledge, lease, or mortgage, the goods or property necessary to exercise the
- 19 board's powers and perform the board's duties subject to KRS Chapters 45,
- 20 45A, and 56; and
- 21 (g) The board shall reimburse any trustee, officer, or employee for any legal
- 22 expense resulting from a civil action arising out of the performance of his or
- 23 her official duties. The hourly rate of reimbursement for any contract for legal
- 24 services under this paragraph shall not exceed the maximum hourly rate
- 25 provided in the Legal Services Duties and Maximum Rate Schedule
- 26 promulgated by the Government Contract Review Committee established
- 27 pursuant to KRS 45A.705, unless a higher rate is specifically approved by the

1 secretary of the Finance and Administration Cabinet or his or her designee.

2 (3) Notwithstanding the provisions of subsection (1) of this section, each trustee shall
3 serve a term of four (4) years or until his or her successor is duly qualified except as
4 otherwise provided in this section. An elected or appointed trustee shall not serve
5 more than three (3) consecutive four (4) year terms. An elected or appointed trustee
6 who has served three (3) consecutive terms may be elected or appointed again after
7 an absence of four (4) years from the board.

8 (4) (a) The trustees selected by the membership of the system shall be elected by
9 ballot. For each trustee to be elected, the board may nominate, not less than
10 six (6) months before a term of office of a trustee is due to expire, three (3)
11 constitutionally eligible individuals.

12 (b) Individuals may be nominated by the system members by presenting to the
13 executive director, not less than four (4) months before a term of office of a
14 trustee is due to expire, a petition, bearing the name, last four (4) digits of the
15 Social Security number, and signature of no less than one-tenth (1/10) of the
16 number voting in the last election by the system members.

17 (c) Within four (4) months of the nominations made in accordance with
18 paragraphs (a) and (b) of this subsection, the executive director shall cause to
19 be prepared an official ballot. The ballot shall carry the name, address, and
20 position title of each individual nominated by the board and by petition.
21 Provision shall also be made for write-in votes.

22 (d) Except as provided by paragraph (j) of this subsection, the ballots shall be
23 distributed to the eligible voters by mail to their last known residence address
24 **on file with the Kentucky Public Pensions Authority. Ballots shall not be**
25 **distributed by mail to member addresses reported as invalid to the Kentucky**
26 **Public Pensions Authority.**

27 (e) The ballots shall be addressed to the County Employees Retirement System in

1 care of a predetermined box number at a United States Post Office or
2 submitted electronically as provided by paragraph (j) of this subsection.
3 Access to this post office box shall be limited to the board's contracted firm.
4 The individual receiving a plurality of votes shall be declared elected.

5 (f) The eligible voter shall cast his or her ballot by selecting the candidate of his
6 or her choice. He or she shall sign and mail the ballot or submit the electronic
7 ballot at least thirty (30) days prior to the date the term to be filled is due to
8 expire. The latest mailing date, or date of submission in the case of electronic
9 ballots, shall be provided on the ballot.

10 (g) The board's contracted firm shall report in writing the outcome to the chair of
11 the board of trustees. Costs of an election shall be payable from the funds of
12 the system.

13 (h) For purposes of this subsection, an eligible voter shall be a person who was a
14 member of the system on December 31 of the year preceding the election year.

15 (i) Each individual who submits a request to be nominated by the board under
16 paragraph (a) of this subsection and each individual who is nominated by the
17 membership under paragraph (b) of this subsection shall:

18 1. Complete an application developed by the system which shall include
19 but not be limited to a disclosure of any prior felonies and any conflicts
20 of interest that would hinder the individual's ability to serve on the
21 board;

22 2. Submit a resume detailing the individual's education and employment
23 history and a cover letter detailing the member's qualifications for
24 serving as trustee to the board; and

25 3. Authorize the system to have a criminal background check performed.
26 The criminal background check shall be performed by the Department of
27 Kentucky State Police.

- 1 (j) In lieu of the ballots mailed to members and retired members as provided by
2 this subsection, the systems may by promulgation of administrative regulation
3 pursuant to KRS Chapter 13A conduct trustee elections using electronic
4 ballots, except that the systems shall mail a paper ballot upon request of any
5 eligible voter.
- 6 (5) (a) Any vacancy which may occur in an appointed position during a term of office
7 shall be filled in the same manner which provides for the selection of the
8 particular trustee, and any vacancy which may occur in an elected position
9 during a term of office shall be filled by appointment by a majority vote of the
10 remaining elected trustees; however, any vacancy shall be filled only for the
11 duration of the unexpired term. In the event of a vacancy of an elected trustee
12 during a term of office, the system shall notify members of the vacancy and
13 the opportunity to be considered for the vacant position. Any vacancy shall be
14 filled within ninety (90) days of the position becoming vacant.
- 15 (b) Any appointments or reappointments to an appointed position on the board
16 shall be made at least thirty (30) days prior to an appointed member's term of
17 office ending. The Governor's Office shall, with each appointment or
18 reappointment, request lists to be submitted and base selections on those lists
19 solely under the procedures and requirements provided by subsection (1)(b) of
20 this section.
- 21 (6) (a) Membership on the board of trustees shall not be incompatible with any other
22 office unless a constitutional incompatibility exists. No trustee shall serve in
23 more than one (1) position as trustee on the board and, if a trustee holds more
24 than one (1) position as trustee on the board, he or she shall resign a position.
- 25 (b) A trustee shall be removed from office upon conviction of a felony or for a
26 finding of a violation of any provision of KRS 11A.020 or 11A.040 by a court
27 of competent jurisdiction.

- 1 (c) A current or former employee of the County Employees Retirement System,
2 Kentucky Retirement Systems, or the Kentucky Public Pensions Authority
3 shall not be eligible to serve as a member of the board.
- 4 (7) Trustees who do not otherwise receive a salary from the State Treasury shall receive
5 a per diem of eighty dollars (\$80) for each day they are in session or on official
6 duty, and they shall be reimbursed for their actual and necessary expenses in
7 accordance with state administrative regulations and standards.
- 8 (8) (a) The board shall meet at least once in each quarter of the year and may meet in
9 special session upon the call of the chair or the chief executive officer.
- 10 (b) The board shall elect a chair and a vice chair. The chair shall not serve more
11 than four (4) consecutive years as chair or vice chair of the board. The vice
12 chair shall not serve more than four (4) consecutive years as chair or vice chair
13 of the board. A trustee who has served four (4) consecutive years as chair or
14 vice chair of the board may be elected chair or vice chair of the board after an
15 absence of two (2) years from the positions.
- 16 (c) A majority of the trustees shall constitute a quorum, and all actions taken by
17 the board shall be by affirmative vote of a majority of the trustees present.
- 18 (9) (a) The board of trustees shall appoint or contract for the services of a chief
19 executive officer and general counsel and fix the compensation and other
20 terms of employment for these positions without limitation of the provisions
21 of KRS Chapters 18A and 45A and KRS 64.640. The chief executive officer
22 shall serve as the legislative and executive adviser to the board. The general
23 counsel shall serve as legal adviser to the board. The chief executive officer
24 and general counsel shall work with the executive director of the Kentucky

- 1 (b) The board shall require the chief executive officer and may require the general

- 4 (c) The board shall have a system of accounting established by the Kentucky
5 Public Pensions Authority.
- 6 (d) The board shall do all things, take all actions, and promulgate all
7 administrative regulations, not inconsistent with the provisions of KRS 78.510
8 to 78.852, necessary or proper in order to carry out the provisions of KRS
9 78.510 to 78.852. Notwithstanding any other evidence of legislative intent, it
10 is hereby declared to be the controlling legislative intent that the provisions of
11 KRS 78.510 to 78.852 conform with federal statute or regulation and meet the
12 qualification requirements under 26 U.S.C. sec. 401(a), applicable federal
13 regulations, and other published guidance. Provisions of KRS 78.510 to
14 78.852 which conflict with federal statute or regulation or qualification under
15 26 U.S.C. sec. 401(a), applicable federal regulations, and other published
16 guidance shall not be available. The board shall have the authority to
17 promulgate administrative regulations to conform with federal statute and
18 regulation and to meet the qualification requirements under 26 U.S.C. sec.
19 401(a), including an administrative regulation to comply with 26 U.S.C. sec.
20 401(a)(9).
- 21 (e) Notwithstanding any other provision of statute to the contrary, including but
22 not limited to any provision of KRS Chapter 12, the Governor shall have no
23 authority to change any provision of KRS 78.510 to 78.852 by executive order
24 or action, including but not limited to reorganizing, replacing, amending, or
25 abolishing the membership of the County Employees Retirement System
26 board of trustees.
- 27 (10) The chief executive officer and general counsel of the board shall serve during its

1 will and pleasure. Notwithstanding any statute to the contrary, the chief executive
2 officer shall not be considered a legislative agent under KRS 6.611.

3 (11) The Attorney General, or an assistant designated by him or her, may attend each
4 meeting of the board and may receive the agenda, board minutes, and other
5 information distributed to trustees of the board upon request. The Attorney General
6 may act as legal adviser and attorney for the board, and the board may contract for
7 legal services, notwithstanding the limitations of KRS Chapter 12 or 13B.

8 (12) (a) The **Kentucky Public Pensions Authority**~~[system]~~ shall publish an annual
9 financial report showing all receipts, disbursements, assets, and liabilities **for**
10 **the systems**. The annual report shall include a copy of an audit conducted in
11 accordance with generally accepted auditing standards. Except as provided by
12 paragraph (b) of this subsection, the board may select **the**~~[an]~~ independent
13 certified public accountant **hired by the Kentucky Public Pensions Authority**
14 or the Auditor of Public Accounts to perform the audit. If the audit is
15 performed by an independent certified public accountant, the Auditor of
16 Public Accounts shall not be required to perform an audit pursuant to KRS
17 43.050(2)(a), but may perform an audit at his or her discretion. All
18 proceedings and records of the board shall be open for inspection by the
19 public. The **Kentucky Public Pensions Authority**~~[system]~~ shall make copies
20 of the audit required by this subsection available for examination by any
21 member, retiree, or beneficiary in the offices of the County Employees
22 Retirement System and in other places as necessary to make the audit
23 available to all members, retirees, and beneficiaries. A copy of the annual
24 audit shall be sent electronically to the Legislative Research Commission no
25 later than ten (10) days after receipt by the board.

26 (b) At least once every five (5) years, the Auditor of Public Accounts shall
27 perform the audit described by this subsection, and the system shall reimburse

1 the Auditor of Public Accounts for all costs of the audit. The Auditor of
2 Public Accounts shall determine which fiscal year during the five (5) year
3 period the audit prescribed by this paragraph will be completed.

4 (13) All expenses incurred by or on behalf of the system and the board in the
5 administration of the system during a fiscal year shall be paid from the retirement
6 allowance account, including any administrative expenses for the Kentucky Public
7 Pensions Authority that are assigned to the County Employees Retirement System
8 by KRS 61.505. The board shall submit any administrative expenses that are
9 specific to the County Employees Retirement System that are not otherwise covered
10 by KRS 61.505(11)(a).

11 (14) Except as provided under subsection (16) of this section or KRS 61.665, any person
12 adversely affected by a decision of the board involving KRS 78.510 to 78.852 may
13 appeal the decision of the board to the Franklin Circuit Court within sixty (60) days
14 of the board action.

15 (15) (a) A trustee shall discharge his or her duties as a trustee, including his or her
16 duties as a member of a committee:

- 17 1. In good faith;
- 18 2. On an informed basis; and
- 19 3. In a manner he or she honestly believes to be in the best interest of the
20 County Employees Retirement System.

21 (b) A trustee discharges his or her duties on an informed basis if, when he or she
22 makes an inquiry into the business and affairs of the system or into a
23 particular action to be taken or decision to be made, he or she exercises the
24 care an ordinary prudent person in a like position would exercise under similar
25 circumstances.

26 (c) In discharging his or her duties, a trustee may rely on information, opinions,
27 reports, or statements, including financial statements and other financial data,

1 if prepared or presented by:

- 2 1. One (1) or more officers or employees of the system or Authority whom
3 the trustee honestly believes to be reliable and competent in the matters
4 presented;
- 5 2. Legal counsel, public accountants, actuaries, or other persons as to
6 matters the trustee honestly believes are within the person's professional
7 or expert competence; or
- 8 3. A committee of the board of trustees of which he or she is not a member
9 if the trustee honestly believes the committee merits confidence.

10 (d) A trustee shall not be considered as acting in good faith if he or she has
11 knowledge concerning the matter in question that makes reliance otherwise
12 permitted by paragraph (c) of this subsection unwarranted.

13 (e) Any action taken as a trustee, or any failure to take any action as a trustee,
14 shall not be the basis for monetary damages or injunctive relief unless:

- 15 1. The trustee has breached or failed to perform the duties of the trustee's
16 office in compliance with this section; and
- 17 2. In the case of an action for monetary damages, the breach or failure to
18 perform constitutes willful misconduct or wanton or reckless disregard
19 for human rights, safety, or property.

20 (f) A person bringing an action for monetary damages under this section shall
21 have the burden of proving by clear and convincing evidence the provisions of
22 paragraph (e)1. and 2. of this subsection, and the burden of proving that the
23 breach or failure to perform was the legal cause of damages suffered by the
24 system.

25 (g) In discharging his or her administrative duties under this section, a trustee
26 shall strive to administer the system in an efficient and cost-effective manner
27 for the taxpayers of the Commonwealth of Kentucky and shall take all actions

1 available under the law to contain costs for the trusts, including costs for
2 participating employers, members, and retirees.

3 (16) When an order by the system substantially impairs the benefits or rights of a
4 member, retired member, or recipient, except action which relates to entitlement to
5 disability benefits, **or when an employer disagrees with an order of the system as**
6 **provided by KRS 61.598**, the affected member, retired member, ~~or~~ recipient, **or**
7 **employer** may request a hearing to be held in accordance with KRS Chapter 13B.
8 The board may establish an appeals committee whose members shall be appointed
9 by the chair and who shall have authority to act upon the recommendations and
10 reports of the hearing officer on behalf of the board. The member, retired member,
11 recipient, or employer aggrieved by a final order of the board following the hearing
12 may appeal the decision to the Franklin Circuit Court, in accordance with KRS
13 Chapter 13B. The board may establish a joint administrative appeals committee
14 with the Kentucky Retirement Systems and may also establish a joint disability
15 appeals committee with the Kentucky Retirement Systems.

16 (17) The board shall establish a formal trustee education program for all trustees of the
17 board. The program shall include but not be limited to the following:

18 (a) A required orientation program for all new trustees elected or appointed to the
19 board. The orientation program shall include training on:

- 20 1. Benefits and benefits administration;
- 21 2. Investment concepts, policies, and current composition and
22 administration of system investments;
- 23 3. Laws, bylaws, and administrative regulations pertaining to the system
24 and to fiduciaries; and
- 25 4. Actuarial and financial concepts pertaining to the system.

26 If a trustee fails to complete the orientation program within one (1) year from
27 the beginning of his or her first term on the board, the system shall withhold

1 payment of the per diem and travel expenses due to the board member under
2 this section until the trustee has completed the orientation program;

3 (b) Annual required training for board members on the administration, benefits,
4 financing, and investing of the system. If a trustee fails to complete the annual
5 required training during the calendar or fiscal year, the retirement system shall
6 withhold payment of the per diem and travel expenses due to the board
7 member under this section until the board member has met the annual training
8 requirements; and

9 (c) The system shall incorporate by reference in an administrative regulation,
10 pursuant to KRS 13A.2251, the trustee education program.

11 (18) In order to improve public transparency regarding the administration of the system,
12 the board of trustees shall adopt a best practices model by posting the following
13 information to the Kentucky Public Pensions Authority's Web site and shall make
14 available to the public:

15 (a) Meeting notices and agendas for all meetings of the board. Notices and
16 agendas shall be posted to the Kentucky Public Pensions Authority's Web site
17 at least seventy-two (72) hours in advance of the board or committee
18 meetings, except in the case of special or emergency meetings as provided by
19 KRS 61.823;

20 (b) The Comprehensive Annual Financial Report with the information as follows:
21 1. A general overview and update on the system by the executive director;
22 2. A listing of the board of trustees;
23 3. A listing of key staff;
24 4. An organizational chart;
25 5. Financial information, including a statement of plan net assets, a
26 statement of changes in plan net assets, an actuarial value of assets, a
27 schedule of investments, a statement of funded status and funding

- 1 progress, and other supporting data;
- 2 6. Investment information, including a general overview, a list of the
3 system's professional consultants, a total net of fees return on system
4 investments over a historical period, an investment summary, contracted
5 investment management expenses, transaction commissions, and a
6 schedule of investments;
- 7 7. The annual actuarial valuation report on the pension benefit and the
8 medical insurance benefit; and
- 9 8. A general statistical section, including information on contributions,
10 benefit payouts, and retirement system demographic data;
- 11 (c) All external audits;
- 12 (d) All board minutes or other materials that require adoption or ratification by
13 the board of trustees. The items listed in this paragraph shall be posted within
14 seventy-two (72) hours of adoption or ratification of the board;
- 15 (e) All bylaws, policies, or procedures adopted or ratified by the board of trustees;
- 16 (f) The system's summary plan description;
- 17 (g) A document containing an unofficial copy of the statutes governing the
18 system;
- 19 (h) A listing of the members of the board of trustees and membership on each
20 committee established by the board, including any investment committees;
- 21 (i) All investment holdings in aggregate, fees, and commissions for each fund
22 administered by the board, which shall be updated on a quarterly basis for
23 fiscal years beginning on or after July 1, 2021. The system shall request from
24 all managers, partnerships, and any other available sources all information
25 regarding fees and commissions and shall, based on the requested information
26 received:
- 27 1. Disclose the dollar value of fees and commissions paid to each

- 1 individual manager or partnership;
- 2 2. Disclose the dollar value of any profit sharing, carried interest, or any
- 3 other partnership incentive arrangements, partnership agreements, or any
- 4 other partnership expenses received by or paid to each manager or
- 5 partnership; and
- 6 3. As applicable, report each fee or commission by manager or partnership
- 7 consistent with standards established by the Institutional Limited
- 8 Partners Association (ILPA).

9 In addition to the requirements of this paragraph, the system shall also

10 disclose the name and address of all individual underlying managers or

11 partners in any fund of funds in which system assets are invested;

12 (j) An update of net of fees investment returns, asset allocations, and the

13 performance of the funds against benchmarks adopted by the board for each

14 fund, for each asset class administered by the board, and for each manager.

15 The update shall be posted on a quarterly basis for fiscal years beginning on or

16 after July 1, 2021;

17 (k) A searchable database of the system's expenditures and a listing of each

18 individual employed by the system along with the employee's salary or wages.

19 In lieu of posting the information required by this paragraph to the Kentucky

20 Public Pensions Authority's Web site, the system may provide the information

21 through a Web site established by the executive branch to inform the public

22 about public employee salaries and wages;

23 (l) All contracts or offering documents for services, goods, or property purchased

24 or utilized by the system for contracts or offering documents entered into on

25 or after July 1, 2021; and

26 (m) Information regarding the system's financial and actuarial condition that is

27 easily understood by the members, retired members, and the public.

1 (19) Notwithstanding the requirements of subsection (18) of this section, the system
2 shall not be required to furnish information that is protected under KRS 61.661,
3 exempt under KRS 61.878, or that, if disclosed, would compromise the system's
4 ability to competitively invest in real estate or other asset classes, except that no
5 provision of this section or KRS 61.878 shall exclude disclosure and review of all
6 contracts, including investment contracts, by the board, the Auditor of Public
7 Accounts, and the Government Contract Review Committee established pursuant to
8 KRS 45A.705 or the disclosure of investment fees and commissions as provided by
9 this section. If any public record contains material which is not excepted under this
10 section, the system shall separate the excepted material by removal, segregation, or
11 redaction, and make the nonexcepted material available for examination.

12 (20) Notwithstanding any other provision of KRS 78.510 to 78.852 to the contrary, no
13 funds of the County Employees Retirement System, including fees and
14 commissions paid to an investment manager, private fund, or company issuing
15 securities, who manages systems assets, shall be used to pay fees and commissions
16 to placement agents. For purposes of this subsection, "placement agent" means a
17 third-party individual, who is not an employee, or firm, wholly or partially owned
18 by the entity being hired, who solicits investments on behalf of an investment
19 manager, private fund, or company issuing securities.

20 ➔Section 26. KRS 18A.225 is amended to read as follows:

21 (1) (a) The term "employee" for purposes of this section means:

22 1. Any person, including an elected public official, who is regularly
23 employed by any department, office, board, agency, or branch of state
24 government; or by a public postsecondary educational institution; or by
25 any city, urban-county, charter county, county, or consolidated local
26 government, whose legislative body has opted to participate in the state-
27 sponsored health insurance program pursuant to KRS 79.080; and who

- 1 is either a contributing member to any one (1) of the retirement systems
2 administered by the state, including but not limited to the Kentucky
3 Retirement Systems, County Employees Retirement System, Kentucky
4 Teachers' Retirement System, the Legislators' Retirement Plan, or the
5 Judicial Retirement Plan; or is receiving a contractual contribution from
6 the state toward a retirement plan; or, in the case of a public
7 postsecondary education institution, is an individual participating in an
8 optional retirement plan authorized by KRS 161.567; or is eligible to

3 (b) The term "health benefit plan" for the purposes of this section means a health
4 benefit plan as defined in KRS 304.17A-005;

5 (c) The term "insurer" for the purposes of this section means an insurer as defined
6 in KRS 304.17A-005; and

7 (d) The term "managed care plan" for the purposes of this section means a
8 managed care plan as defined in KRS 304.17A-500.

9 (2) (a) The secretary of the Finance and Administration Cabinet, upon the
10 recommendation of the secretary of the Personnel Cabinet, shall procure, in
11 compliance with the provisions of KRS 45A.080, 45A.085, and 45A.090,
12 from one (1) or more insurers authorized to do business in this state, a group
13 health benefit plan that may include but not be limited to health maintenance
14 organization (HMO), preferred provider organization (PPO), point of service
15 (POS), and exclusive provider organization (EPO) benefit plans encompassing
16 all or any class or classes of employees. With the exception of employers
17 governed by the provisions of KRS Chapters 16, 18A, and 151B, all
18 employers of any class of employees or former employees shall enter into a
19 contract with the Personnel Cabinet prior to including that group in the state
20 health insurance group. The contracts shall include but not be limited to
21 designating the entity responsible for filing any federal forms, adoption of
22 policies required for proper plan administration, acceptance of the contractual
23 provisions with health insurance carriers or third-party administrators, and
24 adoption of the payment and reimbursement methods necessary for efficient
25 administration of the health insurance program. Health insurance coverage
26 provided to state employees under this section shall, at a minimum, contain
27 the same benefits as provided under Kentucky Kare Standard as of January 1,

1 1994, and shall include a mail-order drug option as provided in subsection
2 (13) of this section. All employees and other persons for whom the health care
3 coverage is provided or made available shall annually be given an option to
4 elect health care coverage through a self-funded plan offered by the
5 Commonwealth or, if a self-funded plan is not available, from a list of
6 coverage options determined by the competitive bid process under the
7 provisions of KRS 45A.080, 45A.085, and 45A.090 and made available
8 during annual open enrollment.

9 (b) The policy or policies shall be approved by the commissioner of insurance and
10 may contain the provisions the commissioner of insurance approves, whether
11 or not otherwise permitted by the insurance laws.

12 (c) Any carrier bidding to offer health care coverage to employees shall agree to
13 provide coverage to all members of the state group, including active
14 employees and retirees and their eligible covered dependents and
15 beneficiaries, within the county or counties specified in its bid. Except as
16 provided in subsection (20) of this section, any carrier bidding to offer health
17 care coverage to employees shall also agree to rate all employees as a single
18 entity, except for those retirees whose former employers insure their active
19 employees outside the state-sponsored health insurance program and as
20 otherwise provided in subsection (2)(b)3.b. of Section 16 of this Act and
21 subsection (2)(b)3.b. of Section 23 of this Act.

22 (d) Any carrier bidding to offer health care coverage to employees shall agree to
23 provide enrollment, claims, and utilization data to the Commonwealth in a
24 format specified by the Personnel Cabinet with the understanding that the data
25 shall be owned by the Commonwealth; to provide data in an electronic form
26 and within a time frame specified by the Personnel Cabinet; and to be subject
27 to penalties for noncompliance with data reporting requirements as specified

1 by the Personnel Cabinet. The Personnel Cabinet shall take strict precautions
2 to protect the confidentiality of each individual employee; however,
3 confidentiality assertions shall not relieve a carrier from the requirement of
4 providing stipulated data to the Commonwealth.

5 (e) The Personnel Cabinet shall develop the necessary techniques and capabilities
6 for timely analysis of data received from carriers and, to the extent possible,
7 provide in the request-for-proposal specifics relating to data requirements,
8 electronic reporting, and penalties for noncompliance. The Commonwealth
9 shall own the enrollment, claims, and utilization data provided by each carrier
10 and shall develop methods to protect the confidentiality of the individual. The
11 Personnel Cabinet shall include in the October annual report submitted
12 pursuant to the provisions of KRS 18A.226 to the Governor, the General
13 Assembly, and the Chief Justice of the Supreme Court, an analysis of the
14 financial stability of the program, which shall include but not be limited to
15 loss ratios, methods of risk adjustment, measurements of carrier quality of
16 service, prescription coverage and cost management, and statutorily required
17 mandates. If state self-insurance was available as a carrier option, the report
18 also shall provide a detailed financial analysis of the self-insurance fund
19 including but not limited to loss ratios, reserves, and reinsurance agreements.

20 (f) If any agency participating in the state-sponsored employee health insurance
21 program for its active employees terminates participation and there is a state
22 appropriation for the employer's contribution for active employees' health
23 insurance coverage, then neither the agency nor the employees shall receive
24 the state-funded contribution after termination from the state-sponsored
25 employee health insurance program.

26 (g) Any funds in flexible spending accounts that remain after all reimbursements
27 have been processed shall be transferred to the credit of the state-sponsored

1 health insurance plan's appropriation account.

2 (h) Each entity participating in the state-sponsored health insurance program shall
3 provide an amount at least equal to the state contribution rate for the employer
4 portion of the health insurance premium. For any participating entity that used
5 the state payroll system, the employer contribution amount shall be equal to
6 but not greater than the state contribution rate.

7 (3) The premiums may be paid by the policyholder:

8 (a) Wholly from funds contributed by the employee, by payroll deduction or
9 otherwise;

10 (b) Wholly from funds contributed by any department, board, agency, public
11 postsecondary education institution, or branch of state, city, urban-county,
12 charter county, county, or consolidated local government; or

13 (c) Partly from each, except that any premium due for health care coverage or
14 dental coverage, if any, in excess of the premium amount contributed by any
15 department, board, agency, postsecondary education institution, or branch of
16 state, city, urban-county, charter county, county, or consolidated local
17 government for any other health care coverage shall be paid by the employee.

18 (4) If an employee moves his or her place of residence or employment out of the service
19 area of an insurer offering a managed health care plan, under which he or she has
20 elected coverage, into either the service area of another managed health care plan or
21 into an area of the Commonwealth not within a managed health care plan service
22 area, the employee shall be given an option, at the time of the move or transfer, to
23 change his or her coverage to another health benefit plan.

24 (5) No payment of premium by any department, board, agency, public postsecondary
25 educational institution, or branch of state, city, urban-county, charter county,
26 county, or consolidated local government shall constitute compensation to an
27 insured employee for the purposes of any statute fixing or limiting the

1 compensation of such an employee. Any premium or other expense incurred by any
2 department, board, agency, public postsecondary educational institution, or branch
3 of state, city, urban-county, charter county, county, or consolidated local
4 government shall be considered a proper cost of administration.

5 (6) The policy or policies may contain the provisions with respect to the class or classes
6 of employees covered, amounts of insurance or coverage for designated classes or
7 groups of employees, policy options, terms of eligibility, and continuation of
8 insurance or coverage after retirement.

9 (7) Group rates under this section shall be made available to the disabled child of an
10 employee regardless of the child's age if the entire premium for the disabled child's
11 coverage is paid by the state employee. A child shall be considered disabled if he or
12 she has been determined to be eligible for federal Social Security disability benefits.

13 (8) The health care contract or contracts for employees shall be entered into for a period
14 of not less than one (1) year.

15 (9) The secretary shall appoint thirty-two (32) persons to an Advisory Committee of
16 State Health Insurance Subscribers to advise the secretary or the secretary's designee
17 regarding the state-sponsored health insurance program for employees. The
18 secretary shall appoint, from a list of names submitted by appointing authorities,
19 members representing school districts from each of the seven (7) Supreme Court
20 districts, members representing state government from each of the seven (7)
21 Supreme Court districts, two (2) members representing retirees under age sixty-five
22 (65), one (1) member representing local health departments, two (2) members
23 representing the Kentucky Teachers' Retirement System, and three (3) members at
24 large. The secretary shall also appoint two (2) members from a list of five (5) names
25 submitted by the Kentucky Education Association, two (2) members from a list of

8 provided to employees pursuant to this section shall not provide coverage for
9 obtaining or performing an abortion, nor shall any state funds be used for the
10 purpose of obtaining or performing an abortion on behalf of employees or their
11 dependents.

12 (11) Interruption of an established treatment regime with maintenance drugs shall be
13 grounds for an insured to appeal a formulary change through the established appeal
14 procedures approved by the Department of Insurance, if the physician supervising
15 the treatment certifies that the change is not in the best interests of the patient.

16 (12) Any employee who is eligible for and elects to participate in the state health
17 insurance program as a retiree, or the spouse or beneficiary of a retiree, under any
18 one (1) of the state-sponsored retirement systems shall not be eligible to receive the
19 state health insurance contribution toward health care coverage as a result of any
20 other employment for which there is a public employer contribution. This does not
21 preclude a retiree and an active employee spouse from using both contributions to

10 aid-related services for insured individuals under eighteen (18) years of age, subject
11 to a cap of one thousand four hundred dollars (\$1,400) every thirty-six (36) months
12 pursuant to KRS 304.17A-132.
- 13 (15) Any policy provided to state employees or their dependents pursuant to this section
14 shall provide coverage for the diagnosis and treatment of autism spectrum disorders
15 consistent with KRS 304.17A-142.
- 16 (16) Any policy provided to state employees or their dependents pursuant to this section
17 shall provide coverage for obtaining amino acid-based elemental formula pursuant
18 to KRS 304.17A-258.
- 19 (17) If a state employee's residence and place of employment are in the same county, and
20 if the hospital located within that county does not offer surgical services, intensive
21 care services, obstetrical services, level II neonatal services, diagnostic cardiac
22 catheterization services, and magnetic resonance imaging services, the employee
23 may select a plan available in a contiguous county that does provide those services,
24 and the state contribution for the plan shall be the amount available in the county
25 where the plan selected is located.
- 26 (18) If a state employee's residence and place of employment are each located in counties
27 in which the hospitals do not offer surgical services, intensive care services,

1 obstetrical services, level II neonatal services, diagnostic cardiac catheterization
2 services, and magnetic resonance imaging services, the employee may select a plan
3 available in a county contiguous to the county of residence that does provide those
4 services, and the state contribution for the plan shall be the amount available in the
5 county where the plan selected is located.

6 (19) The Personnel Cabinet is encouraged to study whether it is fair and reasonable and
7 in the best interests of the state group to allow any carrier bidding to offer health
8 care coverage under this section to submit bids that may vary county by county or
9 by larger geographic areas.

10 (20) Notwithstanding any other provision of this section, the bid for proposals for health
11 insurance coverage for calendar year 2004 shall include a bid scenario that reflects
12 the statewide rating structure provided in calendar year 2003 and a bid scenario that
13 allows for a regional rating structure that allows carriers to submit bids that may
14 vary by region for a given product offering as described in this subsection:

15 (a) The regional rating bid scenario shall not include a request for bid on a
16 statewide option;

17 (b) The Personnel Cabinet shall divide the state into geographical regions which
18 shall be the same as the partnership regions designated by the Department for
19 Medicaid Services for purposes of the Kentucky Health Care Partnership
20 Program established pursuant to 907 KAR 1:705;

21 (c) The request for proposal shall require a carrier's bid to include every county
22 within the region or regions for which the bid is submitted and include but not
23 be restricted to a preferred provider organization (PPO) option;

24 (d) If the Personnel Cabinet accepts a carrier's bid, the cabinet shall award the
25 carrier all of the counties included in its bid within the region. If the Personnel
26 Cabinet deems the bids submitted in accordance with this subsection to be in
27 the best interests of state employees in a region, the cabinet may award the

1 contract for that region to no more than two (2) carriers; and

2 (e) Nothing in this subsection shall prohibit the Personnel Cabinet from including
3 other requirements or criteria in the request for proposal.

4 (21) Any fully insured health benefit plan or self-insured plan issued or renewed on or
5 after July 12, 2006, to public employees pursuant to this section which provides
6 coverage for services rendered by a physician or osteopath duly licensed under KRS
7 Chapter 311 that are within the scope of practice of an optometrist duly licensed
8 under the provisions of KRS Chapter 320 shall provide the same payment of
9 coverage to optometrists as allowed for those services rendered by physicians or
10 osteopaths.

11 (22) Any fully insured health benefit plan or self-insured plan issued or renewed on or
12 after June 29, 2021, to public employees pursuant to this section shall comply with:

13 (a) KRS 304.12-237;

14 (b) KRS 304.17A-270 and 304.17A-525;

15 (c) KRS 304.17A-600 to 304.17A-633;

16 (d) KRS 205.593;

17 (e) KRS 304.17A-700 to 304.17A-730;

18 (f) KRS 304.14-135;

19 (g) KRS 304.17A-580 and 304.17A-641;

20 (h) KRS 304.99-123;

21 (i) KRS 304.17A-138; and

22 (j) Administrative regulations promulgated pursuant to statutes listed in this
23 subsection.

24 (23) Any fully insured health benefit plan or self-insured plan issued or renewed on or
25 after January 1, 2022, to public employees pursuant to this section shall comply
26 with KRS 304.17A-148.

27 ➔Section 27. The amendments to subsection (21)(b) of Section 3 of this Act and

1 subsection (21)(b) of Section 18 of this Act shall be retroactive to March 1, 2020, and
2 shall for purposes of anyone employed or contracted by health departments during and as
3 a result of the state of emergency declared by the Governor of Kentucky during the
4 COVID-19 pandemic apply to any such employment or contracts through December 31,
5 2022, as determined by the health department and regardless of whether or not the state of
6 emergency has expired or been lifted.

7 ➔Section 28. Whereas the prompt administration of retirement benefits by the
8 Kentucky Public Pensions Authority is a matter of the utmost importance to state and
9 local employees and retirees and the Commonwealth, an emergency is declared to exist,
10 and this Act takes effect upon its passage and approval by the Governor or upon its
11 otherwise becoming law.
