

1 AN ACT relating to elections.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 117.001 is amended to read as follows:

4 As used in this chapter, unless the context otherwise requires:

- 5 (1) "Audit log" means a detailed record of all actions and events that have occurred on  
6 the voting system, including:
- 7 (a) Log-in attempts with username and time stamp;
  - 8 (b) Election definition and setup;
  - 9 (c) Ballot preparation and results processing;
  - 10 (d) Diagnostics of any type; and
  - 11 (e) Error and warning messages and operator response;
- 12 (2) "Automatic tabulating equipment" means apparatus necessary to automatically  
13 examine and count votes as designated on ballots and data processing machines  
14 which can be used for counting ballots and tabulating results;
- 15 (3) "Ballot" or "official ballot" means the official presentation of offices and candidates  
16 to be voted for, including write-in candidates, and all public questions submitted for  
17 determination, and shall include a voting machine ballot, a paper ballot, an absentee  
18 ballot, a federal provisional ballot, a federal provisional absentee ballot, or a  
19 supplemental paper ballot which has been authorized for the use of voters in any  
20 primary, regular election, or special election by the Secretary of State or the county  
21 clerk;
- 22 (4) "Ballot box" means any box, bag, or other container that can be locked, sealed, or  
23 otherwise rendered tamper-resistant, for receiving ballots;
- 24 (5) "Ballot marking device" means any approved device for marking a ballot which will  
25 enable the ballot to be tabulated manually or by means of automatic tabulating  
26 equipment;
- 27 (6) "Election" or "elections" means any primary, regular election, or special election;

- 1 (7) "E-poll book" means an electronic device capable of holding a file of voter data  
 2 and related information for use in identifying registered voters prior to a voter's  
 3 receiving or casting a ballot, and allowing a voter to electronically sign in on an  
 4 electronic registered voter roster in lieu of signing a paper registered voter roster;
- 5 (8) "Federal provisional voter" means a person:
- 6 (a) Who does not appear to be registered to vote;
- 7 (b) Whose name does not appear on the precinct roster;
- 8 (c) Who has not provided proof of identification to the precinct election officer  
 9 before voting in a federal election; and
- 10 (d) Who elects to proceed with voting a federal provisional ballot under KRS  
 11 117.229;
- 12 ~~(9)~~~~(8)~~ "Federal provisional ballot" or "federal provisional absentee ballot" means  
 13 ballots which have been authorized by the Secretary of State or the county clerk to  
 14 be used by federal provisional voters in any federal primary or election;
- 15 ~~(10)~~~~(9)~~ "Inner envelope" or "secrecy envelope" means the envelope provided to the  
 16 voter with a ballot into which the voter shall place his or her voted ballot;
- 17 ~~(11)~~~~(10)~~ "Political group" has the same meaning as in KRS 118.015;
- 18 ~~(12)~~~~(11)~~ "Political organization" has the same meaning as in KRS 118.015;
- 19 ~~(13)~~(12) "Precinct ballot counter" means an automatic tabulating device used at the  
 20 precinct to tabulate and process ballots;
- 21 ~~(14)~~~~(13)~~ "Proof of identification" means a document that was issued by:
- 22 (a) The United States or the Commonwealth of Kentucky, and the document  
 23 contains:
- 24 1. The name of the individual to whom the document was issued; and  
 25 2. A photograph of the individual to whom the document was issued;
- 26 (b) The United States Department of Defense, a branch of the uniformed services,  
 27 the Merchant Marine, or the Kentucky National Guard, and the document

1 contains:

2 1. The name of the individual to whom the document was issued; and

3 2. A photograph of the individual to whom the document was issued;

4 (c) A public or private college, university, or postgraduate technical or  
5 professional school located within the United States, and the document

6 contains:

7 1. The name of the individual to whom the document was issued; and

8 2. A photograph of the individual to whom the document was issued; or

9 (d) Any city government, county government, urban-county government, charter  
10 county government, consolidated local government, or unified local  
11 government, which is located within this state, and the document contains:

12 1. The name of the individual to whom the document was issued; and

13 2. A photograph of the individual to whom the document was issued;

14 ~~(15)~~~~(14)~~ "Risk-limiting audit" means an audit protocol that makes use of statistical  
15 principles and methods and is designed to limit to acceptable levels the risk of  
16 certifying a preliminary election outcome that constitutes an incorrect outcome;

17 ~~(16)~~~~(15)~~ "Voting booth" or "ballot completion area" means an area in which a voter  
18 casts his or her vote or completes his or her ballot which is designed to ensure the  
19 secrecy of the vote;

20 ~~(17)~~~~(16)~~ "Vote center" means a consolidated precinct of the county;

21 ~~(18)~~~~(17)~~ "Voting equipment" means any physical component of a voting system and  
22 includes voting machines where voting machines are in operation;

23 ~~(19)~~~~(18)~~ "Voting machine" or "machine":

24 (a) Means a part of a voting system that consists of:

25 ~~1.~~~~(a)~~ A direct recording electronic voting machine that:

26 ~~a.~~~~(1.)~~ Records votes by means of a ballot display provided with  
27 mechanical or electro-operated components that may be actuated

- 1 by the voter;
- 2 ~~b.~~<sup>[2.]</sup>Processes the data by means of a computer program;
- 3 ~~c.~~<sup>[3.]</sup>Records voting data and ballot images in internal and external
- 4 memory components; and
- 5 ~~d.~~<sup>[4.]</sup>Produces a tabulation of the voting data stored in a removable
- 6 memory component and on a printed copy; or
- 7 ~~2.~~<sup>[(b)]</sup> One (1) or more electronic devices that operate independently or as
- 8 a combination of a ballot marking device and an electronic or automatic
- 9 vote tabulation device; ***and***

10 ***(b) Does not include an e-poll book;***

11 ~~(20)~~<sup>[(19)]</sup> "Voting system" ~~[means]~~:

- 12 (a) ***Means*** the total combination of physical, mechanical, electromechanical, or
- 13 electronic equipment, including the software, hardware, firmware, and
- 14 documentation required to program, control, and support that equipment, that
- 15 is used to:
- 16 1. Define ballots;
- 17 2. Cast and count votes;
- 18 3. Report or display election results; and
- 19 4. Maintain and produce any audit trail information;~~[and]~~
- 20 (b) ***Includes*** the practices and associated documentation used to:
- 21 1. Identify system components and versions of those components;
- 22 2. Test the system during its development and maintenance;
- 23 3. Maintain records of system errors and defects;
- 24 4. Determine specific system changes to be made to a system after the
- 25 initial qualification of the system;~~[and]~~
- 26 5. Make available any materials to the voter, such as notices, instructions,
- 27 forms, or paper ballots; and

1        (c) Does not include an e-poll book; and

2        ~~(21)~~~~(20)~~ "Voter-verified paper audit trail" means a contemporaneous paper record of a  
3        ballot printed for the voter to confirm his or her votes before the voter casts his or  
4        her ballot that:

5        (a) Allows the voter to verify the voter's ballot choices before the casting of the  
6        voter's ballot;

7        (b) Is not retained by the voter;

8        (c) Does not contain individual voter information;

9        (d) Is produced on paper that is sturdy, clean, and resistant to degradation; and

10       (e) Is readable in a manner that makes the voter's ballot choices obvious to the  
11       voter or any person without the use of computer or electronic code.

12       ➔Section 2. KRS 117.025 is amended to read as follows:

13       (1) The State Board of Elections shall appoint an executive director, who shall be the  
14       chief administrative officer for the board. The board shall also appoint an assistant  
15       director, who shall be of a different political party than the director. The salaries of  
16       the director and the assistant director shall be set by the board.

17       (2) The State Board of Elections shall employ, on a bipartisan basis, a staff sufficient to  
18       carry out the duties assigned to the board, including legal counsel and a training  
19       officer to provide assistance to the county clerks and the county boards of elections  
20       in their training of precinct election officers.

21       (3) The board shall:

22       (a) Maintain a complete roster of all qualified registered voters within the state by  
23       county and precinct, and institute appropriate safeguards to ensure that there is  
24       no inappropriate use of the voter registration roster. State and local election  
25       officials, including the Secretary of State, employees of the Secretary, and  
26       members of the State Board of Elections and their staff, shall only use the  
27       voter registration roster for purposes relevant to their prescribed duties of

- 1 election administration. The Secretary of State, and two (2) employees of the  
2 Secretary, who may be designated by the Secretary with explicit written  
3 authority and notification to the board, shall have electronic access to the  
4 information contained within the voter registration roster, but shall not  
5 correct, alter, or delete information from the voter registration roster, unless  
6 having obtained prior approval by a majority of the voting members of the  
7 board;
- 8 (b) For each primary, furnish each county clerk with a master list of all registered  
9 voters in the county, together with three (3) signature rosters of all registered  
10 voters in each precinct of the county according to party affiliation, and two (2)  
11 lists of all registered voters in each precinct of the county at least eighteen  
12 ~~(18) [five (5)]~~ days prior to each primary;
- 13 (c) For each regular election, furnish each county clerk with a master list of all  
14 registered voters in the county, together with one (1) signature roster of all  
15 registered voters in each precinct of the county on which each voter's party  
16 affiliation is identified, and two (2) lists of all registered voters in each  
17 precinct of the county at least eighteen (18) ~~[five (5)]~~ days prior to each  
18 regular election;
- 19 (d) Select the required format for any voter registration list provided to a county  
20 clerk including those intended for use in an e-poll book product;
- 21 (e) Maintain all information furnished to the board relating to the inclusion or  
22 deletion of names from the rosters for four (4) years;
- 23 ~~(f) [e)]~~ Furnish, at a reasonable price, the state central executive committee of  
24 each political party qualifying under KRS 118.015 monthly data of all  
25 additions, deletions and changes of registration in each precinct of each county  
26 and the state central executive committee shall furnish a county listing to each  
27 of the county executive committees of each political party;

1        ~~(g)~~~~(f)~~ Purchase, lease or contract for the use of equipment necessary to  
 2                properly carry out its duties under the provisions of this chapter and KRS  
 3                Chapters 116 and 118;

4        ~~(h)~~~~(g)~~ Secure information from any source which may assist the board in  
 5                carrying out the purposes of this section;

6        ~~(i)~~~~(h)~~ Furnish at a reasonable price any and all precinct lists to duly qualified  
 7                candidates, political party committees or officials thereof, or any committee  
 8                that advocates or opposes an amendment or public question. The State Board  
 9                of Elections may also furnish the precinct lists to other persons at the board's  
 10                discretion, at a reasonable price to be determined by the board. The board  
 11                shall not furnish precinct lists to persons who intend to use the lists for  
 12                commercial use; and

13        ~~(j)~~~~(i)~~ Be responsible for oversight of board personnel, including hiring,  
 14                investigations, disciplinary actions, promotions, and other like actions subject  
 15                to KRS Chapter 18A.

16        ➔Section 3. KRS 117.379 is amended to read as follows:

17        (1) Any person or corporation owning, manufacturing, or selling any voting system **or**  
 18                **e-poll book product**, may request the State Board of Elections to examine the voting  
 19                system **or e-poll book product**. Before requesting an examination or reexamination,  
 20                any person, persons, or corporation shall pay to the State Treasurer a nonrefundable  
 21                deposit of five hundred dollars (\$500) and submit a test report from an independent  
 22                testing authority approved by the State Board of Elections. The report shall  
 23                demonstrate that the voting system **or e-poll book product** meets all Election  
 24                Assistance Commission~~[-voting system]~~ standards. Notwithstanding any other  
 25                provision of law to the contrary, if these **Election Assistance Commission**~~[-voting~~  
 26                ~~system]~~ standards have been amended less than thirty-six (36) months prior to the  
 27                request for examination under this subsection, the State Board of Elections may

1 approve and certify a voting system or e-poll book product that meets the prior  
2 standards after determining:

3 (a) The effect that such approval would have on the integrity and security of  
4 elections; and

5 (b) The procedure and cost involved to bring the voting system or e-poll book  
6 product into compliance with the amended standards.

7 The State Board of Elections may, at any time, reexamine any voting system or e-  
8 poll book already approved. The State Board of Elections shall approve or  
9 disapprove any voting system or e-poll book product within sixty (60) days after the  
10 date of its initial submission. Any or all costs associated with the voting system or  
11 e-poll book product being examined or reexamined shall be paid to the State  
12 Treasurer by the person or corporation once the approval or disapproval ~~of the~~  
13 ~~voting machine~~ is complete.

14 (2) Upon receipt of a request for examination or reexamination of a voting system or e-  
15 poll book product, the State Board of Elections shall require that such voting  
16 system or e-poll book be examined or reexamined by three (3) examiners. The State  
17 Board of Elections shall appoint one (1) examiner who is an expert in computer  
18 science, ~~or~~ voting systems, or e-poll book products, whichever is applicable; one  
19 (1) person who is knowledgeable in election procedures, election security, and  
20 election law in Kentucky; and one (1) person who is a present or former county  
21 clerk. The three (3) examiners shall submit one (1) written report on each voting  
22 system or e-poll book product, examined or reexamined, to the State Board of  
23 Elections. The members of the State Board of Elections shall also examine or  
24 reexamine the voting system or e-poll book product. A voting system shall be  
25 approved and certified if the examiners' report states that the voting system meets  
26 all the requirements of KRS 117.125 and applicable federal law, and the State  
27 Board of Elections finds that the voting system meets all of the requirements of



1 KRS 117.125 and applicable federal law. *Beginning September 1, 2022, an e-poll*  
2 *book product shall be approved and certified if the examiners' report and the*  
3 *State Board of Elections find that the e-poll book product meets the certification*  
4 *requirements promulgated by the State Board of Elections pursuant to KRS*  
5 *Chapter 13A and applicable federal law.* The report and a letter of approval shall  
6 be filed in the office of the State Board of Elections.

7 (3) Any voting system *or e-poll book product* not approved by the State Board of  
8 Elections shall not be used at any primary, *regular election,* or *special* election.

9 (4) When a voting system *or e-poll book* has been approved, any improvement or  
10 changes in the voting system *or e-poll book product* shall render necessary the  
11 examination or approval of such voting system or improvement.

12 (5) Neither the members of the State Board of Elections, nor any examiner appointed  
13 by the State Board of Elections, nor any member of a county board of elections shall  
14 have any pecuniary interest in any voting system *or e-poll book product.*

15 (6) Each examiner appointed by the State Board of Elections shall receive fair  
16 compensation to be established by the State Board of Elections.

17 *(7) An e-poll book product approved under this section shall not be used in any*  
18 *primary, regular election, or special election held before May 11, 2023.*

19 ➔Section 4. KRS 117.115 is amended to read as follows:

20 The legislative body of any county, urban-county government, charter county,  
21 consolidated local government, or unified local government may select, in its discretion,  
22 any type and make of voting system *or e-poll book product* that complies with the  
23 specifications and requirements of this chapter. The legislative body may employ  
24 engineers and other skilled persons to advise and aid in the selection of voting systems *or*  
25 *e-poll book products* and in determining compliance with the specifications and  
26 requirements of this chapter.
