- (h) Any deduction allowed for amounts paid to any club, organization, or establishment which has been determined by the courts or an agency established by the General Assembly and charged with enforcing the civil rights laws of the Commonwealth, not to afford full and equal membership and full and equal enjoyment of its goods, services, facilities, privileges, advantages, or accommodations to any person because of race, color, religion, national origin, or sex, except nothing shall be construed to deny a deduction for amounts paid to any religious or denominational club, group, or establishment or any organization operated solely for charitable or educational purposes which restricts membership to persons of the same religion or denomination in order to promote the religious principles for which it is established and maintained; and
- (i) A taxpayer may elect to claim the standard deduction allowed by KRS 141.081 instead of itemized deductions allowed pursuant to 26 U.S.C. sec. 63 and as modified by this section.
- → SECTION 2. A NEW SECTION OF KRS CHAPTER 141 IS CREATED TO
 18 READ AS FOLLOWS:

19 (1) For purposes of this section:

- 20 (a) "Armed Forces" has the same meaning as in KRS 141.175; and
- 21 (b) "Veteran" means any individual who served in the Armed Forces on active
 22 duty as defined in KRS 141.175 and who was discharged or released
 23 therefrom under conditions other than dishonorable.
- (2) For taxable years beginning on or after January 1, 2022, but before January 1,
 25 2026, there shall be allowed a deduction of income from all sources for a veteran.
 26 If the veteran's first year of residency in this state extends beyond the expiration
 27 of this tax deduction, the provisions of this section shall still apply, so long as the

1		residency is maintained or established prior to January 1, 2026.
2	<u>(3)</u>	The deduction shall apply to:

14		returns, if more than one (1) taxable year is affected, and in a manner specified
15		by the department.
16	<u>(6)</u>	In order to evaluate the effectiveness of this tax deduction, the department shall
17		report the following information to the Legislative Research Commission on or
18		before December 1, 2023, and on or before each December 1 thereafter, as long
19		as this deduction may be claimed on a tax return:
20		(a) The location of the taxpayer, by county, as reflected on the return filed for
21		the taxable year;
22		(b) The amount of the deduction claimed by the taxpayer for the taxable year;
23		(c) The total amount of deductions claimed by all taxpayers for the taxable
24		year; and
25		(d) Based on ranges of adjusted gross income of no larger than five thousand
26		dollars (\$5,000) for the taxable year, the total amount of deductions claimed
27		and the number of returns claiming a tax deduction for each adjusted gross

income range.

2 → Section 3. KRS 131.190 is amended to read as follows:

- No present or former commissioner or employee of the department, present or former member of a county board of assessment appeals, present or former property valuation administrator or employee, present or former secretary or employee of the Finance and Administration Cabinet, former secretary or employee of the Revenue Cabinet, or any other person, shall intentionally and without authorization inspect or divulge any information acquired by him or her of the affairs of any person, or information regarding the tax schedules, returns, or reports required to be filed with 10 the department or other proper officer, or any information produced by a hearing or investigation, insofar as the information may have to do with the affairs of the 12 person's business.
- 13 The prohibition established by subsection (1) of this section shall not extend to:
- 14 (a) Information required in prosecutions for making false reports or returns of 15 property for taxation, or any other infraction of the tax laws;
 - (b) Any matter properly entered upon any assessment record, or in any way made a matter of public record;
 - (c) Furnishing any taxpayer or his or her properly authorized agent with information respecting his or her own return;
 - (d) Testimony provided by the commissioner or any employee of the department in any court, or the introduction as evidence of returns or reports filed with the department, in an action for violation of state or federal tax laws or in any action challenging state or federal tax laws;
 - Providing an owner of unmined coal, oil or gas reserves, and other mineral or (e) energy resources assessed under KRS 132.820, or owners of surface land under which the unmined minerals lie, factual information about the owner's property derived from third-party returns filed for that owner's property, under

the provisions of KRS 132.820, that is used to determine the owner's assessment. This information shall be provided to the owner on a confidential basis, and the owner shall be subject to the penalties provided in KRS 131.990(2). The third-party filer shall be given prior notice of any disclosure of information to the owner that was provided by the third-party filer;

- (f) Providing to a third-party purchaser pursuant to an order entered in a foreclosure action filed in a court of competent jurisdiction, factual information related to the owner or lessee of coal, oil, gas reserves, or any other mineral resources assessed under KRS 132.820. The department may promulgate an administrative regulation establishing a fee schedule for the provision of the information described in this paragraph. Any fee imposed shall not exceed the greater of the actual cost of providing the information or ten dollars (\$10);
- (g) Providing information to a licensing agency, the Transportation Cabinet, or the Kentucky Supreme Court under KRS 131.1817;
- (h) Statistics of gasoline and special fuels gallonage reported to the department under KRS 138.210 to 138.448;
- (i) Providing any utility gross receipts license tax return information that is necessary to administer the provisions of KRS 160.613 to 160.617 to applicable school districts on a confidential basis;
- (j) Providing documents, data, or other information to a third party pursuant to an order issued by a court of competent jurisdiction; or
- (k) Providing information to the Legislative Research Commission under:

- (5) Statistics of crude oil as reported to the department under the crude oil excise tax requirements of KRS Chapter 137 and statistics of natural gas production as reported to the department under the natural resources severance tax requirements of KRS Chapter 143A may be made public by the department by release to the Energy and Environment Cabinet, Department for Natural Resources.
- (6) Notwithstanding any provision of law to the contrary, beginning with mine-map submissions for the 1989 tax year, the department may make public or divulge only those portions of mine maps submitted by taxpayers to the department pursuant to KRS Chapter 132 for ad valorem tax purposes that depict the boundaries of mined-out parcel areas. These electronic maps shall not be relied upon to determine actual boundaries of mined-out parcel areas. Property boundaries contained in mine maps required under KRS Chapters 350 and 352 shall not be construed to constitute land surveying or boundary surveys as defined by KRS 322.010 and any administrative regulations promulgated thereto.
