AN ACT relating to massage therapy.

2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

→ Section 1. KRS 309.355 is amended to read as follows:

4 (1) The board shall administer and enforce the provisions of KRS 309.350 to 309.364
5 and shall have the responsibility to evaluate the qualifications of applicants for
6 licensure and to authorize issuing, renewing, suspending, and revoking licenses.

7 The board shall investigate alleged violations brought to its attention, conduct (2)8 investigations, and schedule and conduct administrative hearings in accordance with 9 KRS Chapter 13B to enforce the provisions of KRS 309.350 to 309.364 and 10 administrative regulations promulgated pursuant to KRS 309.350 to 309.364. The 11 board shall have the authority to administer oaths, receive evidence, interview 12 persons, and require the production of books, papers, documents, or other evidence. 13 The board may institute civil and criminal proceedings against violators of KRS 14 309.350 to 309.364. The Attorney General, Commonwealth's attorneys, and county 15 attorneys shall assist the board in prosecuting violations of KRS 309.350 to 16 309.364.

17 (3) The board shall promulgate administrative regulations, pursuant to KRS Chapter
18 13A, to carry out and enforce provisions of KRS 309.350 to 309.364, including
19 creating a code of ethics, standards of practice, standards of educational program
20 curriculum and instructor qualification, and continuing education requirements for
21 licensed massage therapists.

(4) The board shall keep a record of its proceedings and a register of all persons
licensed as massage therapists. The register shall include the name, license number
and date of issue, last known place of business, and residence of each licensee. The
board shall publish annually a directory of licensed massage therapists and their
places of business. The list shall be available to any Kentucky citizen upon request
and payment of a fee not to exceed the cost of the publication.

(6) 4 The board may seek an injunction in the Circuit Court of the county where the 5 alleged violation occurred against any individual who practices massage therapy in 6 the Commonwealth without a license. 7 The board shall require a national and state criminal background investigation (7)for every applicant seeking a license, certificate, or temporary permit issued by 8 9 the board permitting the applicant to engage in the practice of massage therapy. 10 The criminal background investigation shall be by means of a fingerprint check 11 by the Department of Kentucky State Police and Federal Bureau of Investigation, 12 pursuant to the following requirements: The applicant shall provide his or her fingerprints to the Department of 13 (a)14 Kentucky State Police for submission to the Federal Bureau of *Investigation after a state criminal background check is conducted;* 15 16 (b) The results of the national and state criminal background check shall be 17 sent to the board for the screening of applicants; The board shall be prohibited from releasing any criminal history record 18 (c)19 information to any private entity or other licensing board, or authorizing 20 receipt by such entity or board; and 21 (d) Any fee charged by the Department of Kentucky State Police or the Federal 22 Bureau of Investigation shall be an amount no greater than the actual cost 23 of processing the request and conducting the background check. The board 24 may charge this fee to the applicant for licensure or certification. The board 25 shall require a fingerprint-supported criminal record check by the Department of Kentucky State Police and the Federal Bureau of Investigation of any 26 27 applicant for licensure to practice massage therapy.]

The board shall make an annual report to the Governor and the General Assembly,
