15	subdivision, agency, or instrumentality;
16	(4) ''Matter of public concern'' means a statement or activity regarding:
17	(a) A public official, public figure, or other person who has drawn substantial
18	public attention due to the person's official acts, fame, notoriety, or
19	<u>celebrity;</u>
20	(b) A matter of political, social, or other interest to the community; or
21	(c) A subject of concern to the public; and
22	(5) "Person" means an individual, estate, trust, partnership, business or nonprofit
23	entity, governmental unit, or other legal entity.
24	→SECTION 2. A NEW SECTION OF KRS CHAPTER 454 IS CREATED TO

26	(1) Except as otherwise provided in subsection (2) of this section, Sections 1 to 10 of
27	this Act apply to a cause of action asserted against a person based on the

10	<u>(2) (a)</u>	Except as provided in paragraph (b) of this subsection, Sections 1 to 10 of
11		this Act shall not apply to a cause of action asserted:
12		<u>1. Against a governmental unit or an employee or agent of a</u>
13		governmental unit acting or purporting to act in an official capacity;
14		2. By a governmental unit or an employee or agent of a governmental
15		unit acting in an official capacity to enforce a law to protect against
16		an imminent threat to public health or safety;
17		3. Against a person primarily engaged in the business of selling or
18		leasing goods or services if the cause of action arises out of a
19		communication or lack of communication related to the person's sale

7	including KRS 61.101 to 61.103; or enforcement of employee rights

10	10. Under the Kentucky Consumer Protection Act, KRS 367.110 to
11	<u>367.300.</u>
12	(b) Sections 1 to 10 of this Act apply to a cause of action asserted under
13	paragraph (a) of this subsection when the cause of action is:
14	1. An action against a person arising from any act of that person,
15	whether public or private, related to the gathering, receiving, posting,
16	or processing of information for communication to the public,
17	whether or not the information is actually communicated to the
18	public, for the creation, dissemination, exhibition, or advertisement or
19	other similar promotion of a dramatic, literary, musical, political,
20	journalistic, or otherwise artistic work, including audio-visual work
21	regardless of the means of distribution, a motion picture, a television

2	→SECTION 3. A NEW SECTION OF KRS CHAPTER 454 IS CREATED TO
3	READ AS FOLLOWS:
4	<u>No later than sixty (60) days after a party is served with a complaint, crossclaim,</u>
5	counterclaim, third-party claim, or other pleading that asserts a cause of action to
6	which Sections 1 to 10 of this Act apply, or at a later time on a showing of good cause,
7	the party may file a special motion for expedited relief to dismiss the cause of action in
8	whole or in part.
9	→SECTION 4. A NEW SECTION OF KRS CHAPTER 454 IS CREATED TO
10	READ AS FOLLOWS:
11	(1) Except as otherwise provided in subsections (4) to (7) of this section, on the filing
12	of a motion under Section 3 of this Act:
13	(a) All other proceedings between the moving party and responding party,
14	including discovery and any pending hearing or motion, shall be stayed;
15	and
16	(b) On motion by the moving party, the court may stay a hearing or motion
17	involving another party, or discovery by another party, if the hearing or
18	ruling on the motion would adjudicate, or the discovery would relate to, an
19	issue material to the motion.
20	(2) A stay under subsection (1) of this section shall remain in effect until entry of an
21	order ruling on the motion under Section 3 of this Act and expiration of the time
22	under Section 9 of this Act for the moving party to appeal the order.
23	(3) Except as otherwise provided in subsections (5), (6), and (7) of this section, if a
24	party appeals from an order ruling on a motion under Section 3 of this Act, all
25	proceedings between all parties in the action shall be stayed. The stay shall
26	remain in effect until the conclusion of the appeal.
27	(4) During a stay under subsection (1) of this section, the court shall allow limited

19	exercise of the right of freedom of speech and of the press, the right to assemble and
20	petition, and the right of association, as guaranteed by the United States Constitution and
21	the Constitution of Kentucky.
22	→ Section 12. This Act may be cited as the Uniform Public Expression Protection
23	Act.
