

1 AN ACT relating to documentation for property which has a Kentucky certificate of
2 title.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 186A.100 is amended to read as follows:

- 5 (1) A motor vehicle dealer licensed under KRS 186.070 who sells a vehicle for use
6 upon the highways of this state shall equip the vehicle with a temporary tag
7 executed in the manner prescribed below, which shall be valid for sixty (60)~~thirty~~
8 ~~(30)~~ days from the date the vehicle is delivered to the purchaser. The cost of the tag
9 shall be two dollars (\$2), of which the clerk shall retain one dollar (\$1). A motor
10 vehicle dealer licensed under KRS 186.070 shall apply to the county clerk of the
11 county in which the dealer maintains his principal place of business for issuance of
12 temporary tags. Application shall be made for such tags on forms supplied to the
13 county clerk by the Transportation Cabinet.~~[If the purchaser has not received his~~
14 ~~certificate of registration within thirty (30) days from the date of delivery, the~~
15 ~~purchaser may obtain another temporary tag from the dealer.]~~
- 16 (2) The county clerk of any county who receives a proper application for issuance of
17 temporary tags shall record the number of each tag issued upon the application of
18 the dealer for such tags, or if a group of consecutively numbered temporary tags are
19 issued to a dealer in connection with a single application, record the beginning and
20 ending numbers of the group on the application.
- 21 (3) The clerk shall retain, for a period of two (2) years, one (1) copy of the dealer's
22 temporary tag application, and ensure that it reflects the numbers appearing on the
23 tags issued with respect to such application.
- 24 (4) If the owner of a motor vehicle submits to the county clerk a properly completed
25 application for Kentucky certificate of title and registration pursuant to KRS
26 186A.120, any motor vehicle required to be registered and titled in Kentucky, that is
27 not currently registered and titled in Kentucky, may be equipped with a temporary

1 tag, which shall be valid for sixty (60)~~thirty (30)~~ days from the date of issuance,
2 issued by the county clerk for the purpose of operating the vehicle in Kentucky
3 while assembling the necessary documents in order to title and register the vehicle
4 in Kentucky. The Transportation Cabinet may establish administrative regulations
5 governing this section.

- 6 (5) The county clerk may issue a temporary tag to the owner of a motor vehicle that is
7 currently registered and titled in Kentucky. A temporary tag authorized by this
8 subsection shall be used for emergency or unusual purposes as determined by the
9 clerk for the purpose of maintaining the owner's current registration. A temporary
10 tag authorized by this subsection may only be issued by the county clerk and shall
11 be valid for a period of between twenty-four (24) hours and seven (7) days, as
12 determined is necessary by the clerk. A county clerk shall not issue a temporary tag
13 authorized by this subsection unless the owner of the motor vehicle applying for the
14 tag presents proof of motor vehicle insurance pursuant to KRS 304.39-080. On and
15 after January 1, 2006, if the motor vehicle is a personal motor vehicle as defined in
16 KRS 304.39-087, proof of insurance shall be determined by the county clerk as
17 provided in KRS 186A.042. A temporary tag issued pursuant to this subsection
18 shall not be reissued by the county clerk for the same owner and same motor vehicle
19 within one (1) year of issuance of a temporary tag.

20 ➔Section 2. KRS 186A.105 is amended to read as follows:

- 21 (1) Motor vehicle dealers, their agents and county clerks, before equipping a vehicle
22 with a temporary tag, shall print or stamp in waterproof ink, legibly, in the spaces
23 provided on such tag:
- 24 (a) The month, day and year the vehicle was delivered to the purchaser;
 - 25 (b) The month, day and year of expiration of the tag which shall be no more than
26 sixty (60)~~thirty (30)~~ days following the date of delivery of the vehicle to the
27 purchaser;

- 1 (c) The purchaser's or owner's name;
- 2 (d) The year model, make and vehicle identification number of the vehicle sold;
- 3 and
- 4 (e) Either the dealer's name, city of principal place of business and the telephone
- 5 number, including telephone area code, or the clerk's name, county and
- 6 telephone number, including area code.

7 (2) The dealer's employee who executes the temporary tag shall place his signature in

8 the space provided. A dealer who issues, or whose agents issue, temporary tags shall

9 keep a log of each temporary tag obtained and each tag issued, showing all

10 information entered by the dealer or dealer's agent on forms supplied by the cabinet,

11 and shall make such log available for inspection by any law enforcement officer

12 upon request. The log shall be retained by the dealer for a period of at least two (2)

13 years following the date of issuance of the last dated tags whose issuance is

14 indicated on any individual temporary tag log sheet.

15 (3) The county clerk who executes the temporary tag shall place his signature in the

16 space provided. A county clerk who issues temporary tags shall keep a log of each

17 temporary tag obtained and each tag issued, showing all information entered by the

18 county clerk on forms supplied by the cabinet, and shall make the log available for

19 inspection by any law enforcement officer upon request. The log shall be retained

20 by the county clerk for a period of at least two (2) years following the date of

21 issuance of the last dated tags whose issuance is indicated on any individual

22 temporary tag log sheet.

23 ➔Section 3. KRS 186A.297 is amended to read as follows:

24 (1) When a manufactured home is or is to be permanently affixed to real estate, the

25 owner may execute and file an affidavit of conversion to real estate with the county

26 clerk of the county in which the real estate is located. The affidavit shall attest to the

27 fact that the home has been or will be permanently affixed to the real estate and be

1 accompanied by a surrender of the Kentucky certificate of title. The county clerk
2 shall file the affidavit of conversion to real estate in the miscellaneous record book.

3 (2) A county clerk shall not accept a surrender of a Kentucky certificate of title which
4 displays an unreleased lien unless it is accompanied by:

5 (a) A release of the lien; or

6 (b) An affidavit, signed under oath by the attorney who satisfied the liens noted
7 on the Kentucky certificate of title, attesting that all liens noted on the
8 Kentucky certificate of title have been paid. An affidavit filed by an attorney
9 under this paragraph may only be signed by an attorney licensed to practice
10 law in the Commonwealth.

11 (3) The provisions of subsection (2) of this section shall not excuse a lender who
12 placed a lien on the certificate of title from filing a release of the lien.

13 (4) Upon receipt of the information identified in subsection (2) of this section, the
14 county clerk shall accept the affidavit of conversion and the surrender of the
15 Kentucky certificate of title.

16 (5) In the event of an inaccurate or fraudulent affidavit, the title surrender becomes
17 null and void.

18 (6) The county clerk shall be held harmless if he or she relies upon receipt of the
19 information identified in subsection (2) of this section.

20 (7) When the county clerk files the affidavit of conversion to real estate, the county
21 clerk shall furnish a copy to the property valuation administrator for inclusion in the
22 real property tax rolls of the county. A filing of an affidavit of conversion to real
23 estate and a surrender of a Kentucky certificate of title shall be deemed a conversion
24 of the property as an improvement to the real estate upon which it is located.
