1 AN ACT relating to the issuance of a personalized license plate. 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky: 3 → Section 1. KRS 186.174 is amended to read as follows: 4 (1)For purposes of this section, "personalized license plate" means a license plate 5 manufactured by the cabinet upon an applicant's request with specific *lissued* with personal] letters or numbers or combinations of letters and numbers 6 7 significant to the applicant and it also means a license plate that is issued under this 8 section and has been combined with a special license plate]. 9 (2)Any owner or lessee of a motor vehicle that is required to be registered under the 10 provisions of KRS 186.050(1), (3)(a), or (4)(a), or any owner or lessee of a 11 motorcycle required to be registered under the provisions of KRS 186.050(2) may 12 obtain a personalized license plate by submitting an application through a Web site designated by the cabinet.[applying for a personalized license plate in the 13 office of the county clerk and upon] The cabinet shall produce the requested 14 15 *license plate upon approval and receipt of the*[payment of the] fee required in 16 subsection (4) of this section for a special license plate, or the fee required in 17 KRS 186.162 for a standard issue license plate. [A person initially applying for a 18 personalized license plate shall submit the application and appropriate SF fee in 19 person to the county clerk, but may submit the annual application to renew the personalized license plate and entire fee required in KRS 186.162 by mail to the 20 21 county clerk.] 22 Personalized license plates shall expire on the last day of the birth month of the (3) 23 person to whom the license plate is registered [applicant]. 24 A personalized license plate shall be replaced on the same schedule as regular (4) (a)25 issue license plates unless it is damaged or unreadable. [A county clerk shall 26 immediately forward the application and the fee required in KRS 186.162 for 27 a personalized license plate to the Transportation Cabinet. The initial fee for a

3		<u>(b)</u>	A standard issued license plate may be personalized for a forty-three dollar
4			(\$43) fee as provided in KRS 186.162(2)(m), in addition to all other fees
5			established in this section and in KRS 186.050.
6		<u>(c)</u>	Any special license plate may be combined with a personalized license plate
7			for a twenty-five dollar (\$25) state fee in addition to all other fees for the
8			particular special license plate established in this section and in KRS
9			186.164. The twenty-five dollar (\$25) fee required under this subsection
10			shall be divided between the cabinet and the county clerk of the county
11			where the applicant resides with the cabinet receiving twenty dollars (\$20)
12			and the county clerk receiving five dollars (\$5).
13	(5)	(a)	A personalized plate shall not be issued that would conflict with or duplicate
14			any current issued license plate[the alphabetical-numerical system used for
15			regular license plates or any other license plates issued in the Commonwealth,
16			and shall not contain a combination of more than six (6) letters of the alphabet
17			and Arabic numerals, including spaces].
18		(b)	A personalized plate shall not be issued if the cabinet determines [the request
19			fails to comply with the following conditions]:
20			1. The message to be placed on the license plate, if created,
21			discriminates[shall not discriminate] against a[any] race, color, religion,
22			sex, or national origin [, and shall not be construed, as determined by the
23			cabinet, as an attempt to victimize or intimidate any person due to the
24			person's race, color, religion, sex, or national origin];
25			2. [The plate shall not represent a political party and shall not have been
26			created primarily to promote a specific political belief;
27			3. The plate shall not have as its primary purpose the promotion of any

1		specific faith, religion, or antireligion;
2		4.]The plate <i>message is the</i> [shall not be the] name of a <i>trademarked or</i>
3		<u>copyrighted[special]</u> product or brand name[, and shall not be construed,
4		as determined by the cabinet, as promoting a product or brand name];
5		<u>or[and]</u>
6		3.[5.] The plate's lettering or message[to be placed on the license plate, if
7		created, shall not be] is obscene or profane, as determined by the
8		cabinet.
9	(c)	[The owner or lessee shall submit an application and fee to renew a
10		personalized license plate pursuant to the provisions of this section.]Once an
11		applicant obtains a personalized plate, he or she will have first priority on that
12		plate for each of the following years that he or she makes timely <u>renewal</u>
13		payments[and proper application].
