

1 AN ACT relating to elections and declaring an emergency.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 116.025 is amended to read as follows:

- 4 (1) Every person who is a *citizen of the United States, a* resident of this state, and *a*
5 *resident of* the precinct in which he or she offers to vote on or before the day
6 preceding the closing of the registration books for any primary, general, or special
7 election, who possesses on the day of any election the qualifications set forth in
8 Section 145 of the Constitution, exclusive of the durational residency requirements,
9 who is not disqualified under that section or under any other statute, and who is
10 registered as provided in this chapter, may vote for all officers to be elected by the
11 people and on all public questions submitted for determination at that election, in
12 the precinct in which he or she is qualified to vote. Any person who shall have been
13 convicted of any election law offense which is a felony shall not be permitted to
14 vote until his or her civil rights have been restored by executive pardon.
- 15 (2) Any person charged with or indicted for a crime, whether or not in custody for
16 same, who has not yet been convicted of the offense and who is not otherwise
17 ineligible to vote, may vote for all offices to be elected by the people and on all
18 public questions submitted for determination at that election, in the precinct in
19 which he or she is qualified to vote.
- 20 (3) A registered voter who changes his or her place of residence from one (1) precinct
21 to another within the same county while the registration books are closed shall be
22 permitted to update the voting records and to vote in the present election at the
23 appropriate precinct for the current address as set forth in KRS 116.085(3).
- 24 (4) Notwithstanding any provision of law to the contrary, any registered voter who
25 changes his or her place of residence from one (1) precinct to another within the
26 same county prior to the closing of the registration books and who fails to transfer
27 his or her registration with the county clerk prior to the date the registration books

1 are closed shall be permitted to vote in the present election at the appropriate
2 precinct for the current address as set forth in KRS 116.085(2).

3 (5) Any registered voter who changes his or her place of residence to a different county
4 while the registration books are closed shall be permitted to vote at the appropriate
5 precinct for his or her former residence in the present election and shall thereafter
6 transfer his or her voter registration.

7 (6) Any registered voter who changes his or her place of residence to a different county
8 and fails to register to vote in the county of current residence prior to the date the
9 registration books are closed shall not be eligible to vote in the present election in
10 the county of current residence or the county of former residence.

11 (7) Any registered voter who changes his or her place of registration to a different state
12 while the registration books are closed in the new state of residence before a
13 presidential election shall be permitted to cast an absentee ballot for President and
14 Vice President only, notwithstanding subsection (1) of this section, by mail or at the
15 county clerk's office of the former residence or other place designated by the county
16 board of elections and approved by the State Board of Elections.

17 ➔Section 2. KRS 116.065 is amended to read as follows:

18 Each application for registration, change of affiliation, transfer of registration, federal
19 provisional ballot,~~or~~ absentee ballot, or federal provisional absentee ballot, as absentee
20 ballots and federal provisional absentee ballots are provided for by Section 3 of this Act,
21 KRS 117.077, KRS 117.085, and KRS 117.229 shall be verified by a written declaration
22 by the applicant that it is made under the penalties of perjury.

23 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 117 IS CREATED TO
24 READ AS FOLLOWS:

25 (1) Any voter who is qualified to vote on election day in the county of his or her
26 residence may choose to cast a no-excuse in-person absentee ballot on the
27 Thursday, Friday, or Saturday immediately preceding the day of an election. The

1 available hours from which a voter may cast his or her vote during these three (3)
2 days shall be no less than eight (8) hours between 6 a.m. and 8 p.m. prevailing
3 time, as determined by the county board of elections of each county.

4 (2) Any voter who is qualified to vote on election day in the county of his or her
5 residence may make application to cast an excused in-person absentee ballot
6 during normal business hours during the seven (7) business days immediately
7 preceding the Thursday of no-excuse in-person absentee voting under subsection
8 (1) of this section. The voter who makes application under this subsection shall
9 meet one (1) of the following requirements in order to cast his or her excused in-
10 person absentee ballot:

11 (a) Is a resident of Kentucky who is a covered voter as defined in KRS
12 117A.010, who will be absent from the county of his or her residence on the
13 day of an election and during the days of no-excuse in-person absentee
14 voting;

15 (b) Has surgery, or whose spouse has surgery, scheduled that will require
16 hospitalization on the day of an election and during the days of no-excuse
17 in-person absentee voting;

18 (c) Temporarily resides outside the state, but is still eligible to vote in this state
19 and will be absent from the county of his or her residence on the day of an
20 election and during the days of no-excuse in-person absentee voting;

21 (d) Is a resident of Kentucky who is a uniformed-service voter as defined in
22 KRS 117A.010 confined to a military base on election day and during the
23 days of no-excuse in-person absentee voting;

24 (e) Is in her last trimester of pregnancy and the voter completes the form that is
25 prescribed by the State Board of Elections, which contains a sworn
26 statement that the voter is in her last trimester of pregnancy at the time she
27 wishes to vote;

- 1 (f) Has not been declared mentally disabled by a court of competent
2 jurisdiction and, due to age, disability, or illness, is not able to appear at the
3 polls on election day and during the days of no-excuse in-person absentee
4 voting;
- 5 (g) Is a student who temporarily resides outside the county of his or her
6 residence and will be absent from the county of his or her residence on the
7 day of an election and during the days of no-excuse in-person absentee
8 voting; or
- 9 (h) Any person employed in an occupation that is scheduled to work during all
10 days and all hours, which shall include commute time, the polls are open on
11 election day and during the days of no-excuse in-person absentee voting.
- 12 (3) Any voter who votes an in-person absentee or federal provisional in-person
13 absentee ballot shall provide proof of identification as defined in KRS 117.001 or
14 meet the requirements of KRS 117.228 or 117.229.
- 15 (4) In-person absentee voting shall be conducted in a location within the county
16 clerk's office where ballots shall be cast secretly. In-person absentee voting may
17 occur in another location within the county if the location is designated by the
18 county board of elections and approved by the State Board of Elections. The
19 county clerk may provide for voting by the voting equipment in general use in the
20 county or any other voting equipment approved by the State Board of Elections
21 for use in Kentucky. Public notice of the locations shall be given pursuant to KRS
22 Chapter 424, and similar notice by mail shall be given to the county chairs of the
23 two (2) political parties whose candidates polled the largest number of votes in
24 the county at the last regular election.
- 25 (5) Any voter qualifying to vote who receives assistance to vote in-person absentee
26 shall complete the voter assistance form required by KRS 117.255.
- 27 (6) Any voter qualifying to vote whose qualifications are challenged on grounds

- 1 other than inability to provide proof of identification by any clerk or deputy shall
2 complete an oath of voter affidavit.
- 3 (7) Each voter casting his or her vote in-person absentee shall sign an in-person
4 absentee ballot signature roster.
- 5 (8) The members of the county board of elections, or their designees who provide
6 equal representation of both political parties, may serve as precinct election
7 officers, without compensation, for all in-person absentee voting conducted. If
8 the members of the county board of elections or their designees serve as precinct
9 election officers for in-person absentee voting, they shall perform the same duties
10 and exercise the same authority as precinct election officers who serve on the day
11 of an election. If the members of the county board of elections or their designees
12 do not serve as precinct election officers for in-person absentee voting, the county
13 clerk or deputy county clerks shall supervise the in-person absentee voting.
- 14 (9) Any individual qualified to appoint challengers for the day of an election may
15 also appoint challengers to observe all in-person absentee voting, and those
16 challengers may exercise the same privileges as challengers appointed for
17 observing voting on the day of an election at a regular polling place.
- 18 (10) During the days of in-person absentee voting, all voting equipment on which in-
19 person absentee ballots are cast shall remain locked and the keys shall be
20 retained by at least three (3) members of the central ballot counting board if one
21 is appointed, or by three (3) members of the county board of elections, and the
22 voting equipment shall remain locked with a tamper-resistant seal until the
23 ballots are counted.
- 24 (11) No person shall transmit or publicize any tallies or counts of in-person absentee
25 ballots, or any partial results, to any person except those persons, election
26 officials, or entities authorized by law to receive it, until 6 p.m. prevailing time on
27 the day of a primary or an election.

- 1 (12) (a) Before and after each day of in-person absentee voting, on all voting
2 equipment to be used, the tamper-resistant seal shall be checked to ensure it
3 is unaltered and the number on the public counter shall be read and
4 recorded. The status of the tamper-resistant seal shall be indicated and the
5 number on the public counter of each voting equipment shall be recorded
6 by the county clerk or his or her designated election official, member of the
7 county board of elections, or member of the central ballot counting board.
8 The status of the tamper-resistant seal and the number recorded from the
9 public counter shall be witnessed by an election official who is of a different
10 political affiliation than the person recording;
- 11 (b) The status of the tamper-resistant seal and the number on the public
12 counter shall be recorded on a form prescribed and furnished by the State
13 Board of Elections pursuant to administrative regulations promulgated
14 under KRS Chapter 13A;
- 15 (c) The witness who is present shall verify, through validity of his or her
16 signature on the form provided, the accuracy of the number recorded from
17 the public counter, the number recorded on the prescribed form, and the
18 status of the tamper-resistant seal;
- 19 (d) Any irregularities observed by the election official who is recording and the
20 election official who is a witness shall be immediately reported to the county
21 attorney or the Office of Attorney General.

22 (13) The State Board of Elections shall promulgate administrative regulations under
23 KRS Chapter 13A to provide for the casting of ballots in accordance with this
24 section.

25 ➔Section 4. KRS 117.025 is amended to read as follows:

- 26 (1) The State Board of Elections shall appoint an executive director, who shall be the
27 chief administrative officer for the board. The board shall also appoint an assistant

1 director, who shall be of a different political party than the director. The salaries of
2 the director and the assistant director shall be set by the board.

3 (2) The State Board of Elections shall employ, on a bipartisan basis, a staff sufficient to
4 carry out the duties assigned to the board, including legal counsel and a training
5 officer to provide assistance to the county clerks and the county boards of elections
6 in their training of precinct election officers.

7 (3) The board shall:

8 (a) Maintain a complete roster of all qualified registered voters within the state by
9 county and precinct, and institute appropriate safeguards to ensure that there is
10 no inappropriate use of the voter registration roster. State and local election
11 officials, including the Secretary of State, employees of the Secretary, and
12 members of the State Board of Elections and their staff, shall only use the
13 voter registration roster for purposes relevant to their prescribed duties of
14 election administration. The Secretary of State, and two (2) employees of the
15 Secretary, who may be designated by the Secretary with explicit written
16 authority and notification to the board, shall have electronic access to the
17 information contained within the voter registration roster, but shall not
18 correct, alter, or delete information from the voter registration roster, unless
19 having obtained prior approval by a majority of the voting members of the
20 board;

21 (b) For each primary, furnish each county clerk with a master list of all registered
22 voters in the county, together with three (3) signature rosters of all registered
23 voters in each precinct of the county according to party affiliation, and two (2)
24 lists of all registered voters in each precinct of the county at least six (6)~~five~~
25 ~~(5)~~ days prior to each primary;

26 (c) For each regular election, furnish each county clerk with a master list of all
27 registered voters in the county, together with one (1) signature roster of all

1 registered voters in each precinct of the county on which each voter's party
2 affiliation is identified, and two (2) lists of all registered voters in each
3 precinct of the county at least six (6)~~five (5)~~ days prior to each regular
4 election;

5 (d) Maintain all information furnished to the board relating to the inclusion or
6 deletion of names from the rosters for four (4) years;

7 (e) Furnish, at a reasonable price, the state central executive committee of each
8 political party qualifying under KRS 118.015 monthly data of all additions,
9 deletions and changes of registration in each precinct of each county and the
10 state central executive committee shall furnish a county listing to each of the
11 county executive committees of each political party;

12 (f) Purchase, lease or contract for the use of equipment necessary to properly
13 carry out its duties under the provisions of this chapter and KRS Chapters 116
14 and 118;

15 (g) Secure information from any source which may assist the board in carrying
16 out the purposes of this section;

17 (h) Furnish at a reasonable price any and all precinct lists to duly qualified
18 candidates, political party committees or officials thereof, or any committee
19 that advocates or opposes an amendment or public question. The State Board
20 of Elections may also furnish the precinct lists to other persons at the board's
21 discretion, at a reasonable price to be determined by the board. The board
22 shall not furnish precinct lists to persons who intend to use the lists for
23 commercial use; and

24 (i) Be responsible for oversight of board personnel, including hiring,
25 investigations, disciplinary actions, promotions, and other like actions subject
26 to KRS Chapter 18A.

27 ➔Section 5. KRS 117.066 is amended to read as follows:

- 1 (1) The county board of elections may, pursuant to KRS 117.055 and subsection (3) of
2 this section, designate a single voting location for more than one (1) precinct if the
3 voting location is equipped with voting equipment capable of providing or
4 accepting separate ballots without endangering the integrity of the ballots or without
5 violating any other election law.
- 6 (2) If a single voting location for more than one (1) precinct is approved under
7 subsection (3) of this section, the primary or election shall be conducted as follows:
- 8 (a) One (1) voting equipment may be used for more than one (1) precinct if
9 ballots are tabulated for each separate precinct, and if separate ballots may be
10 placed upon any voting equipment to be used without endangering the
11 integrity of the ballots or without violating any other election law. Otherwise,
12 separate voting equipment shall be used for each precinct. In the instance of a
13 precinct which has a small number of voters such that the use of separate
14 voting equipment would be cost-prohibitive, the county clerk may make
15 application to the State Board of Elections to use supplemental paper ballots
16 under KRS 118.215 to conduct the voting for the small precinct on any
17 primary or election day. If the use of supplemental paper ballots is approved
18 by the State Board of Elections, at the close of voting on any primary or
19 election day, the locked supplemental paper ballot box shall be transported to
20 the county board of elections along with the federal provisional ballot
21 receptacle, and ballots shall be counted by the county board of elections as
22 provided by KRS 117.275(10) to ~~(16)~~~~(14)~~;
- 23 (b) Separate precinct voter rosters shall be maintained for each precinct, and steps
24 shall be taken to ensure that voters cast their ballot in their duly authorized
25 precinct; and
- 26 (c) A separate set of election forms and reports required by this chapter and the
27 State Board of Elections shall be maintained for each precinct.

- 1 (3) The county board of elections may petition the State Board of Elections to allow the
2 consolidation of precincts and the consolidation of precinct election officers at any
3 voting location where voters of more than one (1) precinct vote. The petition shall
4 be on a form prescribed by the State Board of Elections in administrative
5 regulations promulgated under KRS Chapter 13A and shall include:
- 6 (a) A list of all precincts designated to vote at the voting location;
 - 7 (b) The address and type of facility of the voting location;
 - 8 (c) The number and type of voting systems or voting equipment to be used at the
9 voting location;
 - 10 (d) The number of registered voters in each precinct designated to vote at the
11 voting location;
 - 12 (e) An explanation of the reasons why the consolidation is desirable;
 - 13 (f) The plan for additional precinct officers at the voting location, the manner in
14 which they will be assigned, and whether the voting location will be fully
15 staffed with election officials;
 - 16 (g) The plan for how the county clerk will publicize the location for where the
17 voting shall occur, in addition to how each location shall be noted
18 conspicuously to residents of the county as a "Vote Center"; and
 - 19 (h) The plan for how the voting location will serve as a focal point to meet the
20 needs of a diverse community.
- 21 (4) If the petition submitted under subsection (3) of this section is approved by the State
22 Board of Elections, the precinct election officers designated to serve as election
23 officers for more than one (1) precinct shall meet the eligibility requirements of
24 KRS 117.045.

25 ➔Section 6. KRS 117.079 is amended to read as follows:

26 The provisions of Section 3 of this Act, KRS 117.085, 117.086, and Chapter 117A
27 notwithstanding, the State Board of Elections shall, as circumstances warrant and with the

1 concurrence of the Attorney General, promulgate necessary administrative regulations to
2 preserve the absentee voting rights of residents of Kentucky who are covered voters as
3 defined in KRS 117A.010.

4 ➔Section 7. KRS 117.085 is amended to read as follows:

- 5 (1) (a) All requests for a mail-in absentee ballot shall be requested through a secure
6 online portal established by the State Board of Elections, except for:
- 7 1. Voters identified in KRS 117.077;
 - 8 2. Disabled voters; and
 - 9 3. Covered voters in paragraph (i) of this subsection;
- 10 who have the additional option of requesting a mail-in absentee ballot
11 application through the county clerk.
- 12 (b) Acquiring a mail-in absentee ballot by means of the online portal shall require
13 the voter to input personally identifiable information for verification.
- 14 (c) For those voters who do not have the means of accessing the online portal, the
15 county clerk shall fulfill a request for a mail-in absentee ballot by taking the
16 voter's information over the telephone or in person and directly inputting that
17 information into the secure online portal.
- 18 (d) The online portal shall have the capacity to ensure the identity of the voter
19 through proof of identification as required under KRS 117.227 or by means of
20 KRS 117.228.
- 21 (e) If a voter qualifies to receive a mail-in absentee ballot, the online portal shall
22 transmit the mail-in absentee ballot request to the county clerk of the county in
23 which the voter is registered to vote.
- 24 (f) The online portal shall not be open or permit any mail-in ballot requests to
25 occur more than forty-five (45) days immediately preceding the day of a
26 primary or an election. The online portal shall close at 11:59 p.m. local time,
27 fourteen (14) days immediately preceding the day of a primary or an election.

1 (g) Except as otherwise provided in KRS 117.077, the mail-in absentee ballot
2 may be requested by the voter or the spouse, parents, or children of the voter,
3 but shall be restricted to the use of the voter.

4 (h) Except as otherwise provided in KRS 117.077 and covered voters in
5 paragraph (i) of this subsection, a qualified voter may apply to cast his or her
6 vote by mail-in absentee ballot if the completed application is received
7 fourteen (14) days before the election, and if the voter is:

- 8 1. A resident of Kentucky who is a covered voter as defined in KRS
9 117A.010;
- 10 2. A student who temporarily resides outside the county of his or her
11 residence;
- 12 3. Incarcerated in jail and charged with a crime, but has not been convicted
13 of the crime;
- 14 4. Changing or has changed his or her place of residence to a different state
15 while the registration books are closed in the new state of residence
16 before an election of electors for President and Vice President of the
17 United States, in which case the voter shall be permitted to cast a mail-in
18 absentee ballot for electors for President and Vice President of the
19 United States only;
- 20 5. Temporarily residing outside the state but still eligible to vote in this
21 state;
- 22 6. Prevented from voting in person at the polls on election day and from
23 casting an excused or no-excuse in-person absentee ballot on all days
24 in-person absentee voting is conducted because he or she will~~his or her~~
25 ~~employment location requires him or her to~~ be absent from the county
26 of his or her residence all hours and all days excused or no-excuse in-
27 person absentee voting is conducted;

- 1 7. A participant in the Secretary of State's crime victim address
2 confidentiality protection program as authorized by KRS 14.312; or
- 3 8. Not able to appear at the polls on election day or the days **excused or**
4 **no-excuse** in-person absentee voting is conducted on the account of age,
5 disability, or illness, and who has not been declared mentally disabled by
6 a court of competent jurisdiction.
- 7 (i) Residents of Kentucky who are covered voters as defined in KRS 117A.010
8 may apply for a mail-in absentee ballot by means of the federal post-card
9 application, which may be transmitted to the county clerk's office by mail, by
10 facsimile machine, or by means of the electronic transmission system
11 established under KRS 117A.030(4). The federal post-card application may be
12 used to register, reregister, and to apply for a mail-in absentee ballot. If the
13 federal post-card application is received at any time not less than seven (7)
14 days before the election, the county clerk shall affix his or her seal to the
15 application form upon receipt.
- 16 (j) Any **qualified** voter who is disabled may use an accessible mail-in absentee
17 ballot portal to request **and receive** a mail-in absentee ballot **by means of an**
18 **electronic transmission system as established under KRS 117A.030(4).**~~[.]~~
19 The standards **necessary to implement this paragraph**~~[of which]~~ shall be set
20 by the State Board of Elections pursuant to administrative regulations
21 promulgated under KRS Chapter 13A.
- 22 (2) ~~In person absentee voting shall be conducted in the county clerk's office or other~~
23 ~~place designated by the county board of elections and approved by the State Board~~
24 ~~of Elections during normal business hours on the Thursday, Friday, and Saturday~~
25 ~~immediately preceding the day of a primary or an election. Any voter who is~~
26 ~~qualified to vote on election day in the county of his or her residence may choose to~~
27 ~~cast an in-person absentee ballot while in-person absentee voting is being conducted~~

1 ~~during the days listed in this subsection. The voter who elects to vote in person~~
2 ~~absentee shall provide proof of identification as defined in KRS 117.001 or meet~~

4 ~~(3) The members of the county board of elections or their designees who provide equal~~
5 ~~representation of both political parties may serve as precinct election officers,~~
6 ~~without compensation, for all in-person absentee voting conducted. If the members~~
7 ~~of the county board of elections or their designees serve as precinct election officers~~
8 ~~for in-person absentee voting, they shall perform the same duties and exercise the~~
9 ~~same authority as precinct election officers who serve on the day of an election. If~~
10 ~~the members of the county board of elections or their designees do not serve as~~
11 ~~precinct election officers for in-person absentee voting, the county clerk or deputy~~
12 ~~county clerks shall supervise the in-person absentee voting.~~

13 ~~(4) Any individual qualified to appoint challengers for the day of an election may also~~
14 ~~appoint challengers to observe all in-person absentee voting, and those challengers~~

16 ~~the day of an election at a regular polling place.~~

17 ~~(5) For those voters who are eligible to receive a mail-in absentee ballot by means~~
18 ~~other than the secure online portal pursuant to subsection (1) of this section, the~~
19 ~~county clerk shall type the name of the voter permitted to vote by mail-in absentee~~
20 ~~ballot on the mail-in absentee ballot application for that person's use and no other.~~
21 The mail-in absentee ballot application shall be in the form prescribed by the State
22 Board of Elections, which shall include the voter affirmation form as prescribed in
23 KRS 117.228(1)(c) and shall contain the following information: name, residential
24 address, precinct, party affiliation, statement of the reason the person cannot vote in
25 person on election day, statement of where the voter shall be on election day,
26 statement of compliance with residency requirements for voting in the precinct, an
27 instructional statement prescribing the requirements for providing a copy of the

1 voter's proof of identification or voter affirmation when applicable, and the voter's
2 mailing address for a mail-in absentee ballot. The mail-in absentee ballot
3 application form shall be verified and signed by the voter, and the voter shall
4 provide a copy of his or her proof of identification, as defined in KRS 117.001, or
5 the executed voter affirmation as described in KRS 117.228(1)(c). A notice of the
6 actual penalty provisions in KRS 117.995(2) and (5) shall be printed on the mail-in
7 absentee ballot application form.

8 ~~(3)~~~~(6)~~ For those voters eligible to receive a mail-in absentee ballot, if the county
9 clerk finds that the voter has completed and submitted an application for a mail-in
10 absentee ballot as provided in this section, is properly registered as stated in his or
11 her mail-in absentee ballot application, and qualifies to receive a mail-in absentee
12 ballot by mail, the county clerk shall mail to the voter a mail-in absentee ballot, two
13 (2) official envelopes for returning the mail-in absentee ballot, and instructions for
14 voting.

15 ~~(4)~~~~(7)~~ Mail-in absentee ballots shall be mailed to a voter's residential address located
16 in the county in which the voter is registered, except for:

- 17 (a) Qualified voters who apply pursuant to the requirements of subsection (1)(h)1.
18 to ~~5~~~~(6)~~ of this section; or
19 (b) Qualified voters covered under KRS 117.077.

20 ~~(5)~~~~(8)~~ The county clerk shall:

- 21 (a) Transmit a mail-in absentee ballot to the voter who is eligible to receive a
22 mail-in absentee ballot within four (4) days of receipt or within four (4) days
23 of the ballots being available;
24 (b) Cause mail-in absentee ballots to be printed fifty (50) days prior to each
25 primary or regular election, and forty-five (45) days prior to a special election;
26 and
27 (c) Complete a postal form for a certificate of mailing for mail-in absentee ballots

1 mailed within the fifty (50) states, and it shall be stamped by the postal service
2 when the mail-in absentee ballots are mailed. Unless a postal form for a
3 certificate of mailing is required, the county clerk may use methods of
4 tracking the mail-in absentee ballots by means of a printed barcode or other
5 label that is unique to the individual voter issued by the State Board of
6 Elections pursuant to administrative regulations promulgated under KRS
7 Chapter 13A.

- 13 (5) If the county clerk determines that the number of certified candidates or slates of
14 candidates cannot be placed on a ballot which can be accommodated by the voting
15 equipment currently in use by the county, he or she shall so notify the State Board
16 of Elections not later than the last Tuesday in February preceding the primary or the
17 last Tuesday in August preceding the regular election. The State Board of Elections
18 shall meet within five (5) days of the notice, review the ballot conditions, and
19 determine whether supplemental paper ballots are necessary for the election. Upon

8 ➔Section 22. Whereas, it is critically important to protect the integrity and
9 reliability of the electoral process in order to safeguard the fundamental right to vote, and
10 it is a reasonable legislative task to seek improvement and modernization of election
11 procedures without undue delay in notice to the people of the Commonwealth and its
12 election officials tasked with administering the election laws within this state, an
13 emergency is declared to exist, and this Act takes effect upon its passage and approval by
14 the Governor or upon its otherwise becoming a law.
