3	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
4	→SECTION 1. A NEW SECTION OF KRS CHAPTER 210 IS CREATED TO
5	READ AS FOLLOWS:
6	(1) As used in this section:
7	(a) "Cabinet" means the Cabinet for Health and Family Services;
8	(b) "CMHC" means a Community Mental Health Center;
9	(c) "Fund" means the mobile crisis services fund; and
10	(d) "Mobile unit" means any vehicle by which a CMHC uses to travel within its
11	region to provide community services for Kentuckians who experience
12	issues with mental health, developmental and intellectual disabilities, and
13	substance use disorder.
14	(2) (a) The mobile crisis services fund is hereby established within the cabinet to
15	provide loans to CMHCs for:
16	1. Increasing access to mental health services; and
17	2. Providing services to individuals who lack sufficient access to
18	transportation and who are:
19	a. Residing in rural areas;
20	b. Residing in homeless shelters; or
21	c. Disadvantaged mentally, physically, or economically.
22	(b) Any loan issued by the cabinet shall not exceed a five (5) year term and the
23	interest rate shall not exceed one percent (1%).
24	(3) The cabinet shall:
25	(a) Determine the terms and conditions of each loan, including the repayment
26	to be deposited back in the fund for issuance of future loans to other
27	CMHCs;

1	(f) Interest earned on any moneys in the fund shall accrue to the fund.
2	(g) Moneys deposited in the fund are hereby appropriated for the sole purpose
3	of providing loans to CMHCs.
4	(6) The Cabinet for Health and Family Service may promulgate administrative
5	regulations in accordance with KRS Chapter 13A to implement this section.
6	→ Section 2. There is hereby appropriated General Fund moneys in the amount of
7	\$2,800,000 in fiscal year 2022-2023 and \$3,500,000 in fiscal year 2023-2024 to the
8	mobile crisis services fund.
9	→ Section 3. Whereas the General Assembly desires to ensure that citizens of the
10	Commonwealth have access to quality and reliable healthcare services, an emergency is
11	declared to exist, and this Act takes effect upon its passage and approval by the Governor
12	or upon its otherwise becoming a law.
