

1 AN ACT relating to reorganization.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 42 IS CREATED TO  
4 READ AS FOLLOWS:

5 *(1) The Office of Fleet Management established in Section 2 of this Act shall be*  
6 *generally responsible for all technical and administrative services related to the*  
7 *Commonwealth's fleet of vehicles, including but not limited to:*

8 *(a) Procuring vehicles;*

9 *(b) Maintaining and repairing vehicles;*

10 *(c) Reserving, assigning, and distributing vehicles;*

11 *(d) Reporting fleet mileage; and*

12 *(e) Performing any additional administrative functions and duties the secretary*  
13 *may assign.*

14 *(2) There shall be established in the Office of Fleet Management the following*  
15 *divisions which shall be headed by a division director who shall report to the*  
16 *executive director of the Office of Fleet Management:*

17 *(a) Division of Maintenance; and*

18 *(b) Division of Operations and Administration.*

19 *(3) The division directors appointed under this section shall be appointed by the*  
20 *secretary with the approval of the Governor under KRS 12.050. There may be, if*  
21 *needed, sections assigned to specific areas of work, responsible directly to the*  
22 *executive director of the Office of Fleet Management.*

23 ➔Section 2. KRS 42.0145 is amended to read as follows:

24 (1) The Office of the Secretary of the Finance and Administration Cabinet shall consist  
25 of the Office of Inspector General, Office of General Counsel, Office of  
26 Administrative Services, Office of Legislative and Intergovernmental Affairs,  
27 Office of Policy and Audit,~~and~~ Office of Equal Employment Opportunity and

1 Contract Compliance, and Office of Fleet Management, each headed by an  
2 executive director who shall be appointed by the secretary with the approval of the  
3 Governor. The Office of the Secretary shall include a deputy secretary who shall be  
4 appointed by the secretary with the approval of the Governor. The deputy secretary  
5 shall be responsible to and have such authority to sign for the secretary as the  
6 secretary designates in writing.

7 (2) The secretary may organize the office into such additional administrative units as he  
8 deems necessary to perform the functions and fulfill the duties of the cabinet,  
9 subject to the provisions of KRS Chapter 12.

10 (3) All appointments under this chapter to positions not in the classified service shall be  
11 made pursuant to KRS 12.050, and such appointees shall be major assistants to the  
12 secretary and shall assist in the development of policy.

13 ➔Section 3. KRS 42.0171 is amended to read as follows:

14 (1) The Office of Administrative Services established in KRS 42.0145 shall be  
15 generally responsible for all internal administrative and human resource functions  
16 of the cabinet, including but not limited to providing administrative assistance;  
17 managing and preparing the cabinet's budget; performing general accounting;  
18 managing fiscal, personnel, and payroll functions of the cabinet; providing  
19 statewide postal and printing services; providing administrative support to boards  
20 and commissions; and performing any additional administrative functions and  
21 duties the secretary may assign.

22 (2) There shall be established in the Office of Administrative Services:

23 (a) The Office of Budget and Fiscal Management, headed by an executive  
24 director who shall report directly to the executive director of the Office of  
25 Administrative Services, and consisting of the:

- 26 1. Division of Budget; and
- 27 2. Division of Fiscal Management; and

1 (b) The following divisions which shall be headed by a division director who  
2 shall report to the executive director of the Office of Administrative Services:

- 3 1. Division of Human Resources; and
- 4 2. Division of Postal Services~~;~~ ~~and~~
- 5 3. ~~Division of Fleet Management~~.

6 (3) Executive directors and division directors appointed under this section shall be  
7 appointed by the secretary with the approval of the Governor under KRS 12.050~~.~~  
8 ~~Each division shall be headed by a division director appointed by the secretary of~~  
9 ~~the Finance and Administration Cabinet~~. There may be, if needed, sections  
10 assigned to specific areas of work, responsible directly to the executive director of  
11 the Office of Administrative Services.

12 ➔Section 4. KRS 12.020 is amended to read as follows:

13 Departments, program cabinets and their departments, and the respective major  
14 administrative bodies that they include are enumerated in this section. It is not intended  
15 that this enumeration of administrative bodies be all-inclusive. Every authority, board,  
16 bureau, interstate compact, commission, committee, conference, council, office, or any  
17 other form of organization shall be included in or attached to the department or program  
18 cabinet in which they are included or to which they are attached by statute or statutorily  
19 authorized executive order; except in the case of the Personnel Board and where the  
20 attached department or administrative body is headed by a constitutionally elected officer,  
21 the attachment shall be solely for the purpose of dissemination of information and  
22 coordination of activities and shall not include any authority over the functions,  
23 personnel, funds, equipment, facilities, or records of the department or administrative  
24 body.

20 transportation fuels as defined in KRS 152.715 to reduce state government's  
21 dependence on petroleum-based transportation fuels, where possible.
- 22 (2) On or before December 1, 2013, and every December 1 thereafter, the cabinet shall  
23 report to the Legislative Research Commission:
  - 24 (a) The strategy for transitioning to motor vehicles outlined in subsection (1) of  
25 this section, including a life-cycle cost comparison, and a projected timetable  
26 to replace motor vehicles in the state motor pool as provided in subsection (1)  
27 of this section; and

- 1 (b) The strategy for increased use of ethanol, cellulosic ethanol, biodiesel, and
- 2 alternative transportation fuels, including the targeted amount and the dates by
- 3 which these targets shall be achieved.
