

1 AN ACT relating to consolidation of the Labor Cabinet and the Education and
2 Workforce Development Cabinet.

3 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

4 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 151B IS CREATED TO
5 READ AS FOLLOWS:

6 *(1) The Education and Labor Cabinet is hereby created, which shall constitute a*
7 *cabinet of the state government within the meaning of KRS Chapter 12. The*
8 *cabinet shall consist of a secretary and those administrative bodies and employees*
9 *as provided by law.*

10 *(2) Subject to KRS Chapter 12, the cabinet shall be composed of the major*
11 *organizational units listed below, units listed in KRS 12.020, and other*
12 *departments, divisions, and sections as are from time to time deemed necessary*
13 *for the proper and efficient operation of the cabinet:*

14 *(a) Office of the Secretary, which shall include the Office of Legal Services, the*
15 *Office of Administrative Services, the Office of Technology Services, the*
16 *Office of Policy and Audit, the Office of Legislative Services, the Office of*
17 *Communications, and the Office of Kentucky Center for Statistics, as*
18 *follows:*

19 *1. The Office of Legal Services shall:*

20 *a. Be headed by an executive director appointed by the secretary*
21 *with the approval of the Governor in accordance with KRS*
22 *12.050 and 12.210; and*

23 *b. Include the Workplace Standards Legal Division, Workforce*
24 *Development Legal Division, and Workers' Claims Legal*
25 *Division, each of which shall be headed by a general counsel*
26 *appointed by the secretary with the approval of the Governor in*
27 *accordance with KRS 12.050 and 12.210; and*

1 2. The following agencies and entities are attached to the Office of the
2 Secretary for administrative purposes only:

3 a. Early Childhood Advisory Council;

4 b. Governor's School for Entrepreneurs Program;

5 c. Governor's Scholar Program;

6 d. Board of the Kentucky Center for Statistics; and

7 e. Foundation for Adult Education;

8 (b) Department of Workers' Claims, which shall be headed by a commissioner
9 appointed by the Governor and confirmed by the Senate in accordance with
10 KRS 342.228. The department shall be divided for administrative purposes
11 into the Office of Administrative Law Judges, the Division of Claims
12 Processing, the Division of Security and Compliance, the Division of
13 Workers' Compensation Funds, and the Division of Specialist and Medical
14 Services. The Office of Administrative Law Judges shall be headed by a
15 chief administrative law judge appointed in accordance with KRS 342.230.
16 Each division in the department shall be headed by a director appointed by
17 the secretary with the approval of the Governor in accordance with KRS
18 12.050. The Workers' Compensation Board shall be attached to the
19 Department of Workers' Claims for administrative purposes only;

20 (c) Department of Workplace Standards, which shall be headed by a
21 commissioner appointed by the Governor in accordance with KRS 12.040
22 and shall be divided for administrative purposes into the Division of
23 Occupational Safety and Health Compliance, the Division of Occupational
24 Safety and Health Education and Training, and the Division of Wages and
25 Hours. Each of these divisions shall be headed by a director appointed by
26 the secretary with the approval of the Governor in accordance with KRS
27 12.050;

- 1 (d) Office of Unemployment Insurance, which shall be headed by an executive
2 director appointed by the Governor in accordance with KRS 12.040;
- 3 (e) Kentucky Unemployment Insurance Commission;
- 4 (f) Department for Libraries and Archives;
- 5 (g) Office of Educational Programs;
- 6 (h) Kentucky Workforce Innovation Board; and
- 7 (i) Department of Workforce Development, which shall be headed by a
8 commissioner appointed by the Governor in accordance with KRS 12.040
9 who shall report to the secretary. Each office or division in the department
10 shall be headed by an executive director or director appointed by the
11 secretary with the approval of the Governor in accordance with KRS 12.050.
12 The department shall be composed of the following offices:
- 13 1. Career Development Office;
- 14 2. Office of Vocational Rehabilitation;
- 15 3. Office of Employer and Apprenticeship Services;
- 16 4. Office of Adult Education;
- 17 5. Kentucky Apprenticeship Council, which shall be attached to the
18 department for administrative purposes only;
- 19 6. Division of Technical Assistance; and
- 20 7. Office of the Kentucky Workforce Innovation Board.
- 21 (3) The following agencies are attached to the cabinet for administrative purposes
22 only:
- 23 (a) Kentucky Occupational Safety and Health Review Commission;
- 24 (b) State Labor Relations Board;
- 25 (c) Workers' Compensation Funding Commission;
- 26 (d) Kentucky Occupational Safety and Health Standards Board;
- 27 (e) Kentucky Environmental Education Council;

- 1 (f) Kentucky Geographic Education Board;
2 (g) Board of Directors for the Center for School Safety;
3 (h) Kentucky Commission on Proprietary Education;
4 (i) Employers' Mutual Insurance Authority;
5 (j) Workers' Compensation Nominating Committee;
6 (k) Kentucky Commission on the Deaf and Hard of Hearing;
7 (l) Kentucky Educational Television;
8 (m) Kentucky Work Ready Skills Advisory Committee; and
9 (n) Foundation for Adult Education.

10 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 151B IS CREATED TO
11 READ AS FOLLOWS:

12 (1) The secretary of the Education and Labor Cabinet shall be appointed by the
13 Governor pursuant to KRS 12.255 and shall serve at the pleasure of the
14 Governor. The secretary shall have general supervision and direction over all
15 activities and functions of the cabinet and its employees shall be responsible for
16 carrying out the programs and policies of the cabinet. The secretary shall be the
17 chief executive officer of the cabinet and shall have authority to enter into
18 contracts, subject to the approval of the secretary of the Finance and
19 Administration Cabinet, when the contracts are deemed necessary to implement
20 and carry out the programs of the cabinet. The secretary shall have the authority
21 to require coordination and nonduplication of services provided under the federal
22 Workforce Investment Act of 1998, Pub. L. No. 105-220, as amended. The
23 secretary shall have the authority to mandate fiscal responsibility dispute
24 resolution procedures among state organizational units for services provided
25 under the federal Workforce Investment Act of 1998.

26 (2) (a) The secretary of the Education and Labor Cabinet, and the secretary's
27 designated representatives, in the discharge of the duties of the secretary

1 may:

2 1. Administer oaths and affirmations, take depositions, certify official
3 acts, and issue subpoenas to compel the attendance of witnesses and
4 parties and the production of books, papers, correspondence,
5 memoranda, and other records considered necessary and relevant to
6 the matter under investigation;

7 2. Administer oaths;

8 3. Examine witnesses under oath;

9 4. Take verification of proof or written instruments; and

10 5. Take testimony, depositions, and affidavits to carry out any law over
11 which the cabinet has jurisdiction.

12 (b) When a person fails to comply with a cabinet subpoena, the Circuit Court of
13 the county in which the person is found, resides, or has his principal place
14 of business may, upon application of the secretary, his or her representative,
15 or the party requesting the subpoena, issue an order requiring compliance.
16 In any proceeding brought under this section, the Circuit Court having
17 issued the order of compliance may modify or set aside the subpoena.

18 (c) Subpoenas issued under this section may be served by an authorized
19 representative of the cabinet, at any place in the state.

20 (3) The secretary of the Education and Labor Cabinet may delegate any duties of the
21 secretary's office to employees of the cabinet as he or she deems necessary and
22 appropriate, unless otherwise prohibited by statute.

23 (4) The secretary of the Education and Labor Cabinet shall promulgate, administer,
24 and enforce administrative regulations that are necessary to implement programs
25 mandated by federal law, qualify for the receipt of federal funds, and cooperate
26 with other state and federal agencies for the proper administration of the cabinet
27 and its programs, except for programs and federal funds within the authority of

1 the Department of Education, the Kentucky Board of Education, and the
2 Education Professional Standards Board.

3 (5) The secretary of the Education and Labor Cabinet shall have the duties,
4 responsibilities, power, and authority relating to labor, wages and hours,
5 occupational safety and health of employees, child labor, workers' compensation,
6 and all other matters pertaining to Kentucky labor laws and the state's regulation
7 of labor in the Commonwealth.

8 (6) The secretary, in person or by representative, shall:

9 (a) Investigate and ascertain the wages of all employees employed in this state;

10 (b) Enter the place of business or employment of any employer of employees to
11 examine and inspect all books, registers, payrolls, and other records that
12 have a bearing upon the question of wages of employees and to ascertain
13 compliance with the orders of the secretary; and

14 (c) Require from the employer a full and correct statement, in writing when the
15 secretary or the secretary's representative considers it necessary, of the
16 wages paid to all employees of the employer.

17 (7) (a) The secretary of the Education and Labor Cabinet, in person or by
18 representative, may prosecute any violation of any provision of any law
19 which is his or her duty to administer or enforce.

20 (b) 1. The secretary may enter into reciprocal agreements with the
21 corresponding labor agency or official of any other state to collect in
22 the other state claims assigned to the secretary.

23 2. To the extent allowed by a reciprocal agreement, the secretary may
24 maintain actions in the courts of another state to collect claims and
25 judgments for wages and assign claims and judgments to the agency
26 or official of another state for collection.

27 3. If a reciprocal agreement extends a like comity to cases arising in the

1 Commonwealth, the secretary may maintain actions in the courts of
2 the Commonwealth to collect claims and judgments for wages arising
3 in the other state in the same manner and to the same extent that
4 actions are authorized when arising in the Commonwealth.

5 (8) The secretary of the Education and Labor Cabinet shall develop and promulgate
6 administrative regulations that protect the confidential nature of all records and
7 reports of the Office of Unemployment Insurance, the Career Development
8 Office, and the Office of Employer and Apprenticeship Services, which directly or
9 indirectly identify a client or former client and which ensure that these records
10 are not disclosed to or by any person, except if:

11 (a) The person identified gives his or her consent; or

12 (b) Disclosure may be permitted under state or federal law.

13 (9) Notwithstanding any other state statute or administrative regulation to the
14 contrary, any information concerning individual clients or applicants in the
15 possession of the Department of Workforce Development may be shared with any
16 authorized representative of any other state or local governmental agency if the
17 agency has a direct, tangible, and legitimate interest in the individual. The
18 agency receiving the information shall ensure the confidentiality of all
19 information received. The Department of Workforce Development may share
20 information concerning a client or applicant with any private or quasi-private
21 agency if the agency has:

22 (a) An agreement with the cabinet ensuring the confidentiality of the
23 information; and

24 (b) A direct, tangible, and legitimate interest in the individual.

25 (10) The secretary of the Education and Labor Cabinet, with the approval of the
26 Governor, shall appoint necessary deputies, attorneys, statisticians, inspectors,
27 and other employees and fix their salaries according to law. These employees

1 shall receive their actual necessary expenses.

2 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 151B IS CREATED TO
3 READ AS FOLLOWS:

4 (1) The Education and Labor Cabinet shall exercise all administrative functions of
5 the state concerned with employer-employee relationships, including the safety of
6 workers and workers' compensation.

7 (2) The cabinet shall:

8 (a) Promote friendly and cooperative relations between employers and
9 employees;

10 (b) Accumulate and publish industrial statistics and aid and encourage the
11 development of new industries and the expansion of existing industries in
12 Kentucky;

13 (c) Encourage, promote, and develop fair practices, both by employers and
14 employees; discourage and eliminate as far as practicable all unfair
15 practices by employers or employees; and enforce laws relating to unfair
16 practices;

17 (d) Foster, promote, and develop the welfare of both wage earners and
18 industries in Kentucky;

19 (e) Improve working and living conditions of employees, and advance their
20 opportunities for profitable employment; and

21 (f) Inquire into the causes of accidental injuries and occupational diseases
22 arising out of and in the course of employment, and advance measures for
23 the prevention of accidents and occupational diseases and for the
24 improvement of sanitary conditions in places of employment.

25 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 151B IS CREATED TO
26 READ AS FOLLOWS:

27 (1) The Education and Labor Cabinet shall require a national and state criminal

1 background check for every prospective and current employee of the cabinet or its
2 agencies, including contract staff, with access to or use of federal tax
3 information. The criminal background investigation shall include a fingerprint
4 check by the Department of Kentucky State Police and Federal Bureau of
5 Investigation, pursuant to the following requirements:

6 (a) The cabinet shall require each employee with access to or use of federal tax
7 information to submit a complete and legible set of fingerprints to the
8 Department of Kentucky State Police on a fingerprint card issued by the
9 Federal Bureau of Investigation;

10 (b) The Department of Kentucky State Police shall submit the fingerprint card
11 to the Federal Bureau of Investigation for a national criminal background
12 check after a state criminal background check is conducted;

13 (c) The results of a national and state criminal background check shall not be
14 distributed or otherwise released by the cabinet, except that the cabinet:

15 1. Shall provide an employee the results of his or her national and state
16 criminal background check upon request; and

17 2. May introduce the results, under seal, as evidence in a legal
18 proceeding that involves a challenge to any personnel action taken by
19 the cabinet based in whole or in part on information contained in the
20 results; and

21 (d) Any fee charged by the Department of Kentucky State Police or for the
22 Federal Bureau of Investigation background check shall be an amount no
23 greater than the actual cost of processing the request and conducting the
24 background check.

25 (2) The cabinet or its agencies shall promulgate administrative regulations in
26 accordance with this section and KRS Chapter 13A to implement this section.

27 ➔Section 5. KRS 11.065 is amended to read as follows:

- 1 (1) The secretaries of the Justice and Public Safety Cabinet, *the Education and Labor*
 2 *Cabinet*~~[the Education and Workforce Development Cabinet]~~, the Public Protection
 3 Cabinet, the Transportation Cabinet, the Cabinet for Economic Development, the
 4 Cabinet for Health and Family Services, the Finance and Administration Cabinet,
 5 the Energy and Environment Cabinet~~[, the Labor Cabinet]~~, the Tourism, Arts and
 6 Heritage Cabinet, the Personnel Cabinet, the Governor's Executive Cabinet, the
 7 chief information officer, the state budget director, the Governor's chief of staff, and
 8 the Lieutenant Governor shall constitute the Governor's Executive Cabinet. There
 9 shall be a vice chairman appointed by the Governor who shall serve in an advisory
 10 capacity to the Executive Cabinet. The Governor shall be the chairman, and the
 11 secretary of the Finance and Administration Cabinet shall be a second vice
 12 chairman of the Executive Cabinet. The Governor may designate others to serve as
 13 vice chairman.
- 14 (2) The cabinet shall meet not less than once every two (2) months and at other times
 15 on call of the Governor. The Executive Cabinet shall be a part of the Office of the
 16 Governor and shall not constitute a separate department or agency of the state.
 17 Members of the cabinet shall be the major assistants to the Governor in the
 18 administration of the state government and shall assist the Governor in the proper
 19 operation of his office and perform other duties the Governor may require of them.
- 20 (3) The cabinet shall consider matters involving policies and procedures the Governor
 21 or any member may place before it. The cabinet shall advise and consult with the
 22 Governor on all matters affecting the welfare of the state.

23 ➔Section 6. KRS 12.020 is amended to read as follows:

24 Departments, program cabinets and their departments, and the respective major
 25 administrative bodies that they include are enumerated in this section. It is not intended
 26 that this enumeration of administrative bodies be all-inclusive. Every authority, board,
 27 bureau, interstate compact, commission, committee, conference, council, office, or any

1 other form of organization shall be included in or attached to the department or program
2 cabinet in which they are included or to which they are attached by statute or statutorily
3 authorized executive order; except in the case of the Personnel Board and where the
4 attached department or administrative body is headed by a constitutionally elected officer,
5 the attachment shall be solely for the purpose of dissemination of information and
6 coordination of activities and shall not include any authority over the functions,
7 personnel, funds, equipment, facilities, or records of the department or administrative
8 body.

22 development of other disease in children, young people, and adults. To accomplish
23 this objective, KY-ASAP shall work with local media to reach all segments of the
24 community quickly and efficiently;
- 25 (18) Certify to the Governor, the secretary of the Justice and Public Safety Cabinet, and
26 the General Assembly during the budget request process established under KRS
27 Chapter 48 the extent to which each entity receiving state funds has cooperated with

1 the Office of Drug Control Policy and KY-ASAP, coordinated with community

4 (19) Promulgate, with the approval of the secretary of the Justice and Public Safety

8 the proper organization of state government agencies that will provide the greatest
9 coordination of services, and report semiannually to the Legislative Research
10 Commission and Governor on the status of the Office of Drug Control Policy and

5 upon quality of the commodity or service and the ability of the respective agencies
6 to supply the commodity or service within the requested delivery time.

6 area needs and to develop strategies to meet those needs.

7 (4) The fund shall include the following strategies:

8 (a) Statewide initiatives. Funds shall be used to encourage collaboration with
9 other organizations, stimulate development of models of adult education
10 programs that may be replicated elsewhere in the state, provide incentives for
11 adults, employers, and providers to encourage adults to establish and
12 accomplish learning contracts, provide incentives to encourage participation
13 in adult education, assist providers of county and area programs in areas of
14 highest need, and for other initiatives of regional or statewide significance as
15 determined by the cabinet. The Collaborative Center for Literacy
16 Development: Early Childhood through Adulthood created under KRS
17 164.0207 shall evaluate the reading and literacy components of model
18 programs funded under this paragraph.

19 (b) Research and demonstration. The funds shall be used to develop:

- 20 1. Standards for the preparation, professional development, and support for
21 adult educators with the advice of the Office of Adult Education and as
22 compatible with funds provided under Title II of the Federal Workforce
23 Investment Act;
- 24 2. A statewide competency-based certification for transferable skills in the
25 workplace; and
- 26 3. A statewide public information and marketing campaign.

14 Kentucky Transportation Cabinet to the authority.

15 If the authority determines that a county which has previously been certified as a

26 representatives shall be selected by mutual agreement of the president of the
27 Council on Postsecondary Education and the commissioner of education;

- 1 (g) Two (2) adult education instructors selected by the secretary of the Education
2 and Labor~~[Workforce Development]~~ Cabinet;
- 3 (h) Two (2) elementary, two (2) middle, and two (2) high school mathematics
4 teachers, appointed by the board of the statewide professional education
5 association having the largest paid membership with approval from their
6 respective local principals and superintendents of schools; and
- 7 (i) Three (3) school administrators, with one (1) each representing elementary,
8 middle, and high school, appointed by the board of the statewide
9 administrators' association having the largest paid membership with approval
10 from their respective local superintendents of schools.

11 When the Center for Mathematics created under KRS 164.525 becomes operational,
12 the executive director of the center shall be added to the committee, which shall
13 then be composed of twenty-six (26) members. Appointments to the committee
14 shall be made no later than thirty (30) days following March 18, 2005, and the first
15 meeting of the committee shall occur no later than thirty (30) days following
16 appointment of the members.

- 17 (5) A majority of the full membership shall constitute a quorum.
- 18 (6) Each member of the committee, other than members who serve by virtue of their
19 positions, shall serve for a term of three (3) years or until a successor is appointed
20 and qualified, except that the initial appointments shall be made in the following
21 manner: six (6) members shall serve a one (1) year term, six (6) members shall
22 serve a two (2) year term, and eight (8) members shall serve a three (3) year term.
- 23 (7) A temporary chair of the committee shall be appointed prior to the first meeting of
24 the committee through consensus of the president of the Council on Postsecondary
25 Education and the commissioner of education, to serve ninety (90) days after his or

27 chair by majority vote. The temporary chair may be a nominee for the chair by

1 majority vote. Thereafter, a chair shall be elected each calendar year. An individual
2 may not serve as chair for more than three (3) consecutive years. The chair shall be
3 the presiding officer of the committee, and coordinate the functions and activities of

5 (8) The committee shall be attached to the Kentucky Department of Education for
6 administrative purposes. The commissioner of education may contract with a
7 mathematics-trained professional to provide part-time staff support to the
8 committee. The commissioner of education and the president of the council shall
9 reach consensus in the selection of a person to fill the position. The person selected
10 shall have a graduate degree, a mathematics major, and teaching or administrative
11 experience in elementary and secondary education. The person shall not be a current
12 employee of any entity represented on the committee. The department shall provide
13 office space and other resources necessary to support the staff position and the work
14 of the committee.

15 (9) The committee, under the leadership of the chair, may organize itself into
16 appropriate subcommittees and work structures to accomplish the purposes of the
17 committee.

18 (10) Members of the committee shall serve without compensation but shall be
19 reimbursed for necessary travel and expenses while attending meetings at the same
20 per diem rate promulgated in administrative regulation for state employees under
21 provisions of KRS Chapter 45. Funds shall be provided school districts to cover the
22 cost of substitute teachers for those teachers on the committee at each district's
23 established rate for substitute teachers.

24 (11) If a vacancy occurs within the committee during its duration, the board of the
25 statewide professional education association having the largest paid membership or
26 the board of the statewide administrators association having the largest paid
27 membership or the president of the Council on Postsecondary Education, as

1 appropriate, shall appoint a person to fill the vacancy.

2 (12) The committee shall:

3 (a) Present a draft strategic plan addressing the requirements in subsection (1) of
4 this section and other issues that arose during the work of the committee to the
5 Education Assessment and Accountability Review Subcommittee no later than
6 August 2005;

7 (b) Present the strategic plan for improving mathematics achievement to the
8 Interim Joint Committee on Education by July 15, 2006, which shall include
9 any recommendations that require legislative action; and

10 (c) Provide a final written report of committee activities to the Interim Joint
11 Committee on Education and the Legislative Research Commission by
12 December 1, 2006.

13 (13) The committee shall have ongoing responsibility for providing advice and guidance
14 to policymakers in the development of statewide policies and in the identification
15 and allocation of resources to improve mathematics achievement. In carrying out
16 this responsibility, the committee shall periodically review the strategic plan and
17 make modifications as deemed appropriate and report those to the Interim Joint
18 Committee on Education.

19 (14) The committee shall collaborate with the Center for Mathematics to ensure that
20 there is ongoing identification of research-based intervention programs for K-12
21 students who have fallen behind in mathematics, rigorous mathematics curricula
22 that prepare students for the next level of schooling, research-based professional
23 development models that prepare teachers in mathematics and pedagogy, and
24 strategies for closing the gap between high school or a High School Equivalency
25 Diploma program and postsecondary mathematics preparation.

26 ➔Section 74. KRS 158.844 is amended to read as follows:

27 (1) The mathematics achievement fund is hereby created to provide developmentally

1 appropriate diagnostic assessment and intervention services to students, primary
2 through grade 12, to help them reach proficiency in mathematics on the state
3 assessments under KRS 158.6453 and in compliance with the "No Child Left
4 Behind Act of 2001," 20 U.S.C. secs. 6301 et seq., as required under KRS 158.840.

5 (2) The grant funds may be used to support the implementation of diagnostic and
6 intervention services in mathematics. The use of funds may include: pay for
7 extended time for teachers, released time for teachers to serve as coaches and
8 mentors or to carry out other responsibilities needed in the implementation of
9 intervention services, payment of substitute teachers needed for the support of
10 mathematics teachers, purchase of materials needed for modification of instruction,
11 and other costs associated with diagnostic and intervention services or to cover
12 other costs deemed appropriate by the Kentucky Board of Education.

13 (3) The fund shall:

14 (a) Provide funding for the Center for Mathematics created in KRS 164.525 and
15 the costs of training selected teachers in the diagnostic assessment and
16 intervention skills that are needed to assist struggling students in the primary
17 program and other grade levels;

18 (b) Provide renewable, two (2) year local grants to school districts and for
19 purposes described in subsection (2) of this section; and

20 (c) Provide operational funding for the Committee for Mathematics Achievement
21 created in KRS 158.842.

22 (4) Any funds appropriated to the mathematics achievement fund that are specifically
23 designated by the General Assembly to support the Center for Mathematics shall be
24 appropriated to the Council on Postsecondary Education and distributed to the
25 university administering the center, as determined by the council under KRS
26 164.525.

27 (5) Any moneys in the fund at the close of a fiscal year shall not lapse but shall be

1 carried forward to be used for the purposes specified in this section.

2 (6) Any interest earnings of the fund shall become a part of the fund and shall not lapse.

3 (7) (a) Any funds appropriated to the mathematics achievement fund and specifically
4 designated by the General Assembly as funding for grants to local school
5 districts or to support the Committee for Mathematics Achievement shall be
6 administered by the Kentucky Department of Education.

7 (b) The Kentucky Board of Education shall promulgate administrative regulations
8 relating to the grants for local school districts based on recommendations from
9 the Committee for Mathematics Achievement, the secretary of the Education
10 and ~~Labor~~~~Workforce Development~~ Cabinet, the commissioner of education,
11 and the Center for Mathematics established in KRS 164.525. The
12 administrative regulations shall:

- 13 1. Identify eligibility criteria for grant applicants;

- 19 2. Technical assistance to potential applicants and grant recipients;
- 20 3. A list of professional development providers offering teacher training in

12 contract, the denial of a public charter school's request to consider a charter
13 amendment, or the unilateral imposition of conditions, in accordance with the

- 15 (2) A charter applicant or approved public charter school who wishes to appeal a
16 decision of an authorizer concerning a charter application, a charter amendment, or
17 the nonrenewal or revocation of a charter, or the unilateral imposition of conditions,

- 4 (a) Within forty-five (45) days after receipt of the notice of appeal or the making
5 of a motion to review by the state board and after reasonable public notice, the

7 which the proposed public charter school has applied for a charter, shall
8 review the decision of the authorizer and make its findings. If the state board
9 finds that the authorizer's decision was contrary to the best interest of the

11 authorizer with written instructions for reconsideration thereof. The
12 instructions shall include specific recommendations concerning the matters

15 and after reasonable public notice, the authorizer, at a public hearing, shall
16 reconsider its decision and make a final decision;

19 applicant, a second notice of appeal may be filed with the State Board of

14 (4) (a) Within ten (10) days of taking action to approve or deny a charter application
15 that has been remanded back to the authorizer for reconsideration, the
16 authorizer shall notify the state board of the action taken.

17 (b) The authorizer shall provide a report to the charter applicant, the state board,
18 and the Education and Labor~~[Workforce—Development]~~ Cabinet
19 simultaneously and shall include a copy of the resolution adopted by the
20 authorizer's board of directors identifying any action taken, the reason for the
21 decision, and an assurance as to compliance with all of the procedural

24 ➔Section 76. KRS 160.1596 is amended to read as follows:

25 (1) (a) For purposes of this section, a member of the board of directors of a public
26 charter school shall be considered an officer under KRS 61.040 and shall,
27 within sixty (60) days of final approval of an application, take an oath of

1 office as required under KRS 62.010.

2 (b) Within seventy-five (75) days of the final approval of an application, the
3 board of directors and the authorizer shall enter into a binding charter contract
4 that establishes the academic and operational performance expectations and
5 measures by which the public charter school will be evaluated.

6 (c) The executed charter contract shall become the final authorization for the
7 public charter school. The charter contract shall include:

- 8 1. The term of the contract;
- 9 2. The agreements relating to each item required under KRS 160.1592(3)
10 and 160.1593(3), as modified or supplemented during the approval

- 12 3. The rights and duties of each party;

- 17 for:

4 ➔Section 77. KRS 161.011 is amended to read as follows:

5 (1) (a) "Classified employee" means an employee of a local district who is not
6 required to have certification for his position as provided in KRS 161.020; and

7 (b) "Seniority" means total continuous months of service in the local school
8 district, including all approved paid and unpaid leave.

9 (2) The commissioner of education shall establish by January, 1992, job classifications
10 and minimum qualifications for local district classified employment positions which
11 shall be effective July 1, 1992. After June 30, 1992, no person shall be eligible to be
12 a classified employee or receive salary for services rendered in that position unless
13 he holds the qualifications for the position as established by the commissioner of
14 education.

15 (3) No person who is initially hired after July 13, 1990, shall be eligible to hold the
16 position of a classified employee or receive salary for services rendered in such
17 position, unless he holds at least a high school diploma or high school certificate of
18 completion or High School Equivalency Diploma, or he shows progress toward
19 obtaining a High School Equivalency Diploma. To show progress toward obtaining
20 a High School Equivalency Diploma, a person shall be enrolled in a High School
21 Equivalency Diploma program and be progressing satisfactorily through the

24 (4) Local school districts shall encourage classified employees who were initially hired
25 before July 13, 1990, and who do not have a high school diploma or a High School
26 Equivalency Diploma to enroll in a program to obtain a High School Equivalency
27 Diploma.

- 1 (5) Local districts shall enter into written contracts with classified employees. Contracts
2 with classified employees shall be renewed annually except contracts with the
3 following employees:
- 4 (a) An employee who has not completed four (4) years of continuous active
5 service, upon written notice which is provided or mailed to the employee by
6 the superintendent, no later than May 15, that the contract will not be renewed
7 for the subsequent school year. Upon written request by the employee, within

- 19 (6) Local districts shall provide in contracts with classified employees of family
20 resource and youth services centers the same rate of salary adjustment as provided
21 for other local board of education employees in the same classification.
- 22 (7) Nothing in this section shall prevent a superintendent from terminating a classified
23 employee for incompetency, neglect of duty, insubordination, inefficiency,
24 misconduct, immorality, or other reasonable grounds which are specifically
25 contained in board policy.
- 26 (8) The superintendent shall have full authority to make a reduction in force due to
27 reductions in funding, enrollment, or changes in the district or school boundaries, or

- 1 other compelling reasons as determined by the superintendent.
- 2 (a) When a reduction of force is necessary, the superintendent shall, within each
3 job classification affected, reduce classified employees on the basis of
4 seniority and qualifications with those employees who have less than four (4)
5 years of continuous active service being reduced first.
- 6 (b) If it becomes necessary to reduce employees who have more than four (4)
7 years of continuous active service, the superintendent shall make reductions
8 based upon seniority and qualifications within each job classification affected.
- 9 (c) Employees with more than four (4) years of continuous active service shall
10 have the right of recall positions if positions become available for which they
11 are qualified. Recall shall be done according to seniority with restoration of
12 primary benefits, including all accumulated sick leave and appropriate rank
13 and step on the current salary schedule based on the total number of years of
14 service in the district.
- 15 (9) Local school boards shall develop and provide to all classified employees written
16 policies which shall include but not be limited to:
- 17 (a) Terms and conditions of employment;
- 18 (b) Identification and documentation of fringe benefits, employee rights, and
19 procedures for the reduction or laying off of employees; and
- 20 (c) Discipline guidelines and procedures that satisfy due process requirements.
- 21 (10) Local school boards shall maintain a registry of all vacant classified employee
22 positions that is available for public inspection in a location determined by the
23 superintendent and make copies available at cost to interested parties. If financially
24 feasible, local school boards may provide training opportunities for classified
25 employees focusing on topics to include but not be limited to suicide prevention,
26 abuse recognition, and cardiopulmonary resuscitation (CPR). If suicide prevention
27 training is offered it may be accomplished through self-study review of suicide

1 prevention materials.

2 (11) The evaluation of the local board policies required for classified personnel as set out
3 in this section shall be subject to review by the Department of Education while it is
4 conducting district management audits pursuant to KRS 158.785.

5 ➔Section 78. KRS 161.028 is amended to read as follows:

6 (1) The Education Professional Standards Board is recognized to be a public body
7 corporate and politic and an agency and instrumentality of the Commonwealth, in
8 the performance of essential governmental functions. The Education Professional
9 Standards Board has the authority and responsibility to:

10 (a) Establish standards and requirements for obtaining and maintaining a teaching
11 certificate;

12 (b) Set standards for, approve, and evaluate college, university, and school district
13 programs for the preparation of teachers and other professional school
14 personnel. College or university programs may be approved by the board for a
15 college or university with regional institutional level accreditation or national
16 institutional level accreditation that is recognized by the United States
17 Department of Education and is eligible to receive federal funding under 20
18 U.S.C. secs. 1061 to 1063. Program standards shall reflect national standards
19 and shall address, at a minimum, the following:

20 1. The alignment of programs with the state's core content for assessment
21 as defined in KRS 158.6457;

22 2. Research-based classroom practices, including effective classroom

24 3. Emphasis on subject matter competency of teacher education students;

25 4. Methodologies to meet diverse educational needs of all students;

- 1 6. The amount of college-wide or university-wide involvement and support
- 2 during the preparation as well as the induction of new teachers;
- 3 7. The diversity of faculty;
- 4 8. The effectiveness of partnerships with local school districts; and
- 5 9. The performance of graduates on various measures as determined by the
- 6 board;
- 7 (c) Conduct an annual review of diversity in teacher preparation programs;
- 8 (d) Provide assistance to universities and colleges in addressing diversity, which
- 9 may include researching successful strategies and disseminating the
- 10 information, encouraging the development of nontraditional avenues of
- 11 recruitment and providing incentives, waiving administrative regulations
- 12 when needed, and other assistance as deemed necessary;
- 13 (e) Discontinue approval of programs that do not meet standards or whose
- 14 graduates do not perform according to criteria set by the board;
- 15 (f) Issue, renew, revoke, suspend, or refuse to issue or renew; impose
- 16 probationary or supervisory conditions upon; issue a written reprimand or
- 17 admonishment; or any combination of actions regarding any certificate;
- 18 (g) Develop specific guidelines to follow upon receipt of an allegation of sexual
- 19 misconduct by an employee certified by the Education Professional Standards
- 20 Board. The guidelines shall include investigation, inquiry, and hearing

- 7 (j) Submit reports to the Governor and the Legislative Research Commission and
8 inform the public on the status of teaching in Kentucky;
- 9 (k) Devise a credentialing system that provides alternative routes to gaining

- 12 (l) Develop a professional code of ethics;

1 alternative administrator or teacher preparation programs through public or
2 private colleges or universities, private contractors, the Department of
3 Education, or the Kentucky Commonwealth Virtual University and waive
4 administrative regulations if needed in order to implement the program;

5 (p) Grant approval, if appropriate, of a university's request for an alternative
6 program that enrolls an administrator candidate in a postbaccalaureate
7 administrator preparation program concurrently with employment as an
8 assistant principal, principal, assistant superintendent, or superintendent in a
9 local school district. An administrator candidate in the alternative program
10 shall be granted a temporary provisional certificate and shall be a candidate in
11 the Kentucky Principal Internship Program, notwithstanding provisions of
12 KRS 161.030, or the Superintendent's Assessment process, notwithstanding
13 provisions of KRS 156.111, as appropriate. The temporary certificate shall be
14 valid for a maximum of two (2) years, and shall be contingent upon the
15 candidate's continued enrollment in the preparation program and compliance
16 with all requirements established by the board. A professional certificate shall
17 be issued upon the candidate's successful completion of the program,
18 internship requirements, and assessments as required by the board;

19 (q) Employ consultants as needed;

20 (r) Enter into contracts. Disbursements to professional educators who receive less
21 than one thousand dollars (\$1,000) in compensation per fiscal year from the
22 board for serving on an assessment validation panel or as a test scorer or
23 proctor shall not be subject to KRS 45A.690 to 45A.725;

24 (s) Sponsor studies, conduct research, conduct conferences, and publish
25 information as appropriate; and

26 (t) Issue orders as necessary in any administrative action before the board.

27 (2) (a) The board shall be composed of seventeen (17) members. The secretary of the

1 Education and ~~Labor~~~~Workforce Development~~ Cabinet and the president of
2 the Council on Postsecondary Education, or their designees, shall serve as ex
3 officio voting members. The Governor shall make the following fifteen (15)
4 appointments:

- 5 1. Nine (9) members who shall be teachers representative of elementary,
6 middle or junior high, secondary, special education, and secondary

15 board of trustees deems to be a member, except that any person who becomes
16 a member on or after January 1, 2022, and subsequently draws a monthly
17 lifetime retirement allowance, shall upon reemployment after retirement not
18 earn a second retirement account;

19 (m) Employees of the former Cabinet for Workforce Development who are
20 transferred to the Kentucky Community and Technical College System and
21 who occupy positions covered by the Kentucky Teachers' Retirement System
22 shall remain in the Teachers' Retirement System. New employees occupying

- 10 (5) "Present teacher" means any teacher who was a teacher on or before July 1, 1940,
11 and became a member of the retirement system created by 1938 (1st Extra. Sess.)

13 after that date, and any teacher who was a member of a local teacher retirement
14 system in the public elementary or secondary schools of the state on or before July

7 ➔Section 80. KRS 163.470 is amended to read as follows:

8 (1) The executive director shall be appointed by the secretary of the Education and
9 Labor~~[Workforce Development]~~ Cabinet pursuant to KRS 12.050.

10 (2) The office shall be the state agency responsible for all rehabilitation services for the
11 blind and the visually impaired and other services as deemed necessary. The office
12 shall be the agency authorized to expend all state and federal funds designated for
13 rehabilitation services for the blind and visually impaired. The Office of the
14 Secretary of the Education and Labor~~[Workforce Development]~~ Cabinet is
15 authorized as the state agency to receive all state and federal funds and gifts and
16 bequests for the benefit of rehabilitation services for the blind and visually
17 impaired. The State Treasurer is designated as the custodian of all funds and shall
18 make disbursements for rehabilitation purposes upon certification by the executive
19 director.

20 (3) The office shall establish and implement policies and procedures for the carrying
21 out of the program of services for the blind.

22 (4) At the close of each biennium, the office shall prepare a financial report and present
23 it to the secretary of the Education and Labor~~[Workforce Development]~~ Cabinet
24 and to the Governor. The biennial report shall be published. The biennial report
25 shall also contain a precise review of the work of the office and contain necessary
26 suggestions for improvement.

27 (5) The office shall coordinate its functions with other appropriate public and private

1 agencies.

2 (6) The office shall perform all other duties as required of it by law.

3 (7) The executive director shall hire personnel as necessary to carry out the work of the
4 office and the provisions of KRS 163.450 to 163.470. Preference shall be given to
5 hiring qualified blind persons.

6 (8) The Office of Vocational Rehabilitation shall provide intake and rehabilitation
7 counseling services; distribute or sell technical educational and other aids to the
8 blind; provide educational materials such as recorded texts, braille or large-type
9 texts, or such other materials as may be deemed necessary for the education of the
10 blind; research into the development of new technical aids for the blind, mobility
11 training, work evaluation, personal adjustment, independent living, and other
12 services as needed for blind adults, and services for the blind who have other
13 disabilities; and promote employment of the blind in public and private sectors.

14 (9) There shall be established under the authority of the office, to be directed by a
15 director appointed by the secretary pursuant to KRS 12.050, the Division of
16 Kentucky Business Enterprise. This division shall manage and supervise the
17 Vending Facilities Program and license qualified blind persons as vendors. In
18 connection therewith, the office shall be authorized to own or lease vending
19 equipment for the operation of vending facilities in federal, state, private, and other
20 buildings. The set-aside charges levied shall comply with the existing federal
21 regulations as specified in 34 CFR 395.9. One (1) or more facility placement agents
22 shall be employed to locate and establish additional vending facilities. The office
23 shall make such surveys as may be deemed necessary to determine the vending
24 facility opportunities for blind vendors in state buildings or on other property
25 owned, leased, or otherwise occupied by the state government and shall install
26 vending facilities in suitable locations on such property for the use of the blind. All
27 of the net income from vending machines which are on the same property as a

1 vending facility shall be paid to the blind vendor of the vending facility. Whenever
2 there exists a conflict of interest between state agencies seeking to vend
3 merchandise on the same state property, the agencies shall negotiate a fair
4 agreement which shall protect the interest of both from unreasonable competition.
5 The agreement shall be submitted to the custodial authority having jurisdiction over
6 the property for approval. Provided, however, that in all situations the blind vendor
7 shall be permitted to vend all items of merchandise customarily sold at similar
8 vending facilities.

9 (10) The office, at all times, shall be authorized to provide industrial evaluation, training,
10 and employment. The office shall provide staff services which shall include staff
11 development and training, program development and evaluation, and other staff
12 services as may be deemed necessary.

13 (11) The provisions of any other statute notwithstanding, the executive director is
14 authorized to use receipt of funds from the Social Security reimbursement program
15 for a direct service delivery staff incentive program. Incentives may be awarded if
16 case service costs are reimbursed for job placement of Social Security or
17 Supplemental Security Income recipients at the Substantial Gainful Activity (SGA)
18 level for nine (9) months pursuant to 42 U.S.C. sec. 422 and under those conditions
19 and criteria as are established by the federal reimbursement program.

24 of students completing apprenticeship programs; and

26 (c) For each college within the Kentucky Community and Technical College
27 System, the percentage of students employed by program area and, as data

1 becomes available, the rate of students gainfully employed in the recognized
2 occupation for which the student was trained or in a related comparable
3 recognized occupation.

4 (2) The Council on Postsecondary Education shall maintain and ensure access to the
5 information by prospective students in the state. The council shall work with the
6 Kentucky Center for Statistics, the Kentucky Department of Education, the
7 Education and ~~Labor~~~~Workforce Development~~ Cabinet, and the Kentucky Higher
8 Education Assistance Authority and other stakeholders the council determines
9 necessary to develop a delivery method to carry out the objectives of this section.

10 (3) The council may promulgate administrative regulations necessary to carry out this

12 postsecondary institutions identified in subsection (1)(b) of this section.

15 (a) "Category I and Category II square feet" means square footage that falls under
16 space categories as defined by the Postsecondary Education Facilities

19 (b) "Comprehensive university" has the same meaning as in KRS 164.001;

20 (c) "Council" means the Council on Postsecondary Education;

14 integral to the instructional mission of the institution and is identified by the

21 (a) Thirty-five percent (35%) of total university allocable resources shall be
22 distributed based on each university's share of total student success outcomes
23 produced, including but not limited to:

24 1. Bachelor's degree production;

25 2. Bachelor's degrees awarded per one hundred (100) undergraduate full-
26 time equivalent students;

27 3. Numbers of students progressing beyond thirty (30), sixty (60), and

- 1 ninety (90) credit hour thresholds;
- 2 4. Science, technology, engineering, math, and health bachelor's degree
- 3 production; and
- 4 5. Bachelor's degrees earned by low-income students and underrepresented
- 5 minority students;
- 6 (b) Thirty-five percent (35%) of total university allocable resources shall be
- 7 distributed based on each university's share of sector total student credit hours
- 8 earned, excluding dual credit enrollment, weighted to account for cost
- 9 differences by academic discipline and course level, such as lower and upper
- 10 division baccalaureate, master's, doctoral research, and doctoral professional;
- 11 and
- 12 (c) Thirty percent (30%) of total university allocable resources shall be distributed
- 13 in support of vital campus operations as follows:
- 14 1. Ten percent (10%) shall be distributed based on each university's share
- 15 of Category I and Category II square feet, net of research, nonclass
- 16 laboratory, and open laboratory space, to support maintenance and
- 17 operation of campus facilities and may include a space utilization factor
- 18 as determined by the council in collaboration with the working group
- 19 established in subsection (11) of this section;
- 20 2. Ten percent (10%) shall be distributed based on each university's share
- 21 of total instruction and student services spending, net of maintenance
- 22 and operation, to support campus administrative functions; and
- 23 3. Ten percent (10%) shall be distributed based on each university's share
- 24 of total full-time equivalent student enrollment to support academic
- 25 support services such as libraries and academic computing.
- 26 (7) The funding formula for the KCTCS sector:
- 27 (a) Shall distribute one hundred percent (100%) of KCTCS institution allocable

- 1 resources for all KCTCS colleges based on rational criteria, including student
2 success, course completion, and operational support components, regardless
3 of whether state funding for postsecondary institution operations increases,
4 decreases, or remains stable;
- 5 (b) May include an adjustment to account for declining enrollment in some
6 regions of the Commonwealth as determined by the council; and
- 7 (c) Shall be constructed to achieve equilibrium, at which point the funding
8 formula rewards rates of improvement above the sector average rate.
- 9 (8) Funding for the KCTCS sector shall be distributed as follows:
- 10 (a) Thirty-five percent (35%) of total KCTCS institution allocable resources shall
11 be distributed based on each college's share of total student success outcomes
12 produced, including but not limited to:
- 13 1. Certificate, diploma, and associate degree production;
 - 14 2. Numbers of students progressing beyond fifteen (15), thirty (30), and
15 forty-five (45) credit hour thresholds;
 - 16 3. Science, technology, engineering, math, and health credentials
17 production;
 - 18 4. Production of high-wage, high-demand, industry credentials as
19 determined using occupational outlook data and employment statistics

 - 23 5. Production of industry credentials designated as targeted industries by
24 the Education and Labor~~Workforce Development~~ Cabinet;
 - 25 6. Credentials earned by low-income students, underprepared students, and
26 underrepresented minority students; and
 - 27 7. Transfers to four (4) year institutions;

- 1 (b) Thirty-five percent (35%) of total KCTCS institution allocable resources shall
2 be distributed based on each college's share of total student credit hours
3 earned, weighted to account for cost differences by academic discipline; and
- 4 (c) Thirty percent (30%) of total KCTCS institution allocable resources shall be
5 distributed in support of vital campus operations as follows:
- 6 1. Ten percent (10%) shall be distributed based on each college's share of
7 Category I and Category II square feet, net of research, nonclass
8 laboratory, and open laboratory space, to support maintenance and
9 operation of campus facilities and may include a space utilization factor
10 as determined by the council in collaboration with the postsecondary
11 education working group established in subsection (11) of this section;
 - 12 2. Ten percent (10%) shall be distributed based on each college's share of
13 total instruction and student services spending, net of maintenance and
14 operation, to support campus administrative functions; and
 - 15 3. Ten percent (10%) shall be distributed based on each college's share of
16 total full-time equivalent student enrollment to support academic
17 support services such as libraries and academic computing.
- 18 (9) (a) The funding formula for both sectors shall include:
- 19 1. A hold-harmless provision for fiscal year 2018-2019 preventing a
20 reduction in an institution's funding amount based solely on the formula
21 calculation, and allowing a hold-harmless amount determined by the
22 formula in fiscal year 2018-2019 to be deducted from an institution's
23 formula base amount in whole or in part in fiscal years 2019-2020 and
24 2020-2021, as determined by the council;
 - 25 2. A hold-harmless provision for fiscal year 2021-2022, and every fiscal
26 year thereafter, preventing a reduction in an institution's funding amount
27 based solely on the formula calculation;

2 funding to any institution to one percent (1%) of that institution's

15 (a) "Alternative format" means any medium or format for the presentation of
16 instructional materials other than standard print needed by a student with a
17 disability for a reading accommodation, including but not limited to braille,
18 large print texts, audio recordings, digital texts, and digital talking books;

19 (b) "Instructional material" means a textbook or other material published
20 primarily for use by students in a course of study in which a student with a
21 disability is enrolled that is required or essential to a student's success, as
22 determined by the course instructor. "Instructional material" includes
23 nontextual mathematics and science material to the extent that software is
24 commercially available to permit the conversion of the electronic file of the
25 material into a format that is compatible with assistive technologies such as
26 speech synthesis software or braille translation software commonly used by
27 students with disabilities;

- 1 (c) "Nonprinted instructional material" means instructional material in a format
2 other than print, including instructional material that requires the availability
3 of electronic equipment in order to be used as a learning resource, including
4 but not limited to software programs, videodiscs, videotapes, and audio tapes;
- 5 (d) "Printed instructional material" means instructional material in book or other
6 printed form;
- 7 (e) "Publisher" means an individual, firm, partnership, corporation, or other entity
8 that publishes or manufactures instructional material used by students
9 attending a public or independent postsecondary education institution in
10 Kentucky;
- 11 (f) "State Repository for Alternative Format Instructional Materials" or
12 "repository" means a consortium established or otherwise designated by the
13 Council on Postsecondary Education under subsection (8) of this section to
14 serve as a state repository for electronic files or alternative format
15 instructional materials obtained from publishers, created by institutions, or
16 received through other means;
- 17 (g) "Structural integrity" means the inclusion of all of the information provided in
18 printed instructional material, including but not limited to the text of the
19 material sidebars, the table of contents, chapter headings and subheadings,
20 footnotes, indexes, and glossaries, but need not include nontextual elements
21 such as pictures, illustrations, graphs, or charts; and
- 22 (h) "Working day" means a day that is not Saturday, Sunday, or a national
23 holiday.
- 24 (2) The purpose of this section is to ensure, to the maximum extent possible, that all
25 postsecondary students with a disability in Kentucky requiring reading
26 accommodations, in accordance with Section 504 of the Rehabilitation Act, 29
27 U.S.C. sec. 794, or the Americans with Disabilities Act, 42 U.S.C. secs. 12101 et

1 seq., including but not limited to students who are blind, are visually impaired, or
2 have a specific learning disability or other disability affecting reading, shall have
3 access to instructional materials in alternative formats that are appropriate to their
4 disability and educational needs.

5 (3) A publisher shall, upon fulfillment of the requirements of subsections (6) and (7) of
6 this section, provide to a postsecondary education institution or to the State
7 Repository for Alternative Format Instructional Materials, at no cost:

8 (a) Printed instructional material in an electronic format; and

9 (b) Nonprinted instructional material in an electronic format, when the technology
10 is available to maintain the material's structural integrity.

11 (4) Instructional material provided by a publisher in electronic format shall:

12 (a) Maintain the structural integrity of the original instructional material, except
13 as provided for in paragraph (b) subsection (3) of this section;

- 26 b. The job placement rate of program graduates in the field of study
27 and the types of jobs for which graduates are eligible;

- 1 c. Articulation agreements with other postsecondary educational
2 institutions and the rights and responsibilities of students regarding
3 transfer of credits;
- 4 d. The complaint procedures available to students; and
- 5 e. The existence of the student protection fund created in KRS
6 165A.450, and procedures for students to file a claim, including
7 but not limited to the documentation required for submission of a
8 claim;
- 9 3. Quality standards and compliance monitoring schedules of traditional
10 programs, correspondence courses, and Web-based, distance learning
11 courses offered over the Internet;
- 12 4. Advertising requirements for schools issued a license, including no
13 distribution of materials containing untrue, deceptive, or misleading
14 statements and no representation that the commission is an accrediting
15 agency for the school or its programs;
- 16 5. A schedule for reviewing advertisements and recruitment materials and
17 practices of member institutions to ensure compliance with this chapter;
- 18 6. An equitable structure of licensure and renewal fees, to be paid by
19 licensed schools, necessary to carry out the provisions and purposes of

16 (1) Applicants accepted to participate in a certified driver training program shall meet
17 the following minimum vision requirements:

18 (a) A distance visual acuity of 20/200 or better, with corrective lenses, in the
19 applicant's better eye;

20 (b) A visual field of at least one hundred twenty (120) degrees horizontally and
21 eighty (80) degrees vertically in the same eye as used in paragraph (a) of this

8 ➔Section 93. KRS 189.635 is amended to read as follows:

9 (1) The Justice and Public Safety Cabinet, Department of Kentucky State Police, shall
10 be responsible for maintaining a reporting system for all vehicle accidents which
11 occur within the Commonwealth. Such accident reports shall be utilized for such
12 purposes as will improve the traffic safety program in the Commonwealth involving
13 the collection, processing, storing, and dissemination of such data and the
14 establishment of procedures by administrative regulations to ensure that uniform
15 definitions, classifications, and other federal requirements are in compliance.

16 (2) Any person operating a vehicle on the highways of this state who is involved in an
17 accident resulting in fatal or nonfatal personal injury to any person or damage to the
18 vehicle rendering the vehicle inoperable shall be required to immediately notify a
19 law enforcement officer having jurisdiction. In the event the operator fails to notify
20 or is incapable of notifying a law enforcement officer having jurisdiction, such

23 investigate the accident and file a written report of the accident with his or her law
24 enforcement agency.

25 (3) Every law enforcement agency whose officers investigate a vehicle accident of
26 which a report must be made as required in this chapter shall file a report of the

1 investigation of the accident upon forms supplied by the department.

2 (4) Any person operating a vehicle on the highways of this state who is involved in an
3 accident resulting in any property damage exceeding five hundred dollars (\$500) in

18 contained in the reports, shall be confidential and exempt from public

- 20 1. Produced pursuant to a properly executed subpoena or court order; or
- 21 2. Disclosed as provided in this section.

22 (c) Accident reports shall be made available to:

- 23 1. The parties to the accident;
- 24 2. The parents or guardians of a minor who is party to the accident;
- 25 3. Insurers or their written designee for insurance business purposes of any
26 party who is the subject of the report;
- 27 4. The attorneys of the parties to the accident;

- 1 5. Any party to litigation who files with the department a request for the
2 report and includes a copy of the first page of a District or Circuit Court
3 clerk-stamped complaint naming all parties; and
- 4 6. The Department of Workplace Standards in the *Education and* Labor
5 Cabinet if the accident report is pertinent to an occupational safety and
6 health investigation.
- 7 (6) (a) Except as provided for in paragraph (b) of this subsection, the department
8 shall not release accident reports for a commercial purpose.
- 9 (b) Notwithstanding any other provision of this section, the department may, as a
10 matter of public safety, contract with an outside entity and release unredacted
11 vehicle damage data extracted from accident reports to the entity if the data is
12 used solely for the purpose of providing the public a means of determining a
13 vehicle's accident history. The department may further contract with a third
14 party to provide electronic access to reports for persons and entities who are
15 entitled to the reports under subsection (5) of this section.

- 26 (c) A news-gathering organization shall not be held to have used or knowingly
27 allowed the use of the report for a commercial purpose merely because of its

1 publication or broadcast.

2 (d) A request under this subsection shall be completed using a form promulgated
3 by the department through administrative regulations in accordance with KRS
4 Chapter 13A. The form under this paragraph shall include:

- 5 1. The name and address of the requestor and the news-gathering
6 organization the requestor represents;
- 7 2. A statement that the requestor is a news-gathering organization under
8 this subsection and identifying the specific subdivision of paragraph
9 (b)1. of this subsection under which the requester qualifies;
- 10 3. A statement that the request is in compliance with the criteria contained
11 in this section; and
- 12 4. A declaration of the requestor as to the accuracy and truthfulness of the
13 information provided in the request.

14 (e) 1. The department shall redact all personal information from a report prior
15 to making it available to a news-gathering organization as defined under
16 paragraph (b)1.f. of this subsection.

17 2. Reports may be provided to news-gathering organizations as defined
18 under paragraph (b)1.a. to e. of this subsection without redaction.

19 3. For the purposes of this paragraph, "personal information" means:

20 a. The address, driver's license number, phone number, date of birth,
21 and any other contact information contained in the report for each
22 person listed on the report; and

23 b. The vehicle identification numbers (VINs) for each vehicle listed
24 on the report.

25 (9) The motor vehicle insurers of any train engineer or other train crew member
26 involved in an accident on a railroad while functioning in their professional capacity
27 shall be prohibited from obtaining a copy of any accident report filed on the

1 accident under this section without written consent from the individual the company
2 insures. Insurance companies issuing motor vehicle policies in the Commonwealth
3 shall be prohibited from raising a policyholder's rates solely because the
4 policyholder, in his or her professional capacity, is a train engineer or other train

6 (10) For reporting and statistical purposes, motor scooters and autocycles as defined in

10 When federal programs require a particular citizens' council within or attached to the
11 cabinet to include state officials as voting members, the secretary shall, for the specific
12 purposes of those federal programs, be authorized to vote in those council meetings and
13 shall further be authorized to call upon either the secretary of the Cabinet for Health and
14 Family Services, the secretary of the Finance and Administration Cabinet, the chief state
15 school officer, the secretary of the Justice and Public Safety Cabinet, the secretary of the
16 Public Protection Cabinet, the secretary of the Energy and Environment Cabinet, the

26 appropriate, shall develop and implement the Homelessness Prevention Project,
27 which offers institutional discharge planning on a voluntary basis to:

- 1 (a) Persons with serious mental illness, persons between the ages of eighteen (18)
2 and twenty-five (25) who may be at risk of developing serious mental illness
3 who are being released from a mental health facility operated or contracted by
4 the cabinet, or persons with a history of multiple utilizations of health care,
5 mental health care, or judicial systems;
- 6 (b) Persons who are being released after serving out a sentence from any state-
7 operated prison or persons who are being paroled from any state-operated
8 prison; or
- 9 (c) Persons who will be aging out of foster care or who have aged out of foster
10 care.
- 11 (2) The primary goal of the project shall be to prepare a limited number of persons in a
12 foster home under supervision by the Cabinet for Health and Family Services, state-
13 operated prisons under supervision by the Justice and Public Safety Cabinet, and
14 mental health facilities operated or contracted by the Cabinet for Health and Family
15 Services for return or reentry into the community, and to offer information about
16 any necessary linkage of the person to needed community services and supports.
- 17 (a) The project shall be jointly supported by each of the cabinets and managed
18 under the direction of the Cabinet for Health and Family Services, Department
19 for Behavioral Health, Developmental and Intellectual Disabilities, Division
20 of Behavioral Health.
- 21 (b) Subject to sufficient funding as provided by an executive branch budget bill,
22 the Division of Behavioral Health shall select the Homelessness Prevention
23 Project sites. These sites shall be in addition to and integrated with the site
24 located in and serving Jefferson County and the site located in a community
25 mental health center serving Clinton, Cumberland, McCreary, and Wayne
26 Counties.
- 27 (c) Within thirty (30) days of July 15, 2016, the cabinets shall supply the project

1 director at each site with the collection of information on available
2 employment, social, housing, educational, medical, mental health, and other
3 community services in the county. The information shall include but not be
4 limited to the service area of each public and private provider of services, the
5 capacity of each provider to render services to persons served by the project,
6 the fees of each provider, contact names and telephone numbers for each
7 provider, and an emergency contact for each provider.

8 (d) Within thirty (30) days of July 15, 2016, the cabinets and directors shall begin
9 a program of education for each of the cabinet and foster home and mental
10 health and appropriate state-operated prison facility staff who will participate
11 in the development of a discharge plan for volunteer participants under this
12 section.

13 (3) The project shall operate on a voluntary basis. Persons eligible for discharge or
14 completing their sentence or who are being paroled from any state-operated prison
15 shall be offered the opportunity to participate in the project. This offer shall be
16 made at least six (6) months prior to discharge. There shall be a cap on the number
17 of persons served in each Homelessness Prevention Project office, to be determined
18 by available funding and staffing requirements.

19 (a) The staff member designated as the homelessness prevention coordinator for
20 each foster home or mental health facility shall maintain a file for each
21 volunteer participant in the foster home or mental health facility, relating to
22 the participant's employment, social, housing, educational, medical, and
23 mental health needs. This file shall be updated from time to time as
24 appropriate and pursuant to an administrative regulation promulgated by the
25 cabinet in accordance with KRS Chapter 13A that establishes standards for
26 the discharge summary. The staff member designated as the homelessness
27 prevention coordinator for the appropriate state-operated prison participating

1 in the project shall maintain a file containing appropriate forms completed and
2 updated by each person voluntarily participating in the project, relating to the
3 information provided under subsection (6) of this section. All applicable
4 privacy and confidentiality laws shall be followed in assembling and
5 maintaining this file.

6 (b) Six (6) months prior to the expected date of discharge, the discharge
7 coordinator for each foster home and mental health and state-operated prison
8 facility shall contact the homelessness prevention director for the appropriate
9 site where the volunteer participant chooses to locate following discharge
10 about the pending release of the volunteer participant who is eligible for
11 discharge from a foster home or mental health facility, who will have served
12 out his or her sentence in a state-operated prison facility, or who is being
13 paroled from any state-operated prison that is participating in the project. The
14 director shall visit the home or facility, as appropriate, to assist with the
15 preparation of the final comprehensive discharge plan.

16 (c) The homelessness prevention director from the site where the participant
17 chooses to locate and the discharge coordinator for each participating foster
18 home and mental health and state-operated prison facility shall work together
19 to develop a final comprehensive discharge plan that addresses the
20 employment, health care, educational, housing, and other needs of the person
21 to be released, subject to the consent of the person and the funding and
22 staffing capabilities of the director. Information provided by the coordinator
23 may include and be limited to, subject to the staffing and funding capabilities
24 of the coordinator, information provided by the person to be released on a
25 form or forms made available by the foster home or mental health or state-
26 operated prison facility. The discharge plan shall contain but not be limited to
27 the following:

- 1 1. Estimated discharge date from the foster home, state-operated prison
2 facility, or mental health facility, or identification by a social service
3 provider of a person who meets the criteria listed in subsection (1) of
4 this section;
- 5 2. Educational background of the person to be released, including any
6 classes completed or skills obtained by the person while in the foster
7 home, state-operated prison facility, or mental health facility;
- 8 3. The person's medical and mental health needs;
- 9 4. Other relevant social or family background information;
- 10 5. A listing of previous attempts to arrange for post-release residence,
11 employment, medical and mental health services, housing, education,
12 and other community-based services for the person; and
- 13 6. Other available funding and public programs that may reimburse any
14 services obtained from a provider listed in the discharge plan. Every
15 effort shall be made in the discharge plan to refer the person to a
16 provider that has agreed to an arranged public or private funding
17 arrangement.

18 No discharge plan shall be completed unless the written consent, consistent
19 with state and federal privacy laws, to compile the information and prepare the
20 plan has been given by the person eligible for release who has volunteered to
21 participate in the project.

22 (4) The homelessness prevention director from the site where the participant chooses to
23 locate shall assist with the completion of a final comprehensive discharge plan that
24 may include but need not be limited to the following:

- 25 (a) Availability of appropriate housing, including but not limited to a twenty-four
26 (24) month transitional program, supportive housing, or halfway house.
27 Planning discharge to an emergency shelter is not appropriate to meet the

- 1 housing needs of the person being discharged from foster care, a state-
2 operated prison facility, or a mental health facility;
- 3 (b) Access to appropriate treatment services for participants who require follow-
4 up treatment;
- 5 (c) Availability of appropriate employment opportunities, including assessment of
6 vocational skills and job training; and
- 7 (d) Identification of appropriate opportunities to further education.
- 8 (5) Discharge planning shall be individualized, comprehensive, and coordinated with
9 community-based services.
- 10 (a) Each discharge plan shall create a continuous, coordinated, and seamless
11 system that is designed to meet the needs of the person.
- 12 (b) Staff of the foster home or facility and staff of community-based services
13 providers shall be involved in the planning.
- 14 (c) Each facility shall utilize, wherever possible, community-based services
15 within the facility to establish familiarity of the person residing in the facility
16 with the community services.
- 17 (6) The Department of Corrections shall, through an administrative regulation
18 promulgated in accordance with KRS Chapter 13A, develop a discharge plan that
19 addresses the education; employment, technical, and vocational skills; and housing,
20 medical, and mental health needs of a person who is to be released after serving out
21 his or her sentence in a state-operated prison facility participating in the project.
- 22 (7) Appropriate data about discharge placements and follow-up measures shall be
23 collected and analyzed. The analysis shall be included in the interim and final
24 reports of the project specified in subsection (8) of this section.
- 25 (8) Each homelessness prevention director shall have regular meetings with appropriate
26 state cabinet and agency staff to review the project and make recommendations for
27 the benefit of the project. Each director shall be assisted by a local advisory council

1 composed of local providers of services and consumer advocates who are familiar
2 with homelessness prevention issues. Priority for membership on the advisory
3 council shall be given to existing resources and regional mental health and
4 substance abuse advisory councils at the discretion of the director.

5 (9) Each cabinet shall collect data about the discharge plans, referrals, costs of services,
6 and rate of recidivism related to the homelessness prevention project, and shall
7 submit an annual report to the Governor and the Legislative Research Commission
8 no later than October 1 that summarizes the data and contains recommendations for
9 the improvement of the project. The annual report also shall be forwarded to the
10 Kentucky Interagency Council on Homelessness.

11 (10) (a) The Kentucky Interagency Council on Homelessness is hereby established to
12 plan, develop, coordinate, and implement programs for the purpose of
13 improving the well-being of homeless Kentuckians. The council shall be
14 attached to the Homeless and Housing Coalition of Kentucky for
15 administrative purposes.

16 (b) The council shall include but not be limited to the following members:

- 17 1. The secretary of the Cabinet for Health and Family Services;
- 18 2. The executive director of the Homeless and Housing Coalition of
19 Kentucky;
- 20 3. The chief executive officer of the Kentucky Housing Corporation;
- 21 4. The commissioner of the Kentucky Department of Veterans' Affairs;
- 22 5. The secretary of the Justice and Public Safety Cabinet;
- 23 6. The secretary of the Education and Labor~~[Workforce Development]~~
24 Cabinet;
- 25 7. The secretary of the Transportation Cabinet;
- 26 8. The executive director of the Administrative Office of the Courts;
- 27 9. The state budget director;

- 1 10. A representative from the Kentucky Housing Association, representing
2 public housing authorities, appointed by the Governor for a two (2) year
3 term; and
- 4 11. An individual who has previously experienced homelessness and
5 addiction, appointed by the Governor for a two (2) year term.
- 6 (c) The chair of the council shall be appointed by the Governor for a two (2) year
7 term and the vice chair shall be elected by the members of the council for a
8 two (2) year term.
- 9 (d) Members of the council who are not state employees shall be reimbursed for
10 actual expenses incurred in the performance of their duties in accordance with
11 KRS 45.101 and administrative regulations promulgated thereunder.
- 12 (e) The council shall have the following functions and duties:
- 13 1. To serve as the single statewide homeless planning and policy
14 development resource for the Commonwealth of Kentucky;
- 15 2. To review, update, and recommend changes to Kentucky's Ten-Year
16 Plan to End Homelessness and monitor its implementation;
- 17 3. To serve as a state clearinghouse for information on services and
18 housing options for the homeless population;
- 19 4. To conduct other activities as appropriate and necessary; and
- 20 5. To report to the Governor and General Assembly as requested.

21 ➔Section 96. KRS 197.105 is amended to read as follows:

- 22 (1) The department may administer a Prison Industry Enhancement Certification
23 Program (PIECP) and may lease the labor of state prisoners within the boundaries
24 of the state's Department of Corrections facilities for the production of
25 nonagricultural goods for sale to both public and private buyers, if the department
26 meets the conditions set out in this section. This section shall apply only to the
27 leasing of labor in accordance with a PIECP and not to programs otherwise operated

11 and state labor and wage laws, shall be made by the Education and Labor Cabinet.

12 (5) The department shall not allow a prisoner whose labor has been leased under this
13 section to:

14 (a) Engage in work that would result in the displacement of employed workers in
15 the specific Department of Corrections locale. As used in this paragraph, a
16 displaced employed worker is:

17 1. A civilian worker employed in the same task by the employer leasing or
18 applying to lease prisoner labor, who would lose his or her job if the
19 prisoner labor were leased; or

20 2. A civilian worker who is employed full-time and, as a result of the
21 prisoner labor lease, is forced to work part-time, regardless of wage
22 increase.

23 A civilian worker is not considered displaced for the purposes of this
24 paragraph if the civilian worker remains employed in a job acceptable to that
25 worker and at equal or higher wages than that worker previously received. The
26 employer shall provide whatever retraining is required of the civilian worker
27 at no cost to the civilian worker;

- 1 (b) Labor in a skill, craft, or trade in which there is a surplus of labor for that skill,
2 craft, or trade in that specific Department of Corrections locale;
- 3 (c) Perform any work that would impair existing contracts for goods or services;
- 4 (d) Perform leased work outside of Department of Corrections facilities; or
- 5 (e) Perform leased construction work inside or outside Department of Corrections
6 facilities.
- 7 (6) Before the commencement of any leased labor project at a Department of
8 Corrections facility under this section, the department shall:
- 9 (a) Receive a written projection from the Education and Labor Cabinet that the
10 leased labor project shall not result in acts prohibited by subsection (5)(a) to
11 (c) of this section;
- 12 (b) Receive written documentation from the employer leasing or applying to lease
13 prisoner labor agreeing to not displace any of its nonprisoner employees with
14 leased prisoner labor;
- 15 (c) Have written documentation of consultation with local unions representing
16 labor in the specific Department of Corrections facility's locale in any skill,
17 craft, or trade in which a prisoner may labor at that facility. If a local union is
18 not available, the department shall consult with a similar statewide union. The
19 department shall present this information to the Kentucky State Corrections
20 Commission;
- 21 (d) Have written documentation of consultation with local private businesses that
22 may be economically impacted by the leased labor project. The department
23 shall present this information to the Kentucky State Corrections Commission;
24 and
- 25 (e) Have written documentation of compliance with the National Environmental
26 Policy Act (NEPA).
- 27 (7) The leasing of prisoner labor shall not be deemed to create an employer-employee

1 relationship between the person leasing the labor of the prisoner and the prisoner.
2 However, the person leasing the labor of the prisoner shall provide for workers'
3 compensation coverage for the prisoner and, if applicable, Social Security coverage
4 for the prisoner.

5 (8) A prisoner, as a condition of participation in a program operating under the
6 provisions of this section, shall agree to the deductions from the prisoner's earnings
7 set out in this subsection. The department or the person leasing the labor of the
8 prisoner shall deduct, in the following order, from a prisoner's gross wages:

9 (a) If the prisoner is the subject of a court or administrative order for the support
10 of a dependent, no less than twenty-five percent (25%) for the payment of the
11 court or administratively ordered support. These deducted wages shall be paid
12 to the Cabinet for Health and Family Services' Child Support Enforcement
13 Program for disbursement in accordance with federal and state law;

14 (b) Twenty percent (20%) to be paid to the crime victim's compensation fund
15 established in KRS 49.480;

16 (c) Applicable federal, state, and local taxes, including Social Security if
17 applicable; and

18 (d) Reasonable room and board fees established by the department by
19 administrative regulation.

20 Total deductions from a prisoner's gross wages shall not exceed eighty percent
21 (80%).

22 (9) The department shall require any person leasing the labor of a prisoner to post bond,
23 with good surety, in an amount determined by the department, against any judgment
24 that may be entered against the department arising from the leasing of prisoner labor
25 to that person.

26 (10) In leasing prisoner labor under this section, the department shall seek to have the
27 labor leased to the highest responsible bidder.

1 (11) The department shall provide for reasonable access to the grounds of the
2 Department of Corrections facilities for the person leasing the inmate labor and for
3 the location of the work and the transporting and siting of equipment and supplies,
4 with the security of the public being paramount.

5 (12) The department may promulgate administrative regulations to implement the
6 provisions of this section.

7 ➔Section 97. KRS 198B.658 is amended to read as follows:

- 8 (1) An applicant for a master heating, ventilation, and air conditioning contractor's
9 license shall:
- 10 (a) Be at least eighteen (18) years of age;

9 program coordinator has direct computer access to all relevant databases used by all

14 subcontractor to the satisfaction of the person lodging the complaint on the same

17 complaint. The program coordinator shall ensure that the cabinet, the Cabinet for
18 Health and Family Services, and the Education and Labor~~[Workforce

21 upon promptly. The cabinet shall be required to inform in writing, every person who
22 has either been denied transportation or who has failed to have a complaint resolved
23 in a prompt manner under the human service transportation delivery program, of
24 their right to a hearing to be held in the county where the person lives, and the
25 process to follow to obtain a hearing.

27 (1) A lien may be placed on all property, both real and personal, of an employer who

1 has been assessed civil penalties by the commissioner for violations of the wages
2 and hours provisions of this chapter, but not before all administrative and judicial
3 appeals have been exhausted. The lien shall be in favor of the Education and Labor
4 Cabinet and shall be an amount totaling the unpaid wages and penalties due,
5 together with interest at a rate of twelve percent (12%) per annum from the date the

20 (1) There is hereby established the Kentucky Occupational Safety and Health Standards
21 Board consisting of the secretary and twelve (12) members equally representing
22 industry, labor, agriculture, and the safety and health profession. The members shall
23 be appointed by the Governor for terms of three (3) years and until their successors
24 are appointed and qualified, from lists of nominees submitted by bona fide
25 associations representative of industry, labor, agriculture, and the safety and health
26 profession. Members shall receive twenty-five dollars (\$25) per day for attending
27 each meeting and shall be reimbursed for actual expenses incurred in carrying out

1 their duties. The secretary shall act as chairman of the board. No member of the

10 (4) The board shall be attached to the Education and Labor Cabinet for administrative
11 purposes.

13 (1) There is hereby established the Kentucky Occupational Safety and Health Review
14 Commission consisting of three (3) members appointed by the Governor on the
15 basis of their experience and competence in the fields of occupational safety and
16 health. The members selected shall be qualified to represent the interest of
17 employers, employees, and the occupational safety and health profession with a
18 minimum of five (5) years experience in their respective fields.

19 (2) Members of the review commission shall serve terms of four (4) years and until
20 their successors are appointed.

7 chapter; and
- 8 (b) Any employee who believes that he or she has been discharged or otherwise
9 discriminated against by any person in violation of this subsection may, within
10 a reasonable time after such violation occurs, file a complaint with the
11 commissioner alleging such discrimination. Upon receipt of such complaint,
12 the commissioner shall cause such investigation to be made as deemed
13 appropriate. If upon such investigation, the commissioner determines that the
14 provisions of this subsection have been violated, he or she shall issue a
15 citation to the employer which may be challenged or contested in accordance
16 with the provisions of this chapter and the review commission may order all
17 appropriate relief including rehiring and reinstatement of the employee to his
18 or her former position with back pay. Upon an initial determination by the
19 commissioner that an employee has been discharged by an employer in
20 violation of subsection (3)(a) of this section, the secretary of the Education
21 and Labor Cabinet may order reinstatement of the employee pending a final
22 determination and order of the review commission.

10 benefits shall apply to benefits otherwise payable under this chapter, the laws of the
11 other state or any federal unemployment program administered by either state.

13 (1) As used in this section:

14 (a) "Agent" means one who acts for or in the place of an individual, an employing
15 unit, or a public official by the authority of that individual, employing unit, or
16 public official; and

17 (b) "Public official" means an official, agency, or public entity within the
18 executive branch of federal, state, or local government who or which has
19 responsibility for administering or enforcing a law, or an elected official in
20 federal, state, or local government.

- 14 (c) A third party other than an agent, or third party on an ongoing basis, shall be

17 signed written release which shall specify:
- 18 1. The information and records to be disclosed;
- 19 2. The purpose for which the information and records are sought,
20 specifying the expected service or benefit to the individual signing the
21 release, or specifying their use in the administration or evaluation of the
22 public program to which the release pertains;
- 23 3. Assurance that the information and records shall be used solely for that

- 25 4. All parties who may receive the information and records disclosed; and
- 26 5. That state government files shall be accessed to obtain information and

1 Disclosures shall be made under this subsection only if the recipient has
2 entered into a written, enforceable, and terminable agreement with the cabinet
3 and has satisfied the safeguards set forth in federal statutes and regulations;

4 (d) Precedential orders issued by the Unemployment Insurance Commission shall
5 be released provided that Social Security numbers and employer identification
6 numbers have been removed and the disclosure is otherwise consistent with
7 federal and state law;

8 (e) A public official with authority under state or federal law to obtain the
9 information and records by subpoena, other than a clerk of court on behalf of a
10 litigant, shall be provided information and records upon service of a duly
11 issued subpoena;

12 (f) A federal official, when required for the purposes of oversight and auditing of
13 the unemployment insurance program, shall be provided information and
14 records;

15 (g) Statistical information derived from information and records obtained or made
16 by the cabinet may be released to the Bureau of Labor Statistics under a
17 cooperative agreement or may be published, if it in no way reveals the identity
18 of any individual or employing unit; and

19 (h) Nothing in this section shall preclude the secretary or any employee of the
20 cabinet from testifying in any proceeding under this chapter or in any court, or
21 from introducing as evidence information and records obtained or made by the
22 cabinet in an action for violation of state or federal law to which the cabinet is
23 a party or upon order of the court.

24 (5) Disclosures shall be made under subsection (4) of this section only if:

25 (a) The disclosure is necessary for the proper administration of the unemployment

8 section, this requirement shall be met if the recipient provides a reciprocal
9 benefit to the cabinet in the administration of the unemployment insurance
10 program, or if a reasonable reimbursement for the disclosure shall be
11 determined under federal law.
- 12 (6) Recipients of information and records disclosed under subsection (4)(a) and (c) of
13 this section may redisclose the information and records only as follows:
- 14 (a) To the individual or employing unit who is the subject of the information and
15 records;
- 16 (b) To an attorney or duly authorized agent representing the individual or
17 employing unit;
- 18 (c) In any civil or criminal proceedings for or on behalf of the recipient;
- 19 (d) In response to a subpoena but only as provided in subsection (4)(e) and (h) of
20 this section;
- 21 (e) A public official may redisclose to an agent or contractor, but only if the

4 (7) Any disclosure or use of information and records that is inconsistent with the
5 provisions of this section shall be subject to the penalty prescribed in KRS
6 341.990(11).

7 (8) No information and records held confidential under subsection (4) of this section
8 shall be the subject matter or basis for any suit for slander or libel in any court, but
9 no employer or employee, or his representative, testifying before the commission,
10 the secretary, or any duly authorized representative thereof, shall be exempt from
11 punishment for perjury.

12 ➔Section 135. KRS 341.230 is amended to read as follows:

13 The secretary may authorize the destruction of such original reports and records as have
14 been properly recorded and summarized in the permanent records of the Education and

5 date all money received by the Office of Unemployment Insurance~~],~~

18 provided it files with the cabinet a written notice of its election within the
19 thirty (30) day period immediately following such date.

20 (b) Any nonprofit organization which becomes a subject employer after July 1,
21 1972, may elect to become liable for payments in lieu of contributions for a
22 period of not less than the period of subjectivity during the year in which such
23 subjectivity begins and the following calendar year by filing a written notice
24 of its election with the cabinet not later than thirty (30) days immediately
25 following the date of the determination of such subjectivity.

26 (c) Any nonprofit organization which makes an election in accordance with
27 paragraph (a) or (b) of this subsection will continue to be liable for payments

1 in lieu of contributions until it files with the secretary a written notice
2 terminating its election not later than thirty (30) days prior to the beginning of
3 the calendar year for which such termination shall first be effective, except
4 that liability for payments in lieu of contributions shall continue thereafter
5 with respect to wages paid prior to the effective date of such termination.

6 (d) Any nonprofit organization which has been paying contributions under this
7 chapter for a period subsequent to July 1, 1972, may change to a reimbursable
8 basis by filing with the cabinet not later than thirty (30) days prior to the

12 (e) The secretary may for good cause extend the period within which a notice of
13 election, or a notice of termination, must be filed and may permit an election
14 to be retroactive but not any earlier than with respect to benefits paid after

17 which may be made of its status as an employer and of the effective date of
18 any election which it makes and of any termination of such election. Such
19 determinations shall be subject to appeal and review in accordance with the

21 (3) Payments in lieu of contributions shall be made in accordance with the provisions
22 of this subsection.

23 (a) At the end of each calendar quarter or at the end of any other period as
24 determined by the secretary, the cabinet shall bill each nonprofit organization
25 (or group of such organizations) which has elected to make payments in lieu
26 of contributions for an amount equal to the full amount of regular benefits
27 plus one-half (1/2) of the amount of extended benefits paid during such

1 quarter plus any prior period adjustments, which are attributable to service

3 interest on the total amount billed at the average rate of earnings in the

7 (b) Payment of any bill rendered under paragraph (a) shall be made not later than

10 an application for review in accordance with paragraph (d) of this subsection.

11 (c) Payments made by any nonprofit organization under the provisions of this
12 subsection shall not be deducted or deductible, in whole or in part, from the
13 remuneration of workers in the employ of the organization.

14 (d) The amount due specified in any bill from the secretary shall be conclusive on
15 the organization unless, not later than fifteen (15) days after the bill was
16 mailed to its last known address or otherwise delivered to it, the organization
17 files an appeal to the commission setting forth the grounds for such appeal.
18 Proceedings on appeal to the commission from the amount of a bill rendered
19 under this subsection shall be in accordance with the provisions of KRS
20 341.430, and the decision of the commission shall be subject to review under
21 the provisions of KRS 341.460(1).

22 (e) Past-due payments of amounts in lieu of contributions shall be subject to the
23 same interest, penalties, collection service, and lien provisions that, pursuant
24 to KRS 341.300 to 341.310, apply to past-due contributions.

25 (4) (a) The secretary may, in accordance with regulations prescribed by the cabinet,
26 require any nonprofit organization that elects to become liable for payments in
27 lieu of contributions to deposit with the cabinet, within thirty (30) days after

1 the effective date of its election as a condition thereof, money equal to two
2 percent (2%) of the organization's total wages paid for employment as defined
3 in KRS 341.050(1)(e) for the four (4) calendar quarters immediately preceding

16 the provisions of this subsection to deposit sufficient additional money to
17 make whole the organization's deposit at the prior level. The secretary may, at

19 a result of such review, he determines that an adjustment is necessary, he shall
20 require the organization to make additional deposit within thirty (30) days of
21 written notice of his determination or shall return to it such portion of the

24 whole the amount of a previously made deposit, as provided under this

13 (1) Contributions unpaid on the date on which they are due and payable, as prescribed
14 by the secretary, shall be subject to interest at the rate of one and five-tenths percent
15 (1.5%) per month or fraction thereof, not to exceed ninety percent (90%) of the
16 amount of such contributions, from and after such date until payment is received by
17 the Office of Unemployment Insurance~~[, Department of Workforce Investment,]~~

27 instituted in the Franklin Circuit Court or the Franklin District Court depending

1 upon the jurisdictional amount in controversy including interest and penalties in the
2 name of the state, and the subject employer adjudged in default shall pay the costs
3 of the action. Civil actions brought under this section shall be heard by the court,
4 without the intervention of a jury, at the earliest possible date, and shall be entitled

8 (3) At or after the commencement of an action under subsection (2) of this section,
9 attachment may be had against the property of the liable subject employer for such
10 contributions, interest, and penalties, without the execution of a bond, or after
11 judgment has been entered an execution may be issued against the property of such
12 employer without the execution of a bond.

13 (4) An action for the recovery of contributions, interest, or penalties under this section
14 shall be barred and any lien therefor shall be canceled and extinguished unless
15 collected or suit for collection has been filed within ten (10) years from the due date
16 of such contributions, except, in the case of the filing of a false or fraudulent report,
17 the contributions due shall not be barred and may at any time be collected by the
18 methods set out in this chapter, including action in a court of competent jurisdiction.

20 (1) No worker may be paid benefits for any week of unemployment:

21 (a) With respect to which a strike or other bona fide labor dispute which caused
22 him to leave or lose his employment is in active progress in the establishment

25 ~~Workforce Investment,]~~ in writing within seven (7) days after the beginning of

1 deemed to be a strike or a bona fide labor dispute and no worker shall be
2 denied benefits by reason of a lockout;

5 except as otherwise provided by an arrangement between this state and such
6 other state or the United States; but if the appropriate agency of such state or

9 (c) 1. Which, when based on service in an instructional, research, or principal
10 administrative capacity in an institution of higher education as defined in
11 KRS 341.067(2) or in an educational institution as defined in KRS
12 341.067(4), begins during the period between two (2) successive
13 academic years, or during a similar period between two (2) regular
14 terms, whether or not successive, or during a period of paid sabbatical
15 leave provided for in the individual's contract, if the worker performs
16 such services in the first of such academic years or terms and if there is a
17 contract or a reasonable assurance that the worker will perform such
18 services in any such capacity for any institution or institutions of higher
19 education or an educational institution in the second of such academic
20 years or such terms; or

21 2. Which, when based on service other than as defined in subparagraph 1.
22 of this paragraph, in an institution of higher education or an educational
23 institution, as defined in KRS 341.067(2) or (4), begins during the
24 period between two (2) successive academic years or terms, if the
25 worker performs such services in the first of such academic years or
26 terms and there is a reasonable assurance that the worker will perform
27 such services in the second of such academic years or terms; except that

1 if benefits are denied to any worker under this paragraph and such
2 worker was not offered an opportunity to perform such services for such
3 institution of higher education or such educational institution for the
4 second of such academic years or terms, such worker shall be entitled to
5 a retroactive payment of benefits for each week for which the worker
6 filed a timely claim for benefits and for which benefits were denied
7 solely by reason of this paragraph; or

8 3. Which, when based on service in any capacity defined in subparagraphs
9 1. and 2. of this paragraph, begins during an established and customary
10 vacation period or holiday recess if the worker performs any such
11 services in the period immediately before such vacation period or
12 holiday recess, and there is a reasonable assurance that such worker will
13 perform any such services in the period immediately following such
14 vacation period or holiday recess; or

15 4. Based on service in any capacity defined in subparagraph 1. or 2. of this
16 paragraph when such service is performed by the worker in an institution
17 of higher education or an educational institution, as defined in KRS
18 341.067(2) or (4), while the worker is in the employ of an educational
19 service agency, and such unemployment begins during the periods and
20 pursuant to the conditions specified in subparagraphs 1., 2., and 3. of
21 this paragraph. For purposes of this paragraph, the term "educational
22 service agency" means a governmental agency or governmental entity
23 which is established and operated exclusively for the purpose of
24 providing such services to one (1) or more institutions of higher
25 education or educational institutions;

26 Notwithstanding any other provision of this paragraph, any benefits paid to a
27 worker based on service other than as defined in subparagraph 1. of this

1 paragraph performed in an institution of higher education as defined in KRS
2 341.067(2) shall be deemed to have been paid as a result of Office of
3 Unemployment Insurance~~[- Department of Workforce Investment,]~~ error and
4 not recoverable by the cabinet or such institution if such payment is improper
5 by virtue of the retroactive application to October 30, 1983, of subparagraph
6 2. of this paragraph; or

7 (d) With respect to which the worker is suspended from work for misconduct, as
8 defined in KRS 341.370(6), connected with the work.

9 (2) Benefits shall not be paid to any individual on the basis of any services,
10 substantially all of which consist of participating in sports or athletic events or
11 training or preparing to so participate, for any week which commences during the
12 period between two (2) successive sport seasons or similar periods and there is a
13 reasonable assurance that such individual will perform such services in the later of
14 such seasons or similar periods.

15 (3) (a) Benefits shall not be paid on the basis of services performed by an alien unless
16 such alien is an individual who was lawfully admitted for permanent residence
17 at the time such services were performed, was lawfully present for purposes of
18 performing such services, or was residing in the United States under color of
19 law at the time such services were performed, including an alien who was
20 lawfully present in the United States as a result of the application of the
21 provisions of Section 203(a)(7) or Section 212(d)(5) of the Immigration and
22 Nationality Act.

23 (b) Any data or information required of individuals applying for benefits to
24 determine whether benefits are not payable to them because of their alien
25 status shall be uniformly required from all applicants for benefits.

26 (c) In the case of an individual whose application for benefits would otherwise be
27 approved, no determination that benefits to such individual are not payable

1 because of his alien status shall be made except upon a preponderance of the
2 evidence.

9 employment when so directed by the secretary; or
 - 10 (b) He has been discharged for misconduct or dishonesty connected with his most
11 recent work, or from any work which occurred after the first day of the

13 legitimate activity in connection with labor organizations or failure to join a
14 company union shall not be construed as misconduct; or

23 measured on a one (1) way basis, from his home to accept work which is
24 less than one hundred (100) road miles from his home;

 - 27 4. Leaving work to accompany the worker's spouse to a different state,

1 military base of assignment, or duty station that is one hundred (100)

4 (2) A worker shall be disqualified from receiving benefits for any week with respect to
5 which he knowingly made a false statement to establish his right to or the amount of
6 his benefits, and, within the succeeding twenty-four (24) months, for the additional
7 weeks immediately following the date of discovery, not to exceed a total of fifty-
8 two (52), as may be determined by the secretary.

9 (3) No worker shall be disqualified under paragraph (b) or (c) of subsection (1) of this
10 section unless the employer, within a reasonable time as prescribed by regulations
11 promulgated by the secretary, notifies the ~~Education and Workforce Development~~
12 cabinet and the worker in writing of the alleged voluntary quitting or the discharge
13 for misconduct. Nothing in this subsection shall restrict the right of the secretary to

4 management contract or agreement, or pursuant to an established employer plan,

7 (6) "Discharge for misconduct" as used in this section shall include but not be limited
8 to, separation initiated by an employer for falsification of an employment
9 application to obtain employment through subterfuge; knowing violation of a
10 reasonable and uniformly enforced rule of an employer; unsatisfactory attendance if
11 the worker cannot show good cause for absences or tardiness; damaging the
12 employer's property through gross negligence; refusing to obey reasonable
13 instructions; reporting to work under the influence of alcohol or drugs or consuming

20 failure to apply for or accept suitable work and running until the worker has worked
21 in each of ten (10) weeks, whether or not consecutive, and has earned ten (10) times
22 his weekly benefit rate in employment covered under the provisions of this chapter
23 or a similar law of another state or of the United States.

24 ➔Section 144. KRS 341.412 is amended to read as follows:

25 For the purposes of KRS 341.412 to 341.414:

26 (1) "National Directory of New Hires" means the database that stores personal and
27 financial data on employed individuals across the country and contains information

1 and data on individuals receiving unemployment compensation;

2 (2) "New hire records" means the directory of newly hired and rehired employees
3 reported under state and federal law and managed by the federal Office of Child
4 Support Enforcement, Administration for Children and Families, United States

5 deemed to be uncollectible and shall be permanently charged to the pooled account,

21 (1) No agreement by a worker to waive, release, or commute his rights to benefits or
22 any other rights under this chapter shall be valid. No agreement by any worker to
23 pay any portion of a subject employer's contributions, required under this chapter
24 from such subject employer, shall be valid. No subject employer shall directly or
25 indirectly make or require or accept any deductions from wages to finance the
26 subject employer's contributions required of him. In cases involving awards to a

3 (5) The provisions of this section shall not be applicable to child support deductions
4 made in accordance with KRS 341.392 and withholding for federal and state

6 ➔Section 148. KRS 341.530 is amended to read as follows:

7 (1) The Office of Unemployment Insurance~~[- Department of Workforce Investment,]~~
8 shall maintain a reserve account for each subject employer making contributions to
9 the fund and a reimbursing employer account for each subject employer making
10 payment in lieu of contributions, and shall, except as provided in KRS 341.590,
11 credit to such account the total amount of all contributions or benefit reimbursement
12 paid by the employer on his own behalf. Nothing in this section or elsewhere in this
13 chapter shall be construed to grant any employer or individual who is or was in his
14 employ prior claims or rights to the amounts paid by him into the fund.

15 (2) Except as provided in subsection (3) of this section, all regular benefits paid to an
16 eligible worker in accordance with KRS 341.380 plus the extended benefits paid in
17 accordance with KRS 341.700 to 341.740, subject to the provisions of paragraphs
18 (a) and (b) of this subsection, shall be charged against the reserve account or
19 reimbursing employer account of his most recent employer. No employer shall be
20 deemed to be the most recent employer unless the eligible worker to whom benefits

23 (a) Subject employers, which are not governmental entities as defined in KRS
24 341.069, shall be charged one-half (1/2) of the extended benefits paid in
25 accordance with KRS 341.700 to 341.740; and

26 (b) Subject employers which are governmental entities, as defined in KRS
27 341.069, shall be charged for all extended benefits paid in accordance with

1 KRS 341.700 to 341.740 for compensable weeks occurring on or after January
2 1, 1979, and for one-half (1/2) of the extended benefits paid for compensable
3 weeks occurring prior to such date.

4 (3) Notwithstanding the provisions of subsection (2) of this section, benefits paid to an
5 eligible worker and chargeable to a contributing employer's reserve account under
6 such subsection shall be charged against the pooled account if such worker was
7 discharged by such employer for misconduct connected with his most recent work
8 for such employer, voluntarily left his most recent work with such employer without
9 good cause attributable to the employment, or the employer has continued to
10 provide part-time employment and wages, without interruption, to the same extent
11 that was provided from the date of hire, and the employer within a reasonable time,
12 as prescribed by regulation of the secretary, notifies the office, in writing, of the
13 alleged voluntary quitting, discharge for misconduct or continuing part-time
14 employment; provided, however, that no employer making payments to the fund in
15 lieu of contributions shall be relieved of charges by reason of this subsection.

17 employer's reserve account shall be relieved of any charges for benefits relating to
18 an improper benefit payment to a worker established after October 21, 2013, if:

19 (a) The improper benefit payment was made because the employer, or an agent of
20 the employer, was at fault for failing to respond timely or adequately to the
21 request of the secretary for information relating to a claim for benefits; and

22 (b) The employer, or an agent of the employer, has a pattern of failing to respond
23 timely or adequately to requests under paragraph (a) of this subsection. For
24 purposes of this paragraph, a "pattern of failing" means at least six (6) failures

10 their reserve account as of the computation date. Any employer who is delinquent in

12 be entitled to make voluntary payments only after the amount of the delinquency is

14 (9) Notwithstanding any other provisions of this chapter, any benefits paid to an
15 eligible worker for reasons related to a state or federal state of emergency or disaster
16 declaration shall be paid from the pooled account provided in KRS 341.550 and not
17 from the reserve account of the employer of that individual. The reserve account
18 shall not be charged for benefits related to a state of emergency or disaster
19 declaration. Payments shall be accounted for separately to allow the secretary to
20 seek reimbursement from the federal government.

1 shall be actuarially adequate to cover the entire liability of the employer for

4 for deductibles with effective dates of May 6, 1993, through December 31,

8 plus any reimbursements invoiced for losses, expenses, and fees charged

10 reimbursements invoiced for losses, expenses, or fees charged under the

9 shall be imposed as calculated by the deductible program adjustment. The cost
10 for coverage calculated under this paragraph by insurance companies that
11 issue only deductible insurance policies in Kentucky shall be actuarially
12 adequate to cover the entire liability of the employer for compensation under
13 this chapter, including all expenses and allowances normally used to calculate
14 the cost for coverage. For policies with provisions for deductibles with
15 effective dates of May 6, 1993, through December 31, 1993, for which the
16 insurance company did not report premiums and remit special fund
17 assessments based on the calculated cost for coverage prior to the reduction
18 for deductibles, "premium" includes the initial consideration plus any
19 reimbursements invoiced for losses, expenses, or fees charged under the

21 (d) "Return premiums" for insurance companies means amounts returned to
22 insureds due to endorsements, retrospective adjustments, cancellations,
23 dividends, or errors.

24 (e) "Deductible program adjustment" means calculating premium and premiums
25 received on a gross basis without regard to the following:

- 26 1. Schedule rating modifications, debits, or credits;
- 27 2. Deductible credits; or

1 3. Modifications to the cost of coverage from inception through and
2 including any audit that are based on negotiated retrospective rating
3 arrangements, including but not limited to large risk alternative rating
4 options;

5 (26) "Insurance policy" for an insurance company or self-insured group means the term
6 of insurance coverage commencing from the date coverage is extended, whether a
7 new policy or a renewal, through its expiration, not to exceed the anniversary date
8 of the renewal for the following year;

9 (27) "Self-insurance year" for a self-insured group means the annual period of
10 certification of the group created pursuant to KRS 342.350(4) and 304.50-010;

11 (28) "Premium" for each employer carrying his own risk pursuant to KRS 342.340(1)
12 shall be the projected value of the employer's workers' compensation claims for the
13 next calendar year as calculated by the commissioner using generally-accepted
14 actuarial methods as follows:

15 (a) The base period shall be the earliest three (3) calendar years of the five (5)
16 calendar years immediately preceding the calendar year for which the
17 calculation is made. The commissioner shall identify each claim of the
18 employer which has an injury date or date of last injurious exposure to the
19 cause of an occupational disease during each one (1) of the three (3) calendar
20 years to be used as the base, and shall assign a value to each claim. The value
21 shall be the total of the indemnity benefits paid to date and projected to be
22 paid, adjusted to current benefit levels, plus the medical benefits paid to date
23 and projected to be paid for the life of the claim, plus the cost of medical and
24 vocational rehabilitation paid to date and projected to be paid. Adjustment to
25 current benefit levels shall be done by multiplying the weekly indemnity
26 benefit for each claim by the number obtained by dividing the statewide
27 average weekly wage which will be in effect for the year for which the

1 premium is being calculated by the statewide average weekly wage in effect
2 during the year in which the injury or date of the last exposure occurred. The
3 total value of the claims using the adjusted weekly benefit shall then be
4 calculated by the commissioner. Values for claims in which awards have been
5 made or settlements reached because of findings of permanent partial or
6 permanent total disability shall be calculated using the mortality and interest
7 discount assumptions used in the latest available statistical plan of the
8 advisory rating organization defined in Subtitle 13 of KRS Chapter 304. The
9 sum of all calculated values shall be computed for all claims in the base
10 period;

11 (b) The commissioner shall obtain the annual payroll for each of the three (3)
12 years in the base period for each employer carrying his own risk from records
13 of the department and from the records of the Department of Workforce
14 Development~~[Investment]~~, Education and Labor~~[Workforce Development]~~
15 Cabinet. The commissioner shall multiply each of the three (3) years of
16 payroll by the number obtained by dividing the statewide average weekly
17 wage which will be in effect for the year in which the premium is being
18 calculated by the statewide average weekly wage in effect in each of the years
19 of the base period;

20 (c) The commissioner shall divide the total of the adjusted claim values for the
21 three (3) year base period by the total adjusted payroll for the same three (3)
22 year period. The value so calculated shall be multiplied by 1.25 and shall then

26 on a quarterly basis as reported, to obtain the premium for the next calendar

- 1 (d) For November 1, 1987, through December 31, 1988, premium for each
2 employer carrying its own risk shall be an amount calculated by the board
3 pursuant to the provisions contained in this subsection and such premium
4 shall be provided to each employer carrying its own risk and to the funding
5 commission on or before January 1, 1988. Thereafter, the calculations set
6 forth in this subsection shall be performed annually, at the time each employer

- 23 (f) If an employer is certified to carry its own risk after having previously insured
24 the risk, its premium shall be calculated using values obtained from claims
25 incurred while insured for as many of the years of the base period as may be
26 necessary to create a full three (3) year base. After the employer is certified to
27 carry its own risk and has paid all amounts due for assessments upon

- 1 premiums paid while insured, the employer shall be assessed only upon the
2 premium calculated under this subsection;
- 3 (g) "Premium" for each employer defined in KRS 342.630(2) shall be calculated
4 as set forth in this subsection; and
- 5 (h) Notwithstanding any other provision of this subsection, the premium of any
6 employer authorized to carry its own risk for purposes of assessments due
7 under this chapter shall be no less than thirty cents (\$0.30) per one hundred
8 dollars (\$100) of the employer's most recent annualized payroll for employees
9 covered by this chapter;
- 10 (29) "SIC code" as used in this chapter means the Standard Industrial Classification
11 Code contained in the latest edition of the Standard Industrial Classification Manual
12 published by the Federal Office of Management and Budget;
- 13 (30) "Investment interest" means any pecuniary or beneficial interest in a provider of
14 medical services or treatment under this chapter, other than a provider in which that
15 pecuniary or investment interest is obtained on terms equally available to the public
16 through trading on a registered national securities exchange, such as the New York
17 Stock Exchange or the American Stock Exchange, or on the National Association of
18 Securities Dealers Automated Quotation System;
- 19 (31) "Managed health care system" means a health care system that employs gatekeeper
20 providers, performs utilization review, and does medical bill audits;
- 21 (32) "Physician" means physicians and surgeons, psychologists, optometrists, dentists,
22 podiatrists, and osteopathic and chiropractic practitioners acting within the scope of
23 their license issued by the Commonwealth;
- 24 (33) "Objective medical findings" means information gained through direct observation
25 and testing of the patient applying objective or standardized methods;
- 26 (34) "Work" means providing services to another in return for remuneration on a regular
27 and sustained basis in a competitive economy;

- 1 (35) "Permanent impairment rating" means percentage of whole body impairment caused
2 by the injury or occupational disease as determined by the "Guides to the Evaluation

- 12 ➔Section 152. KRS 342.120 is amended to read as follows:
- 13 (1) There is created the Division of Workers' Compensation Funds in the Department
14 of Workers' Claims which shall be responsible for the administration of the special
15 fund and the coal workers' pneumoconiosis fund and the maintenance of records
16 regarding the payment of claims by these funds. The Division of Workers'
17 Compensation Funds shall have no responsibility for the coal workers'
18 pneumoconiosis fund once the assets and liabilities have been transferred to the
19 Kentucky Employers' Mutual Insurance Authority, which will administer the fund

8 (1) (a) For calendar year 1997 and for each calendar year thereafter, for the purpose

1 date of the policy, regardless of the date that the premium is actually received by the

3 (4) A self-insured group may elect to report its premiums and to have its assessments
4 computed in the same manner as insurance companies. This election may not be

19 operating under the provision of KRS 342.350(4) and Chapter 304, and against the
20 premium, as defined in KRS 342.0011, of every employer carrying its own risk.

21 ➔Section 154. KRS 342.1223 is amended to read as follows:

22 (1) The Kentucky Workers' Compensation Funding Commission is created as an
23 agency of the Commonwealth for the public purpose of controlling, investing, and
24 managing the funds collected pursuant to KRS 342.122.

26 (a) Hold, administer, invest, and reinvest the funds collected pursuant to KRS

- 7 (b) The initial member appointed by the Governor to represent employers shall

8 Commission are hereby determined to be officers and agents of the Commonwealth

13 The Kentucky Workers' Compensation Funding Commission shall not be subject to the
14 Governor's power of reorganization under KRS Chapter 12, including attachment or

21 by the commissioner as follows: On or before September 1 of each year, the total wages

5 falls within the calendar year commencing January 1 following the September 1
6 determination. Whenever a change in the average weekly wage of the state is of such
7 amount that the minimum weekly income benefits for total disability or for death are
8 increased or decreased by one dollar (\$1) or more, or the maximum weekly income
9 benefits for total disability or for death are increased or decreased by two dollars (\$2) or
10 more, computed in each case and rounded to the nearest dollar, an adjustment in those
11 minimums or maximums which are affected in the requisite amount by the change in the
12 average weekly wage of the state shall be made which will reflect this increase or
13 decrease, but no change in such limitations shall otherwise be made. Notwithstanding the
14 provisions of this section, KRS 342.140 and 342.740, or any other provisions of this
15 chapter to the contrary, the average weekly wage for calendar years 1995 and 1996 shall
16 be determined to be no higher than the average weekly wage determined by the
17 commissioner to be in effect in the calendar year of 1994. If the average weekly wage
18 calculated by the commissioner is determined to be lower than the 1994 calendar year
19 wage, the average weekly wage may be lowered as provided by this section. Beginning in
20 calendar year 1997 and annually thereafter, the average weekly wage shall be calculated
21 based upon the state average weekly wage in effect two (2) years prior to that calculation.

22 ➔Section 158. KRS 342.215 is amended to read as follows:

23 (1) The Workers' Compensation Board is hereby created and established. The board
24 shall rule on appeals of decisions rendered by administrative law judges under this
25 chapter. The board shall rule on an appeal of a decision of an administrative law
26 judge no later than sixty (60) days following the date on which the last appeal brief
27 was filed.

- 1 (2) The Workers' Compensation Board shall consist of three (3) members appointed by
2 the Governor. Each member shall hold no other public office and shall devote his or
3 her full time to the duties of his or her office. Each member shall be exempt from
4 the classified service, and his or her support staff may be exempt from the classified
5 service.
- 6 (3) Of the members of the board appointed under this section, one (1) shall serve a term
7 that shall expire on January 4, 2002; one (1) shall serve a term that shall expire on

4 The Education and Labor Cabinet shall report monthly to the Committee on
5 Appropriations and Revenue its monthly expenditures of restricted agency funds and the
6 nature of such expenditures. Separate reporting shall be done by each office within the
7 Education and Labor Cabinet and for general administration and support.

8 ➔Section 160. KRS 342.342 is amended to read as follows:

9 (1) Notwithstanding the provisions of KRS 342.340, KRS 342.350, or any
10 administrative regulations promulgated pursuant to those provisions, the
11 commissioner shall annually review the adequacy of the financial or other security
12 requirements contained in administrative regulations, promulgated pursuant to the
13 individual self-insurance provisions in this chapter. The commissioner shall report
14 the results of the review to the Economic Development and Workforce Investment
15 Committee of the General Assembly and any recommendations for proposed
16 changes to insure the financial soundness of the individual self-insurers authorized
17 pursuant to this chapter. In addition, the commissioner shall report not less often
18 than annually a summary report on the financial soundness of the individual self-
19 insurers.

20 (2) The Economic Development and Workforce Investment Committee of the General
21 Assembly shall annually review the administrative regulations promulgated

- 3 (1) One of the primary purposes of this chapter shall be restoration of the injured
4 employee to gainful employment, and preference shall be given to returning the
5 employee to employment with the same employer or to the same or similar
6 employment.
- 7 (2) The commissioner shall continuously study the problems of rehabilitation, both
8 physical and vocational, and shall investigate and maintain a directory of all
9 rehabilitation facilities, both private and public.
- 10 (3) An employee who has suffered an injury covered by this chapter shall be entitled to
11 prompt medical rehabilitation services for whatever period of time is necessary to
12 accomplish physical rehabilitation goals which are feasible, practical, and

15 such vocational rehabilitation services, including retraining and job placement, as

19 her own motion, or upon application of any party or carrier, after affording the
20 parties an opportunity to be heard, may refer the employee to a qualified physician

22 treatment, or training necessary and appropriate to render him or her fit for a
23 remunerative occupation. Upon receipt of such report, the administrative law judge
24 may order that the services and treatment recommended in the report, or such other
25 rehabilitation treatment or service likely to return the employee to suitable, gainful
26 employment, be provided at the expense of the employer or its insurance carrier.
27 Vocational rehabilitation training, treatment, or service shall not extend for a period

1 of more than fifty-two (52) weeks, except in unusual cases when by special order of
2 the administrative law judge, after hearing and upon a finding, determined by sound
3 medical evidence which indicates such further rehabilitation is feasible, practical,
4 and justifiable, the period may be extended for additional periods.

5 (4) Where rehabilitation requires residence at or near the facility or institution, away

20 treatment or services by the employer or its insurance carrier as apportioned in the

23 promulgated pursuant to this section that require mandatory referral to a qualified
24 rehabilitation counselor shall expire on April 4, 1994.

26 training pursuant to this section may elect to receive an acceleration of benefits as
27 awarded under KRS 342.730. Such acceleration shall be available to the employee

1 during the period of retraining, but in no event shall be paid in a weekly amount

12 and then deducted on a dollar-for-dollar basis from weekly benefits otherwise due
13 the employee subject to the maximum amount of the award. Such remaining
14 benefits, after the discount, shall be divided by the number of weeks remaining
15 payable under the award, and that amount shall be the weekly benefit due the
16 employee. In no event shall this subsection be construed as requiring payment of
17 benefits in excess of the total of those benefits which would otherwise be payable
18 under the award.

19 ➔Section 162. KRS 342.732 is amended to read as follows:

20 (1) Notwithstanding any other provision of this chapter, income benefits and retraining
21 incentive benefits for occupational pneumoconiosis resulting from exposure to coal
22 dust in the severance or processing of coal shall be paid as follows:

23 (a) 1. If an employee has a radiographic classification of category 1/0, 1/1 or
24 1/2, coal workers' pneumoconiosis and spirometric test values of eighty
25 percent (80%) or more, the employee shall be awarded a one (1) time
26 only retraining incentive benefit which shall be an amount equal to
27 sixty-six and two-thirds percent (66-2/3%) of the employee's average

1 weekly wage as determined by KRS 342.740, but not more than seventy-

10 completing the course for a trade, occupation, or profession and which
11 program can be completed within the period benefits are payable under
12 this subsection. The program must be approved under administrative
13 regulations to be promulgated by the commissioner. These benefits shall
14 also be paid to an employee who is a part-time student taking not less
15 than the equivalent of six (6) nor more than eleven (11) credit hours per
16 week, except that benefits shall be an amount equal to thirty-three and
17 one-third percent (33-1/3%) of the employee's average weekly wage as
18 determined by KRS 342.740, but not more than thirty-seven and one-
19 half percent (37-1/2%) of the state average weekly wage, payable
20 biweekly for a period not to exceed two hundred eight (208) weeks.

18 week retraining benefits are further deferred;

20 workers' pneumoconiosis and respiratory impairment evidenced by
21 spirometric test values of fifty-five percent (55%) or more but less than eighty
22 percent (80%) of the predicted normal values, or category 3/2 or 3/3 coal
23 workers' pneumoconiosis and spirometric test values of eighty percent (80%)
24 or more, there shall be an irrebuttable presumption that the employee has a
25 disability rating of fifty percent (50%) resulting from exposure to coal dust,
26 and the employee shall be awarded an income benefit which shall be an

5 (d) If it is determined that an employee has a radiographic classification of
6 category 2/1, 2/2, or 2/3 coal workers' pneumoconiosis, based on the latest
7 ILO International Classification of Radiographics, and respiratory impairment
8 as evidenced by spirometric test values of less than fifty-five percent (55%) of
9 the predicted normal values or category 3/2 or 3/3 pneumoconiosis and
10 respiratory impairment evidenced by spirometric test values of fifty-five
11 percent (55%) or more but less than eighty percent (80%) of the predicted
12 normal values, there shall be an irrebuttable presumption that the employee
13 has a seventy-five percent (75%) disability rating resulting from exposure to
14 coal dust and the employee shall be awarded income benefits which shall be
15 equal to sixty-six and two-thirds percent (66-2/3%) of the employee's average
16 weekly wage but not to exceed seventy-five percent (75%) of the state average
17 weekly wage as determined by KRS 342.740 multiplied by the disability
18 rating of seventy-five percent (75%). The award shall be payable for a period
19 not to exceed five hundred twenty (520) weeks. Income benefits awarded
20 under this paragraph shall be payable to the employee during the disability;
21 and

22 (e) If it is determined that an employee has radiographic classification of 3/2 or
23 3/3 occupational pneumoconiosis and respiratory impairment evidenced by
24 spirometric test values of less than fifty-five percent (55%) of the predicted
25 normal values, or complicated pneumoconiosis (large opacities category A, B,
26 or C progressive massive fibrosis), there shall be an irrebuttable presumption
27 that the employee is totally disabled resulting from exposure to coal dust, and

1 the employee shall be awarded income benefits equal to sixty-six and two-
2 thirds percent (66-2/3%) of the employee's average weekly wage but not more
3 than one hundred percent (100%) of the state average weekly wage and not
4 less than twenty percent (20%) of the average weekly wage of the state as
5 determined by KRS 342.740. Income benefits awarded under this paragraph
6 shall be payable to the employee during such disability.

7 (2) The presence of respiratory impairment resulting from exposure to coal dust shall
8 be established by using the largest forced vital capacity (FVC) value or the largest
9 forced expiratory volume in one second (FEV1) value determined from the totality
10 of all such spirometric testing performed in compliance with accepted medical
11 standards.

12 (3) When valid spirometric tests are not provided and a physician certifies to the
13 administrative law judge that spirometric testing is not medically indicated because
14 of the permanent physical condition of the employee, the administrative law judge
15 shall make his or her decision on the basis of evidence admitted which establishes
16 the existence of a diagnosis of occupational pneumoconiosis and respiratory
17 impairment due to the occupational pneumoconiosis. The evidence submitted by the
18 employee shall include one (1) or more arterial blood gas studies performed in
19 accordance with accepted medical standards. Income benefits shall not be awarded
20 in the absence of valid spirometric tests if the claimant's PO₂ arterial blood gas
21 value is equal to or higher than one (1) standard deviation from the normal value
22 obtained by the formula $(103.5 - 0.42X)$, where X equals the claimant's age at the
23 time of the arterial blood gas study.

24 (4) Upon request, the commissioner shall refer an employee who has been awarded
25 retraining incentive benefits under subsection (1)(a) of this section to the Office of
26 Vocational Rehabilitation for evaluation and assessment of the training, education,
27 or other services necessary to prepare the employee for a trade, occupation, or

1 profession that will return the employee to remunerative employment, or services
2 necessary and appropriate to prepare and enable the employee to successfully
3 complete a bona fide training or education program approved by the commissioner.
4 The commissioner shall contract with the Office of Vocational Rehabilitation to
5 provide vocational rehabilitation or education services commensurate with the skill
6 levels and abilities of the employee. Services provided under this subsection shall
7 be funded by the coal workers' pneumoconiosis fund, KRS 342. 1242
8 notwithstanding, for claims filed on or before June 30, 2017, and by the employer
9 for claims filed after June 30, 2017.

10 (5) The commissioner shall promulgate administrative regulations sufficient to
11 effectuate the provisions relating to retraining incentive benefits provided under
12 subsection (1)(a) of this section. The administrative regulations shall:

13 (a) Create an online portal through which employees shall select a facility or
14 institution to provide their retraining. This portal shall list bona fide training
15 or education programs. These programs shall include postsecondary programs
16 registered with the Higher Education Assistance Authority, and will qualify
17 the employee for a trade, occupation, or profession. The programs listed shall
18 be capable of completion within the period benefits are payable under
19 subsection (1)(a) of this section;

20 (b) Establish requirements for approval and certification of a bona fide training or
21 education program;

22 (c) Provide that funds paid to the training or education program by the employer
23 as required under subsection (1)(a)4. of this section shall be applied only to
24 instruction, tuition, material costs, and any fees necessary for the completion

9 (6) In no event shall income benefits awarded under this section be stacked or added to

11 in no event shall income or retraining incentive benefits be paid to the employee
12 while the employee is working in the mining industry in the severance or processing
13 of coal as defined in KRS 342.0011(23)(a).

14 ➔Section 163. KRS 342.740 is amended to read as follows:

15 (1) For the purposes of this chapter, the average weekly wage of the state shall be
16 determined by the commissioner as follows: On or before September 1 of each year,
17 the total wages reported by subject employers under the Kentucky Unemployment
18 Insurance Law for the preceding calendar year shall be divided by the average
19 monthly number of insured workers (determined by dividing the total number of
20 insured workers reported for the preceding year by twelve (12)). The average annual
21 wage thus obtained shall be divided by 52 and the average weekly wage thus
22 determined rounded to the nearest cent. This average weekly wage shall be certified

5 for death by \$2 or more, computed in each case and rounded to the nearest dollar, an
6 adjustment in those minimums or maximums which are affected in the requisite
7 amount by the change in the average weekly wage of the state shall be made which
8 will reflect the increase or decrease, but no change in these limitations shall
9 otherwise be made.

10 ➔Section 164. KRS 342.760 is amended to read as follows:

11 (1) There is hereby authorized in the Education and Labor Cabinet an uninsured
12 employers' fund for the purpose of making payments in accordance with the
13 provisions of subsection (4) of this section. The secretary of the Education and
14 Labor Cabinet shall be the custodian of the fund, and all moneys and securities in
15 the fund shall be held in trust by the secretary of the Education and Labor Cabinet
16 and shall not be considered a part of the general funds of the state.

17 (2) The secretary of the Education and Labor Cabinet is authorized to disburse moneys
18 from the fund only upon written order of the administrative law judge or the board.

19 (3) All amounts collected as fines and penalties under this chapter shall be paid into the

9 lump-sum settlements in addition to biweekly payment plans. An initial distribution

23 shall these provisions be interpreted in a manner that would transfer or create

27 (10) The special fund shall issue trust fund checks in the amounts and to the claimants or

1 claimants' representatives as directed by the commissioner of the Department of

3 (11) The personnel and other costs of administering a trust fund established pursuant to
4 this section shall be paid out of the investment income of the trust fund.

5 (12) Attorney fees shall be subject to the limitations and maximum amounts for the

7 the commissioner or his or her designee.

8 (13) If a workers' compensation claimant elects not to participate in a comprehensive
9 distribution plan proposed by the commissioner of the Department of Workers'

12 A claimant shall have sixty (60) days following issuance of a comprehensive

2 privilege at any time by order entered with or without notice. The jailer shall advise

7 section. If a prisoner is employed for wages or salary, they shall, by wage

10 each prisoner. The wages or salary shall not be subject to garnishment of either the
11 employer or the District Court during the prisoner's term, and shall be disbursed
12 only as provided in this section. For tax purposes they shall be the income of the
13 prisoner.

14 (4) Every prisoner gainfully employed shall be liable for the cost of his board in the jail,
15 for an amount up to twenty-five percent (25%) of the prisoner's gross daily wages,
16 not to exceed forty dollars (\$40) per day, but not less than twelve dollars (\$12) per
17 day, established by the fiscal court of a county or the urban-county council if an
18 urban-county government. If he defaults, his privilege under this section shall be
19 automatically forfeited. All moneys shall be paid directly to the jailer and paid to
20 the county treasury for use on the jail as provided in KRS 441.206. The fiscal court
21 of a county or the urban-county council if an urban-county government may, by
22 ordinance, provide that the county furnish or pay for the transportation of prisoners
23 employed under this section to and from the place of employment and require that
24 the costs be repaid by the prisoner.

26 defendant's wages or salary payments for the following purposes:

27 (a) The board of the prisoner and transportation costs incurred by the county;
