- 3 (5) Students pursuing early graduation may take two (2) high school English courses in 4 an academic year.
- Students pursuing early graduation may complete selected courses at the middle 5 (6)6 school level. Each school district is encouraged to provide access to all middle 7 school students to English I and Algebra I courses for high school credit. Access 8 may be provided by each middle school offering the course on-site or by the district 9 providing transportation for students to a central location within the district, to a 10 neighboring school within the district, or to a neighboring school district. The 11 district may also provide access for the student to take these courses online based on 12 the local board of education policy.
  - (7) (a) In addition to the regular high school diploma, a student who completes a program of study that meets the requirements of subsection (3) of this section shall receive an Early Graduation Scholarship Certificate signed by the high school principal and district superintendent.

- (b) A student who earns an Early Graduation Scholarship Certificate shall be eligible for a scholarship award to be used at an institution described in subsection (1) of this section. The award amount shall be equal to one-half (1/2) of the state portion of the average statewide per pupil guaranteed base funding level as described in KRS 157.360 for the year in which the student graduates.
- (c) The student shall be eligible for the scholarship award only for the next academic year following early graduation.
- (d) Each public high school shall report all Early Graduation Scholarship

  Certificate recipients by July 1 for the previous academic year to the Kentucky

  Higher Education Assistance Authority.

	notify the Kentucky Higher Education Assistance Authority of students with
