1	A RESOLUTION adjourning the Senate in honor and loving memory of Senator
2	Tom Buford.
3	WHEREAS, this august body rightfully honors a dear friend of the General
4	Assembly and a true Kentucky statesman on this day, the late Senator Tom Buford, the
5	esteemed gentleman from Jessamine, Senate District 22; and
6	WHEREAS, Tom Buford was elected to the Kentucky State Senate in 1990 and was
7	the second longest-serving member of the current Kentucky Senate. As a freshman
8	legislator, he was elected to serve as the Senate Republican Whip from 1991-1992. From
9	1993 to 1996, Senator Buford served as Senate Republican Caucus Chair; and
10	WHEREAS, Senator Buford served on numerous standing, statutory, and special
11	committees of the Legislative Research Commission. Most notably, he was a member of
12	the Banking and Insurance committee since his first term of office and for almost two
13	decades served as its chair; and
14	WHEREAS, during his time in the legislature, Senator Buford was the primary
15	sponsor of more than 450 Senate bills, of which over 100 were passed by the General
16	Assembly; and he sponsored approximately 320 Senate Resolutions, of which almost 300
17	were adopted; and
18	WHEREAS, the enacted legislative initiatives included more than two dozen bills
19	relating to banking and insurance, including legislation regulating banks, insurance
20	companies, pawnbrokers, and money transmitters; legislation regulating the securities
21	industry; and legislation regulating health insurance. Additional topics of legislation that
22	Senator Buford was instrumental in passing involved helping people with disabilities,
23	cancer, and diabetes. In 2008, Tom Buford was the primary sponsor of Senate Bill 58,
24	"Romeo's Law," which expanded the penalty for torture of a dog or cat if the dog or cat
25	suffered physical injury; and
26	WHEREAS, Senator Buford is rightfully honored for his service to the Kentucky
27	State Senate and this Commonwealth. His tireless work on behalf of his constituents is

1 justly acknowledged, and his professionalism, wit, and leadership is deeply appreciated
