

1 A RESOLUTION adjourning the Senate in honor and loving memory of Jordan
2 Wesley Morgan.

3 WHEREAS, Jordan Wesley Morgan was born on August 28, 1989, in Lexington,
4 Kentucky, to C. Wesley Morgan and Lisa Chasteen Foster; and

5 WHEREAS, Jordan attended the Salmon P. Chase Law School at Northern
6 Kentucky University and graduated in 2015. While at Chase Law School, she contributed
7 to the legal community through internships. Jordan served as the President of the
8 Federalist Society where she created programming to inform students about political and
9 legal topics; and

10 WHEREAS, Jordan served crime victims and was committed to justice while acting
11 as an Assistant Commonwealth Attorney for Boone and Gallatin Counties. She was a
12 member of the Boone and Gallatin Drug Court Committee and Northern Kentucky
13 Human Trafficking Task Force. Jordan served the Commonwealth while working for
14 Governor Matt Bevin's office. She most recently began working as an attorney for
15 Reminger Co. in Lexington, Kentucky; and

16 WHEREAS, Jordan was committed to educating young people about conservative
17 principles in order to inform voters. She was passionately patriotic and fiercely
18 conservative, and through her work in the political arena, many young people were
19 introduced to the political process. She served on the board of Northern Kentucky Young
20 Republicans as the 2017-2018 Campaign and Community Liaison. In this role she
21 connected campaigns to young volunteers and also connected the community to Northern
22 Kentucky Young Republican's mission as an organization; and

23 WHEREAS, Jordan is survived by her father, C. Wesley (Lindsey) Morgan; her
24 mother, Lisa Chasteen (Don) Foster; three sisters, Sydney Morgan, Shonda Burrows, and
25 Tracy Cope; step-sister, Donna (Ned) Willis; two nieces, Hayleigh Burrows and Ashley
26 Willis; five nephews, Chase Burrows, Douglas Williams, Micah Williams, Jakob
27 Williams, and Kristopher Foster; uncles, Bill (Marilyn) Chasteen, Darryl Chasteen, and

1 Bobby Chasteen; aunts, Linda Morgan, Beverly Morgan, Bobbie Smallwood, and
2 Stephanie Turner; cousins, Matthew Williams, Michelle Morris, Diana Sizemore,
3 Jennifer McIntyre, Stevie Smallwood, Bruce Chasteen, Anthony Chasteen, Kyle
4 Chasteen, Brian Chasteen, Kim Stephens, Krista Ledesma, and Matthew Turner; special
