

1 A RESOLUTION honoring Senator Wil Schroder upon the occasion of his
2 retirement from the General Assembly.

3 WHEREAS, Senator Schroder was elected in November 2014 to represent the 24th
4 District, comprising Campbell, Pendleton, and Bracken Counties, while balancing a
5 challenging career as an attorney with the law firm Dinsmore and Shohl; and

6 WHEREAS, Senator Schroder has served his constituents and the General
7 Assembly with honor and integrity and worked tirelessly for the good of the citizens of
8 his community and the Commonwealth of Kentucky; and

9 WHEREAS, Senator Schroder currently serves as chair of the Economic
10 Development, Tourism, and Labor Committee and is the former chair of the State and
11 Local Government Committee and former co-chair of the Public Pension Working
12 Group; and

13 WHEREAS, Senator Schroder has also faithfully served on the Judiciary
14 Committee; the Veterans, Military Affairs, and Public Protection Committee; and the
15 Legislative Oversight and Investigations Committee; and

16 WHEREAS, Senator Schroder has shown his commitment to children, families, and
17 the citizens of the Commonwealth by expanding economic development in Northern
18 Kentucky and across the Commonwealth through removing artificial barriers to the
19 creation of entertainment destination centers, enhancing the public's access to open
20 records, protecting the right to free speech on university campuses, safeguarding
21 taxpayers by ensuring the efficient operation of local governments, removing the statute
22 of limitations on child abuse and neglect cases, preventing hackers and online vigilantes
23 from publishing private information, and creating a special license plate for Gold Star
24 Sons and Gold Star Daughters; and

25 WHEREAS, Senator Schroder's devotion to conservative principles, strong work
26 ethic, and unmatched level of integrity naturally garnered respect from not only his
27 contemporaries in the Senate but also statewide; and

1 WHEREAS, although the contributions of this public servant will be sorely missed,
2 Senator Schroder's service to the Commonwealth of Kentucky will never be forgotten;

4 *Be it resolved by the Senate of the General Assembly of the Commonwealth of*
5 *Kentucky:*

7 hereby recognize and honor the gentleman from Campbell 24 on the occasion of his
8 retirement.
