1	A RESOLUTION recognizing April as Sexual Assault Awareness and Prevention
2	Month in Kentucky and honoring Kentucky's 13 regional rape crisis centers and those
3	who have been sexually assaulted and abused.
4	WHEREAS, Kentucky has a higher rate of sexual assault and abuse than the
5	national average. This fact must be brought to light as sexual assault and abuse can only
6	be prevented when they are openly recognized and addressed; and
7	WHEREAS, sexual assault and abuse have been determined to be a public health
8	crisis, which hurts individuals and communities mentally, physically, and financially; and
9	WHEREAS, all Kentuckians have a right to be safe from harm, and Kentucky can
10	reduce sexual assault and abuse through policies that increase protective factors and
11	decrease risk factors; and
12	WHEREAS, survivors of sexual assault and abuse are at a substantially greater risk
13	for trauma-related illness, including depression, post-traumatic stress disorder, suicidal
14	ideation, sleep disorders, and eating disorders; and
15	WHEREAS, it is important to recognize the strength, courage, and challenges faced
16	by those who are sexually assaulted and abused, as well as their families and friends, and
17	to acknowledge that some individuals do not survive the horrific long-term trauma that
18	often occurs in the wake of sexual harm; and
19	WHEREAS, a coalition of rape crisis centers, known as the Kentucky Association
20	of Sexual Assault Programs, was formed 32 years ago to confront sexual assault and
21	abuse; and
22	WHEREAS, last year Kentucky's regional rape crisis centers responded to over
23	5,000 crisis calls, provided more than 18,800 counseling sessions, performed over 3,700
24	advocacy services, and provided over 2,300 educational programs for nearly 69,400
25	Kentuckians; and
26	WHEREAS, sexual assault and abuse can be prevented and Kentucky's regional
27	rape crisis centers are working with allies to implement primary prevention efforts by
