14	President for regional and graduate education and expanded the university's accessibility

16	new locations in Kentucky, California, India, and Ontario, Canada; and
17	WHEREAS, he has led efforts to enhance the communication impact of the
18	university by moving broadcast services to digital transmission, increasing publications of
19	the university's magazine, The Campbellsvillian, and developing the new Mass
20	Communication Center that houses both broadcast and academic programs; and
21	WHEREAS, he is an active member in several chambers of commerce, is a Deacon
22	in his home church, and he and his wife, Rita Kelly Spears, are the proud parents of two
23	children and grandparents of three children; and
24	WHEREAS, in 2019, Dr. Spears was named Senior Vice President of
25	Campbellsville University, and he was appointed Acting President following the
26	retirement of his predecessor in December 2020; and
