

1 AN ACT relating to dual credit scholarships.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 164.786 is amended to read as follows:

4 (1) For purposes of this section:

5 (a) "Academic term" means the fall or spring academic semester;

6 (b) "Academic year" means July 1 through June 30 of each year;

7 (c) "Approved dual credit course" means a dual credit course developed in
8 accordance with KRS 164.098 and shall include:

9 1. General education courses ***that are transferable as part of the***
10 ***curricular pathway of a degree or credential or outlined in the***
11 ***statewide general education core approved by the Council on***
12 ***Postsecondary Education;*** and

13 2. Career and technical education courses within a career pathway
14 approved by the Kentucky Department of Education that leads to an
15 industry-recognized credential;

16 (d) "Authority" means the Kentucky Higher Education Assistance Authority;

17 (e) "Dual credit" has the same meaning as in KRS 158.007;

18 (f) "Dual credit tuition rate ceiling" means ***one-half (1/2)***~~one-third (1/3)~~ of the
19 per credit hour tuition amount charged by the Kentucky Community and
20 Technical College System for in-state students;

21 (g) "Eligible high school student" means a student who:

22 1. Is a Kentucky resident;

23 2. Is enrolled in a Kentucky high school~~[as a senior or junior];~~

24 3. Has completed a thirty (30) minute college success counseling session;
25 and

26 4. Is enrolled, or accepted for enrollment, in an approved dual credit course
27 at a participating institution; ***and***

- 1 (h) "Participating institution" means a postsecondary institution that:
- 2 1. Has an agreement with the authority for the administration of the Dual
- 3 Credit Scholarship Program;
- 4 2. Charges no more than the dual credit tuition rate ceiling per credit hour,
- 5 including any additional fees, for any dual credit course it offers to any
- 6 Kentucky public or nonpublic high school student;
- 7 3. Does not charge any tuition or fees to an eligible high school student for
- 8 an approved dual credit course beyond what is paid by the Dual Credit
- 9 Scholarship Program ~~when the course is not successfully completed~~;
- 10 and
- 11 4. Is a:
- 12 a. Kentucky Community and Technical College System institution;
- 13 b. Four (4) year Kentucky public college or university; or
- 14 c. Four (4) year private college or university that is accredited by the
- 15 Southern Association of Colleges and Schools and whose main
- 16 campus is located in Kentucky~~; and~~
- 17 ~~(i) "Successfully completed" means a student receiving both secondary and~~
- 18 ~~postsecondary credit upon completion of an approved dual credit course~~.
- 19 (2) To promote dual credit coursework opportunities at no cost to eligible Kentucky
- 20 high school students, the General Assembly hereby establishes the Dual Credit
- 21 Scholarship Program.
- 22 (3) In consultation with the *Council on Postsecondary Education, the Kentucky*
- 23 *Department of Education, and the* Education and Labor Cabinet, the authority
- 24 shall administer the Dual Credit Scholarship Program and shall promulgate
- 25 administrative regulations in accordance with KRS Chapter 13A as may be needed
- 26 for the administration of the program.
- 27 (4) (a) Each high school shall apply to the authority for dual credit scholarship funds

1 for each eligible high school student.

2 (b) The authority may award a dual credit scholarship to an eligible high school
3 student for an academic term on a first-come, first-served basis by
4 application date to the extent funds are available for that purpose~~, except that~~
5 ~~a scholarship shall be awarded to an eligible high school senior prior to~~
6 ~~awarding an eligible high school junior~~.

7 (c) An eligible high school student may receive a dual credit scholarship for
8 enrollment in:

9 1. Two (2) career and technical education dual credit courses per
10 academic year in grades nine (9), ten (10), eleven (11), and twelve
11 (12); and

12 2. Two (2) general education dual credit courses per academic year in
13 grades eleven (11) and twelve (12)~~[a maximum of two (2) successfully~~
14 ~~completed dual credit courses]~~.

15 (d) The dual credit scholarship award amount shall be equal to the amount
16 charged by a participating institution, not to exceed the dual credit tuition rate
17 ceiling for each dual credit hour~~, except the scholarship amount shall be~~
18 ~~reduced by fifty percent (50%) if the dual credit course is not successfully~~
19 ~~completed by the student~~.

20 (e) Dual credit scholarship funds shall not be used for remedial or developmental
21 coursework.

22 (5) Each participating institution shall submit information each academic term to the
23 authority required for the administration of the scholarship as determined by the
24 authority.

25 (6) Beginning August 1, 2017, and each year thereafter, the authority shall provide a
26 report to the Interim Joint Committee on Education, the secretary of the Education
27 and Labor Cabinet, the president of the Council on Postsecondary Education, and

1 the commissioner of the Kentucky Department of Education to include:

2 (a) The number of students, by local school district and in total, served by the
3 Dual Credit Scholarship Program; and

4 (b) The number of general education and career and technical education dual
5 credits earned by students by high school and in total.

6 (7) By May 31, 2019, and each year thereafter, the Kentucky Center for ~~Education and~~
7 ~~Workforce~~ Statistics, in collaboration with the authority, shall publish data on the
8 Dual Credit Scholarship Program's academic and workforce outcomes. The center
9 shall annually provide a report on the data to the Interim Joint Committee on
10 Education.

11 (8) (a) The Dual Credit Scholarship Program trust fund is hereby created as a trust
12 fund in the State Treasury to be administered by the Kentucky Higher
13 Education Assistance Authority for the purpose of providing scholarships
14 described in this section.

15 (b) The trust fund shall consist of state general fund appropriations, gifts and
16 grants from public and private sources, and federal funds. All moneys
17 included in the fund shall be appropriated for the purposes set forth in this
18 section.

19 (c) Any unallotted~~unalloted~~ or unencumbered balances in the trust fund shall be
20 invested as provided in KRS 42.500(9). Income earned from the investments
21 shall be credited to the trust fund.

22 (d) Notwithstanding KRS 45.229, any fund balance at the close of the fiscal year
23 shall not lapse but shall be carried forward to the next fiscal year and
24 continuously appropriated only for the purposes specified in this section.

25 ➔Section 2. KRS 164.787 is amended to read as follows:

26 (1) The General Assembly hereby establishes the Work Ready Kentucky Scholarship
27 Program to ensure that all Kentuckians who have not yet earned a postsecondary

1 degree have affordable access to an industry-recognized certificate, diploma, or
 2 associate of applied science degree and, for students with intellectual disabilities
 3 enrolled in comprehensive transition and postsecondary programs, affordable
 4 access to meaningful credentials to prepare for competitive integrated employment.

5 (2) For purposes of this section:

6 (a) "Academic term" means a fall, spring, or summer academic term or other time
 7 period specified in an administrative regulation promulgated by the authority;

8 (b) "Academic year" means July 1 through June 30 of each year;

9 (c) ~~["Approved dual credit course" means a dual credit course developed in
 10 accordance with KRS 164.098 that is a career and technical education course
 11 within a career pathway approved by the Kentucky Department of Education
 12 that leads to an industry-recognized credential;~~

13 ~~(d) "Dual credit tuition rate ceiling" means the same as defined in 164.786;~~

14 ~~(e)]~~"Eligible institution" means an institution defined in KRS 164.001 that:

15 1. Actively participates in the federal Pell Grant program;

16 2. Executes a contract with the authority on terms the authority deems
 17 necessary or appropriate for the administration of its programs; ***and***

18 3. ~~[Charges no more than the dual credit tuition rate ceiling per credit hour,
 19 including any additional fees, for any dual credit course it offers to any
 20 Kentucky public or nonpublic high school student; and~~

21 4. ~~]Is a:~~

22 a. Kentucky Community and Technical College System institution;

23 b. Kentucky public university; or

24 c. College, university, or vocational-technical school that is
 25 accredited by a recognized regional or national accrediting body
 26 and licensed to operate at a site in Kentucky;

27 ~~(d)~~~~(f)~~ "Eligible program of study" means a program approved by the authority

1 that leads to an industry-recognized certificate, diploma, or associate of
 2 applied science degree in one (1) of Kentucky's top five (5) high-demand
 3 workforce sectors identified by the Kentucky Workforce Innovation Board
 4 and the Education and Labor Cabinet or a program of study in a
 5 comprehensive transition and postsecondary program that leads to a
 6 credential, certificate, diploma, or degree;

7 ~~(e)~~~~(g)~~ "Fees" means mandatory fees charged by an eligible institution for
 8 enrollment in a course, including but not limited to online course fees, lab
 9 fees, and administrative fees. "Fees" does not include tools, books, or other
 10 instructional materials that may be required for a course; and

11 ~~(f)~~~~(h)~~ "Tuition" means the in-state tuition charged to all students as a condition
 12 of enrollment in an eligible institution.

13 (3) In consultation with the Education and Labor Cabinet~~, the Kentucky Department of~~
 14 ~~Education,~~ and the Council on Postsecondary Education, the Kentucky Higher
 15 Education Assistance Authority shall administer the Work Ready Kentucky
 16 Scholarship Program and promulgate administrative regulations in accordance with
 17 KRS Chapter 13A as may be needed for the administration of the scholarship.

18 (4) ~~[An eligible high school student shall:~~

19 ~~(a) Be a Kentucky resident;~~

20 ~~(b) Be enrolled in a Kentucky high school;~~

21 ~~(c) Be enrolled, or accepted for enrollment, in an approved dual credit course at~~
 22 ~~an eligible institution; and~~

23 ~~(d) Complete and submit a Work Ready Kentucky Scholarship dual credit~~
 24 ~~application to the authority.~~

25 ~~(5)]An eligible workforce student shall:~~

26 (a) Be a citizen or permanent resident of the United States;

27 (b) Be a Kentucky resident as determined by the eligible institution in accordance

- 1 with criteria established by the Council on Postsecondary Education for the
2 purposes of admission and tuition assessment;
- 3 (c) 1. Have earned a high school diploma or a High School Equivalency
4 Diploma or be enrolled in a High School Equivalency Diploma
5 program; or
- 6 2. For a student enrolled in a comprehensive transition and postsecondary
7 program, have received an alternative high school diploma described in
8 KRS 158.140(2)(b) or have attended a Kentucky public high school and
9 is a student with an intellectual disability as defined in 34 C.F.R. sec.
10 668.231;
- 11 (d) Not have earned an associate's degree or higher level postsecondary degree;
- 12 (e) Complete the Free Application for Federal Student Aid for the academic year
13 in which the scholarship is awarded;
- 14 (f) Complete and submit a Work Ready Kentucky Scholarship application to the
15 authority;
- 16 (g) Enroll in an eligible program of study at an eligible institution;
- 17 (h) Not be enrolled in an ineligible degree program, such as a bachelor or
18 unapproved associate program, at any postsecondary institution;
- 19 (i) Following the first academic term scholarship funds are received, achieve and
20 maintain satisfactory academic progress as determined by the eligible
21 institution; and
- 22 (j) Not be in default on any program under Title IV of the federal act or any
23 obligation to the authority under any program administered by the authority
24 under KRS 164.740 to 164.7891 or 164.7894, except that ineligibility for this
25 reason may be waived by the authority for cause.
- 26 ~~(5)(6)~~ (a) Beginning with the 2019-2020 academic year, the authority shall award
27 a Work Ready Kentucky Scholarship each academic term to any person who

1 meets the requirements of this section to the extent funds are available for that
2 purpose.

3 (b) The scholarship amount awarded to an eligible workforce student for an
4 academic term shall be the amount remaining after subtracting the student's
5 federal and state grants and scholarships from the maximum scholarship
6 amount. The maximum scholarship amount shall be the per credit hour in-
7 state tuition rate at the Kentucky Community and Technical College System
8 multiplied by the number of credit hours in which the student is enrolled and
9 the fees charged to the student. The authority shall promulgate an
10 administrative regulation in accordance with KRS Chapter 13A to specify the
11 maximum amount to be awarded for fees, ~~except that for the 2019-2020~~
12 ~~academic year the amount awarded for fees shall not exceed four hundred~~
13 ~~dollars (\$400).~~

14 ~~(c) The scholarship award for an eligible high school student shall be limited to~~
15 ~~two (2) approved dual credit courses per academic year. The scholarship~~
16 ~~amount awarded shall be equal to the amount charged by an eligible~~
17 ~~institution for an approved dual credit course, in accordance with subsection~~
18 ~~(2)(e)3. of this section].~~

19 ~~(6)~~~~(7)~~ (a) Except as provided in paragraph (b) of this subsection, an eligible
20 workforce student's eligibility for the scholarship shall terminate upon the
21 earlier of:

- 22 1. Receiving the scholarship for a total of sixty (60) credit hours; or
- 23 2. Obtaining an associate's degree.

24 (b) For an eligible workforce student enrolled in a comprehensive transition and
25 postsecondary program, eligibility for the scholarship shall terminate upon the
26 earlier of completing the program or receiving the scholarship for up to nine
27 (9) academic terms within three (3) academic years.

1 ~~(7)~~⁽⁸⁾ The authority shall annually provide a report on the Work Ready Kentucky
2 Scholarship Program, prepared in collaboration with the Kentucky Center~~[Office]~~
3 for ~~Education and Workforce~~ Statistics, to the Interim Joint Committee on
4 Education, the president of the Council on Postsecondary Education, and the
5 secretary of the Education and Labor Cabinet that includes, by academic term,
6 academic year, institution, and workforce sector, the number of:

- 7 (a) Students served by the scholarship and the total amount disbursed;
8 (b) Credits, certificates, diplomas, and associate of applied science degrees earned
9 by students receiving the scholarship; and
10 (c) Students receiving the scholarship who are enrolled in a comprehensive
11 transition and postsecondary program and credentials earned by those
12 students.

13 ~~(8)~~⁽⁹⁾ The authority shall report Work Ready Kentucky Scholarship program data to
14 the Kentucky Center~~[Office]~~ for ~~Education and Workforce~~ Statistics for analysis
15 of the program's success in meeting the goal of increasing skilled workforce
16 participation rates.

17 ~~(9)~~⁽¹⁰⁾ (a) The Work Ready Kentucky Scholarship fund is hereby created as a trust
18 fund in the State Treasury to be administered by the authority for the purpose
19 of providing scholarships as described in this section.

20 (b) The trust fund shall consist of state general fund appropriations, gifts and
21 grants from public and private sources, and federal funds. All moneys
22 included in the fund shall be appropriated for the purposes set forth in this
23 section.

24 (c) Any unallotted or unencumbered balances in the trust fund shall be invested
25 as provided in KRS 42.500(9). Income earned from the investments shall be
26 credited to the trust fund.

27 (d) Notwithstanding KRS 45.229, any fund balance at the close of the fiscal year

1 shall not lapse but shall be carried forward to the next fiscal year and
2 continuously appropriated only for the purposes specified in this section.
