- 17 and withhold upon the wages a tax determined under KRS 141.315 or by the tables

- 19 (2) If wages are paid with respect to a period which is not a payroll period, the amount
- 20 to be deducted and withheld shall be that applicable in the case of a miscellaneous
- 21 payroll period containing a number of days, including Sundays and holidays, equal

- 23 If wages are paid by an employer without regard to any payroll period or other (3)

1 commencement of employment with the employer during the year, or January 1 of 2 the year, whichever is the later. 3 In determining the amount to be deducted and withheld under this section, the (4) 4 wages may, at the election of the employer, be computed to the nearest dollar. 5 The tables mentioned in subsection (1) of this section shall consider the standard (5)6 deduction. 7 (6)The department may permit the use of accounting machines to calculate the proper 8 amount to be deducted from wages when the calculation produces substantially the 9 same result as set forth in the tables authorized by KRS 141.370. Prior approval of 10 the calculation shall be secured from the department at least thirty (30) days before 11 the first payroll period for which it is to be used. 12 The department may, by administrative regulations, authorize employers: (7)13 To estimate the wages which will be paid to any employee in any quarter of (a) 14 the calendar year; 15 (b) To determine the amount to be deducted and withheld upon each payment of 16 wages to the employee during the quarter as if the appropriate average of the 17 wages estimated constituted the actual wages paid; and 18 To deduct and withhold upon any payment of wages to the employee during (c) 19 the quarter the amount necessary to adjust the amount actually deducted and 20 withheld upon the wages of the employee during the quarter to the amount 21 that would be required to be deducted and withheld during the quarter if the 22 payroll period of the employee was quarterly.

(8) The department may provide by regulation, under the conditions and to the extent it deems proper, for withholding in addition to that otherwise required under this section and KRS 141.315 in cases in which the employer and the employee agree to the additional withholding. The additional withholding shall for all purposes be considered tax required to be deducted and withheld under this chapter.

(9) Effective January 1, 1992, any employer required by this section to withhold Kentucky income tax who assesses and withholds from employees the job assessment fee provided in KRS 154.24-110 may offset a portion of the fee against the Kentucky income tax required to be withheld from the employee under this section. The amount of the offset shall be four-fifths (4/5) of the amount of the assessment fee withheld from the employee or the Commonwealth's contribution of KRS 154.24-110(3) applies. If the provisions in KRS 154.24-150(3) or (4) apply, the offset, the offset shall be one hundred percent (100%) of the assessment.

- (10) Any employer required by this section to withhold Kentucky income tax who assesses and withholds from employees an assessment provided in KRS 154.22-070 or KRS 154.28-110 may offset the fee against the Kentucky income tax required to be withheld from the employee under this section.
