Be it enacted by the General Assembly of the Commonwealth of Kentucky:

3 → Section 1. KRS 158.150 is amended to read as follows:

- 4 (1) All <u>students</u>[pupils] admitted to the common schools shall comply with the lawful regulations for the government of the schools:
 - (a) Willful disobedience or defiance of the authority of the teachers or administrators, use of profanity or vulgarity, assault or battery or abuse of other students, the threat of force or violence, the use or possession of alcohol or drugs, stealing or destruction or defacing of school property or personal property of students, the carrying or use of weapons or dangerous instruments, or other incorrigible bad conduct on school property, as well as off school property at school-sponsored activities, constitutes cause for suspension or expulsion from school; and
 - (b) Assault or battery or abuse of school personnel; stealing or willfully or wantonly defacing, destroying, or damaging the personal property of school personnel on school property, off school property, or at school-sponsored activities constitutes cause for suspension or expulsion from school.
- 18 (2) (a) Each local board of education shall adopt a policy requiring the expulsion
 19 from school for a period of <u>at least twelve (12) months</u> [not less than one (1)
 20 <u>year</u>] for a student who:
 - 1. Is determined by the board through clear and convincing evidence to

 have made threats that pose a danger to the well-being of students,

 faculty, or staff of the district; or
 - 2. Is determined by the board to have brought a weapon to a school under its jurisdiction. In determining whether a student has brought a weapon to school, a local board of education shall use the definition of "unlawful possession of a weapon on school property" stated in KRS 527.070.

1	(b)	The board shall also adopt a policy requiring disciplinary actions, up to and
2		including expulsion from school, for a student who is determined by the board
3		to have <u>:</u>
4		<u>1.</u> Possessed prescription drugs or controlled substances for the purpose of

7		<u>2.</u> Physically assaulted or battered or abused educational personnel or other

12	(3) (a)	The board may modify the expulsion requirement <u>and length</u> for students on a

16	<u>(b)</u>	Nothing in this section shall prohibit a board from expelling a student for
17		longer than twelve (12) months.
18	<u>(c)</u>	A board that has expelled a student from the student's regular school setting
19		shall provide or <i>ensure</i> [assure] that educational services are provided to the
20		student in an appropriate alternative program or setting, unless the board has
21		made a determination, on the record, supported by clear and convincing
22		evidence, that the expelled student posed a threat to the safety of other
23		students or school staff and could not be placed into a state-funded agency
24		program. Behavior which constitutes a threat shall include but not be limited
25		to the physical assault, battery, or abuse of others; the threat of physical force;
26		being under the influence of drugs or alcohol; the use, possession, sale, or
27		transfer of drugs or alcohol; the carrying, possessing, or transfer of weapons

2		safety of others. Other intervention services as indicated for each student may
3		be provided by the board or by agreement with the appropriate state or

6	<u>(d)</u>	1. In lieu of expelling a student, or upon the expiration of a student's
7		expulsion, a superintendent may place a student into an alternative
8		program or setting if the superintendent determines placement of the
9		student in his or her regular school setting is likely to substantially
10		disrupt the education process or constitutes a threat to the safety of
11		other students or school staff. The action shall not be taken until the
12		parent, guardian, or other person having legal custody or control of
13		the student has had an opportunity to have a hearing before the board.
14		2. The alternative program or setting may be provided virtually.
15		3. Notwithstanding any other statute or administrative regulation to the
16		contrary, students placed in an alternative program or setting under

(4)[(3)] For purposes of this subsection, "charges" means substantiated behavior that falls within the grounds for suspension or expulsion enumerated in subsection (1) of this section, including behavior committed by a student while enrolled in a private or public school, or in a school within another state. A school board may adopt a policy providing that, if a student is suspended or expelled for any reason or faces charges that may lead to suspension or expulsion but withdraws prior to a hearing from any public or private school in this or any other state, the receiving district may review the details of the charges, suspension, or expulsion and determine if the student will be admitted, and if so, what conditions may be imposed upon the admission, which may include placement of the student into an alternative program or setting as described in subsection (3)(d) of this section.

(5)[(4)] (a) School administrators, teachers, or other school personnel may immediately remove or cause to be removed threatening or violent students from a classroom setting or from the district transportation system pending any further disciplinary action that may occur. Each board of education shall adopt a policy to assure the implementation of this section and to assure the safety of the students and staff.

(b) Except as described in subsection (10) of this section:

1. When a student violates a school behavior policy and is disruptive to the classroom environment and education process, a teacher may immediately remove or cause to be removed the student from the classroom, and the student shall not reenter the same classroom for the remainder of the school day without the agreement of the teacher and the principal or assistant principal. In addition to removal, the student shall be subject to further discipline for the behavior consistent with the school's code of conduct.

2. A student who is removed from the same classroom three (3) times

1	within a thirty (30) day period shall be considered chronically
2	disruptive and may be suspended from school in accordance with this
3	section, and no other basis for suspension shall be deemed necessary.
4	3. At any time during the school year, for a student who has been
5	removed from the classroom under this paragraph, a principal may
6	require a review of the classroom issues with the teacher and the
7	parent, guardian, or other person having legal custody or control of
8	the student and determine a course of action for the teacher and
9	student regarding the student's continued placement in the classroom.
10	4. At any time during the school year, a principal may permanently
11	remove a student from a classroom for the remainder of the school
12	year if the principal determines the student's continued placement in
13	the classroom will chronically disrupt the education process for other

4	(a)	The student[pupil] has been given oral or written notice of the charge or
5		charges against him <u>or her</u> which constitute cause for suspension;
6	(b)	The student[pupil] has been given an explanation of the evidence of the
7		charge or charges if the <u>student</u> [pupil] denies them; and
8	(c)	The <u>student</u> [pupil] has been given an opportunity to present his <u>or her</u> own

12		school year; or
13		2. The child is subjected to a series of removals that constitute a pattern
14		because the removals accumulate to more than ten (10) school days
15		during a school year and because of other factors, such as the length of
16		each removal, the total amount of time the child is removed, and the
17		proximity of removals to one another.
18	(b)	The admissions and release committee shall meet to review the placement and
19		make a recommendation for continued placement or a change in placement
20		and determine whether regular suspension or expulsion procedures apply.
21		Additional evaluations shall be completed, if necessary.
22	(c)	If the admissions and release committee determines that an exceptional child's
23		behavior is related to his or her disability, the child shall not be suspended
24		any further or expelled unless the current placement could result in injury to
25		the child, other children, or the educational personnel, in which case an
26		appropriate alternative placement shall be provided that will provide for the
27		child's educational needs and will provide a safe learning and teaching
