1	A RESOLUTION recognizing February 14, 2023, as Certified Registered Nurse
2	Anesthetists Day in Kentucky.
3	WHEREAS, Certified Registered Nurse Anesthetists (CRNAs) are advanced
4	practice registered nurses, are among the most trusted health care professionals, and have
5	been providing anesthesia care to patients in the United States for more than 150 years;
6	and
7	WHEREAS, legislation passed by the United States Congress in 1986 made nurse
8	anesthetists the first nursing specialty to be accorded direct reimbursement rights by
9	Medicare; and
10	WHEREAS, CRNAs are the primary anesthesia providers in rural communities,
11	continue to be the primary providers of anesthesia care to United States military
12	personnel, and comprise two-thirds of the anesthesia providers in the Commonwealth;
13	and
14	WHEREAS, CRNAs provide anesthesia services in every Kentucky county that has
15	a hospital or surgery center with surgical services and are the sole providers of anesthesia
16	services in nearly half of those counties, including 17 critical access hospitals; and
17	WHEREAS, CRNAs practice in every setting in which anesthesia is delivered,
18	including traditional hospital surgical suites, obstetrical delivery rooms, critical access
19	hospitals, ambulatory surgical centers, and the offices of dentists, podiatrists,
20	ophthalmologists, and pain management specialists; and
21	WHEREAS, CRNAs are qualified to make independent judgments regarding all
22	aspects of anesthesia care based on their education, training, and licensure; and
23	WHEREAS, CRNAs are trusted anesthesia experts on the frontline, delivering
24	specialized, cost-effective care to all patients, from newborns to seniors, for every type of
25	procedure, and in all types of facilities; and
26	WHEREAS, CRNAs are courageously serving on the frontlines of the COVID-19
27	pandemic using their advanced skills in airway management, intubation, and ventilator

- WHEREAS, during the COVID-19 pandemic, CRNAs have been leaving their
- 3 homes and families and putting their health at risk to travel to hospitals and facilities
