

1           A RESOLUTION adjourning the Senate in honor and loving and memory of Bill  
2 Patrick, former Executive Director of the Kentucky County Attorney's Association.

3           WHEREAS, Bill Patrick, was born on October 17, 1955, in Powell County,  
4 Kentucky to the late Wayne and Betty Patrick; and

5           WHEREAS, Bill Patrick attended Clay City Elementary and Powell County High  
6 School, and graduated from Eastern Kentucky University; and

7           WHEREAS, during his time as a student at Eastern Kentucky University Bill  
8 Patrick accepted Jesus Christ as his Lord and Savior and became a youth pastor at Church  
9 of God in Lexington before he assumed pastoral duties at Stanton First Church of God;  
10 and

11           WHEREAS, never one for idle hands, while attending to his studies at Eastern  
12 Kentucky University and serving his parishioners at Stanton First Church of God, Bill  
13 Patrick also became involved with the Kentucky Young Democrats organization; and

14           WHEREAS, Bill Patrick's uncle, Henry Bascum "Bass" Patrick, was the Powell  
15 County Democratic Chairman and helped Bill become a legislative aide to State Senator  
16 Walter Strong. Shortly thereafter, in 1977, Bill was elected state president of the Young  
17 Democrats the same year he founded his insurance agency in Clay City; and

18           WHEREAS, Bill Patrick was 26 years old when he began his inaugural run for  
19 elected office in 1982 where he upset a long-term incumbent for Powell County  
20 Judge/Executive, becoming the youngest County Judge/Executive in Kentucky history at  
21 the time, and in 1986 he was re-elected for a second term; and

22           WHEREAS, Bill Patrick's legacy as County Judge/Executive was shaped by his  
23 aggressive leadership in economic development, job creation, advocacy for clean  
24 drinking water, and expanding tourism in the region; and

25           WHEREAS, Bill Patrick's leadership caught the eye of Governor-elect Wallace  
26 Wilkinson, who appointed him commissioner of the Department for Local Government.  
27 During Governor Wilkinson's time in office, Bill also served as Chairman of the

1 Kentucky Democratic Party; and

2 WHEREAS, Bill Patrick served in the executive branch under several different  
3 administrations before becoming Executive Director of the Kentucky County Attorney's  
4 Association, a position he held for over a decade; and

5 WHEREAS, Bill Patrick departed this earthly life on October 4th, 2022, after a  
6 courageous six month-long battle with an inoperable glioblastoma brain tumor; and

7 WHEREAS, Bill Patrick is preceded in death by his parents, Wayne and Betty  
8 Patrick, his brother-in-law, J.C. Hall, and his father-in-law, Willard Rogers; and

9 WHEREAS, Bill Patrick is survived by his wife, Tina Goad Patrick, his sons,  
10 William Jacob "Jake" Patrick and Corey Goad, his daughter, Whitney Brewer, and his  
11 sister Connie Patrick Hall; and

12 WHEREAS, Bill Patrick's contributions to the Commonwealth will be remembered  
13 and he will be deeply missed;

14 NOW, THEREFORE,

15 ***Be it resolved by the Senate of the General Assembly of the Commonwealth of***  
16 ***Kentucky:***

17 ➔Section 1. The Senate hereby expresses its most profound sympathy upon the  
18 passing of Bill Patrick.

19 ➔Section 2. When the Senate adjourns this day, it does so in honor and loving  
20 memory of Bill Patrick.
