2	WHEREAS, it is fitting that the members of the General Assembly recognize those
3	venerable institutions that provide their communities with high-quality service and
4	contribute significantly to the economic health of Kentucky; and
5	WHEREAS, this year will mark one century that Kentucky credit unions have
6	operated in this Commonwealth, a noteworthy anniversary that is most worthy of
7	recognition and celebration, as credit unions have contributed greatly to the financial
8	well-being of the citizens of this Commonwealth; and
9	WHEREAS, in March 1922, the General Assembly enacted legislation to establish
10	state-chartered credit unions in Kentucky; and
11	WHEREAS, since the establishment of state-chartered credit unions in Kentucky,
12	credit unions have been an integral component of the banking system and of the economy
13	of Kentucky; and
14	WHEREAS, Berea Credit Union, which was founded in November 1923 to serve
15	educators at Berea College, has the distinction of being the first credit union to be
16	founded in Kentucky; and
17	WHEREAS, credit unions are democratic, with control in the hands of member-
18	owners, who elect a volunteer board of directors; and
19	WHEREAS, credit unions are voluntary organizations open to all people able to use
20	their services and willing to accept the responsibilities of membership without
21	discrimination; and
22	WHEREAS, credit unions offer low loan rates, high savings yields, minimal fees,
23	and exceptional products and services; and
24	WHEREAS, credit unions are independent, with ownership by members rather than
25	outside shareholders; and
26	WHEREAS, credit unions believe in financial education and are actively involved
27	with schools and in helping members grow their knowledge and increase agency over
