1	A RESOLUTION honoring the life and accomplishments of former Kentucky
2	Governor John Young Brown Jr.
3	WHEREAS, John Young Brown Jr. was born on December 28, 1933, in Lexington,
4	Kentucky, to the late U.S. Congressman John Y. Brown Sr. and Dorothy Inman Brown;
5	and
6	WHEREAS, John Y. Brown Jr. was an avid sportsman in high school and
7	distinguished himself as one of Encyclopedia Britannica's top salesmen in the country,
8	paying his way through college and law school at the University of Kentucky; and
9	WHEREAS, John Y. Brown Jr. initially practiced law with his father in Lexington
10	and Louisville, Kentucky, before leaving the active practice of law in 1964; and
11	WHEREAS, John Y. Brown Jr. was only 30 years old when he purchased Kentucky
12	Fried Chicken (KFC) from its founder Harland Sanders in 1964 and, within seven years,
13	he transformed the restaurant into one of the world's largest fast-food chains; and
14	WHEREAS, because of John Y. Brown Jr.'s exceptional business management
15	skills, KFC became a worldwide success, resulting in a huge personal profit when he sold
16	the company in 1971; and
17	WHEREAS, after selling his interest in KFC, John Y. Brown Jr. went on to invest
18	in several other restaurant ventures and also purchased three separate professional
19	basketball teams: the American Basketball Association's Kentucky Colonels and the
20	National Basketball Association's Boston Celtics and Buffalo Braves (now known as the
21	Los Angeles Clippers); and
22	WHEREAS, John Y. Brown Jr. was a talented businessman and was named one of
23	the top 200 American business leaders of the 20th century by Harvard Business School in
24	2009; and
25	WHEREAS, John Y. Brown Jr. was elected Kentucky's 55th Governor in 1979.
26	During his term as Governor, John Y. Brown Jr. created a more diverse cabinet than
27	previous administrations and brought in top Kentucky business leaders as cabinet

- 1 secretaries; and
- WHEREAS, John Y. Brown Jr. had many successes as Governor, including the
- 3 establishment of the Governor's Scholars Program, which still exists today; and
- 4 WHEREAS, as Governor, John Y. Brown Jr. also used his business and marketing
- 5 skills to promote Kentucky nationally and abroad, which attracted major businesses like
- 6 UPS; and
- WHEREAS, in addition to his business and political accomplishments, John Y.
- 8 Brown Jr. was also a philanthropist who built the Pamela Brown Auditorium at
- 9 Louisville's Actors Theatre in honor of his sister and was instrumental in creating the
- Muhammad Ali Center. He also helped fund the downtown Louisville YMCA and helped
- establish the Sanders-Brown Center on Aging at the University of Kentucky; and
- WHEREAS, John Y. Brown Jr. passed away on November 21, 2022, surrounded by
- his loving family, at the age of 88. He is survived by his five children: Lincoln Brown,
- 14 Pamela Brown, John Y. Brown III, Sissy Brown, and Sandy Steier; 12 grandchildren; and
- 15 longtime partner Mary Ellen Wheeler;
