

1 AN ACT relating to the administrative writings of the Kentucky Department of  
2 Revenue.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 131.010 is amended to read as follows:

5 As used in this chapter, unless the context requires otherwise:

- 6 (1) "Commissioner" means the commissioner of *the department*~~[revenue]~~;
- 7 (2) "Department" means the Department of Revenue;
- 8 (3) "Fiduciary" means a guardian, trustee, executor, administrator, receiver,  
9 conservator, or any individual or corporation acting in a fiduciary capacity for any  
10 other person;
- 11 (4) "Taxpayer" means any person required or permitted by law or administrative  
12 regulation to perform any act subject to the administrative jurisdiction of the  
13 department including the following:
- 14 (a) File a report, return, statement, certification, claim, estimate, declaration,  
15 form, or other document;
- 16 (b) Furnish any information;
- 17 (c) Withhold, collect, or pay any tax, installment, estimate, or other funds; *and*
- 18 (d) Secure any license, permit, or other authorization to conduct a business or  
19 exercise any privilege, right, or responsibility;
- 20 (5) "Adjusted prime rate charged by banks" means the average predominant prime rate  
21 quoted by commercial banks to large businesses, as determined by the board of  
22 governors of the Federal Reserve System;
- 23 (6) "Tax interest rate" means the interest rate determined under KRS 131.183;
- 24 (7) "Tax" includes any assessment or license fee administered by the department;  
25 however, it shall not include moneys withheld or collected by the department  
26 pursuant to KRS 131.560 or 160.627;
- 27 (8) "Return" or "report" means any properly completed and, if required, signed form,

1 statement, certification, claim estimate, declaration, or other document permitted or  
2 required to be submitted or filed with the department, including returns and reports  
3 or composites thereof which are permitted or required to be electronically  
4 transmitted;

5 (9) "Reasonable cause" means an event, happening, or circumstance entirely beyond  
6 the knowledge or control of a taxpayer who has exercised due care and prudence in  
7 the filing of a return or report or the payment of moneys due the department  
8 pursuant to law or administrative regulation;

9 (10) "Fraud" means:

10 (a) Intentional or reckless disregard for the law, administrative regulations, or the  
11 department's established policies to evade the filing of any return, report, or  
12 the payment of any moneys due to the department pursuant to law or  
13 administrative regulation; or

14 (b) The deliberate false reporting of returns or reports with the intent to gain a  
15 monetary advantage;

16 (11) "Hard copy" means any document, record, report, or other data printed on paper or  
17 stored by an imaging system that does not permit additions, deletions, or other  
18 changes to the original documents;

19 (12) "Electronic record" means a collection of related information stored as bits of data  
20 in a medium that supports electronic extraction of the data at the field level, but  
21 does not include electronic imaging systems;

22 (13) "Electronic imaging systems" means a computer-based system used to store  
23 reproductions of documents and records through the use of electronic data  
24 processing, or computerized, digital, or optical scanning which records and indexes  
25 the document, but does not support electronic extraction of the data at the field  
26 level;

27 (14) "Electronic fund transfer" means an electronic data processing medium that takes

1 the place of a paper check for debiting or crediting an account and of which a  
2 permanent record is made;

3 (15) "Specified tax return preparer" has the same meaning as in 26 U.S.C. sec.  
4 6011(e)(3);~~and~~

5 (16) "Tax return preparer" has the same meaning as in 26 U.S.C. sec. 7701(a)(36)(A);

6 **(17) "Administrative writings" means the following, as created, published, issued, or**  
7 **released by the department and redacted to protect taxpayer-specific information:**

8 **(a) Final rulings;**

9 **(b) Manuals and training procedures;**

10 **(c) Presentations;**

11 **(d) Technical advice memoranda;**

12 **(e) General information letters; and**

13 **(f) Private letter rulings; and**

14 **(18) "Tax form":**

15 **(a) Means any instrument that is:**

16 **1. Created, published, issued, approved, or released by the department**  
17 **upon which taxpayers insert information; and**

18 **2. Permitted or required to be submitted to or filed with the department;**  
19 **and**

20 **(b) Includes any of the following instruments, except that the instrument shall**  
21 **not contain any information inserted by a taxpayer:**

22 **1. A return, report, schedule, claim estimate, declaration, or any other**  
23 **similar document; and**

24 **2. A facsimile of information the taxpayer is required to, or may, submit**  
25 **to the department electronically.**

26 ➔Section 2. KRS 131.020 is amended to read as follows:

27 (1) The department~~[of Revenue]~~, headed by a commissioner appointed by the secretary

1 with the approval of the Governor, shall be organized into the following functional  
2 units:

3 (a) Office of the Commissioner, which shall consist of:

- 4 1. The Division of Protest Resolution, headed by a division director who  
5 shall report directly to the commissioner. The division shall administer  
6 the protest functions for the department from office resolution through  
7 court action;
- 8 2. The Division of Taxpayer Ombudsman, headed by a division director  
9 who shall report to the commissioner. The division shall perform those  
10 duties set out in KRS 131.083;
- 11 3. The Special Investigations Division, headed by a division director who  
12 shall report directly to the commissioner. The division shall investigate  
13 alleged violations of the tax laws and recommend criminal prosecution  
14 of the laws when warranted; and
- 15 4. The Division of Information Management, headed by a division director  
16 who shall report directly to the commissioner. The division shall provide  
17 project management, planning, analysis, application development,  
18 implementation, security, support, and maintenance for new and existing  
19 legacy systems of the department;

20 (b) Office of Tax Policy and Regulation, headed by an executive director who  
21 shall report directly to the commissioner. The office shall be responsible for:

- 22 1. Providing oral and written technical advice on Kentucky tax law;
- 23 2. Drafting proposed tax legislation and regulations;
- 24 3. Testifying before legislative committees on tax matters;
- 25 4. Analyzing tax publications;
- 26 5. **Publishing administrative writings on its official website promptly**  
27 **after issuance or finalization, but no more than one hundred twenty**

- 1                    (120) days thereafter;
- 2                    6. Publishing all tax forms and instructions to those tax forms on its
- 3                    official website no later than:
- 4                    a. Forty-five (45) days prior to the date a taxpayer is required to:
- 5                    i. File a tax form;
- 6                    ii. Make a payment of taxes due or estimated to be due; or
- 7                    iii. Electronically submit the information or payment; or
- 8                    b. In the case of income tax forms, thirty (30) days prior to the end
- 9                    of the calendar year for which the tax form, payment, or
- 10                   information applies;
- 11                   7. Providing expert witness testimony in tax litigation cases;
- 12                   8.~~[6.]~~ Providing consultation and assistance in protested tax cases; and
- 13                   9.~~[7.]~~ Conducting training and education programs;
- 14                   (c) Office of Registration and Operations, headed by an executive director who
- 15                   shall report directly to the commissioner. The office shall be responsible for
- 16                   processing documents, depositing funds, collecting debt payments, and
- 17                   coordinating, planning, and implementing a data integrity strategy. The office
- 18                   shall consist of the:
- 19                   1. Division of Operations, which shall be responsible for opening all tax
- 20                   returns, preparing the returns for data capture, coordinating the data
- 21                   capture process, depositing receipts, maintaining tax data, and assisting
- 22                   other state agencies with similar operational aspects as negotiated
- 23                   between the department and the other agency; and
- 24                   2. Division of Registration, which shall be responsible for registering
- 25                   businesses for tax purposes, ensuring that the data entered into the
- 26                   department's tax systems is accurate and complete, and assisting the
- 27                   taxing areas in proper procedures to ensure the accuracy of the data over

1 time;

2 (d) Office of Property Valuation, headed by an executive director who shall  
3 report directly to the commissioner. The office shall consist of the:

4 1. Division of Local Support, which shall be responsible for providing  
5 supervision, assistance, and training to the property valuation  
6 administrators and sheriffs within the Commonwealth;

7 2. Division of State Valuation, which shall be responsible for providing  
8 assessments of public service companies and motor vehicles, and  
9 providing assistance to property valuation administrators and sheriffs  
10 with the administration of tangible and omitted property taxes within the  
11 Commonwealth; and

12 3. Division of Minerals Taxation and Geographical Information System  
13 Services, which shall be responsible for providing geographical  
14 information system mapping support, ensuring proper filing of  
15 severance tax returns, ensuring consistency of unmined coal  
16 assessments, and gathering and providing data to properly assess  
17 minerals to the property valuation administrators within the  
18 Commonwealth;

19 (e) Office of Sales and Excise Taxes, headed by an executive director who shall  
20 report directly to the commissioner. The office shall administer all matters  
21 relating to sales and use taxes and miscellaneous excise taxes, including but  
22 not limited to technical tax research, compliance, taxpayer assistance, tax-  
23 specific training, and publications. The office shall consist of the:

24 1. Division of Sales and Use Tax, which shall administer the sales and use  
25 tax; and

26 2. Division of Miscellaneous Taxes, which shall administer various other  
27 taxes, including but not limited to alcoholic beverage taxes; cigarette

1 enforcement fees, stamps, meters, and taxes; gasoline tax; bank  
2 franchise tax; inheritance and estate tax; insurance premiums and  
3 insurance surcharge taxes; motor vehicle tire fees and usage taxes; and  
4 special fuels taxes;

5 (f) Office of Income Taxation, headed by an executive director who shall report  
6 directly to the commissioner. The office shall administer all matters related to  
7 income and corporation license taxes, including technical tax research,  
8 compliance, taxpayer assistance, tax-specific training, and publications. The  
9 office shall consist of the:

- 10 1. Division of Individual Tax, which shall administer the following taxes  
11 or returns: individual income, fiduciary, and employer withholding; and
- 12 2. Division of Corporation Tax, which shall administer the corporation  
13 income tax, corporation license tax, pass-through entity withholding,  
14 and pass-through entity reporting requirements;

15 (g) Office of Field Operations, headed by an executive director who shall report  
16 directly to the commissioner. The office shall manage the regional taxpayer  
17 service centers and the field audit program; and

18 (h) Office of Enforcement, headed by an executive director who shall report  
19 directly to the commissioner. The office shall initiate all collection  
20 enforcement activity related to due and owing tax assessments, including  
21 protest resolution, and shall assist other state agencies with similar collection  
22 aspects as negotiated between the department and other state agencies. The  
23 office shall consist of the Division of Collections.

24 (2) The functions and duties of the department shall include conducting conferences,  
25 administering taxpayer protests, and settling tax controversies on a fair and  
26 equitable basis, taking into consideration the hazards of litigation to the  
27 Commonwealth of Kentucky and the taxpayer. The mission of the department shall

1 be to afford an opportunity for taxpayers to have an independent informal review of  
2 the determinations of the audit functions of the department, and to attempt to fairly  
3 and equitably resolve tax controversies at the administrative level.

4 (3) The department shall maintain an accounting structure for the one hundred twenty  
5 (120) property valuation administrators' offices across the Commonwealth in order  
6 to facilitate use of the state payroll system and the budgeting process.

7 (4) Except as provided in KRS 131.190(4), the department shall fully cooperate with  
8 and make tax information available as prescribed under KRS 131.190(3) to the  
9 Governor's Office for Economic Analysis as necessary for the office to perform the  
10 tax administration function established in KRS 42.410.

11 (5) Executive directors and division directors established under this section shall be  
12 appointed by the secretary with the approval of the Governor under KRS 12.050.

13 ➔Section 3. KRS 131.030 is amended to read as follows:

14 (1) The Department of Revenue shall exercise all administrative functions of the state  
15 in relation to:

16 (a) The state revenue and tax laws;[;]

17 (b) **The publishing of administrative writings, tax forms, and instructions to**  
18 **those tax forms on its official website;**

19 (c) The licensing and registering of motor vehicles;[;]

20 (d) The equalization of tax assessments;[;]

21 (e) The assessment of public utilities and public service corporations for taxes;[;]

22 (f) The assessment of franchises;[;]

23 (g) The supervision of tax collections;[;] and

24 (h) The enforcement of revenue and tax laws, either directly or through  
25 supervision of tax administration activity in other departments to which the  
26 department may commit administration of certain taxes.

27 (2) The department shall have all the powers and duties with reference to assessment or



1 equalization of the assessment of property heretofore exercised or performed by any  
2 state board or commission.

3 (3) The department shall have all the powers and duties necessary to consider and settle  
4 tax cases under KRS 131.110 and refund claims made under KRS 134.580. The  
5 department is encouraged to settle controversies on a fair and equitable basis and  
6 shall be authorized to settle tax controversies based on the hazards of litigation  
7 applicable to them.

8 (4) The department shall have all the powers and duties necessary to collect any debts  
9 owed to the Commonwealth, or any local government of the Commonwealth, that  
10 are referred to the department by an organizational unit or administrative body in  
11 the executive branch of state government, as defined in KRS 12.010, the Court of  
12 Justice in the judicial branch of state government, and any local government, under  
13 KRS 45.237 and 45.241.

14 ➔Section 4. KRS 131.081 is amended to read as follows:

15 The following rules, principles, or requirements shall apply in the administration of all  
16 taxes subject to the jurisdiction of the department:

17 (1) The department shall develop and implement a Kentucky tax education and  
18 information program ***that:***

19 ***(a) Is*** directed at new taxpayers, taxpayer and industry groups, and department  
20 employees to enhance the understanding of and compliance with Kentucky  
21 tax laws; ~~including~~

22 ***(b) Includes information on:***

23 ***1.*** The application of new tax legislation to taxpayer activities; ~~and~~

24 ***2.*** Areas of recurrent taxpayer noncompliance or inconsistency of  
25 administration; ***and***

26 ***(c) Is published as part of the administrative writings posted on its official***  
27 ***website;***

- 1 (2) The department shall publish brief statements in simple and nontechnical language  
2 which explain procedures, remedies, and the rights and obligations of taxpayers and  
3 the department. These statements shall be provided to taxpayers with the initial  
4 notice of audit; each original notice of tax due; each denial or reduction of a refund  
5 or credit claimed by a taxpayer; each denial, cancellation, or revocation of any  
6 license, permit, or other required authorization applied for or held by a taxpayer;  
7 and, if practical and appropriate, in informational publications by the department  
8 distributed to the public;
- 9 (3) Taxpayers shall have the right to be assisted or represented by an attorney,  
10 accountant, or other person in any conference, hearing, or other matter before the  
11 department. The taxpayer shall be informed of this right prior to conduct of any  
12 conference or hearing;
- 13 (4) The department shall perform audits and conduct conferences and hearings only at  
14 reasonable times and places;
- 15 (5) Taxpayers shall have the right to make audio recordings of any conference with or  
16 hearing by the department. The department may make similar audio recordings if  
17 prior written notice is given to the taxpayer or if the taxpayer records the conference  
18 or hearing. The taxpayer shall be entitled to a copy of this department recording or a  
19 transcript as provided in KRS 61.874;
- 20 (6) If any taxpayer's failure to submit a timely return or payment to the department is  
21 due to the taxpayer's reasonable reliance on written advice from the department, the  
22 taxpayer shall be relieved of any penalty or interest with respect thereto, provided  
23 the taxpayer requested the advice in writing from the department and the specific  
24 facts and circumstances of the activity or transaction were fully described in the  
25 taxpayer's request, the department did not subsequently rescind or modify the  
26 advice in writing, and there were no subsequent changes in applicable laws or  
27 regulations or a final decision of a court which rendered the department's earlier

1 written advice no longer valid;

2 (7) Taxpayers shall have the right to receive a copy of any audit of the department by  
3 the Auditor of Public Accounts relating to the department's compliance with the  
4 provisions of KRS 131.041 to 131.081;

5 (8) (a) The department shall include with each notice of tax due a clear and concise  
6 description of the basis and amount of any tax, penalty, and interest assessed  
7 against the taxpayer and the agent's written narrative setting forth the grounds  
8 upon which the assessment is made.

9 (b) Copies of the agent's audit workpapers shall be:

10 1. Included with the notice of tax due; or

11 2. Delivered electronically to the taxpayer.

12 (c) Taxpayers shall be similarly notified regarding the denial or reduction of any  
13 refund or credit claim filed by a taxpayer;

14 (9) (a) Taxpayers shall have the right to an installment payment agreement for the  
15 payment of delinquent taxes, penalties, and interest owed, provided the  
16 taxpayer requests the agreement in writing clearly demonstrating:

17 1. His or her inability to pay in full; and

18 2. That the agreement will facilitate collection by the department of the  
19 amounts owed.

20 (b) The department may modify or terminate an installment payment agreement  
21 and may pursue statutory remedies against the taxpayer if it determines that:

22 1. The taxpayer has not complied with the terms of the agreement,  
23 including minimum payment requirements established by the  
24 agreement;

25 2. The taxpayers' financial condition has sufficiently changed;

26 3. The taxpayer fails to provide any requested financial condition update  
27 information;

- 1           4. The taxpayer gave false or misleading information in securing the  
2           agreement; or
- 3           5. The taxpayer fails to timely report and pay any other tax due the  
4           Commonwealth.
- 5           (c) The department shall give written notice to the taxpayer at least thirty (30)  
6           days prior to modifying or terminating an installment payment agreement  
7           unless the department has reason to believe that collection of the amounts  
8           owed will be jeopardized in whole or in part by delay;
- 9           (10) The department shall not knowingly authorize, require, or conduct any investigation  
10          or surveillance of any person for nontax administration related purposes, except  
11          internal security related investigations involving department personnel;
- 12          (11) In addition to the circumstances under which an extension of time for filing reports  
13          or returns may be granted pursuant to KRS 131.170, taxpayers shall be entitled to  
14          the same extension of the due date of any comparable Kentucky tax report or return  
15          for which the taxpayer has secured a written extension from the Internal Revenue  
16          Service provided the taxpayer notifies the department in writing and provides a  
17          copy of the extension at the time and in the manner which the department may  
18          require;
- 19          (12) The department shall bear the cost or, if paid by the taxpayer, reimburse the  
20          taxpayer for recording or bank charges as the direct result of any erroneous lien or  
21          levy by the department, provided the erroneous lien or levy was caused by  
22          department error and, prior to issuance of the erroneous lien or levy, the taxpayer  
23          timely responded to all contacts by the department and provided information or  
24          documentation sufficient to establish his or her position. When the department  
25          releases any erroneous lien or levy, notice of the fact shall be mailed to the taxpayer  
26          and, if requested by the taxpayer, a copy of the release, together with an  
27          explanation, shall be mailed to the major credit reporting companies located in the

1 county where it was filed;

2 (13) (a) The department shall not evaluate individual officers or employees on the  
3 basis of taxes assessed or collected or impose or suggest tax assessment or  
4 collection quotas or goals.

5 (b) No arrangement or contract shall be entered into for the service to:

6 1. Examine a taxpayer's books and records;

7 2. Collect a tax from a taxpayer; or

8 3. Provide legal representation of the department;

9 if any part of the compensation or other benefits paid or payable for the  
10 service is contingent upon or otherwise related to the amount of tax, interest,  
11 fee, or penalty assessed against or collected from the taxpayer. Any such  
12 arrangement or contract shall be void and unenforceable;

13 (14) Taxpayers shall have the right to bring an action for damages against the  
14 Commonwealth to the Board of Tax Appeals for actual and direct monetary  
15 damages sustained by the taxpayer as a result of willful, reckless, or intentional  
16 disregard by department employees of the rights of taxpayers as set out in KRS  
17 131.041 to 131.081 or in the tax laws administered by the department. In the  
18 awarding of damages pursuant to this subsection, the board shall take into  
19 consideration the negligence or omissions, if any, on the part of the taxpayer which  
20 contributed to the damages. If any proceeding brought by a taxpayer is ruled  
21 frivolous by the Board of Tax Appeals, the department shall be reimbursed by the  
22 taxpayer for its costs in defending the action. Any claims brought pursuant to this  
23 subsection shall be in accordance with KRS 49.040 to 49.180; and

24 (15) Taxpayers shall have the right to privacy with regard to the information provided on  
25 their Kentucky tax returns and reports, including any attached information or  
26 documents. Except as provided in KRS 131.190, no information pertaining to the  
27 returns, reports, or the affairs of a person's business shall be divulged by the

1 department to any person or be intentionally and without authorization inspected by  
2 any present or former commissioner or employee of the department, member of a  
3 county board of assessment appeals, property valuation administrator or employee,  
4 or any other person.

5 ➔Section 5. KRS 131.130 is amended to read as follows:

6 Without limitation of other duties assigned to it by law, the following powers and duties  
7 are vested in the department~~[of Revenue]~~:

- 8 (1) The department may promulgate administrative regulations, and direct proceedings  
9 and actions, for the administration and enforcement of all tax laws of this state. To  
10 assist taxpayers in understanding and interpreting the tax laws, the department may,  
11 through incorporation by reference, include examples as part of any administrative  
12 regulation. The examples may include demonstrative, nonexclusive lists of items if  
13 the department determines the lists would be helpful to taxpayers in understanding  
14 the application of the tax laws.
- 15 (2) The department, by representatives it appoints in writing, may take testimony or  
16 depositions, and may examine hard copy or electronic records, any person's  
17 documents, files, and equipment if those records, documents, or equipment will  
18 furnish knowledge concerning any taxpayer's tax liability, when it deems this  
19 reasonably necessary to the performance of its functions. The department may  
20 enforce this right by application to the Circuit Court in the county where the person  
21 is domiciled or has his or her principal office, or by application to the Franklin  
22 Circuit Court, which courts may compel compliance with the orders of the  
23 department.
- 24 (3) The department shall prescribe the style, and determine and enforce the use or  
25 manner of keeping, of all assessment and tax forms and records employed by state  
26 and county officials, and may prescribe forms necessary for the administration of  
27 any revenue law.

- 1 (4) The department shall advise on all questions respecting the construction of state  
2 revenue laws and its application to various classes of taxpayers and property.
- 3 (5) Attorneys employed by the Finance and Administration Cabinet and approved by  
4 the Attorney General as provided in KRS 15.020 may prosecute all violations of the  
5 criminal and penal laws relating to revenue and taxation. If a Finance and  
6 Administration Cabinet attorney undertakes any of the actions prescribed in this  
7 subsection, that attorney shall be authorized to exercise all powers and perform all  
8 duties in respect to the criminal actions or proceedings which the prosecuting  
9 attorney would otherwise perform or exercise, including the authority to sign, file,  
10 and present any complaints, affidavits, information, presentments, accusations,  
11 indictments, subpoenas, and processes of any kind, and to appear before all grand  
12 juries, courts, or tribunals.
- 13 (6) In the event of the incapacity of attorneys employed by the Finance and  
14 Administration Cabinet or at the request of the secretary of the Finance and  
15 Administration Cabinet, the Attorney General or his or her designee shall prosecute  
16 all violations of the criminal and penal laws relating to revenue and taxation. If the  
17 Attorney General undertakes any of the actions prescribed in this subsection, he or  
18 she shall be authorized to exercise all powers and perform all duties in respect to  
19 the criminal actions or proceedings which the prosecuting attorney would otherwise  
20 perform or exercise, including but not limited to the authority to sign, file, and  
21 present any and all complaints, affidavits, information, presentments, accusations,  
22 indictments, subpoenas, and processes of any kind, and to appear before all grand  
23 juries, courts, or tribunals.
- 24 (7) The department may require the Commonwealth's attorneys and county attorneys to  
25 prosecute actions and proceedings and perform other services incident to the  
26 enforcement of laws assigned to the department for administration.
- 27 (8) (a) Notwithstanding KRS Chapter 13A, the department may research the fields of

1           taxation, finance, and local government administration, publish its findings,  
2           respond to the public's and taxpayers' questions, and publish its responses~~], as~~  
3           ~~the commissioner may deem wise].~~

4           **(b)** To assist taxpayers and the public in understanding and interpreting the tax  
5           laws, the department:

6           **1.** May include examples as part of any response or publication. The  
7           examples may include demonstrative, nonexclusive lists of items, if the  
8           department determines that the list would be helpful to taxpayers in  
9           understanding the application of the tax laws; **and**

10           **2.** **Shall publish its administrative writings, tax forms, and instructions to**  
11           **those tax forms on its official website in accordance with subsection**  
12           **(1)(b) of Section 2 of this Act.**

13           (9) The department may promulgate administrative regulations necessary to establish a  
14           system of taxpayer identifying numbers for the purpose of securing proper  
15           identification of taxpayers subject to any tax laws or other revenue measure of this  
16           state, and may require the taxpayer to place on any return, report, statement, or  
17           other document required to be filed, any number assigned pursuant to the  
18           administrative regulations.

19           (10) The department may, when it is in the best interest of the Commonwealth and  
20           helpful to the efficient and effective enforcement, administration, or collection of  
21           sales and use tax, motor fuels tax, or the petroleum environmental assurance fee,  
22           enter into agreements with out-of-state retailers or other persons for the collection  
23           and remittance of sales and use tax, the motor fuels tax, or the petroleum  
24           environmental assurance fee.

25           (11) The department may enter into annual memoranda of agreement with any state  
26           agency, officer, board, commission, corporation, institution, cabinet, department, or  
27           other state organization to assume the collection duties for any debts due the state



1       entity, except for consumer debt owed for health care goods and services, and may  
2       renew that agreement for up to five (5) years. Under such an agreement, the  
3       department shall have all the powers, rights, duties, and authority with respect to the  
4       collection, refund, and administration of those liquidated debts as provided under:

14       services. For the purpose of this section, "consumer debt" shall be defined as a debt  
15       incurred by an individual, as defined in KRS 141.010, for a personal or family  
16       purpose, regardless of whether an obligation has been reduced to judgment.

17   (13) The department may refuse to accept a personal check in payment of taxes due or  
18       collected from any person who has ever tendered a check to the state which, when  
19       presented for payment, was not honored. Any check so refused shall be considered  
20       as never having been tendered.
