"(1) As used in this section:

- (a) "School is in session" means that time as established by local school district authorities pursuant to KRS 160.290; and
- (b) "School is not in session" means that period of time not included in paragraph (a) of this subsection."; and

On page 1, line 5, delete "(1)" and insert "(2)" in lieu thereof; and

On page 1, line 5, after "*subsection*", delete "(2)" and insert "(3)" in lieu thereof; and

On page 2, line 11, after "*room*;" delete "*or*"; and

On page 2, line 13, delete "." and insert ": or" in lieu thereof; and

On page 2, between lines 13 and 14 insert:

(u) Any occupation which the United States Secretary of Labor finds and declares to be <u>hazardous for the employment of minors as established in 29 C.F.R. secs. 570.50 to</u>

570.68."; and

On page 2, line 14, delete "(2)" and insert "(3)" in lieu thereof; and

On page 2, line 15, delete "(1)" and insert "(2)" in lieu thereof; and

On page 2, line 17, delete "<u>sec. 570.50(b)</u>" and insert "<u>secs. 570.50 to 570.68</u>" in lieu thereof; and

On page 2, line 22, delete "(3)" and insert "(4)" in lieu thereof; and

On page 2, line 22, delete "*under sixteen (16)*" and insert "*fourteen (14) to fifteen (15)*" in lieu thereof; and

On page 2, line 24, delete "(1)" and insert "(2)" in lieu thereof; and

On page 3, between lines 9 and 10 insert:

"(5) A person fourteen (14) to fifteen (15) years of age shall not be employed in any occupation beyond that which the United States Secretary of Labor permits a fourteen (14) to fifteen (15) year old to perform, as established in 29 C.F.R. pt. 570."; and

On page 3, line 24, delete "*under sixteen (16)*" and insert "*fourteen (14) to fifteen (15)*" in lieu thereof; and

On page 3, line 26, between "section" and "if" insert ", but not to exceed twenty-three (23)

hours during the work week,"; and

On page 4, delete lines 17 to 19 in their entirety and insert in lieu thereof:

- "(3) Subject to the restrictions listed in subsection (2) of Section 1 of this Act, minors sixteen (16) to seventeen (17) years of age shall not be employed in a gainful occupation unless <u>it occurs:</u>
 - (a) For not more than forty (40) hours in any week when school is in session;
 - (b) Between 6 a.m. and 11 p.m., except on a night preceding a nonschool day, which allows hours worked to 1 a.m.; and

(c) When school is not in session, as there shall be no restriction on hours.".
