6	(1) As us	sed in this section:
7	<u>(a)</u>	"Approved career and technical education dual credit" means earning a
8		grade of "C" or higher for a Kentucky Department of Education approved
9		career and technical education dual credit course equivalent to three (3)
10		hours of college credit;
11	<u>(b)</u>	"Administrative operations costs" means costs associated with the
12		operations and staffing of a state-operated area technology center,
13		including but not limited to personnel, facility costs, building utilities and
14		maintenance, and custodial and office supplies;
15	<u>(c)</u>	"Approved career and technical education pathway" means a four (4)
16		course career and technical education pathway approved by the Kentucky
17		Department of Education that provides a coherent, articulated sequence of
18		rigorous academic and career-related courses within a career and technical
19		education program area, and leads to an associate degree, an industry-
20		recognized certificate or license, or a baccalaureate or higher degree;
21	<u>(d)</u>	"Concentrator" means a student who has earned at least two (2) credits for
22		no less than two (2) courses in a single career and technical education
23		pathway;
24	<u>(e)</u>	"Converted career and technical education center" means a center
25		providing locally operated career and technical education for which a local
26		district assumed authority from the state for the management and control of
27		the center during the 2020-2021, 2021-2022, or 2022-2023 academic years;

1	<u>(f)</u>	"General-cost career and technical education program" means a career
2		and technical education program or pathway in which high-cost technical
3		equipment, materials, or facilities are not required;
4	<u>(g)</u>	"General-cost full-time equivalents" means the total number of secondary
5		students enrolled in general-cost career and technical education programs,
6		multiplied by the number of hours those students are enrolled, and divided
7		by six (6) hours;
8	<u>(h)</u>	"High-cost career and technical education program" means a career and
9		technical education program or pathway in which high-cost equipment,
10		materials, or facilities are required;
11	<u>(i)</u>	"Locally operated career and technical education" means a district
12		program that provides secondary students with one (1) or more approved
13		career and technical education pathways;
14	<u>(j)</u>	"State-operated area technology center" means a state-operated secondary
15		school facility with the primary purpose of offering approved career and
16		technical education pathways;
17	<u>(k)</u>	"Technical skill attainment" means earning an industry-recognized
18		certification, licensure, or credential as identified by the Kentucky
19		Workforce Innovation Board pursuant to KRS 158.6455(1)(e) or passing an
20		end-of-program assessment for articulated postsecondary credit as
21		designated by the Kentucky Department of Education Office of Career and
22		Technical Education;
23	<u>(1)</u>	"Weighted high-cost full-time equivalents" means the total number of
24		secondary students enrolled in high-cost career and technical education
25		programs, multiplied by the number of credit hours in which those students
26		are enrolled, divided by six (6) hours, and multiplied by one and one-half
27		(1.5); and

1		(m) "Work-based learning program" means a cooperative education program,
2		internship, or registered apprenticeship within the student's chosen
3		approved career and technical education pathway.
4	<u>(2)</u>	The Kentucky Department of Education shall provide funds from the
5		department's annual general fund appropriation to support the administrative
6		operations cost of area technology centers and converted career and technical
7		education centers.
8	<u>(3)</u>	For converted career and technical education centers, beginning with fiscal year
9		2024-2025, the Kentucky Department of Education shall deduct from funds
10		designated for the area technology centers an amount equal to the administrative
11		operations costs of each converted career and technical education center in the
12		amount received by the center in the most recent fiscal year that the center was
13		under state management and control. The funds for each converted career and
14		technical education center shall be divided as follows:
15		(a) Seventy-five percent (75%) of the funds shall be sent to the local district that
16		has assumed management and control of the center; and
17		(b) Twenty-five percent (25%) of the funds shall be sent to the career and
18		technical education innovation and support fund established in subsection
19		(4) of this section.
20	<u>(4)</u>	(a) There is hereby established in the State Treasury a restricted fund to be
21		known as the career and technical education innovation and support fund
22		to receive the funds allocated under subsection (3)(b) of this section. The
23		fund shall consist of moneys received from state appropriations, gifts,
24		grants, and federal funds. The fund shall be administered by the Office of
25		Career and Technical Education. Amounts deposited in the fund shall be
26		used for:
27		1. Supporting innovation in new or emerging career fields;

1	2. Supporting state-operated area technology centers that may
2	experience hardship or natural disasters;
3	3. Personnel costs to provide technical assistance to local districts
4	providing locally operated career and technical education, including
5	technical assistance relating to the monitoring and oversight on the
6	use of supplemental career and technical education funding; and
7	4. Any other purposes reasonably related to improving student outcomes
8	in career and technical education.
9	(b) Notwithstanding KRS 45.229, fund amounts not expended at the close of a
10	fiscal year shall not lapse but shall be carried forward into the next fiscal
11	<u>year.</u>
12	(c) Moneys deposited in the fund are hereby appropriated for the purposes see
13	forth in paragraph (a) of this subsection and shall not be appropriated or
14	transferred by the General Assembly for any other purposes.
15	(5) Beginning with the 2024-2025 fiscal year and for each fiscal year thereafter, the
16	Kentucky Department of Education shall distribute to local boards of education
17	providing locally operated career and technical education and state-operated area
18	technology centers all general funds designated to supplement career and
19	technical education programs.
20	(a) A local district providing locally operated career and technical education or
21	a state-operated area technology center shall maintain eligibility for receipt
22	of federal funding pursuant to the Strengthening Career and Technica
23	Education for the 21st Century Act, Pub. L. No. 115-224, to be eligible to
24	receive supplemental funding pursuant to this subsection.
25	(b) All supplemental funds distributed pursuant to this subsection shall be used
26	to improve student outcomes in career and technical education pathways for
27	students in grades nine (9) through twelve (12), including but not limited to

1	student supplies, resources, materials, and equipment that is designed for
2	enhanced quality of instruction in a career and technical education
3	pathway, the purchase and maintenance of industry standard equipment,
4	assisting students with achieving technical skill attainment, and supporting
5	career and technical student organization participation.
6	(c) 1. Supplemental funds for career and technical education shall be
7	divided and allocated to each local district providing locally operated
8	career and technical education and each area technology center with
9	sixty percent (60%) dedicated for enrollment-based funding and forty
10	percent (40%) for incentive-based funding.
11	2. The sixty percent (60%) enrollment-based funding shall be based on a
12	statewide full-time equivalent calculation of the total weighted high-
13	cost full-time equivalents and general cost full-time equivalents during
14	the prior school year.
15	a. The department shall then distribute the enrollment-based funds
16	for each area technology center or local district providing locally
17	operated career and technical education based on the center's or
18	district's proportional share of the combined weighted high-cost
19	full-time equivalents and general-cost full-time equivalents of
20	the prior year.
21	b. The department shall distribute the area technology center fund
22	portion to the respective area technology centers and the local
23	district fund portion to the respective local districts.
24	c. The department shall classify qualifying programs as either a
25	high-cost career and technical education program or a general-
26	cost career and technical education program.
27	3. The forty percent (40%) incentives-based funding shall be based on an

1	annual statewide calculation of the total number of qualifying student
2	incentives. The calculation shall only use students that are in grade
3	twelve (12) and use the total incentives earned by those students
4	during secondary education at a state-operated area technology center
5	or within a local district. Once a student has been included in a year's
6	calculation, that student shall not be included in any subsequent
7	year's calculation.
8	a. Qualifying student incentives for students in their grade twelve
9	(12) year shall include:
10	i. Reaching the designation of a concentrator;
11	ii. Technical skill attainment;
12	iii. Completing a required number of hours or achieving a
13	benchmark within a work-based learning program; and
14	iv. Earning an approved career and technical education dual
15	<u>credit.</u>
16	b. The incentives in subdivision a. of this subparagraph shall be
17	allotted to the area technology center or local district in which it
18	was earned. Each type of incentive shall only be counted once
19	per student at state-operated area technology centers and once
20	per student at local districts for a maximum of four (4) incentives
21	per student at state-operated area technology centers and four
22	(4) incentives at local districts throughout their secondary career
23	and technical education. For incentive criteria that is achieved
24	more than once at area technology centers, the incentive shall be
25	counted for the area technology center where it was first
26	achieved. For incentive criteria that is achieved more than once
27	at local districts, the incentive shall be counted for the local

1	district where it was first achieved.
2	c. The department shall distribute incentives-based funds for each
3	area technology center or local district based on the center's or
4	district's proportional share of the combined number of
5	qualifying student incentives achieved by students in grade
6	twelve (12) at a state-operated area technology center or within a
7	local district throughout their secondary career and technical
8	education. The incentives-based funds shall be distributed to the
9	area technology center or local district in which the incentive
10	was achieved.
11	d. The department shall distribute the area technology center fund
12	portion to the respective area technology centers and the local
13	district fund portion to the respective local districts.
14	(d) There shall be no mid-year adjustment to the allocation of career and
15	technical education supplemental funding for a center or local district.
16	(e) Notwithstanding the restriction in paragraph (b) of this subsection, a district
17	may submit a waiver request to the Office of Career and Technical
18	Education to use a portion of its allocation of supplemental funds for career
19	and technical education programming for students in grades (5) through
20	eight (8). The district shall submit a request which details the district's plan
21	for career and technical education programming for students in grades five
22	(5) through eight (8). In reviewing the request, the Office of Career and
23	Technical Education shall consider whether:
24	1. The district details a plan for orientation and exploration of broad-
25	based industries by giving students knowledge and experience
26	regarding careers within these industries and exploratory or hands-on
27	skills used in the industry;

1	2. There is direct alignment between middle and secondary career and
2	technical education pathways within the requesting district; and
3	3. Such designation of supplemental funding for programming for
4	students in grades five (5) through eight (8) does not have a
5	significant detrimental impact on the programming available for
6	students in secondary grades.
7	(6) The Office of Career and Technical Education shall monitor and provide
8	oversight of state funds distributed pursuant to this section to ensure that the use
9	of funding by eligible recipients meets the approved criteria as described in this
10	section.
11	(7) The Kentucky Board of Education shall promulgate such administrative
12	regulations in accordance with KRS Chapter 13A as may be needed in the
13	administration of this section and for disbursement of moneys from the funds.
14	→ Section 2. Whereas it is critical to ensure that funding for career and technical
15	education reflects student enrollment and successful outcomes in workforce preparation,
16	an emergency is declared to exist, and this Act takes effect on July 1, 2024.
