3		→ SECTION 1. A NEW SECTION OF KRS CHAPTER 40 IS CREATED TO
4	REA	AD AS FOLLOWS:
5	<u>(1)</u>	The Kentucky Service Members, Veterans, and their Families Suicide Prevention
6		Program is hereby created within the Kentucky Department of Veterans' Affairs
7		and shall be attached to the office of the commissioner for administrative
8		purposes.
9	<u>(2)</u>	The Kentucky Service Members, Veterans, and their Families Suicide Prevention
10		Program shall operate in collaboration with the Cabinet for Health and Family
11		Services and in conjunction with additional community partnerships, as
12		appropriate.
13	<u>(3)</u>	The mission of the program shall be to raise awareness of and reduce death by
14		suicide within the population of service members, veterans, and their families.
15		The program shall work to reduce barriers at the community and individual level
16		that increase the risk of suicide by increasing access to services and collaborating
17		with a statewide network of partners including state government agencies,
18		community partners, nonprofit organizations, federal partners, and individuals
19		directly impacted by risk of or loss from suicide.
20	<u>(4)</u>	The program shall connect service members, veterans, and their families, whose
21		need for services is based upon their risk of death by suicide or other
22		circumstances as outlined by the program, with appropriate community and
23		mental health resources. The program shall:
24		(a) 1. Raise awareness of and access to behavioral health services and
25		resources, promote evidence-based best practices and safe messaging
26		to increase awareness of veteran suicide prevention hotlines and other
27		crisis resources, and connect service members, veterans, and their

1		families to trained mental health providers and appropriate
2		community resources; and
3		2. Advocate for service members, veterans, and their families at risk for
4		suicide, and work to increase public awareness about the issue of
5		suicide among veterans and its root causes;
6	<u>(b)</u>	Provide support and guidance to communities aiding in the development of
7		strategic planning designed to reduce suicide among service members,
8		veterans, and their families, including the engagement and coordination of
9		local leadership, faith-based entities, schools, chambers of commerce,
10		public and private providers, grassroots coalitions, and additional
11		stakeholders as identified and appropriate. These efforts shall include but
12		not be limited to the promotion of mental health awareness, the 988 Suicide
13		Crisis Lifeline created in accordance with Pub. L. No. 116-172, the Green
14		Alert under KRS 39F.180, and local resources available to assist in crisis
15		intervention and ongoing supports; and
16	<u>(c)</u>	Promote training opportunities and provide educational materials to
17		department and partnering agencies to increase the capacity to raise
18		awareness, identify, and engage service members, veterans, and their
19		families at risk of suicide.
20	(5) Th	e department shall submit an annual written report to the Governor and the
21	<u>Le</u>	gislative Research Commission by October 30 of each year. The report shall
22	<u>inc</u>	clude efforts made, data-driven information, and legislative and budgetary
23	<u>ba</u>	rriers. The report shall be available to the public on the department's website.
24	(6) No	twithstanding any other statute to the contrary, nothing in this section shall
25	<u>per</u>	rmit any state agency to seize or advocate for the seizure of weapons.
26	(7) Th	e department shall promulgate administrative regulations in accordance with
27	<u>KF</u>	RS Chapter 13A as necessary to effectuate this section.

1		→ SECTION 2. A NEW SECTION OF KRS CHAPTER 337 IS CREATED TO
2	REA	AD AS FOLLOWS:
3	<u>(1)</u>	The Kentucky Department of Veterans' Affairs shall create and prominently
4		display on its website a veterans' benefits and services document. The document
5		shall be made for the purpose of downloading to print and not exceed two (2)
6		standard size eight and one-half (8-1/2) by eleven (11) inches pages. The
7		document shall include contact information for and a description of the following
8		resources for veterans:
9		(a) The Kentucky Department of Veterans' Affairs;
10		(b) Substance abuse and mental health treatment;
11		(c) Education, workforce, and training;
12		(d) Tax benefits;
13		(e) Kentucky driver's licenses and identification cards;
14		(f) Eligibility for unemployment insurance benefits under state and federal
15		<u>law;</u>
16		(g) Legal services; and
17		(h) The United States Department of Veterans Affairs Veterans Crisis Line.
18	<u>(2)</u>	Every employer subject to any provision of KRS 337.275 to 337.325, 337.345, or
19		337.385 to 337.405 or of any administrative regulations or orders issued under
20		KRS 337.295 may download, print, and keep copies of the most recent version of
21		the veterans' benefits and services document in a conspicuous and accessible
22		place in or about the premises wherein any person subject thereto is employed.
