

1 AN ACT proposing to amend Sections 145 and 155 of the Constitution of Kentucky  
2 relating to persons entitled to vote.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. Are you in favor of amending Sections 145 and 155 of the  
5 Constitution of Kentucky to prohibit persons who are not citizens of the United States  
6 from being allowed to vote in the Commonwealth of Kentucky, as stated below?

7 ➔Section 2. It is proposed that Section 145 of the Constitution of Kentucky be  
8 amended to read as follows:

9 Every citizen of the United States of the age of eighteen years who has resided in  
10 the state one year, and in the county six months, and the precinct in which he ***or she***  
11 offers to vote sixty days next preceding the election, shall be a voter in said precinct and  
12 not elsewhere. ***No person who is not a citizen of the United States shall be allowed to***  
13 ***vote in this state.*** ~~but~~ The following persons ***also*** ~~are excepted and~~ shall not have the  
14 right to vote: ~~[-]~~

15 1. Persons convicted in any court of competent jurisdiction of treason, or felony,  
16 or bribery in an election, or of such high misdemeanor as the General Assembly may  
17 declare shall operate as an exclusion from the right of suffrage, but persons hereby  
18 excluded may be restored to their civil rights by executive pardon.

19 2. Persons who, at the time of the election, are in confinement under the  
20 judgment of a court for some penal offense.

21 3. Idiots and insane persons.

22 ➔Section 3. It is proposed that Section 155 of the Constitution of Kentucky be  
23 amended to read as follows:

24 The provisions of Sections 145 to 154, inclusive, shall not apply to the election of  
25 school trustees and other common school district elections. Said elections shall be  
26 regulated by the General Assembly, except as otherwise provided in this Constitution.

27 ***No person who is not a citizen of the United States shall be allowed to vote in said***

1 *elections.*

2       ➔Section 4. This amendment shall be submitted to the voters of the  
3 Commonwealth for their ratification or rejection at the time and in the manner provided  
4 for under Sections 256 and 257 of the Constitution, KRS 118.415, and Sections 5 and 6  
5 of this Act.

6       ➔Section 5. Notwithstanding any provision of KRS 118.415 to the contrary, the  
7 Secretary of State shall cause the entirety of the question in Section 1 of this Act and the  
8 entirety of the proposed amendment to the Constitution of Kentucky contained in  
9 Sections 2 and 3 of this Act to be published at least one time in a newspaper of general  
10 circulation published in this state, and shall also cause to be published at the same time  
11 and in the same manner the fact that the amendment will be submitted to the voters for  
12 their acceptance or rejection at the next regular election at which members of the General  
13 Assembly are to be voted for. The publication required by this section and KRS 118.415  
14 shall be made no later than the first Tuesday in August preceding the election at which  
15 the amendment is to be voted on.

16       ➔Section 6. Notwithstanding any provision of KRS 118.415 to the contrary, the  
17 Secretary of State, not later than the second Monday after the second Tuesday in August  
18 preceding the next regular election at which members of the General Assembly are to be  
19 chosen in a year in which there is not an election for President and Vice President of the  
20 United States, or not later than the Thursday after the first Tuesday in September  
21 preceding a regular election in a year in which there is an election for President and Vice  
22 President of the United States, shall certify the entirety of the question in Section 1 of this  
23 Act and the entirety of the proposed amendment to the Constitution of Kentucky  
24 contained in Sections 2 and 3 of this Act to the county clerk of each county, and the  
25 county clerk shall have the entirety of the question and the amendment, as so certified,  
26 indicated on the ballots provided to the voters in paper or electronic form as applicable to  
27 the voting machines in use in each county or precinct.
