1	AN ACT relating to emergency medical services.
2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 311A IS CREATED TO
4	READ AS FOLLOWS:
5	(1) There is hereby established an emergency medical services education grant
6	program overseen by the board to increase the number of persons seeking
7	paramedic initial certification, provide more facilities for certification, and
8	encourage persons to be employed by Class I ground ambulance providers
9	located in Kentucky. The program shall consist of three (3) components:
10	(a) Student tuition support;
11	(b) Agency support; and
12	(c) Emergency medical services training or educational institution support.
13	(2) The student tuition support component shall be used for the training and
14	education of individuals seeking initial paramedic certification under this chapter
15	who are employed by a Class I ground ambulance provider. The tuition support
16	shall be paid periodically to the emergency medical services training or education
17	institution in which the person is enrolled seeking paramedic certification. The
18	board shall, at a minimum, promulgate administrative regulations on the
19	following aspects of this component:
20	(a) Time limits for the individual seeking initial paramedic certification to
21	complete certification and begin or continue service with a Class I ground
22	ambulance provider;
23	(b) Minimum service length requirements that may be imposed by the board, by
24	contract, or both, on the individual seeking initial paramedic certification;
25	(c) Uses of the funds, including but not limited to a prohibition against
26	spending funds on prerequisite courses not included in the core course
27	content of the paramedic certification program;

1	(d) Providing priority consideration for geographic areas that are underserved
2	in terms of paramedic coverage, including those with lower populations and
3	higher emergency medical response times, and for agencies that do not meet
4	national standards of minimum staffing levels or response times for the
5	dispatch of emergency medical care; and
6	(e) Any other aspect necessary to implement the student tuition support
7	<u>component.</u>
8	(3) The agency support component shall be used to reimburse Class I ground
9	ambulance providers the wages paid to an employee while the employee seeks
10	initial paramedic certification. The board shall, at a minimum, promulgate
11	administrative regulations on the following aspects of this component:
12	(a) Maximum reimbursement for each employee of a Class I ground
13	ambulance provider seeking initial paramedic certification;
14	(b) Maximum number of employees eligible for wage reimbursement within
15	each Class I ground ambulance provider; and
16	(c) Any other aspect necessary to implement the agency support component.
17	(4) The emergency medical services training or educational institution support
18	component shall be used to provide funding to existing and start-up emergency
19	medical service training and educational institutes that are certified or seeking
20	certification by the board and that offer or will offer initial education courses for
21	emergency medical technician, advanced emergency medical technician, and
22	paramedic programs. The board shall, at a minimum, promulgate administrative
23	regulations on the following aspects of this component:
24	(a) Grant ceilings per applicant;
25	(b) Applicant qualification priorities, including but not limited to those that are
26	nonprofit entities operating under KRS Chapter 273 and those that are
27	serving or plan to serve areas in need of improved emergency medical

2		<u>(c)</u>	Time limits for commencing the classes or programs for which the grant
3			was sought;
4		<u>(d)</u>	1. Eligible costs, which shall include but not be limited to:

18			travel and meals, and perquisites that are part of a compensation
19			package;
20			<u>d. Lobbying; and</u>
21			e. Uniforms and clothing; and
22		<u>(e)</u>	Any other aspect necessary to implement the emergency medical services
23			training or educational institution support component.
24	<u>(5)</u>	(a)	There is established in the State Treasury a trust and agency account to be
25			known as the emergency medical services education grant fund.
26		<u>(b)</u>	The fund shall be administered by the Kentucky Board of Emergency
27			Medical Services.

1		(c) The fund shall consist of state appropriations, contributions, donations, and
2		<u>gifts.</u>
3		(d) Amounts deposited in the fund shall be used for the purposes outlined
4		under this section.
5		(e) Notwithstanding KRS 45.229, fund amounts not expended at the close of a
6		fiscal year shall not lapse but shall remain in the fund.
7		(f) Moneys deposited in the fund are hereby appropriated for the purposes set
8		forth in this section.
