1 AN ACT relating to economic development and declaring an emergency.

- 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:
- 3 → Section 1. KRS 103.240 is amended to read as follows:
- 4 All money received from the sale of the bonds shall be applied solely for:
- 5 (1) The acquisition of the industrial building and:
- 6 (a) Any utilities;
- 7 (b) Pollution control structures or equipment;
- 8 (c) Equipment or technologies employed to increase the energy efficiency of manufacturing facilities; or
- 10 (d) Other equipment requisite to the use of these assets;
- 11 (2) The acquisition of pollution control facilities and the structures or equipment
- requisite to the use thereof;
- 13 (3) The necessary expense of preparing, printing, and selling said bonds;
- 14 (4) The refunding of any issued and outstanding bonds whether matured or otherwise;
- 15 (5) Providing a debt service reserve fund or any other reserve funds, if necessary; [or ]
- 16 (6) To advance the payment of interest on the bonds during any portion of the first
- three (3) years following the date of the bonds; or
- 18 (7) To pay working capital expenditures.
- → Section 2. Whereas the payment of working capital expenditures is important
- 20 for economic growth in the Commonwealth, an emergency is declared to exist, and this
- 21 Act takes effect upon its passage and approval by the Governor or upon its otherwise
- becoming a law.
