1	<u>(c)</u>	A student shall be considered to have successfully completed the test if at
2		least seventy percent (70%) of the questions are answered correctly. A
3		student who has passed a similar test within the previous five (5) years may
4		provide the board with evidence of successful completion and shall not be
5		required to take the test under this section;
6	<u>(d)</u>	By September 1, 2026, and each year thereafter, each school district
7		requiring a civics test for graduation shall submit annual testing data to the
8		Kentucky Department of Education. The department shall compile the data
9		and by November 1 of each year submit an annual report to the Legislative
10		Research Commission for referral to the Interim Joint Committee on
11		Education. The report shall include:
12		1. The first-time successful completion rate of the civics test; and
13		2. The average number of times a student takes the civics test for
14		successful completion; and
15	<u>(e)</u>	Provisions of this section shall be subject to the requirements and
16		accommodations of a student's individualized education program as defined
